1 moves to amend the bill on page 170, line 36, by deleting "**CREATE REGIONAL BASE**
2 **RATES FOR HOSPITALS**" and substituting "**CREATE STATEWIDE BASE RATE FOR**
3 **HOSPITALS**"; and

5 on page 170, lines 41 through 49, by deleting Section 12H.20(b) of the bill and substituting the
6 following:

8 "**SECTION 12H.20.(b)** The Department of Health and Human Services, Division
9 of Medical Assistance, shall replace the existing base rates for individual hospitals with a single
10 statewide base rate for all hospitals. The new base rate for all hospitals shall be the
11 mathematical average of the all of the hospitals' base rates prior to the rate revision, after first
12 adjusting the base rates as required by subsection (a) of this section."; and

14 on page 152, lines 26 through 27, by deleting "**REPEAL UNAUTHORIZED STATE PLAN**
15 **AMENDMENT**" and substituting "**AMEND STATE PLAN**"; and

17 on page 153, lines 44 through 48, by deleting Section 12H.2(c) of the bill and substituting the
18 following:

20 "**SECTION 12H.2.(c)** The Department of Health and Human Services shall take
21 any and all action necessary to amend the Medicaid State Plan, Attachment 4.19-B, Section 5,
22 Page 2, which pertains to supplemental payments that increase reimbursement to the average
23 commercial rate for certain eligible medical professional providers, in order to limit the
24 definition of eligible medical professional providers to only physicians employed by the East
25 Carolina University school of medicine or the University of North Carolina at Chapel Hill
26 school of medicine as academic faculty. The supplemental payments shall be made only for
27 services provided at these schools of medicine."
