1 moves to amend the bill on page 159, line 21,  
2 by inserting a new section on the line to read:

4 **"EXPAND MEDICAID COVERAGE TO PERSONS FOR WHOM THE FEDERAL**  
5 **GOVERNMENT WILL PAY ONE-HUNDRED PERCENT OF THE SERVICE**  
6 **COSTS UNDER THE AFFORDABLE CARE ACT**

7 **SECTION 12H.10A.(a)** Effective January 1, 2014, G.S. 108A-54.6(c), enacted by  
8 Section 12H.10 of this act, is amended by adding a new subdivision to read as follows:

9 '(7) All people under age 65 who have incomes equal to or less than one hundred  
10 thirty-three percent (133%) of the federal poverty guidelines.'

11 **SECTION 12H.10A.(b)** Section 3 of S.L. 2013-5 is repealed.

12 **SECTION 12H.10A.(c)** Notwithstanding any provision of this act to the contrary,  
13 from the savings generated as a result of expanding Medicaid eligibility to all people under age  
14 65 who have incomes equal to or less than one hundred thirty-three percent (133%) of the  
15 federal poverty guidelines:

16 (1) The sum of ten million three hundred sixty-three thousand one hundred  
17 seventy-six dollars (\$10,363,176) for the 2013-2014 fiscal year and the sum  
18 of fourteen million six hundred twenty-eight thousand seventeen dollars  
19 (\$14,628,017) for the 2014-2015 fiscal year is appropriated to the Division  
20 of Medical Assistance for the State's share of additional Medicaid contract  
21 costs for administrative expenses related to this expansion.

22 (2) The balance of the savings generated as a result of this expansion in the sum  
23 of twelve million one hundred thirty-one thousand four hundred forty-three  
24 dollars (\$12,131,443) for the 2013-2014 fiscal year and in the sum of thirty  
25 million three hundred sixty-one thousand two hundred twenty-two dollars  
26 (\$30,361,222) for the 2014-2015 fiscal year is appropriated to the Division  
27 of Mental Health, Developmental Disabilities, and Substance Abuse  
28 Services.

29 **SECTION 12H.10A.(d)** Notwithstanding any provision of this act to the contrary,  
30 as a result of the savings achieved by the expansion described in Section 12H.10A.(c):

31 (1) Funds appropriated in this act to the Department of Health and Human  
32 Services shall be reduced as follows:
