4 The General Assembly of North Carolina enacts:

5  
6 **STRATEGIC TRANSPORTATION INVESTMENTS**

7 **SECTION 1.1.(a)** Chapter 136 of the General Statutes is amended by adding a new  
8 Article to read:

9 "Article 14B.

10 "Strategic Prioritization Funding Plan for Transportation Investments.

11 "**§ 136-189.10. Definitions.**

12 The following definitions apply in this Article:

- 13 (1) Statewide strategic mobility projects. – Includes only the following:  
14 a. Interstate highways and future interstate highways approved by the  
15 federal government.  
16 b. Routes on the National Highway System as of July 1, 2012,  
17 excluding intermodal connectors.  
18 c. Highway routes on the United States Department of Defense  
19 Strategic Highway Network (STRAHNET).  
20 d. Interstate highway toll routes designated by the Department of  
21 Transportation, pursuant to its authority under State law, or  
22 extensions of highway toll projects in existence on, or for which  
23 funds have been obligated, by July 1, 2013.  
24 e. Highway projects listed in G.S. 136-179, as it existed on July 1,  
25 2012, that are not authorized for construction as of July 1, 2015.  
26 f. Appalachian Development Highway System.  
27 g. Commercial service airports included in the Federal Aviation  
28 Administration's National Plan of Integrated Airport Systems  
29 (NPIAS) that provide international passenger service or 375,000 or  
30 more enplanements annually, provided that the State's annual  
31 financial participation in any single airport project included in this

- 1 subdivision may not exceed five hundred thousand dollars  
2 (\$500,000).
- 3 h. Freight capacity and safety improvements to Class I freight rail  
4 corridors.
- 5 (2) Regional impact projects. – Includes only the following:
- 6 a. Projects listed in subdivision (1) of this section, subject to the  
7 limitations noted in that subdivision.
- 8 b. U.S. highway routes not included in subdivision (1) of this section.
- 9 c. N.C. highway routes not included in subdivision (1) of this section.
- 10 d. Highway toll routes not included in subdivision (1) of this section.
- 11 e. Commercial service airports included in the NPIAS that are not  
12 included in subdivision (1) of this section, provided that the State's  
13 annual financial participation in any single airport project included in  
14 this subdivision may not exceed three hundred thousand dollars  
15 (\$300,000).
- 16 f. The State-maintained ferry system, excluding passenger vessel  
17 replacement.
- 18 g. Freight capacity and safety improvements to rail corridors spanning  
19 two or more counties and not included in subdivision (1) of this  
20 section.
- 21 (3) Division needs projects. – Includes only the following:
- 22 a. Projects listed in subdivision (1) or (2) of this section, subject to the  
23 limitations noted in those subsections.
- 24 b. State highway routes not included in subdivision (1) or (2) of this  
25 section.
- 26 c. Airports included in the NPIAS that are not included in subdivision  
27 (1) or (2) of this section, provided that the State's total annual  
28 financial participation under this sub-subdivision shall not exceed  
29 eighteen million five hundred thousand dollars (\$18,500,000).
- 30 d. Freight capacity and safety improvements to rail corridors not  
31 included in subdivision (1) or (2) of this section.
- 32 e. Public transportation service improvements, facilities, and  
33 equipment, including intercity rail, commuter rail, light rail,  
34 multimodal terminals and stations used for passenger transit.
- 35 f. Federally funded bicycle and pedestrian improvements.
- 36 g. Replacement of State-maintained ferry vessels.
- 37 h. Federally funded municipal road projects.
- 38 (4) Distribution Regions. – The following Distribution Regions apply to this  
39 Article:
- 40 a. Distribution Region A consists of the following counties: Bertie,  
41 Camden, Chowan, Currituck, Dare, Edgecombe, Gates, Halifax,  
42 Hertford, Hyde, Johnston, Martin, Nash, Northampton, Pasquotank,  
43 Perquimans, Tyrrell, Washington, Wayne, and Wilson.
- 44 b. Distribution Region B consists of the following counties: Beaufort,  
45 Brunswick, Carteret, Craven, Duplin, Greene, Jones, Lenoir, New  
46 Hanover, Onslow, Pamlico, Pender, Pitt, and Sampson.
- 47 c. Distribution Region C consists of the following counties: Bladen,  
48 Columbus, Cumberland, Durham, Franklin, Granville, Harnett,  
49 Person, Robeson, Vance, Wake, and Warren.

- 1           d.     Distribution Region D consists of the following counties: Alamance,  
2           Caswell, Davidson, Davie, Forsyth, Guilford, Orange, Rockingham,  
3           Rowan, and Stokes.  
4           e.     Distribution Region E consists of the following counties: Anson,  
5           Cabarrus, Chatham, Hoke, Lee, Mecklenburg, Montgomery, Moore,  
6           Randolph, Richmond, Scotland, Stanly, and Union.  
7           f.     Distribution Region F consists of the following counties: Alexander,  
8           Alleghany, Ashe, Avery, Caldwell, Catawba, Cleveland, Gaston,  
9           Iredell, Lincoln, Surry, Watauga, Wilkes, and Yadkin.  
10          g.     Distribution Region G consists of the following counties: Buncombe,  
11          Burke, Cherokee, Clay, Graham, Haywood, Henderson, Jackson,  
12          Macon, Madison, McDowell, Mitchell, Polk, Rutherford, Swain,  
13          Transylvania, and Yancey.

14 **"§ 136-189.11. Transportation Investment Strategy Formula.**

15       (a)     Funds Subject to Formula. – The following sources of funds are subject to this  
16 section:

- 17           (1)     Highway Trust Fund funds, in accordance with G.S. 136-176.  
18           (2)     Federal aid funds.

19       (b)     Funds Excluded From Formula. – The following funds are not subject to this  
20 section:

- 21           (1)     Federal congestion mitigation and air quality improvement program funds  
22 appropriated to the State by the United States pursuant to 23 U.S.C. §  
23 104(b)(2) and 23 U.S.C. § 149.  
24           (2)     Funds received through competitive awards or discretionary grants through  
25 federal appropriations either for local governments, transportation  
26 authorities, transit authorities, or the Department.  
27           (3)     Funds received from the federal government that under federal law may only  
28 be used for Appalachian Development Highway System projects.  
29           (4)     Funds used in repayment of "GARVEE" bonds related to Phase I of the  
30 Yadkin River Veterans Memorial Bridge project.  
31           (5)     Funds committed to gap funding for toll roads funded with bonds issued  
32 pursuant to G.S. 136-176.  
33           (6)     Funds obligated for projects in the State Transportation Improvement  
34 Program that are scheduled for construction as of April 1, 2013, in State  
35 fiscal year 2012-2013, 2013-2014, or 2014-2015.  
36           (7)     Toll collections from a turnpike project under Article 6H of this Chapter and  
37 other revenue from the sale of the Authority's bonds or notes or project  
38 loans, in accordance with G.S. 136-89.192.  
39           (8)     Toll collections from the State-maintained ferry system collected under the  
40 authority of G.S. 136-82.

41       (b1)    Funds Excluded From Regional Impact Project Category. – Federal Surface  
42 Transportation Program-Direct Attributable funds expended on eligible projects in the Regional  
43 Impact Project category are excluded from that category.

44       (c)     Funds With Alternate Criteria. – The following federal program activities shall be  
45 included in the applicable category of the Transportation Investment Strategy Formula set forth  
46 in subsection (d) of this section but shall not be subject to the prioritization criteria set forth in  
47 that subsection:

- 48           (1)     Bridge replacement.  
49           (2)     Interstate maintenance.  
50           (3)     Highway safety improvement.

1        (d) Transportation Investment Strategy Formula. – Funds subject to the Formula shall  
2 be distributed as follows:

3            (1) Statewide Strategic Mobility Projects. – Forty percent (40%) of the funds  
4 subject to this section shall be used for Statewide Strategic Mobility  
5 Projects.

6            a. Criteria. – Transportation-related quantitative criteria shall be used  
7 by the Department to rank highway projects that address  
8 cost-effective Statewide Strategic Mobility needs and promote  
9 economic and employment growth. The criteria for selection of  
10 Statewide Strategic Mobility Projects shall utilize a numeric scale of  
11 100 points, based on consideration of the following quantitative  
12 criteria:

- 13            1. Benefit cost.
- 14            2. Congestion.
- 15            3. Safety.
- 16            4. Economic competitiveness.
- 17            5. Freight.
- 18            6. Multimodal.
- 19            7. Pavement condition.
- 20            8. Lane width.
- 21            9. Shoulder width.

22            b. Project cap. – No more than ten percent (10%) of the funds projected  
23 to be allocated to the Statewide Strategic Mobility category over any  
24 five-year period may be assigned to any contiguous project or group  
25 of projects in the same corridor within a Highway Division or within  
26 adjoining Highway Divisions.

27            (2) Regional Impact Projects. – Thirty percent (30%) of the funds subject to this  
28 section shall be used for Regional Impact Projects and allocated by  
29 population of Distribution Regions based on the most recent estimates  
30 certified by the Office of State Budget and Management.

31            a. Criteria. – A combination of transportation-related quantitative  
32 criteria, qualitative criteria, and local input shall be used to rank  
33 Regional Impact Projects involving highways that address  
34 cost-effective needs from a region-wide perspective and promote  
35 economic growth. Local input is defined as the rankings identified by  
36 the Department's Transportation Division Engineers, Metropolitan  
37 Planning Organizations, and Rural Transportation Planning  
38 Organizations. The criteria utilized for selection of Regional Impact  
39 Projects shall be based thirty percent (30%) on local input and  
40 seventy percent (70%) on consideration of a numeric scale of 100  
41 points based on the following quantitative criteria:

- 42            1. Benefit cost.
- 43            2. Congestion.
- 44            3. Safety.
- 45            4. Freight.
- 46            5. Multimodal.
- 47            6. Pavement condition.
- 48            7. Lane width.
- 49            8. Shoulder width.
- 50            9. Accessibility and connectivity to employment centers, tourist  
51 destinations, or military installations.

1           (3)   Division Need Projects. – Thirty percent (30%) of the funds subject to this  
2           section shall be allocated in equal share to each of the Department divisions,  
3           as defined in G.S. 136-14.1, and used for Division Need Projects.

4           a.     Criteria. – A combination of transportation-related quantitative  
5           criteria, qualitative criteria, and local input shall be used to rank  
6           Division Need Projects involving highways that address  
7           cost-effective needs from a Division-wide perspective, provide  
8           access, and address safety-related needs of local communities. Local  
9           input is defined as the rankings identified by the Department's  
10           Transportation Division Engineers, Metropolitan Planning  
11           Organizations, and Rural Transportation Planning Organizations. The  
12           criteria utilized for selection of Division Need Projects shall be based  
13           fifty percent (50%) on local input and fifty percent (50%) on  
14           consideration of a numeric scale of 100 points based on the following  
15           quantitative criteria, except as provided in sub-subdivision b. of this  
16           subdivision:

17           1.     Benefit cost.

18           2.     Congestion.

19           3.     Safety.

20           4.     Freight.

21           5.     Multimodal.

22           6.     Pavement condition.

23           7.     Lane width.

24           8.     Shoulder width.

25           9.     Accessibility and connectivity to employment centers, tourist  
26           destinations, or military installations.

27           b.     Alternate criteria. – Funding from the following programs shall be  
28           included in the computation of each of the Department division equal  
29           shares but shall be subject to alternate quantitative criteria:

30           1.     Federal Surface Transportation Program-Direct Attributable  
31           funds expended on eligible projects in the Division Need  
32           Projects category.

33           2.     Federal Transportation Alternatives funds appropriated to the  
34           State.

35           3.     Federal Railway-Highway Crossings Program funds  
36           appropriated to the State.

37           4.     Projects requested from the Department in support of a  
38           time-critical job creation opportunity, when the opportunity  
39           would be classified as transformational under the Job  
40           Development Investment Grant program established pursuant  
41           to G.S. 143B-437.52, provided that the total State investment  
42           in each fiscal year for all projects funded under this  
43           sub-subdivision shall not exceed ten million dollars  
44           (\$10,000,000) in the aggregate or two million dollars  
45           (\$2,000,000) per project.

46           5.     Federal funds for municipal road projects.

47           c.     Bicycle and pedestrian limitation. – The Department shall not  
48           provide financial support for bicycle and pedestrian improvement  
49           projects, except for federal funds administered by the Department for  
50           that purpose. This sub-subdivision shall not apply to funds allocated  
51           to a municipality pursuant to G.S. 136-41.1 which are committed by

- 1                   the municipality as matching funds for federal funds administered by  
2                   the Department and used for bicycle and pedestrian improvement  
3                   projects. This limitation shall not apply to projects under construction  
4                   or authorized for construction on June 30, 2013.
- 5           (4)   Criteria for nonhighway projects. – Nonhighway projects subject to this  
6           subsection shall be evaluated through a separate prioritization process  
7           established by the Department that complies with all of the following:
- 8                   a.   The criteria used for selection of projects for a particular  
9                   transportation mode shall be based on a minimum of four  
10                   quantitative criteria.
- 11                   b.   Local input shall include rankings of projects identified by the  
12                   Department's Transportation Division Engineers, Metropolitan  
13                   Planning Organizations, and Rural Transportation Planning  
14                   Organizations.
- 15                   c.   The criteria shall be based on a scale not to exceed 100 points that  
16                   includes no bonus points or other alterations favoring any particular  
17                   mode of transportation.
- 18           (e)   Authorized Formula Variance. – The Department may vary from the Formula set  
19           forth in this section if it complies with the following:
- 20                   (1)   Limitation on variance. – The Department, in obligating funds in accordance  
21                   with this section, shall ensure that the percentage amount obligated to  
22                   Statewide Strategic Mobility Projects, Regional Impact Projects, and  
23                   Division Need Projects does not vary by more than five percent (5%) over  
24                   any five-year period from the percentage required to be allocated to each of  
25                   those categories by this section. Funds obligated among distribution regions  
26                   or divisions pursuant to this section may vary up to ten percent (10%) over  
27                   any five-year period.
- 28                   (2)   Calculation of variance. – Each year the Secretary shall calculate the amount  
29                   of Regional Impact and Division Need funds allocated in that year to each  
30                   division and region, the amount of funds obligated, and the amount the  
31                   obligations exceeded or were below the allocation. In the first variance  
32                   calculation under this subdivision following the end of fiscal year  
33                   2015-2016, the target amounts obtained according to the Formula set forth in  
34                   this section shall be adjusted to account for any differences between  
35                   allocations and obligations reported for the previous year. In the first  
36                   variance calculation under this subdivision following the end of fiscal year  
37                   2016-2017, the target amounts obtained according to the Formula set forth in  
38                   this section shall be adjusted to account for any differences between  
39                   allocations and obligations reported for the previous two fiscal years. In the  
40                   first variance calculation under this subdivision following the end of fiscal  
41                   year 2017-2018, the target amounts obtained according to the Formula set  
42                   forth in this section shall be adjusted to account for any differences between  
43                   allocations and obligations reported for the previous three fiscal years. In the  
44                   first variance calculation under this subdivision following the end of fiscal  
45                   year 2018-2019, the target amounts obtained according to the Formula set  
46                   forth in this section shall be adjusted to account for any differences between  
47                   allocations and obligations reported for the previous four fiscal years. The  
48                   new target amounts shall be used to fulfill the requirements of subdivision  
49                   (1) of this subsection for the next update of the Transportation Improvement  
50                   Program. The adjustment to the target amount shall be allocated by  
51                   Distribution Region or Division, as applicable.

1       (f)     Incentives for Local Funding and Highway Tolling. – The Department may revise  
2 highway project selection ratings based on local government funding initiatives and capital  
3 construction funding directly attributable to highway toll revenue. Projects authorized for  
4 construction after November 1, 2013, and contained in the 10-year Department of  
5 Transportation work program are eligible for a bonus allocation under this subsection.

6           (1)     Definitions. – The following definitions apply in this subsection:

7           a.     Bonus allocation. – The allocation obtained as a result of local  
8 government funding participation or highway tolling.

9           b.     Local funding participation. – Non-State or nonfederal funds  
10 committed by local officials to leverage the commitment of State or  
11 federal transportation funds towards construction.

12          (2)     Funds obtained from local government funding participation. – Upon  
13 authorization to construct a project with funds obtained by local government  
14 funding participation, the Department shall make available for allocation as  
15 set forth in subdivision (4) of this section an amount equal to one-half of the  
16 local funding commitment for other eligible highway projects that serve the  
17 local entity or entities that provided the local funding.

18          (3)     Funds obtained through highway tolling. – Upon authorization to construct a  
19 project with funding from toll revenue, the Department shall make available  
20 for allocation an amount equal to one-half of the project construction cost  
21 derived from toll revenue bonds. The amount made available for allocation  
22 to other eligible highway projects shall not exceed two hundred million  
23 dollars (\$200,000,000) of the capital construction funding directly  
24 attributable to the highway toll revenues committed in the Investment Grade  
25 Traffic and Revenue Study, for a project for which funds have been  
26 committed on or before July 1, 2015. The amount made available for  
27 allocation to other eligible highway projects shall not exceed one hundred  
28 million dollars (\$100,000,000) of the capital construction funding directly  
29 attributable to the highway toll revenues committed in the Investment Grade  
30 Traffic and Revenue Study, for a project for which funds are committed after  
31 July 1, 2015. If the toll project is located in one or more Metropolitan  
32 Planning Organization or Rural Transportation Planning Organization  
33 boundaries, based on the boundaries in existence at the time of letting of the  
34 project construction contract, the bonus allocation shall be distributed  
35 proportionately to lane miles of new capacity within the Organization's  
36 boundaries. The Organization shall apply the bonus allocation only within  
37 those counties in which the toll project is located.

38          (4)     Use of bonus allocation. – The Metropolitan Planning Organization, Rural  
39 Transportation Planning Organization, or the local government may choose  
40 to apply its bonus allocation in one of the three categories or in a  
41 combination of the three categories as provided in this subdivision.

42          a.     Statewide Strategic Mobility Projects category. – The bonus  
43 allocation shall apply over the five-year period in the State  
44 Transportation Improvement Program in the cycle following the  
45 contractual obligation.

46          b.     Regional Impact Projects category. – The bonus allocation is capped  
47 at ten percent (10%) of the regional allocation, or allocation to  
48 multiple regions, made over a five-year period and shall be applied  
49 over the five-year period in the State Transportation Improvement  
50 Program in the cycle following the contractual obligation.

1           c.     Division Needs Projects category. – The bonus allocation is capped  
2           at ten percent (10%) of the division allocation, or allocation to  
3           multiple divisions, made over a five-year period and shall be applied  
4           over the five-year period in the State Transportation Improvement  
5           Program in the cycle following the contractual obligation.

6           (g)    Reporting. – The Department shall publish on its Web site, in a link to the "Strategic  
7           Transportation Investments" Web site linked directly from the Department's home page, the  
8           following information in an accessible format as promptly as possible:

9           (1)    The quantitative criteria used in each highway and nonhighway project  
10           scoring, including the methodology used to define each criteria, the criteria  
11           presented to the Board of Transportation for approval, and any adjustments  
12           made to finalize the criteria.

13           (2)    The quantitative and qualitative criteria in each highway or nonhighway  
14           project scoring that is used in each region or division to finalize the local  
15           input score and shall include distinctions between Metropolitan Planning  
16           Organization and Rural Transportation Planning Organization scoring and  
17           methodologies.

18           (3)    Notification of changes to the methodologies used to calculate quantitative  
19           criteria.

20           (4)    The final quantitative formulas, including the number of points assigned to  
21           each criteria, used in each highway and nonhighway project scoring used to  
22           obtain project rankings in the Statewide, Regional, and Division categories.  
23           If the Department approves different formulas or point assignments  
24           regionally or by division, the final scoring for each area shall be noted.

25           (5)    The project scorings associated with the release of the draft and final State  
26           Transportation Improvement Program."

27           **SECTION 1.1.(b)** Effective July 1, 2019, G.S. 136-189.11(e)(2), as enacted by  
28 subsection (a) of this section, reads as rewritten:

29           "(e)    Authorized Formula Variance. – The Department may vary from the Formula set  
30 forth in this section if it complies with the following:

31           ...

32           (2)    Calculation of Variance. – Each year, the Secretary shall calculate the  
33 amount of Regional Impact and Division Need funds allocated in that year to  
34 each ~~division, division and region~~, the amount of funds obligated, and the  
35 amount the obligations exceeded or were below the allocation. ~~In the first~~  
36 ~~variance calculation under this subdivision following the end of fiscal year~~  
37 ~~2015-16, the target amounts obtained according to the Formula set forth in~~  
38 ~~this section shall be adjusted to account for any differences between~~  
39 ~~allocations and obligations reported for the previous year. In the first~~  
40 ~~variance calculation under this subdivision following the end of fiscal year~~  
41 ~~2016-17, the target amounts obtained according to the Formula set forth in~~  
42 ~~this section shall be adjusted to account for any differences between~~

1 The new target amounts shall be used to fulfill the requirements of  
2 subdivision (1) of this subsection for the next update of the Transportation  
3 Improvement Program. The adjustment to the target amount shall be  
4 allocated by Distribution Region or Division, as applicable."

5 **SECTION 1.2.** Strategic Prioritization Process Reporting. – The Department shall  
6 issue a draft revision to the State Transportation Improvement Program required by  
7 G.S. 143B-350(f)(4) no later than January 1, 2015. The Board of Transportation shall approve  
8 the revised State Transportation Improvement Program no later than July 1, 2015.

## 10 **SECONDARY ROADS CHANGES**

11 **SECTION 2.1.** G.S. 20-85 reads as rewritten:

### 12 **"§ 20-85. Schedule of fees.**

13 ...

14 (a1) One dollar (\$1.00) of the fee imposed for any transaction assessed a fee under  
15 subdivision (a)(1), (a)(2), (a)(3), (a)(7), (a)(8), or (a)(9) of this section shall be credited to the  
16 North Carolina Highway Fund. The Division shall use the fees derived from transactions with  
17 the Division for technology improvements. The Division shall use the fees derived from  
18 transactions with commission contract agents for the payment of compensation to commission  
19 contract agents. An additional fifty cents (50¢) of the fee imposed for any transaction assessed  
20 a fee under subdivision (a)(1) of this section shall be credited to the Mercury Switch Removal  
21 Account in the Department of Environment and Natural Resources. ~~An additional fifty cents~~  
22 ~~(50¢) of the fee imposed for any transaction assessed a fee under subdivision (a)(1) of this~~  
23 ~~section shall be credited as follows:~~

- 24 (1) ~~The first four hundred thousand dollars (\$400,000) collected shall be~~  
25 ~~credited to the Reserve for Visitor Centers in the Highway Fund.~~  
26 (2) ~~Any additional funds collected shall be credited to the Highway Trust Fund~~  
27 ~~and, notwithstanding G.S. 136-176(b), shall be allocated and used for urban~~  
28 ~~loop projects.~~

29 (a2) From the fees collected under subdivisions (a)(1) through (a)(9) of this section, the  
30 Department shall annually credit the sum of four hundred thousand dollars (\$400,000) to the  
31 Reserve for Visitor Centers in the Highway Fund.

32 (b) Except as otherwise provided in ~~subsection (a1)~~ subsections (a1) and (a2) of this  
33 section, the fees collected under subdivisions (a)(1) through (a)(9) of this section shall be  
34 credited to the North Carolina Highway Trust Fund. The fees collected under subdivision

12 receipts and expenditures of such funds. It shall be unlawful for any municipal employee or  
13 member of any governing body to authorize, direct, or permit the expenditure of any funds  
14 accruing to any municipality by virtue of G.S. 136-41.1 and 136-41.2 for any purpose not  
15 herein authorized. Any member of any governing body or municipal employee shall be  
16 personally liable for any unauthorized expenditures. On or before the first day of August each

The form of the performance and payment security may consist of bonds, letters of credit, parent guaranties, or other instruments acceptable to the Department of Transportation.
- c. Notwithstanding the provisions of G.S. 143B-426.40A, an agreement entered into under this subdivision may allow the private entity to assign, transfer, sell, hypothecate, and otherwise convey some or all of its right, title, and interest in and to such agreement, and any rights and remedies thereunder, to a lender, bondholder, or any other party. However, in no event shall any such assignment create additional debt or debt-like obligations of the State of North Carolina, the Department, or any other agency, authority, commission, or similar subdivision of the State to any lender, bondholder, entity purchasing a participation in the right to receive the payment, trustee, trust, or any other party providing financing or funding of projects described in this section. The foregoing shall not preclude the Department from making any payments due and owing pursuant to an agreement entered into under this section.
- d. ~~The Department of Transportation may fix, revise, charge, and collect tolls and fees to the same extent allowed under Article 6H of Chapter 136 of the General Statutes. Statutes shall apply to the Department of Transportation and to projects undertaken by the Department of Transportation under subdivision (39) of this section. The Department may assign its authority under that Article to fix, revise, charge, retain, enforce, and collect tolls and fees to the private entity.~~
- e. Any contract under this subdivision or under Article 6H of this Chapter for the development, construction, maintenance, or operation of a project shall provide for revenue sharing between the private party and the Department, notwithstanding the provisions of G.S. 136-89.188(d). Excess toll revenues from a Turnpike project shall be used for the funding or financing of transportation projects within the corridor where the Turnpike Project is located. For purposes of this subdivision, the term "excess toll revenues" means those toll revenues derived from a Turnpike Project that are not otherwise used or allocated to the Authority or a private entity pursuant to this subdivision. For purposes of this subdivision, the

1 term "corridor" means (i) the right-of-way limits of the Turnpike  
2 Project and any facilities related to the Turnpike Project or any  
3 facility or improvement necessary for the use, design, construction,  
4 operation, maintenance, repair, rehabilitation, reconstruction, or

6. The Turnpike Authority annual report under G.S. 136-89.193 shall include reporting on all revenue collections associated with projects subject to this subdivision under the Turnpike Authority.

7. The Department shall develop standards for entering into comprehensive agreements with private entities under the authority of this subdivision and report those standards to the Joint Legislative Transportation Oversight Committee on or before October 1, 2013.

(43) For the purposes of financing an agreement under subdivision (39a) of this section, the Department of Transportation may act as a conduit issuer for private activity bonds to the extent the bonds do not constitute a debt obligation of the State. The issuance of private activity bonds under this subdivision and any related actions shall be governed by The State and Local Government Revenue Bond Act, Article 5 of Chapter 159 of the General Statutes, with G.S. 159-88 satisfied by adherence to the requirements of ~~subdivisions (39) and~~ subdivision (39a) of this section."

**SECTION 5.3.** G.S. 136-89.183(a)(5) reads as rewritten:

(a) The Authority shall have all of the powers necessary to execute the provisions of this Article, including the following:

(5) To fix, revise, charge, retain, enforce, and collect tolls and fees for the use of the Turnpike Projects. Prior to the effective date of any toll or fee for use of a Turnpike Facility, the Authority shall submit a description of the proposed toll or fee to the Board of Transportation, the Joint Legislative Transportation Oversight Committee and the Joint Legislative Commission on Governmental Operations for review.

**SECTION 5.4.** G.S. 136-89.188 reads as rewritten:

(a) Revenues derived from Turnpike Projects authorized under this Article shall be used only for the following:

17 for operation as a nontoll facility shall only be used for the funding or financing of the right of

19 administration costs associated with the converted segment or a contiguous toll facility."

20       **SECTION 5.5.** Part 1 of Article 6H of Chapter 136 of the General Statutes is  
21 amended by adding a new section to read:

23       Notwithstanding any other provision of this Article, the Authority may designate one or  
24 more lanes of any highway, or portion thereof, within the State, including lanes that may

11 (a) Administration. – The Authority is responsible for collecting tolls on Turnpike  
12 projects. In exercising its authority under G.S. 136-89.183 to perform or procure services  
13 required by the Authority, the Authority may contract with one or more providers to perform  
14 part or all of the collection functions and may enter into agreements to exchange information,  
15 including confidential information under subsection (a1) of this section, that identifies motor  
16 vehicles and their owners with one or more of the following entities: the Division of Motor  
17 Vehicles of the Department of Transportation, another state, another toll operator, ~~or~~ a toll  
18 collection-related ~~organization~~ organization, or a private entity that has entered into a  
19 partnership agreement with the Authority pursuant to G.S. 136-89.183(a)(17). Further, the  
20 Authority may assign its authority to fix, revise, charge, retain, enforce, and collect tolls and  
21 fees under this Article to a private entity that has entered into a partnership agreement with the  
22 Authority pursuant to G.S. 136-89.183(a)(17).

23 ...

24 (b) Open Road Tolls. – If a Turnpike project uses an open road tolling system, the  
25 Authority must operate a facility that is in the immediate vicinity of the Turnpike project ~~and~~  
26 ~~that accepts or provide an alternate means to accept~~ cash payment of the toll and must place  
27 signs on the Turnpike project that give drivers the following information:

- 28 (1) Notice that the driver is approaching a highway for which a toll is required.  
29 Signs providing this information must be placed before the toll is incurred.  
30 (2) The methods by which the toll may be paid.  
31 (3) ~~Directions~~ If applicable, directions to the nearby facility that accepts cash  
32 payment of the toll.

33 **"§ 136-89.214. Bill for unpaid open road toll.**

34 (a) Bill. – If a motor vehicle travels on a Turnpike project that uses an open road tolling  
35 system and a toll for traveling on the project is not paid prior to travel or at the time of travel,  
36 the Authority must send a bill by first-class mail to the registered owner of the motor vehicle or  
37 the person who had care, custody, and control of the vehicle as established under  
38 G.S. 136-89.212(b) for the amount of the unpaid toll. The Authority must send the bill within  
39 90 days after the travel ~~occurs~~ occurs, or within 90 days of receipt of a sworn affidavit  
40 submitted under G.S. 136-89.212(b) identifying the person who had care, custody, and control  
41 of the motor vehicle. If a bill is not sent within the required time, the Authority waives  
42 collection of the toll. The Authority must establish a billing period for unpaid open road tolls  
43 that is no shorter than 15 days. A bill for a billing period must include all unpaid tolls incurred  
44 by the same person during the billing period.

45 (b) Information on Bill. – A bill sent under this section must include all of the following  
46 information:

- 47 (1) The name and address of the registered owner of the motor vehicle that  
48 traveled on the Turnpike ~~project~~ project or of the person identified under  
49 G.S. 136-89.212(b).  
50 (2) The date the travel occurred, the approximate time the travel occurred, and  
51 each segment of the Turnpike project on which the travel occurred.

- 1 (3) An image of the registration plate of the motor vehicle, if the Authority  
2 captured an electronic image of the motor vehicle when it traveled on the  
3 Turnpike project.
- 4 (4) The amount of the toll due and an explanation of how payment may be  
5 made.
- 6 (5) The date by which the toll must be paid to avoid the imposition of a  
7 processing fee under G.S. 136-89.215 and the amount of the processing fee.
- 8 (6) A statement that a vehicle owner who has unpaid tolls is subject to a civil  
9 penalty and may not renew the vehicle's registration until the tolls and civil  
10 penalties are paid.
- 11 (7) A clear and concise explanation of how to contest liability for the toll.
- 12 (8) If applicable, a copy of the affidavit submitted under G.S. 136-89.212(b)  
13 identifying the person with care, custody, and control of the motor vehicle.

14 **"§ 136-89.215. Required action upon receiving bill for open road toll and processing fee**  
15 **for unpaid toll.**

16 (a) Action Required. – A person who receives a bill from the Authority for an unpaid  
17 open road toll must take one of the following actions within 30 days of the date of the bill:

- 18 (1) Pay the bill.
- 19 (2) Send a written request to the Authority for a review of the toll.

20 (b) Fee. – If a person does not take one of the actions required under subsection (a) of  
21 this section within the required time, the Authority may add a processing fee to the amount the  
22 person owes. The processing fee may not exceed six dollars (\$6.00). A person may not be  
23 charged more than forty-eight dollars (\$48.00) in processing fees in a 12-month period.

24 The Authority must set the processing fee at an amount that does not exceed the costs of  
25 ~~collecting the unpaid toll, identifying the owner of a motor vehicle that is subject to an unpaid~~  
26 ~~toll and billing the owner for the unpaid toll. The fee is a receipt of the Authority and must be~~  
27 ~~applied to these costs.~~

28 ...."

29 **SECTION 5.7.** DOT/Southeast Extension-Triangle Expressway. – The Department  
30 of Transportation shall strive to expedite the federal environmental impact statement process to  
31 define the route for the Southeast Extension of the Triangle Expressway Turnpike Project by  
32 promptly garnering input from local officials and other stakeholders, accelerating any required  
33 State studies, promptly submitting permit applications to the federal government, working  
34 closely with the federal government during the permitting process, and taking any other  
35 appropriate actions to accelerate the environmental permitting process.

36 **SECTION 5.8.** Monitoring. – As part of its oversight of the Department of  
37 Transportation, the Joint Legislative Transportation Oversight Committee shall closely monitor  
38 the progress of the Southeast Extension of the Triangle Expressway Turnpike Project.

39 **TRANSITION STUDY AND REPORTING REQUIREMENTS**

40 **SECTION 6.1.** Formula Implementation Report. – The Department of  
41 Transportation shall report to the Joint Legislative Transportation Oversight Committee and the  
42 Fiscal Research Division no later than August 15, 2013, on the Department's recommended  
43 formulas that will be used in the prioritization process to rank highway and nonhighway  
44 projects. The Department of Transportation's Prioritization Office shall develop the  
45 prioritization processes and formulas for all modes of transportation. The report will include a  
46 statement on the process used by the Department to develop the formulas, include a listing of  
47 external partners consulted during this process, and include feedback from its 3.0 workgroup  
48 partners on the Department's proposed recommendations. The Department shall not finalize the  
49 formula without consulting with the Joint Legislative Transportation Oversight Committee. The  
50 Joint Legislative Transportation Oversight Committee has 30 days after the report is received to  
51



1 meet and consult on the Department's recommendations. If no meeting occurs within 30 days  
2 after the report is received, the consultation requirement will be met. If consultation occurs and  
3 a majority of members serving on the Committee request changes to the Department's  
4 recommended formulas for highway and nonhighway modes, the Department shall review the  
5 requests and provide to the Committee its response to the requested changes no later than  
6 October 1, 2013. A final report on the highway and intermodal formulas shall be submitted to  
7 the Joint Legislative Transportation Oversight Committee by January 1, 2014.

8 **SECTION 6.2.** State Transportation Improvement Program Transition Report. –  
9 The Department of Transportation shall submit transition reports to members of the Joint  
10 Legislative Transportation Oversight Committee, House of Representatives Appropriations  
11 Subcommittee on Transportation and the Senate Appropriations Committee on Department of  
12 Transportation, and the Fiscal Research Division on March 1, 2014, and November 1, 2014.  
13 The reports shall include information on the Department's transition to Strategic Prioritization,  
14 overview changes to the State Transportation Improvement Program (STIP) and other internal  
15 and external processes that feed into the STIP, and offer statutory and policy recommendations  
16 or items for consideration to the General Assembly that will enhance the prioritization process.  
17 The March 1, 2014, report shall also include an analysis of the distribution of tax and fee  
18 revenues between the Highway Fund and Highway Trust Fund and an analysis to determine if  
19 maintenance, construction, operations, administration, and capital expenditures are properly  
20 budgeted within the two funds and existing revenues are most effectively distributed between  
21 the two funds.

#### 22 **EFFECTIVE DATE**

23 **SECTION 7.1.(a)** Except as provided herein, this act becomes effective July 1,  
24 2013.

25 **SECTION 7.1.(b)** This act is effective only if the General Assembly appropriates  
26 funds in the Current Operations and Capital Improvements Appropriations Act of 2013 to  
27 implement this act.
