1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE VARIOUS
3 SPECIAL LICENSE PLATES.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.4(b) is amended by adding new subdivisions to read:

6 "(b) Types. – The Division shall issue the following types of special registration plates:

7 ...

8 () Charlotte Checkers. – Issuable to the registered owner of a motor vehicle in
9 accordance with G.S. 20-81.12. The plate shall bear the phrase
10 "GOCHECKERS.COM" and the logo of the Charlotte Checkers.

11 () Flag of the United States of America. – Issuable to the registered owner of a
12 motor vehicle in accordance with G.S. 20-81.12. The plate shall bear an
13 image of a waving American flag.

14 () First Tee. – Issuable to the registered owner of a motor vehicle in accordance
15 with G.S. 20-81.12. The plate may bear a phrase and logo representing youth
16 golf or The First Tee, Inc.

17 () Mission Foundation. – Issuable to the registered owner of a motor vehicle in
18 accordance with G.S. 20-81.12. The plate may bear a phrase and logo
19 selected by Mission Healthcare Foundation, Inc.

20 () Morehead Planetarium. – Issuable to the registered owner of a motor vehicle
21 in accordance with G.S. 20-81.12. The plate shall bear a phrase and logo
22 selected by the Morehead Planetarium and Science Center.

23 () Municipality plate. – Issuable to the registered owner of a motor vehicle in
24 accordance with G.S. 20-81.12. The plate shall bear a graphic selected by the
25 municipality represented by the plate and approved by the Division.

26 () Native Brook Trout. – Issuable to the registered owner of a motor vehicle in
27 accordance with G.S. 20-81.12. The plate shall bear the phrase "Native
28 Brook Trout" with a picture of a Brook Trout native to North Carolina in the
29 background.

30 () NCSC. – Issuable to the registered owner of a motor vehicle in accordance
31 with G.S. 20-81.12. The plate shall bear the phrase "NC Sportsmen's
32 Caucus" and a logo provided by the Congressional Sportsmen's Foundation.

33 () North Carolina Cattlemen's Association. – Issuable to the registered owner
34 of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the
35 seal of the North Carolina Cattlemen's Association.

- 1 () Order of the Long Leaf Pine. – Issuable to a person who has received the
2 award of membership in the Order of the Long Leaf Pine from the Governor.
3 The plate shall bear the phrase "Order of the Long Leaf Pine."
4 () Red Drum. – Issuable to the registered owner of a motor vehicle in
5 accordance with G.S. 20-81.12. The plate shall bear the phrase "Red Drum"
6 with a picture of a Red Drum native to North Carolina in the background.
7 () RiverLink. – Issuable to the registered owner of a motor vehicle in
8 accordance with G.S. 20-81.12. The plate shall bear the phrase
9 "RiverLink.org" and a logo representing RiverLink, Inc.
10 () Town of Holden Beach. – Issuable to the registered owner of a motor vehicle
11 in accordance with G.S. 20-81.12. The plate shall bear a phrase and graphic
12 selected by the Board of Commissioners of the Town of Holden Beach.
13 () Town of Matthews. – Issuable to the registered owner of a motor vehicle in
14 accordance with G.S. 20-81.12. The plate shall bear a graphic selected by the
15 Town of Matthews and approved by the Division.
16 () Turtle Rescue Team. – Issuable to the registered owner of a motor vehicle in
17 accordance with G.S. 20-81.12. The plate shall bear a phrase and logo
18 selected by the North Carolina State University College of Veterinary
19 Medicine Turtle Rescue Team.
20 () Volunteers in Law Enforcement. – Issuable to a volunteer member of a State
21 or local law enforcement agency. The plate shall bear the phrase "Volunteers
22 in Law Enforcement."
23 () YMCA. – Issuable to the registered owner of a motor vehicle in accordance
24 with G.S. 20-81.12. The plate shall bear the logo of the YMCA and the
25 letters "SA" on the right side of the plate.

26 "

27 **SECTION 1.1.** G.S. 20-79.4(b)(41) reads as rewritten:

28 "(41) ~~City/County~~ Clerk.—NCAMC/NCACC Clerk. – Issuable to a clerk of a ~~city~~
29 ~~or town~~municipal governing board or a clerk of a county board of
30 commissioners of a ~~city~~municipality or county in this State. For a
31 ~~city~~municipal clerk, the plate shall bear the words "~~City~~NCAMC Clerk"
32 followed by a number representing the ~~city~~municipal clerk's city or town.
33 The number of a city shall be the order of the city in an alphabetical list of
34 cities that assigns number one to the first city in the list. For a county clerk,
35 the plate shall bear the words "~~County~~NCACC Clerk" followed by a
36 number representing the county clerk's county. The number of a county shall
37 be the order of the county in an alphabetical list of counties that assigns
38 number one to the first county in the list. The Division may not issue the
39 plate authorized by this subdivision unless it receives at least 300
40 applications for the plate."

41 **SECTION 1.2.** G.S. 20-79.4(b)(163) is repealed.

42 **SECTION 2.** G.S. 20-79.4(b)(172) reads as rewritten:

43 "(172) Register of Deeds. – Issuable to a register of deeds. The plate shall bear the
44 words "Register of Deeds" and the letter "R" followed by a number
45 representing the county of the register of deeds. The number of a county
46 shall be the order of the county in an alphabetical list of counties that assigns
47 number one to the first county in the list. A plate issued to a retired register
48 of deeds shall bear the phrase "Register of Deeds, Retired," followed by a
49 number that indicates the county where the register of deeds served and a
50 designation indicating the retired status of the register of deeds."

51 **SECTION 3.** G.S. 20-79.4(b)(224) reads as rewritten:

"(224) Vietnam Veterans of America. – Issuable to a member of the Vietnam Veterans of America. The plate shall bear the words "Vietnam Veterans of America" or "VVA" and the emblem of the VVA. A person may obtain from the Division a special registration plate under this subdivision for a motor vehicle or a motorcycle registered in that person's name. The registration fees and the restrictions on the issuance of a specialized registration plate for a motorcycle are the same as for any motor vehicle. The Division may not issue either type of the plate authorized by this subdivision unless it receives at least 300 applications for the plate."

SECTION 4. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge a single Legion of Valor, 100% Disabled Veteran, and Ex-Prisoner of War registration plate to a recipient of a Legion of Valor award, a 100% disabled veteran, and an ex-prisoner of war each year. The preceding special registration plates are subject to the regular motor vehicle registration fees in G.S. 20-88, if the registered weight of the vehicle is greater than 6,000 pounds. All other special registration plates are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

SECTION 5. G.S. 20-79.7(b) reads as rewritten:

"(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) of this section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

40 Charlotte Checkers plate before the plate may be developed. The Division shall transfer
41 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
42 sale of Charlotte Checkers plates to the Charlotte Checkers Charitable Foundation to support
43 school programming, athletics, and various children's related nonprofit groups that promote and
44 encourage education, physical fitness, and development of character.

45 (b127) First Tee. – The Division must receive 300 or more applications for a First Tee plate
46 before the plate may be developed. The Division shall transfer quarterly the money in the
47 Collegiate and Cultural Attraction Plate Account derived from the sale of First Tee plates to
48 The Carol S. Petrea Youth Golf Foundation, Inc., to support its mission of helping to shape the
49 lives of young people from all walks of life by reinforcing values like integrity, respect, and
50 perseverance through the game of golf.

1 (b128) Mission Foundation. – The Division must receive 300 or more applications for a
2 Mission Foundation plate before the plate may be developed. The Division shall transfer
3 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
4 sale of Mission Foundation plates to Mission Healthcare Foundation, Inc., to support its
5 mission of sustaining and expanding its provision of health services to Western North Carolina.

6 (b129) Municipality Plate. – The Division must receive 300 or more applications for a
7 municipality plate for a municipality before a municipality plate may be developed. The color,
8 design, and material for the plate must be approved by both the Division and the municipality.
9 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
10 Account derived from the sale of a municipality plate to the municipality represented by the
11 plate.

12 (b130) Native Brook Trout. – The Division must receive 300 or more applications for the
13 Native Brook Trout plate before the plate may be developed. The Division must transfer
14 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
15 sale of Native Brook Trout plates to the North Carolina Wildlife Resources Commission to be
16 used to fund public access to and habitat protection of Brook Trout waters.

17 (b131) Morehead Planetarium. – The Division must receive 300 or more applications for a
18 Morehead Planetarium plate before the plate may be developed. The Division shall transfer
19 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
20 sale of Morehead Planetarium plates to the Morehead Planetarium and Science Center to
21 support its mission of informing and inspiring the public about the foundations and frontiers of
22 scientific discovery.

23 (b132) NCSC. – The Division must receive 300 or more applications for an NCSC plate
24 before the plate may be developed. The Division shall transfer quarterly the money in the
25 Collegiate and Cultural Attraction Plate Account derived from the sale of NCSC plates to the
26 Congressional Sportsmen's Foundation to support its mission of protecting and advancing the
27 rights of hunters, recreational anglers, shooters, and trappers in North Carolina.

28 (b133) North Carolina Cattlemen's Association. – The Division must receive 300 or more
29 applications for the "North Carolina Cattlemen's Association" plate before the plate may be
30 developed. The Division shall transfer quarterly the money in the Collegiate and Cultural
31 Attraction Plate Account derived from the sale of "North Carolina Cattlemen's Association"
32 plates to the North Carolina Cattlemen's Association, Inc.

33 (b134) Order of the Long Leaf Pine. – The Division must receive 300 or more applications
34 for the Order of the Long Leaf Pine plate before the plate may be developed. The Division shall
35 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
36 from the sale of Order of the Long Leaf Pine plates to the General Fund.

37 (b135) Red Drum. – The Division must receive 300 or more applications for the Red Drum
38 plate before the plate may be developed. The Division must transfer quarterly the money in the
39 Collegiate and Cultural Attraction Plate Account derived from the sale of Red Drum plates to
40 the North Carolina Marine Fisheries Commission to be used to fund public access to and
41 habitat protection of Red Drum waters.

42 (b136) RiverLink. – The Division must receive 300 or more applications for a "RiverLink"
43 plate before the plate may be developed. The Division shall transfer quarterly the money in the
44 Collegiate and Cultural Attraction Plate Account derived from the sale of "RiverLink" plates to
45 RiverLink, Inc., to support the economic and environmental revitalization of the French Broad
46 River and its tributaries as a place to work, live, and play.

47 (b137) Town of Holden Beach. – The Division must receive 300 or more applications for a
48 Town of Holden Beach plate before the plate may be developed. The Division shall transfer
49 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
50 sale of Town of Holden Beach plates to the Town of Holden Beach for programs in support of
51 travel and tourism and for the protection and nourishment of the beach.

1 (b138) Town of Matthews. – The Division must receive 300 or more applications for the
2 Town of Matthews plate before the plate may be developed. The Division shall transfer
3 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
4 sale of Town of Matthews plates to the Town of Matthews.

5 (b139) Turtle Rescue Team. – The Division must receive 300 or more applications for a
6 Turtle Rescue Team plate before the plate may be developed. The Division shall transfer
7 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
8 sale of Turtle Rescue Team plates to the North Carolina State University College of Veterinary
9 Medicine Turtle Rescue Team to support its mission of providing medical, surgical, and
10 husbandry services free of charge in the hope of releasing rehabilitated turtles back into the
11 wild.

12 (b140) Volunteers in Law Enforcement. – The Division must receive 300 or more
13 applications for a "Volunteers in Law Enforcement" plate before the plate may be developed.
14 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
15 Account derived from the sale of "Volunteers in Law Enforcement" plates to the International
16 Association of Chiefs of Police Incorporated to support the Volunteers in Police Service (VIPS)
17 Program and its mission of enhancing the capacity of State and local law enforcement agencies
18 to utilize volunteers."

19 **SECTION 6.1.** G.S. 20-81.12(b114) is repealed.

20 **SECTION 7.** G.S. 20-81.12(b2) reads as rewritten:

21 "(b2) State Attraction Plates. – The Division must receive 300 or more applications for a
22 State attraction plate before the plate may be developed. The Division must transfer quarterly
23 the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of
24 State attraction plates to the organizations named below in proportion to the number of State
25 attraction plates sold representing that organization:

26 (1) Aurora Fossil Museum. – The revenue derived from the special plate shall
27 be transferred quarterly to the Aurora Fossil Museum Foundation, Inc., to be
28 used for educational programs, for enhancing collections, and for operating
29 expenses of the Aurora Fossil Museum.

30 (2) Blue Ridge Parkway Foundation. – The revenue derived from the special
31 plate shall be transferred quarterly to Blue Ridge Parkway Foundation for
32 use in promoting and preserving the Blue Ridge Parkway as a scenic
33 attraction in North Carolina. A person may obtain from the Division a
34 special registration plate under this subdivision for the registered owner of a
35 motor vehicle or a motorcycle. The registration fees and the restrictions on
36 the issuance of a specialized registration plate for a motorcycle are the same
37 as for any motor vehicle. The Division must receive a minimum of 300
38 applications to develop a special registration plate for a motorcycle.

39 (3) Friends of the Great Smoky Mountains National Park. – The revenue derived
40 from the special plate shall be transferred quarterly to the Friends of the
41 Great Smoky Mountains National Park, Inc., to be used for educational
42 materials, preservation programs, capital improvements for the portion of the
43 Great Smoky Mountains National Park that is located in North Carolina, and
44 operating expenses of the Great Smoky Mountains National Park.

45 (4) Friends of the Appalachian Trail. – The revenue derived from the special
46 plate shall be transferred quarterly to The Appalachian Trail Conference to
47 be used for educational materials, preservation programs, trail maintenance,
48 trailway and viewshed acquisitions, trailway and viewshed easement
49 acquisitions, capital improvements for the portions of the Appalachian Trail
50 and connecting trails that are located in North Carolina, and related
51 administrative and operating expenses.

- 1 (5) North Carolina State Parks. – One-half of the revenue derived from the
2 special plate shall be transferred quarterly to Natural Heritage Trust Fund
3 established under G.S. 113-77.7, and the remaining revenue shall be
4 transferred quarterly to the Parks and Recreation Trust Fund established
5 under G.S. 113-44.15.
- 6 (6) "Old Baldy," Bald Head Island Lighthouse. – The revenue derived from the
7 special plate shall be transferred quarterly to the Old Baldy Foundation, Inc.,
8 for its programs in support of the Bald Head Island Lighthouse.
- 9 (7) The North Carolina Aquariums. – The revenue derived from the special plate
10 shall be transferred quarterly to the North Carolina Aquarium Society, Inc.,
11 for its programs in support of the North Carolina Aquariums.
- 12 (8) The North Carolina Arboretum. – The revenue derived from the special plate
13 shall be transferred quarterly to The North Carolina Arboretum Society and
14 used to help the Society obtain grants for the North Carolina Arboretum and
15 for capital improvements to the North Carolina Arboretum.
- 16 (9) The North Carolina Maritime Museum. – The revenue derived from the
17 special plate shall be transferred quarterly to Friends of the Museum, North
18 Carolina Maritime Museum, Inc., to be used for educational programs and
19 conservation programs and for operating expenses of the North Carolina
20 Maritime Museum.
- 21 (10) The North Carolina Museum of Natural Sciences. – The revenue derived
22 from the special plate shall be transferred quarterly to the Friends of the
23 North Carolina State Museum of Natural Sciences for its programs in
24 support of the museum.
- 25 (11) The North Carolina Transportation Museum. – The revenue derived from the
26 special plate shall be transferred quarterly to the North Carolina
27 Transportation Museum Foundation to be used for educational programs and
28 conservation programs and for operating expenses of the North Carolina
29 Transportation Museum.
- 30 ~~(11)~~(12) The North Carolina Zoological Society. – The revenue derived from the
31 special plate shall be transferred quarterly to The North Carolina Zoological
32 Society, Incorporated, to be used for educational programs and conservation
33 programs at the North Carolina Zoo at Asheboro and for operating expenses
34 of the North Carolina Zoo at Asheboro.
- 35 ~~(12)~~(13) U.S.S. North Carolina Battleship Commission. – The revenue derived from
36 the special plate shall be transferred quarterly to the U.S.S. North Carolina
37 Battleship Commission to be used for educational programs and preservation
38 programs on the U.S.S. North Carolina (BB-55) and for operating expenses
39 of the U.S.S. North Carolina Battleship Commission."

40 **SECTION 8.** G.S. 20-81.12(b38) reads as rewritten:

41 "(b38) Stock Car Racing Theme. – The Division may issue any plate in this series without
42 a minimum number of applications if the person providing the State with the license to use the
43 words, logos, trademarks, or designs associated with the plate produces the plate for the State
44 without a minimum order quantity.

45 The cost of the Stock Car Racing Theme plate shall include all costs to produce blank plates
46 for issuance by the Division. Notwithstanding G.S. 66-58(b), the Division or the Division of
47 Adult Correction of the Department of Public Safety may contract for the production of the
48 blank plates in this series to be issued by the Division, provided the plates meet or exceed the
49 State's specifications including durability and retroreflectivity, and provided the plates are
50 manufactured using high-quality embossable aluminum. The cost of the blank plates to the

1 State shall be substantially equivalent to the price paid to the Division of Adult Correction of
2 the Department of Public Safety for license tags, as provided in G.S. 66-58(b)(15).

3 The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction
4 Plate Account derived from the sale of Stock Car Racing Theme plates to the North Carolina
5 Motorsports Foundation, ~~Inc.~~, except that the Division shall transfer quarterly the money in
6 the Collegiate and Cultural Attraction Plate Account derived from the sale of Charlotte Motor
7 Speedway plates to Speedway Children's Charities."

8 **SECTION 9.** The Revisor of Statutes is authorized to alphabetize, number, and
9 renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
10 registration plates are listed in alphabetical order and numbered accordingly.

11 **SECTION 10.** This act becomes effective July 1, 2013.
