2 Moves to amend the bill on page 204, lines 23-24, by inserting between those lines a new  
3 section to read as follows:

4 **"COMMERCE NONPROFITS/FUNDS**

5 **SECTION 15.23A.** Notwithstanding any other provision of this act, the following  
6 items are reduced for the 2013-2014 fiscal year as follows: (i) LUST (Noncommercial Fund) by  
7 \$365,000 NR; and (ii) NC Biotechnology Center by \$635,000 NR. The reductions in funds  
8 provided for in this section are appropriated to the Department of Commerce, State-Aid, to be  
9 allocated for the 2013-2014 fiscal year as follows: (i) Community Development Initiative  
10 \$520,651 NR; (ii) Institute of Minority Economic Development \$279,886 NR; (iii) Land Loss  
11 Prevention Project \$78,662 NR; (iv) NC Association of Community Development  
12 Corporations \$109,036 NR; and (v) NC Indian Economic Development Initiative \$11,765  
13 NR.";

14  
15 and on page 204, lines 26-31, by rewriting those lines to read as follows:

16 **"SECTION 15.25.** High Point Furniture Market Authority, Johnson & Wales  
17 University, North Carolina's Eastern Region, North Carolina's Northeast Commission,  
18 Southeastern North Carolina Regional Economic Development Commission, Western North  
19 Carolina Regional Economic Development Commission, Charlotte Regional Partnership, Inc.,  
20 Piedmont Triad Partnership, RTI International, Research Triangle Regional Partnership,  
21 Community Development Initiative, Institute of Minority Economic Development, Land Loss  
22 Prevention Project, NC Association of Community Development Corporations, NC Indian  
23 Economic Development Initiative, and The Support Center shall do the following:";
