1 moves to amend the bill on page 32, lines 21 through 29, by rewriting the lines to read:

2 "(6) A bulk tobacco barn or rack, parts and accessories attached to the tobacco  
3 barn or rack, and any similar apparatus, part, or accessory used to cure or dry  
4 tobacco or another crop.

5 (7) A container used for commercial fertilizer, lime, land plaster, plastic mulch,  
6 plant bed covers, potting soil, baler twine, and seeds.

7 (8) A container used in packaging and transporting the farmer's product for sale.

8 (9) A grain, feed, or soybean storage facility, and parts and accessories attached  
9 to the facility.

10 (10) A commercially manufactured facility to be used for commercial purposes  
11 for housing, raising, or feeding animals or for housing equipment necessary  
12 for these commercial activities. The refund also applies to commercially  
13 manufactured equipment, and parts and accessories for the equipment, used  
14 in the facility.

15 (11) Building materials, supplies, fixtures, and equipment that become a part of  
16 and are used in the construction, repair, or improvement of an enclosure or a  
17 structure specifically designed, constructed, and used for housing, raising, or  
18 feeding animals or for housing equipment necessary for one of these  
19 commercial activities. The refund also applies to commercially  
20 manufactured equipment, and parts and accessories for the equipment, used  
21 in the enclosure or a structure."

24 "**SECTION 10.(b)** G.S. 105-164.13(1), (1a), (1b), (2a), (4a), (4c) and (4d) are  
25 repealed.
