A BILL TO BE ENTITLED

1 AN ACT TO (1) ADJUST THE FEES CHARGED FOR CERTAIN HUNTING AND
2 FISHING LICENSES ISSUED BY THE WILDLIFE RESOURCES COMMISSION AND
3 REPEAL THE COUNTY HUNTING, FISHING, AND TRAPPING LICENSES AND
4 THE NONCOMMERCIAL SPECIAL DEVICE LICENSES; (2) ESTABLISH A BLACK
5 BEAR MANAGEMENT STAMP THAT MUST BE PROCURED BEFORE TAKING
6 BEAR WITHIN THE STATE AND AMEND THE LAW RESTRICTING THE TAKING
7 OF BLACK BEAR WITH BAIT; (3) ADJUST THE AGE FOR DISCOUNTED SPECIAL
8 LICENSES FROM AGE SIXTY-FIVE TO AGE SEVENTY; (4) PROVIDE THAT
9 EFFECTIVE JANUARY 1, 2015, THOSE HUNTING AND FISHING LICENSE FEES IN
10 EFFECT SHALL REMAIN AT THE EXISTING LEVELS UNTIL THE WILDLIFE
11 RESOURCES COMMISSION ESTABLISHES NEW FEES THROUGH RULE
12 MAKING, AND AUTHORIZE THE WILDLIFE RESOURCES COMMISSION TO
13 ESTABLISH LICENSE FEES THROUGH RULE MAKING BEGINNING IN 2015; (5)
14 REPLACE THE CURRENT SIX PERCENT WILDLIFE SERVICE AGENT
15 COMMISSION FEE WITH A TWO-DOLLAR TRANSACTION FEE; (6) PROVIDE
16 THAT NO MORE THAN TWENTY-FIVE PERCENT OF THE WILDLIFE
17 RESOURCES COMMISSION'S AUTHORIZED OPERATING BUDGET SHALL BE
18 KEPT IN RESERVE; AND (7) PROVIDE AN ANNUAL TARGET FOR UTILIZATION
19 OF THE ANNUAL EXPENDABLE INTEREST OF THE WILDLIFE ENDOWMENT
20 FUND.

22 The General Assembly of North Carolina enacts:

23 **SECTION 1.** G.S. 113-270.1C(b) reads as rewritten:

24 "(b) Combination hunting and inland fishing licenses issued by the Wildlife Resources
25 Commission are:

- 26 (1) Resident Annual Combination Hunting and Inland Fishing License –
27 ~~\$20.00.~~\$25.00. This license shall be issued only to an individual resident of
28 the State.
29 (2), (3) Repealed by Session Laws 1997-326, s. 2.
30 (4) Repealed by Session Laws 2005-455, s. 1.6, effective January 1, 2007.
31 (5) Resident Disabled Veteran Lifetime Combination Hunting and Inland
32 Fishing License —~~\$10.00.~~ \$12.00. This license shall be issued only to an
33 individual who is a resident of the State and who is a fifty percent (50%) or
34 more disabled veteran as determined by the United States Department of
35 Veterans Affairs. ~~Affairs.~~ Affairs or as established by rules of the Wildlife Resources

1 Commission. This license remains valid for the lifetime of the licensee so
2 long as the licensee remains fifty percent (50%) or more disabled. This
3 license entitles the licensee to fish in public mountain trout waters as
4 provided in G.S. 113-272(a).

- 5 (6) Resident Totally Disabled Lifetime Combination Hunting and Inland Fishing
6 License —~~\$10.00.~~ \$12.00. This license shall be issued only to an individual
7 who is a resident of the State and who is totally and permanently disabled as
8 determined by the Social Security ~~Administration.~~ Administration or as
9 established by rules of the Wildlife Resources Commission. This license
10 remains valid for the lifetime of the licensee. This license entitles the
11 licensee to fish in public mountain trout waters as provided in
12 G.S. 113-272(a)."

13 **SECTION 2.** G.S. 113-270.1D reads as rewritten:

14 **"§ 113-270.1D. Sportsman licenses.**

15 (a) Annual Sportsman License — ~~\$40.00.~~ \$50.00. This license shall be issued only to an
16 individual resident of the State and entitles the licensee to take all wild animals and wild birds,
17 including waterfowl, by all lawful methods in all open seasons, including the use of game
18 lands, and to fish with hook and line for all fish in all inland and joint fishing waters, including
19 public mountain trout waters. An annual sportsman license issued under this subsection does
20 not entitle the licensee to engage in recreational fishing in coastal fishing waters that are not
21 joint fishing waters.

22 (b) Lifetime Sportsman Licenses. Except as provided in subdivision (7) of this
23 subsection, lifetime sportsman licenses are valid for the lifetime of the licensees. Lifetime
24 sportsman licenses entitle the licensees to take all wild animals and wild birds by all lawful
25 methods in all open seasons, including the use of game lands, and to fish with hook and line for
26 all fish in all inland and joint fishing waters, including public mountain trout waters. A lifetime
27 sportsman license issued under this subsection does not entitle the licensee to engage in
28 recreational fishing in coastal fishing waters that are not joint fishing waters. Lifetime
29 sportsman licenses issued by the Wildlife Resources Commission are:

- 30 (1) Infant Lifetime Sportsman License — ~~\$200.00.~~ \$240.00. This license shall be
31 issued only to an individual under one year of age.
32 (2) Youth Lifetime Sportsman License — ~~\$350.00.~~ \$420.00. This license shall be
33 issued only to an individual under 12 years of age.
34 (3) Adult Resident Lifetime Sportsman License — ~~\$500.00.~~ \$600.00. This license
35 shall be issued only to an individual resident of the State.
36 (4) Nonresident Lifetime Sportsman License — ~~\$1,000.~~ \$1,200. This license shall
37 be issued only to an individual nonresident of the State.
38 (5) Age ~~65~~70 Resident Lifetime Sportsman License — ~~\$15.00.~~ \$18.00. This
39 license shall be issued only to an individual resident of the State who is at
40 least ~~65~~70 years of age.
41 (6) Repealed by Session Laws 2005-455, s. 1.7 effective January 1, 2007.
42 (7) Resident Disabled Veteran Lifetime Sportsman License — ~~\$100.00.~~ \$50.00.
43 This license shall be issued only to an individual who is a resident of the
44 State and who is a fifty percent (50%) or more disabled veteran as
45 determined by the United States Department of Veterans ~~Affairs.~~ Affairs or
46 as established by rules of the Wildlife Resources Commission. This license
47 remains valid for the lifetime of the licensee so long as the licensee remains
48 fifty percent (50%) or more disabled.
49 (8) Resident Totally Disabled Lifetime Sportsman License — ~~\$100.00.~~ \$50.00.
50 This license shall be issued only to an individual who is a resident of the
51 State and who is totally and permanently disabled as determined by the

1 Social Security ~~Administration~~ Administration or as established by rules of
2 the Wildlife Resources Commission."

3 **SECTION 3.** G.S. 113-270.2(c) reads as rewritten:

4 "(c) The hunting licenses issued by the Wildlife Resources Commission are as follows:

- 5 (1) Resident State Hunting License – ~~\$15.00.~~ \$20.00. This license shall be
6 issued only to an individual resident of the State.
- 7 (2) Lifetime Resident Comprehensive Hunting License – ~~\$250.00.~~ \$300.00. This
8 license shall be issued only to an individual resident of the State and is valid
9 for the lifetime of the holder.
- 10 (3) ~~Resident County Hunting License – \$10.00. This license shall be issued only
11 to an individual resident of the State and is valid only in the county of
12 residence of the license holder.~~
- 13 (4) Controlled Hunting Preserve Hunting License – ~~\$15.00.~~ \$20.00. This license
14 shall be issued to an individual resident or nonresident to take only foxes and
15 domestically raised game birds, other than wild turkey, only within a
16 controlled hunting preserve licensed and operated in accordance with
17 G.S. 113-273(g) and implementing rules of the Wildlife Resources
18 Commission.
- 19 (5) Resident Annual Comprehensive Hunting License – ~~\$30.00.~~ \$36.00. This
20 license shall be issued only to an individual resident of the State.
- 21 (6) Nonresident State Hunting License. This license shall be issued only to a
22 nonresident. The nonresident State hunting licenses issued by the Wildlife
23 Resources Commission are:
- 24 a. Season License – ~~\$60.00.~~ \$80.00.
- 25 b. ~~Six Day Ten-Day~~ License – ~~\$40.00.~~ \$60.00. This license is valid for
26 the ~~six~~ 10 consecutive dates indicated on the license."

27 **SECTION 4.** G.S. 113-270.3 reads as rewritten:

28 "**§ 113-270.3. Special activity licenses; stamps; big game kill reports.**

29 (a) In addition to any hunting, trapping, or fishing license that may be required pursuant
30 to G.S. 113-270.1B(a), individuals engaging in specially regulated activities must have the
31 appropriate special activity license and stamp prescribed in this section before engaging in the
32 regulated activity.

33 (b) The special activity licenses and stamp issued by the Wildlife Resources
34 Commission are as follows:

- 35 (1) Resident Big Game Hunting License – ~~\$10.00.~~ \$13.00. This license shall be
36 issued only to an individual resident of the State and entitles the holder to
37 take big game by all lawful methods and during all open seasons.
- 38 (1a) Nonresident Bear Hunting License – ~~\$125.00.~~ \$225.00. This license is valid
39 for use only by an individual within the State and must be procured before
40 taking any bear within the State. Notwithstanding any other provision of
41 law, a nonresident individual may not take any bear within the State without
42 procuring this license; provided, that those persons who have a nonresident
43 lifetime sportsman combination license purchased prior to May 24, 1994,
44 shall not have to purchase this license.
- 45 (1b) Bear Management Stamp – \$10.00. This electronically generated stamp must
46 be procured before taking any bear within the State. Notwithstanding any
47 other provision of law, a resident or nonresident individual may not take any
48 bear within the State without procuring this stamp; provided, that those
49 persons who have purchased a lifetime license established by
50 G.S. 113-270.1D(b), 113-270.2(c)(2), or 113-351(c)(3) prior to July 1, 2014,
51 and those persons exempt from the license requirements as set forth in

G.S. 113-276(c) and G.S. 113-276(n) shall obtain this stamp free of charge. All of the revenue generated by this stamp shall be dedicated to black bear research and management.

- (2) Nonresident Big Game Hunting License. This license shall be issued only to an individual nonresident of the State and entitles the holder to take big game by all lawful methods and during all open seasons. The nonresident big game hunting licenses issued by the Wildlife Resources Commission are:
- a. Season License – ~~\$60.00.~~ \$80.00.
 - b. ~~Six-Day~~ Ten-Day License – ~~\$40.00.~~ \$60.00. This license is only valid for the ~~six~~ 10 consecutive dates indicated on the license.

...

- (5) Migratory Waterfowl Hunting License – ~~\$10.00.~~ \$13.00. This license shall be issued to an individual resident or nonresident of the State and entitles the holder to take migratory waterfowl in accordance with applicable laws and regulations. The Wildlife Resources Commission may implement this license requirement through the sale of an official waterfowl stamp which may be a facsimile, in an appropriate size, of the waterfowl conservation print authorized by G.S. 113-270.2B. An amount not less than one-half of the annual proceeds from the sale of this license shall be used by the Commission for cooperative waterfowl habitat improvement projects through contracts with local waterfowl interests, with the remainder of the proceeds to be used by the Commission in its statewide programs for the conservation of waterfowl."

SECTION 5. G.S. 113-270.4(b) reads as rewritten:

"(b) The hunting and fishing guide licenses issued by the Wildlife Resources are:

- (1) Resident Hunting and Fishing Guide License – ~~\$10.00.~~ \$15.00. This license is valid for use only by an individual resident of the State.
- (2) Nonresident Hunting and Fishing Guide License – ~~\$100.00.~~ \$150.00. This license is valid for use by a nonresident individual in the State."

SECTION 6. G.S. 113-270.5(b) reads as rewritten:

"(b) The trapping licenses issued by the Wildlife Resources Commission are as follows:

- (1) Resident State Trapping License – ~~\$25.00.~~ \$30.00. This license is valid only for use by an individual resident of the State.
- (2) ~~Resident County Trapping License — \$10.00. This license is valid only for use by an individual resident of the State within the county in which he resides.~~
- (3) Nonresident State Trapping License – ~~\$100.00.~~ \$125.00. This license is valid for use by an individual within the State."

SECTION 7. G.S. 113-271(d) reads as rewritten:

"(d) The hook-and-line fishing licenses issued by the Wildlife Resources Commission are as follows:

- (1) Resident Annual Comprehensive Inland Fishing License – ~~\$20.00.~~ \$25.00. This license shall be issued only to an individual resident of the State.
- (2) Resident State Inland Fishing License – ~~\$15.00.~~ \$20.00. This license shall be issued only to an individual resident of the State.
- (3) Lifetime Resident Comprehensive Inland Fishing License – ~~\$250.00.~~ \$300.00. This license shall be issued only to an individual resident of the State and is valid for the lifetime of the licensee.
- (4) ~~Resident County Inland Fishing License — \$10.00. This license shall be issued only to an individual resident of the State and is valid only within the county of residence of the licensee.~~

- 1 (5) Nonresident State Inland Fishing License – ~~\$30.00.~~\$36.00. This license
2 shall be issued to an individual nonresident of the State.
- 3 (6) Short-Term Inland Fishing Licenses. Short-term inland fishing licenses are
4 valid only for the date or consecutive dates indicated on the licenses.
5 Short-term inland fishing licenses issued by the Wildlife Resources
6 Commission are:
- 7 a. Resident 10-day Inland Fishing License – ~~\$5.00.~~\$7.00. This license
8 shall be issued only to a resident of the State.
- 9 b. Nonresident 10-day Inland Fishing License – ~~\$10.00.~~\$18.00. This
10 license shall be issued only to a nonresident of the State.
- 11 c. Repealed by Session Laws 2005-455, s. 1.8, effective January 1,
12 2007.
- 13 (6a) Age ~~65~~70 Resident Lifetime Inland Fishing License – ~~\$15.00.~~ \$18.00. This
14 license shall be issued only to an individual resident of the State who is at
15 least ~~65~~70 years of age.
- 16 (6b) Resident Disabled Veteran Lifetime Inland Fishing License – ~~\$10.00.~~\$12.00.
17 This license shall be issued only to an individual who is a resident of the
18 State and who is a fifty percent (50%) or more disabled veteran as
19 determined by the United States Department of Veterans ~~Affairs.~~Affairs or
20 as established by rules of the Wildlife Resources Commission. This license
21 remains valid for the lifetime of the licensee so long as the licensee remains
22 fifty percent (50%) or more disabled.
- 23 (6c) Resident Totally Disabled Lifetime Inland Fishing License – ~~\$10.00.~~ \$12.00.
24 This license shall be issued only to an individual who is a resident of the
25 State and who is totally and permanently disabled as determined by the
26 Social Security ~~Administration.~~Administration or as established by rules of
27 the Wildlife Resources Commission. This license remains valid for the
28 lifetime of the licensee.
- 29 (7), (8) Repealed by Session Laws 2005-455, s. 1.8, effective January 1, 2007.
- 30 (9) Special Landholder and Guest Fishing License – ~~\$50.00.~~ \$100.00. This
31 license shall be issued only to the landholder of private property bordering
32 inland or joint fishing waters. This license shall entitle the landholder and
33 guests of the landholder to fish from the shore or any pier or dock
34 originating from the property without any additional fishing license. This
35 license is applicable only to private property and private docks and piers and
36 is not valid for any public property, pier, or dock nor for any private
37 property, pier, or dock operated for any commercial purpose whatsoever.
38 This license shall not be in force unless displayed on the premises of the
39 property and only entitles fishing without additional license to persons
40 fishing from the licensed property and then only when fishing within the
41 private property lines. This license is not transferable as to person or
42 location. For purposes of this subdivision, a guest is any individual invited
43 by the landholder to fish from the property at no charge. A charge includes
44 any fee, assessment, dues, rent, or other consideration which must be paid,
45 whether directly or indirectly, in order to be allowed to fish from the
46 property, regardless of the stated reason for such charge."

47 **SECTION 8.** G.S. 113-272 reads as rewritten:

48 "**§ 113-272. Special trout license; mountain heritage trout waters 3-day fishing license.**

49 ...

1 (d) Special Trout License: Fee. – ~~\$10.00~~–\$13.00. This license shall be issued to an
2 individual resident or nonresident of the State and entitles the holder to fish with hook and line
3 in public mountain trout waters.

4 (e) Mountain Heritage Trout Waters 3-Day Fishing License: Fee. – ~~\$5.00~~–\$7.00. This
5 license shall be issued to an individual resident or nonresident of the State and shall entitle the
6 holder to fish in waters designated by the Wildlife Resources Commission as mountain heritage
7 trout waters for the three consecutive days indicated on the license. An individual who holds a
8 mountain heritage trout waters 3-day fishing license does not need to hold a hook-and-line
9 fishing license issued pursuant to G.S. 113-271 in order to fish in mountain heritage trout
10 waters."

11 **SECTION 9.** G.S. 113-272.2(c) reads as rewritten:

12 "(c) The special device licenses issued by the Wildlife Resources Commission are as
13 follows:

14 (1) ~~Resident Noncommercial Special Device License – \$10.00. Except as rules~~
15 ~~of the Wildlife Resources Commission provide for use of equipment by~~
16 ~~more than one person, this license is valid only for use by an individual~~
17 ~~resident of the State. It authorizes the taking of nongame fish from inland~~
18 ~~fishing waters with no more than three special devices authorized by the~~
19 ~~rules of the Wildlife Resources Commission for use in specified waters. The~~
20 ~~Wildlife Resources Commission may restrict the user of the license to~~
21 ~~specified registered equipment, require tagging of items of equipment,~~
22 ~~charge up to one dollar (\$1.00) per tag issued, and require periodic catch~~
23 ~~data reports. Unless specifically prohibited, nongame fish lawfully taken~~
24 ~~under this license may be sold.~~

25 (1a) Resident ~~Commercial~~ Special Device License – ~~\$100.00~~–\$75.00. Except as
26 rules of the Wildlife Resources Commission provide for use of equipment by
27 more than one person, this license is valid only for use by an individual
28 resident of the State. It authorizes the taking of nongame fish from inland
29 fishing waters with ~~four or more~~ special devices authorized by the rules of
30 the Wildlife Resources Commission for use in specified waters. The Wildlife
31 Resources Commission may restrict the user of the license to specified
32 registered equipment, require tagging of items of equipment, charge up to
33 one dollar (\$1.00) per tag issued, and require periodic catch data reports.
34 Nongame fish lawfully taken under this license may be sold.

35 (2) ~~Nonresident Noncommercial Special Device License – \$50.00. Except as~~
36 ~~rules of the Wildlife Resources Commission provide for use of equipment by~~
37 ~~more than one person, this license is valid for use only by an individual~~
38 ~~within the State. It is otherwise subject to the terms and conditions set out in~~
39 ~~subdivision (1) of this subsection.~~

40 (2a) Nonresident ~~Commercial~~ Special Device License – ~~\$200.00~~–\$500.00.
41 Except as rules of the Wildlife Resources Commission provide for use of
42 equipment by more than one person, this license is valid only for use by an
43 individual within the State. It is otherwise subject to the terms and
44 conditions set out in subdivision (1a) of this subsection.

45 (3), (4) Repealed by Session Laws 1987, c. 156, s. 11."

46 **SECTION 10.** G.S. 113-351(c) reads as rewritten:

47 "(c) Types of Unified Hunting and Fishing Licenses; Fees; Duration. – The Wildlife
48 Resources Commission shall issue the following Unified Hunting and Fishing Licenses:

49 (1) Annual Resident Unified Sportsman/Coastal Recreational Fishing License. –
50 ~~\$55.00~~–\$65.00. This license is valid for a period of one year from the date of
51 issuance. This license shall be issued only to an individual who is a resident

1 of the State. This license authorizes the licensee to take all wild animals and
2 wild birds, including waterfowl, by all lawful methods in all open seasons,
3 including the use of game lands; to fish with hook and line for all fish in all
4 inland fishing waters and joint fishing waters, including public mountain
5 trout waters; and to engage in recreational fishing in coastal fishing waters.

6 (2) Annual Resident Unified Inland/Coastal Recreational Fishing License. –
7 ~~\$35.00.~~\$40.00. This license is valid for a period of one year from the date of
8 issuance. This license shall be issued only to an individual who is a resident
9 of the State. This license authorizes the licensee to fish with hook and line
10 for all fish in all inland fishing waters and joint fishing waters, including
11 public mountain trout waters, and to engage in recreational fishing in coastal
12 fishing waters.

13 (3) Lifetime Unified Sportsman/Coastal Recreational Fishing Licenses. – Except
14 as provided in sub-subdivision f. of this subdivision, a license issued under
15 this subdivision is valid for the lifetime of the licensee. A license issued
16 under this subdivision authorizes the licensee to take all wild animals and
17 wild birds, including waterfowl, by all lawful methods in all open seasons,
18 including the use of game lands; to fish with hook and line for all fish in all
19 inland fishing waters and joint fishing waters, including public mountain
20 trout waters; and to engage in recreational fishing in coastal fishing waters.

21 a. Infant Lifetime Unified Sportsman/Coastal Recreational Fishing
22 License. – ~~\$275.00.~~ \$315.00. This license shall be issued only to an
23 individual who is younger than one year of age.

24 b. Youth Lifetime Unified Sportsman/Coastal Recreational Fishing
25 License. – ~~\$450.00.~~ \$520.00. This license shall be issued only to an
26 individual who is one year of age or older but younger than 12 years
27 of age.

28 c. Resident Adult Lifetime Unified Sportsman/Coastal Recreational
29 Fishing License. – ~~\$675.00.~~ \$775.00. This license shall be issued only
30 to an individual who is 12 years of age or older but younger than
31 ~~65~~70 years of age and who is a resident of the State.

32 d. Nonresident Adult Lifetime Unified Sportsman/Coastal Recreational
33 Fishing License. – ~~\$1,350.~~ \$1,550. This license shall be issued only to
34 an individual who is 12 years of age or older and who is not a
35 resident of the State.

36 e. Resident Age ~~65~~70 Lifetime Unified Sportsman/Coastal Recreational
37 Fishing License. – ~~\$30.00.~~ \$33.00. This license shall be issued only to
38 an individual who is ~~65~~70 years of age or older and who is a resident
39 of the State.

40 f. Resident Disabled Veteran Lifetime Unified Sportsman/Coastal
41 Recreational Fishing License. – ~~\$110.00.~~ \$60.00. This license shall be
42 issued only to an individual who is a resident of the State and who is
43 a fifty percent (50%) or more disabled veteran as determined by the
44 United States Department of Veterans ~~Affairs.~~ Affairs or as
45 established by rules of the Wildlife Resources Commission. This
46 license remains valid for the lifetime of the licensee so long as the
47 licensee remains fifty percent (50%) or more disabled.

48 g. Resident Totally Disabled Lifetime Unified Sportsman/Coastal
49 Recreational Fishing License. – ~~\$110.00.~~ \$60.00. This license shall be
50 issued only to an individual who is a resident of the State and who is
51 totally and permanently disabled as determined by the Social

~~Security Administration~~ Administration or as established by rules of the Wildlife Resources Commission.

- (4) Lifetime Unified Inland/Coastal Recreational Fishing Licenses. – Except as provided in sub-subdivisions b. and c. of this subdivision, a license issued under this subdivision is valid for the lifetime of the licensee. A license issued under this subdivision authorizes the licensee to fish with hook and line for all fish in all inland fishing waters and joint fishing waters, including public mountain trout waters, and to engage in recreational fishing in coastal fishing waters.
 - a. Resident Lifetime Unified Inland/Coastal Recreational Fishing License. – ~~\$450.00.~~ \$500.00.
 - b. Resident Legally Blind Lifetime Unified Inland/Coastal Recreational Fishing License. – No charge. This license shall be issued only to an individual who is a resident of the State and who has been certified by the Department of Health and Human Services as an individual whose vision with glasses is insufficient for use in ordinary occupations for which sight is essential. This license remains valid for the lifetime of the licensee so long as the licensee remains legally blind.
 - c. Resident Adult Care Home Lifetime Unified Inland/Coastal Recreational Fishing License. – No charge. This license shall be issued only to an individual who is a resident of the State and who resides in an adult care home as defined in G.S. 131D-2.1 or G.S. 131E-101(1). This license remains valid for the lifetime of the licensee so long as the licensee remains a resident of an adult care home."

SECTION 11. G.S. 113-174.2(c) reads as rewritten:

"(c) Types of CRFLs; Fees; Duration. – The Wildlife Resources Commission shall issue the following CRFLs:

- ...
 - (6) Lifetime CRFLs. – Except as provided in sub-subdivision j. of this subdivision, CRFLs issued under this subdivision are valid for the lifetime of the licensee.
 - g. Resident Adult Lifetime CRFL. – \$250.00. This license shall be issued only to an individual who is 12 years of age or older but younger than ~~65~~70 years of age and who is a resident of the State.
 - ...
 - i. Resident Age ~~65~~70 Lifetime CRFL. – \$15.00. This license shall be issued only to an individual who is ~~65~~70 years of age or older and who is a resident of the State.

SECTION 12. G.S. 113-291.1(b) reads as rewritten:

"(b) No wild animals or wild birds may be taken:

- (1) From or with the use of any vehicle; vessel, other than one manually propelled; airplane; or other conveyance except that the use of vehicles and vessels is authorized:
 - a. As hunting stands, subject to the following limitations. No wild animal or wild bird may be taken from any vessel under sail, under power, or with the engine running or while still in motion from such propulsion. No wild animal or wild bird may be taken from any

1 vehicle if it is in motion, the engine is running, or the passenger area
 2 of the vehicle is occupied. The prohibition of occupying the
 3 passenger area of a vehicle does not apply to a disabled individual
 4 whose mobility is restricted.

5 b. For transportation incidental to the taking.

- 6 (2) With the use or aid of any artificial light, net, trap, snare, electronic or
 7 recorded animal or bird call, or fire, except as may be otherwise provided by
 8 statute[;] provided, however, that the Wildlife Resources Commission may
 9 adopt rules prescribing seasons and the manner of taking of wild animals and
 10 wild birds with the use of artificial light and electronic calls. No wild birds
 11 may be taken with the use or aid of salt, grain, fruit, or other bait. No black
 12 bear may be taken with the use or aid of any salt, salt lick, grain, fruit,
 13 honey, sugar-based material, animal parts or products, or other bait, ~~and no~~
 14 except as provided by the rules of the Wildlife Resources Commission.
 15 However, no rule established by the Wildlife Resources Commission shall
 16 allow for the taking of a black bear with the use and aid of bear bait
 17 attractants, including scented sprays, aerosols, scent balls, and scent
 18 powders, and no rule established by the Wildlife Resources Commission
 19 shall allow for the taking of a black bear while it is consuming bait. No wild
 20 turkey may be taken from an area in which bait has been placed until the
 21 expiration of 10 days after the bait has been consumed or otherwise
 22 removed. The taking of wild animals and wild birds with poisons, drugs,
 23 explosives, and electricity is governed by G.S. 113-261, G.S. 113-262, and
 24 Article 22A of this Subchapter.

25 Upon finding that the placement of processed food products in areas
 26 frequented by black bears is detrimental to the health of individual black
 27 bears or is attracting and holding black bears in an area to the extent that the
 28 natural pattern of movement and distribution of black bears is disrupted and
 29 bears' vulnerability to mortality factors, including hunting, is increased to a
 30 level that causes concern for the population, the Wildlife Resources
 31 Commission may adopt rules to regulate, restrict, or prohibit the placement
 32 of those products and prescribe time limits during which hunting is
 33 prohibited in areas where those products have been placed.

34 Any person who is convicted of unlawfully taking bear with the use or
 35 aid of any type of bait as provided by this subsection or by rules adopted
 36 pursuant to this subsection is punishable as provided by G.S. 113-294(c1)."

37 **SECTION 13.** Chapter 828 of the 1981 Session Laws is repealed.

38 **SECTION 14.** G.S. 113-276 reads as rewritten:

39 **"§ 113-276. Exemptions and exceptions to license and permit requirements.**

40 (a), (b) Repealed by Session Laws 1979, c. 830, s. 1.

41 (c) Except as otherwise provided in this Subchapter, every landholder, his spouse, and
 42 dependents under 18 years of age residing with him may take wildlife upon the land held by the
 43 landholder without any license required by G.S. 113-270.1B or G.S. 113-270.3(a), except that
 44 such persons are not exempt from the bear management stamp established in
 45 G.S. 113-270.3(b)(1b) and the falconry license described in G.S. 113-270.3(b)(4).

46 ...

47 (n) The Wildlife Resources Commission may adopt rules to exempt individuals from
 48 the hunting and fishing license requirements of G.S. 113-270.1B, 113-270.3(b)(1),
 49 113-270.3(b)(1a), 113-270.3(b)(1b), 113-270.3(b)(2), 113-270.3(b)(3), 113-270.3(b)(5),
 50 113-271, 113-272, and 113-272.2(c)(1) who participate in organized hunting and fishing events
 51 for the specified time and place of the event when the purpose of the event is consistent with

1 the conservation objectives of the Commission. A person exempted from licensing
2 requirements under this subsection is responsible for complying with any reporting
3 requirements prescribed by rule of the Wildlife Resources Commission, purchasing any federal
4 migratory waterfowl stamps as a result of waterfowl hunting activity, and complying with any
5 other requirements that the holder of a North Carolina license is subject to. Those exempted
6 persons shall comply with the hunter safety requirements of G.S. 113-270.1A or shall be
7 accompanied by a properly licensed adult who maintains a proximity to the license exempt
8 individual which enables the adult to monitor the activities of, and communicate with, the
9 individual at all times."

10 **SECTION 15.** G.S. 113-270.1(b) reads as rewritten:

11 "(b) License agents may ~~deduct from the amount collected for each license or permit a~~
12 ~~fee of six percent (6%)~~ charge a fee of two dollars (\$2.00) per transaction for licenses or
13 permits issued."

14 **SECTION 16.** G.S. 113-270.1B is amended by adding a new subsection to read:

15 "(c) For those licenses sold directly through the Commission by telephone, mail, online,
16 or at a service counter, the Commission may charge a fee of two dollars (\$2.00) per transaction.
17 A fee may not be charged by the Commission for federal Harvest Information Program (HIP)
18 certification, big game harvest report cards for lifetime license holders, exempt landowners,
19 persons of less than 16 years of age, or for any other license or vessel transactions for which
20 there is no charge."

21 **SECTION 17.** G.S. 75A-5.2(c) reads as rewritten:

22 "(c) As compensation for services rendered to the Commission and to the general public,
23 vessel agents shall receive the ~~following specified commission from the statutory fee for each~~
24 ~~listed transaction~~ surcharge listed below. The surcharge shall be added to the fee for each
25 certificate issued.

26 (1) Renewal of certificate of number – ~~\$1.25~~ \$3.00.

27 (2) Transfer of ownership and certificate of number – ~~\$3.00~~ \$5.00.

28 (3) Issuance of new certificate of number – ~~\$3.00~~ \$5.00.

29 (4) Issuance of duplicate certificate of number – ~~\$0.50~~ \$3.00.

30 (5) Issuance or transfer of certificate of title – ~~\$3.00~~ \$5.00."

31 **SECTION 18.** Article 24 of Chapter 143 of the General Statutes is amended by
32 adding a new section to read:

33 **§ 143-249.1. Operating budget.**

34 No more than twenty-five percent (25%) of the certified operating budget of the Wildlife
35 Resources Commission shall be allowed to accumulate in a cash balance. It is the intent of the
36 General Assembly to implement in any subsequent fiscal year a nonrecurring reduction in an
37 amount equal to the cash balance that exceeds twenty-five percent (25%) of the authorized
38 operating budget in the prior fiscal year."

39 **SECTION 19.** G.S. 143-250.1 is amended by adding a new subsection to read:

40 "(f1) At all times during which the cash balance in the Wildlife Endowment Fund is equal
41 to or greater than the sum of one hundred million dollars (\$100,000,000), the Wildlife
42 Resources Commission shall budget at least fifty percent (50%) of the annual expendable
43 interest from the Fund, as determined by the Board of Trustees of the Fund, to implement the
44 conservation goals set forth in the Wildlife Resource Commission's strategic plan."

45 **SECTION 20.(a)** Effective January 1, 2015, the statutory fees for the hunting,
46 fishing, trapping, and activity licenses issued and administered by the Wildlife Resources
47 Commission shall remain at the levels existing on that date until the rules required to be
48 adopted pursuant to subsection (b) of this section become effective.

49 **SECTION 20.(b)** The Wildlife Resources Commission shall adopt rules to
50 establish fees for the hunting, fishing, trapping, and activity licenses issued and administered by
51 the Wildlife Resources Commission. No rule to increase fees above January 1, 2015, levels

1 may increase a fee in excess of the average increase in the Consumer Price Index for All Urban
2 Consumers over the preceding five years.

3 **SECTION 20.(c)** The statutory fees for the hunting, fishing, trapping, and activity
4 licenses issued and administered by the Wildlife Resources Commission shall expire when the
5 rules adopted pursuant to subsection (b) of this section become effective.

6 **SECTION 21.** All discounted licenses for persons at least 65 years of age provided
7 for in G.S. 113-270.1D(b), 113-271(d), 113-351(c), and 113-174.2(c) for which the age
8 requirement is increased from 65 to 70 by Sections 2, 7, 10, and 11 of this act shall remain
9 available at age 65 for all persons who were born on or before August 1, 1953.

10 **SECTION 22.** Sections 1 through 11 and Sections 14 and 21 of this act become
11 effective August 1, 2014. Sections 12 and 13 are effective when they become law. Sections 15,
12 16, 17, and 18 of this act become effective January 1, 2014. Section 20 becomes effective
13 January 1, 2015. The remainder of this act becomes effective July 1, 2013.
