The House and Senate agree to the following amendments to the Senate Health Care Committee Substitute Adopted 6/5/13, and the House concurs in the Senate Committee Substitute as amended:

On page 1, lines 24 through 31, by rewriting the lines to read:

"(2) A member of the ward's immediate family who is under contract with a local management entity (LME) for the delivery of mental health, developmental disabilities, and substance abuse services and is ~~was~~ serving as a guardian ~~as of~~ on January 1, 2013. For the purposes of this subsection, the term "immediate family" is defined as a spouse, child, sibling, parent, grandparent, or grandchild. The term also includes stepparents, stepchildren, stepsiblings, and adoptive relationships."
