## 2 AN ACT TO DEANNEX CERTAIN DESCRIBED TERRITORY FROM THE CITY OF 3 ASHEVILLE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** The following described territory is removed from the corporate 6 limits of the City of Asheville:
