2 ELECTED FROM COMBINED DISTRICTS,";

4 and on page 1, line 10 through page 3, line 34, by rewriting those lines to read:

6 "SECTION 2.(a) Section 1 of Chapter 193 of the 1987 Session Laws reads as
7 rewritten:

8 "Section 1. Beginning ~~December 7, 1987,~~ in December 2014, the Pitt County Board of
9 Education shall consist of ~~12 members, with two each elected from six districts in nonpartisan~~
10 ~~plurality elections.~~ nine members. Only voters residing in a ~~district~~ the county may vote for the
11 ~~members from that district.~~ members."

12 SECTION 2.(b) Section 2 of Chapter 193 of the 1987 Session Laws is repealed.

13 SECTION 2.(c) Section 3 of Chapter 193 of the 1987 Session Laws is repealed.

14 SECTION 2.(d) Section 4 of Chapter 193 of the 1987 Session Laws reads as
15 rewritten:

16 "Sec. 4. ~~After the initial election, elections shall be held in 1990 and subsequent~~ Elections
17 shall be held in even-numbered years thereafter as terms expire, at the time of the regular
18 election of county officers. ~~set by general State law for the election of county boards of~~
19 ~~education.~~ Members elected in 1990 and subsequent years shall take office at the time set by
20 general State law and shall serve for terms of six-four years.

21 SECTION 2.(e) This section becomes effective the first Monday in December
22 2014. In the 2014 election, the individual elected to fill the vacant seat for District 1, Seat A,
23 for the remainder of the term shall serve a term of two years. In the 2014 election, three
24 individuals shall be elected at large to serve a term of two years. This act does not affect the
25 terms of office of any member elected in 2008 for a six-year term.

26 SECTION 3.(a) Section 1 of Chapter 193 of the 1987 Session Laws, as amended
27 by Section 2(a) of this Act, reads as rewritten:

28 "Section 1. Beginning in December 2014, the Pitt County Board of Education shall consist
29 of nine members. Nine members shall be elected from single-member districts, as described in
30 Section 5. Only voters residing in the ~~county~~ district may vote for the ~~members.~~ member from
31 that district."
