SENATE RESOLUTION DRSR35073-TC-9B (02/26)

Sponsors: Senator Apodaca (Primary Sponsor).

Referred to:

1 A SENATE RESOLUTION TO AMEND THE PROCEDURE FOR NOMINATING AND
2 ELECTING MEMBERS OF THE BOARD OF GOVERNORS OF THE UNIVERSITY OF
3 NORTH CAROLINA.

4 Be it resolved by the Senate:

5 **SECTION 1.** Section 1.I.2. of Senate Resolution 46, 2013 Regular Session of the
6 General Assembly, reads as rewritten:

7 "2. The Senate Committee shall receive suggestions of proposed candidates for
8 nomination for election to the Board of Governors of The University of North Carolina from
9 Monday, February 18, 2013, through Friday, ~~February 22, 2013~~ March 1, 2013. In 2013, the
10 total number of positions available for election by the Senate is eight, and each position is for a
11 four-year term. A Senator may propose candidates for nomination only for the openings
12 available for election by the Senate. In order for a person to have standing to be considered as a
13 candidate for nomination by the Senate Committee, that person must be formally nominated as
14 a candidate by a member of the Senate. Only a written nomination on a form provided by the
15 Chair of the Senate Committee for that purpose and received in the Office of the Senate
16 Principal Clerk on or after Monday, February 18, 2013, and no later than 5:00 P.M. on Friday,
17 ~~February 22, 2013~~ March 1, 2013, shall constitute a formal nomination of a candidate. Delivery
18 to the Office of the Senate Principal Clerk of a nomination form by facsimile transmission or
19 e-mail transmission shall not constitute a formal nomination of a candidate. An individual is
20 not eligible for nomination in the Senate if he or she was nominated and not elected to the
21 Board of Governors by the House of Representatives during the 2013 Session."

22 **SECTION 2.** Section 1.I.3. of Senate Resolution 46, 2013 Regular Session of the
23 General Assembly, reads as rewritten:

24 "3. Notwithstanding G.S. 138A-22, every person who has been formally nominated
25 shall file a completed North Carolina State Ethics Commission 2013 Long Form Statement of
26 Economic Interest with the North Carolina State Ethics Commission to be received by the
27 North Carolina State Ethics Commission no later than 5:00 P.M. on Friday, ~~February 22,~~
28 ~~2013~~ March 1, 2013. Submission of a Statement of Economic Interest 2013 No Change Form
29 shall not constitute a complete submission for a formal nomination of a candidate. The 2013
30 Long Form Statement of Economic Interest must clearly state that the person is a candidate
31 who has been nominated for the Board of Governors of The University of North Carolina."

32 **SECTION 3.** Section 1.I.4. of Senate Resolution 46, 2013 Regular Session of the
33 General Assembly, reads as rewritten:

34 "4. On or after ~~February 23, 2013~~ March 4, 2013, the Senate Committee shall list all
35 proposed candidates for nomination. The Senate Committee shall screen the proposed
36 candidates for nomination as to their qualifications and background and may interview each



1 one to make sure that suitable persons are nominated. The Senate Committee shall ascertain
2 that each candidate for nomination is willing and able to serve and has no statutory disability.
3 On completion of the screening process, the Senate Committee shall conduct a vote to ensure
4 that the slate of legally qualified candidates lists no more than twice the number of candidates
5 for the total seats open."

6 **SECTION 4.** This resolution is effective upon adoption.
