2	AN ACT TO CREATE THE CHARLOTTE REGIONAL AIRPORT AUTHORITY.			
3	The General Assembly of North Carolina enacts:			
4	SECTION 1. This act shall be known and may be cited as the "Charlotte Regional			
5	Airport Authority Act."			
6	<b>SECTION 2.</b> There is hereby created the Charlotte Regional Airport Authority,			
7	which shall be a body corporate and politic, having the powers, authority, and jurisdiction			
8	hereinafter enumerated and such other and additional powers and authority as shall be			
9	conferred upon it by future acts of the General Assembly.			
10	<b>SECTION 3.</b> Unless the context requires otherwise, the following definitions apply			
11	throughout this act to the defined words and phrases and their cognates:			
12	(1) Airport facilities. – Airport facilities of all kinds, including, but not limited			
13	to, landing fields, hangars, fixed base operations, shops, restaurants and			
14	catering facilities, terminals, buildings, automobile parking facilities, and all			
15	other facilities necessary, beneficial, and/or helpful for the landing, taking			
16	off, operating, servicing, repairing, and parking of aircraft, the loading,			
17	unloading, and handling of cargo and mail, express and freight, and the			
18	accommodation, convenience, and comfort of crews and passengers,			
19	together with related transportation facilities, all necessary, beneficial,			
20	and/or helpful appurtenances, machinery, and equipment, and all lands,			
21	properties, rights, easements, and franchises relating thereto and considered			
22	necessary, beneficial, and/or helpful by the Authority in connection			
23	therewith.			
24	(2) Authority. – The Charlotte Regional Airport Authority created by this act or,			
25	if such Authority is abolished, the authority, board, body, commission, or			
26	other entity succeeding to the principal functions thereof.			
27	(3) Member. – An individual who is appointed to the Authority, as provided by			
28	this act. <b>EXECUTION</b> $A(z)$ The Arthonize shall consist of 12 members. The consisting			
29	<b>SECTION 4.(a)</b> The Authority shall consist of 13 members. The appointing			
30	authorities are encouraged to appoint members who, when practical, have experience in aviation logistics construction and/or facilities management law, accounting, and/or finance

30 31 32 33 34	<b>SECTION 4.(b)</b> Members of the Authority shall serve four-year terms and may serve up to a total of two successive four-year terms. A member may not be reappointed to the Authority except after a lapse of four years following the most recent term served. In the event a member is appointed to fill an unexpired term, and at least two years of the unexpired term

47 48 49 50	SECTION 4.(f) Members of the Authority shall not be personally liable, in any manner, for their acts or omissions as members of the Authority, except for malfeasance. SECTION 4.(g) Each member may continue to serve until a successor has been duly appointed and qualified, but not for more than 60 days.

1 **SECTION 4.(h)** In order to ensure that the terms of all members of the Authority 2 do not expire at the same time, the initial terms of the members of the Authority appointed by 3 the Counties of Cabarrus, Gaston, Iredell, Lincoln, Mecklenburg, Union, and one of the two 4 at-large members shall be for two years. 5 **SECTION 5.(a)** The organization and business of the Authority shall be conducted 6 as provided in this act. 7 **SECTION 5.(b)** Members of the Authority shall constitute the governing board of 8 the Authority and may, among other things and from time to time, adopt suitable bylaws not 9 inconsistent with the provisions of this act. 10 **SECTION 5.(c)** The Authority shall appoint from its members a chair, vice-chair, 11 and such other officers as it may from time to time deem necessary, beneficial, and/or helpful 12 for the orderly conduct of its business. The term of office of the chair and vice-chair is one 13 year. 14 **SECTION 5.(d)** Each member of the Authority, including the chair, shall have one 15 vote. A majority of the members of the Authority shall constitute a quorum, and, unless 16 otherwise provided in this act, all actions of the Authority shall be determined by a majority 17 vote of all the members, that is seven votes in favor. 18 SECTION 5.(e) The Authority shall hold meetings at least monthly at such times 19 and places as it from time to time may designate and at such other times on the call of the chair 20 or by seven members of the Authority. Notice of meetings shall be provided as required by 21 Article 33C of Chapter 143 of the General Statutes. A monthly meeting of the Authority may 22 be cancelled if it is determined by the chair or seven members that such meeting is not required. 23 **SECTION 5.(f)** Members may receive payment or reimbursement for travel, 24 lodging, and meal expenses incurred in transacting business on behalf of the Authority. 25 Members may also receive free parking at any airport owned, leased, subleased, or controlled 26 by the Authority, which members may use for official purposes during the respective member's 27 term of office. 28 **SECTION 5.(g)** The fiscal year of the Authority shall begin on July 1 and end on 29 June 30. On or before May 15 of each year, the Authority shall prepare and adopt a proposed 30 budget for the next ensuing fiscal year and deliver copies of such proposed budget to the 31 Cabarrus, Gaston, Iredell, Lincoln, Mecklenburg, and Union County Boards of Commissioners 32 and the Charlotte City Council. 33 **SECTION 5.(h)** All meetings and closed sessions of the Authority shall be 34 conducted in accordance with Article 33C of Chapter 143 of the General Statutes, as it may be 35 amended or in accordance with any successor statute. 36 **SECTION 6.(a)** The Authority shall constitute a body, both corporate and politic, 37 and shall have the power and authority to do the following: 38 Adopt and from time to time revise an official seal. (1)39 (2)Maintain an office or offices at such place or places as it may designate within Mecklenburg County only. 40 41 Purchase, acquire, develop, establish, construct, own, control, lease, equip, (3) 42 improve, administer, maintain, operate, and/or regulate airports and/or 43 landing fields for the use of airplanes and other aircraft and all facilities 44 incidental thereto, within the limits of Mecklenburg County; and for any of 45 such purposes, purchase, acquire, own, develop, hold, lease, sublease, and 46 operate real and/or personal property. 47 (4) Purchase real and personal property. 48 Sue and be sued in the name of the Authority, to acquire by purchase or (5) 49 otherwise and to hold lands for the purpose of constructing, maintaining, 50 and/or operating any airport within the limits of said counties, and to make

50 SECTION 7.(c) Property needed by the Authority for any airport, landing field, or

51 facility may be acquired by the Authority by gift, devise, or purchase. Aviation easements

needed by the Authority for any airport, landing field, or facility may likewise be acquired by 1 2 gift, devise, or purchase. The power of eminent domain may be used by the Authority, pursuant 3 to Article 3 of Chapter 40A of the General Statutes, but only for public use for an airport 4 purpose, and any eminent domain proceeding must be authorized by a majority of the local 5 government appointee members of the Authority, as provided in Sections 4(a)(1) through (8) of 6 this act. In no case, however, may the power of eminent domain be used for purposes not necessary for the operation of the airport, and more specifically no property may be acquired by 7 8 eminent domain for such uses as hotels, motels, restaurants, or industrial parks. For purposes of 9 Chapter 40A of the General Statutes, the authority is a public condemnor under G.S. 40A-3(c).

10 **SECTION 7.(d)** Any lands acquired, owned, controlled, or occupied by the 11 Authority shall and/or are hereby declared to be acquired, owned, controlled, and occupied for 12 a public purpose.

**SECTION 7.(e)** The Authority is not authorized to levy any tax.

14 **SECTION 7.(f)** Any claim by the City of Charlotte on account of acquisition of 15 property by the Authority is extinguished.

16 **SECTION 8.** The Authority shall make annual reports to the Cabarrus, Gaston, 17 Iredell, Lincoln, Mecklenburg, and Union County Boards of Commissioners and the Charlotte 18 City Council setting forth a summary of its general operations and transactions conducted by it 19 pursuant to this act. The Authority shall be regarded as the corporate instrumentality and agent 20 for Cabarrus, Gaston, Iredell, Lincoln, Mecklenburg, and Union Counties and the City of 21 Charlotte for the purpose of developing aviation facilities in the Counties of Cabarrus, Gaston, 22 Iredell, Lincoln, Mecklenburg, and Union, but it shall have no power to pledge the credit of the 23 Counties of Cabarrus, Gaston, Iredell, Lincoln, Mecklenburg, and Union or the City of 24 Charlotte, or to impose any obligation upon those counties, or the City of Charlotte, except and 25 when such power is expressly granted by statute.

SECTION 9. All rights, powers, and authority given to the counties and/or municipalities by the statutes of North Carolina, which may now be in effect or which may be enacted in the future, relating to the development, operation, maintenance, regulation, and/or control of municipal or other governmental airports, and the regulations of aircraft are hereby vested in the Authority.

31 **SECTION 10.** The Authority is hereby expressly authorized to make and enter into 32 contracts, leases, subleases, conveyances, and other agreements with any political subdivision, 33 agency, department, or instrumentality of this State; any agency, department, or subdivision of 34 the United States; or any other legal entity or person for the purpose of carrying out the 35 provisions of this act.

36 SECTION 11. The powers of the Authority created by this act shall be construed 37 liberally in favor of the Authority. No listing of powers included in this act is intended to be 38 exclusive or restrictive, and the specific mention of, or failure to mention, particular powers in 39 this act shall not be construed as limiting in any way the general powers of the Authority as 40 stated in Section 6(a) of this act. It is the intent of this act to grant the Authority full power and 41 right to exercise all authority necessary for the effective operation and conduct of the 42 Authority. It is further intended that the Authority should have all implied powers necessary or 43 incidental to carrying out the expressed powers and the expressed purposes for which the 44 Authority is created. The fact that this act specifically states that the Authority possesses a 45 certain power does not mean that the Authority must exercise such power unless this act 46 specifically so requires.

47 SECTION 12. G.S. 66-58(a) shall not apply to the Charlotte Regional Airport
48 Authority or a lessee or sublessee of the Charlotte Regional Airport Authority.

49 **SECTION 13.** If any provision of this act or its application is held invalid, the 50 invalidity does not affect other provisions or applications of this act that can be given effect

without the invalid provisions or application, and to this end the provisions of this act areseverable.

**SECTION 14.** This act is effective when it becomes law.
