5 **"EXTEND EXISTING IMAGING UTILIZATION MANAGEMENT SERVICES**
6 **CONTRACT; CONTAIN COSTS OF FUTURE CONTRACTS**

7 **SECTION 12H.30.(a)** The Department of Health and Human Services, Division of
8 Medical Assistance, shall renegotiate the existing contract for imaging utilization management
9 services in order to achieve five million five hundred thousand dollars (\$5,500,000) in annual
10 savings of net General Fund appropriations.

11 **SECTION 12H.30.(b)** The Department of Health and Human Services, Division of
12 Medical Assistance, shall issue a request for proposals (RFP) for a contract for imaging
13 utilization management services to ascertain whether the State can achieve better savings with
14 an alternative vendor and, if so, enter into a contract with the alternative vendor. Such an RFP
15 shall incorporate the same requirements as those specified in Section 10.68B of S.L. 2009-451,
16 which was enacted by Section 6 of S.L. 2009-575.

17 **SECTION 12H.30.(c)** No later than March 1, 2015, the Department of Health and
18 Human Services, Division of Medical Assistance, shall report on the results of this section to (i)
19 the House Appropriations Subcommittee on Health and Human Services, (ii) the Senate
20 Appropriations Committee on Health and Human Services, and (iii) the Fiscal Research
21 Division.";

23 And on Page 128, Line 48, by inserting between the words "Administration" and "for" the
24 words "or the Department of Environment and Natural Resources";

26 And in the Senate Appropriations/Base Budget Committee Report on the Continuation,
27 Expansion, and Capital Budgets, dated May 29, 2014, on page H-12 by adding the following
28 two new items:
