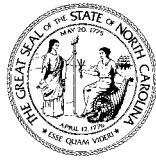

4 **"JLEOC STUDY ON VOCATIONAL TRAINING FOR INDIVIDUALS WITH**  
5 **INTELLECTUAL DISABILITIES**

6 **SECTION 10.4.(a)** The Joint Legislative Education Oversight Committee shall  
7 study at least the following issues related to vocational training for individuals with intellectual  
8 disabilities:

- 9 (1) Model programs for implementation on a systemwide basis at community  
10 college campuses and constituent institutions of The University of North  
11 Carolina for training and developing vocational expertise and job readiness  
12 in students with intellectual disabilities.
- 13 (2) Enhancing employment outcomes for individuals with intellectual  
14 disabilities.
- 15 (3) Barriers to employment for individuals with intellectual disabilities.
- 16 (4) Establishment and expansion of partnerships between community colleges  
17 and community-based organizations that offer job training and job  
18 placement opportunities for individuals with intellectual disabilities, and  
19 between constituent institutions of The University of North Carolina and  
20 these community-based organizations.
- 21 (5) Policies for ensuring that students with intellectual disabilities are prepared  
22 for higher educational opportunities upon completion of their elementary  
23 and secondary school education.
- 24 (6) Policies for transition planning and job training for students with intellectual  
25 disabilities as they complete their elementary and secondary school  
26 education.

27 **SECTION 10.4.(b)** The Joint Legislative Education Oversight Committee shall  
28 report the results of the study required by subsection (a) of this section to the General Assembly  
29 prior to the convening of the 2015 General Assembly."
