4 1, 2014,"; and

6 on page 77, lines 23 and 31, by deleting the word "shall" on each of those lines and inserting  
7 the word "may"; and  
8  
9 on page 77, line 44, by inserting the words "Medicaid and NC Health Choice" after the words  
10 "any social services,"; and  
11  
12 on page 78, lines 16-20, by deleting subsection 12C.3.(e) on those lines and inserting a new  
13 subsection 12C.3.(e) as follows:  
14  
15 **"SECTION 12C.3.(e)** No later than October 1, 2014, the Department of Health  
16 and Human Services, Division of Medical Assistance, shall submit to the Centers for Medicare  
17 and Medicaid Services (CMS) Medicaid and NC Health Choice state plan amendments and  
18 Medicaid waivers necessary to achieve the following:  
19 (1) To effectuate the changes required by this section.  
20 (2) To address the healthcare needs identified in community health assessments and  
21 plans conducted by the Eastern Band of Cherokee Indians, provided that  
22 changes to Medicaid and NC Health Choice services made by the state plan  
23 amendments or waivers will be one hundred percent (100%) federally funded. If  
24 any state plan amendments or waivers authorized by this subdivision will  
25 increase the state share of administrative or other costs, the Department shall  
26 report the anticipated increased costs to the Joint Legislative Oversight  
27 Committee on Health and Human Services.  
28 The state plan amendments and waivers authorized by this section shall have an effective  
29 date no later than October 1, 2015."
