2 AN ACT TO (1) AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO CONVERT
3 PAPER TITLES TO ELECTRONIC TITLES AND TO CHARGE A FEE FOR EACH
4 CONVERSION; AND (2) TO EXCLUDE FEDERAL LANDS ACCESS PROGRAM
5 FUNDS FROM THE STRATEGIC TRANSPORTATION INVESTMENTS ACT
6 FORMULA, AS RECOMMENDED BY THE JOINT LEGISLATIVE
7 TRANSPORTATION OVERSIGHT COMMITTEE.

8 The General Assembly of North Carolina enacts:

10 **DMV CONVERSION OF PAPER TITLES**

11 **SECTION 1.** G.S. 20-58.4A is amended by adding a new subsection to read:

12 "(1) The Division may convert an existing paper title to an electronic title upon request
13 of a primary lienholder. The Division is authorized to collect a fee not to exceed three dollars
14 (\$3.00) for each conversion."

16 **EXCLUDE FEDERAL LANDS ACCESS FUNDS**

17 **SECTION 2.** G.S. 136-189.11(b) reads as rewritten:

18 "(b) Funds Excluded From Formula. – The following funds are not subject to this
19 section:

- 20 (1) Federal congestion mitigation and air quality improvement program funds
21 appropriated to the State by the United States pursuant to 23 U.S.C. §
22 104(b)(2) and 23 U.S.C. § 149.
- 23 (2) Funds received through competitive awards or discretionary grants through
24 federal appropriations either for local governments, transportation
25 authorities, transit authorities, or the Department.
- 26 (3) Funds received from the federal government that under federal law may only
27 be used for Appalachian Development Highway System projects.
- 28 (4) Funds used in repayment of "GARVEE" bonds related to Phase I of the
29 Yadkin River Veterans Memorial Bridge project.
- 30 (5) Funds committed to gap funding for toll roads funded with bonds issued
31 pursuant to G.S. 136-176.
- 32 (6) Funds obligated for projects in the State Transportation Improvement
33 Program that are scheduled for construction as of October 1, 2013, in State
34 fiscal year 2012-2013, 2013-2014, or 2014-2015.

- 1 (7) Toll collections from a turnpike project under Article 6H of this Chapter and
2 other revenue from the sale of the Authority's bonds or notes or project
3 loans, in accordance with G.S. 136-89.192.
4 (8) Toll collections from the State-maintained ferry system collected under the
5 authority of G.S. 136-82.
6 (9) Federal State Planning and Research Program funds (23 U.S.C. § 505) and
7 Metropolitan Planning funds (23 U.S.C. §§ 104 and 134).
8 (10) Federal Lands Access Program funds received by the State pursuant to 23
9 U.S.C. § 204."
