1 moves to amend the bill on page 75, lines 45-46,
2 by inserting between those lines the following:

3 **"THE UNIVERSITY OF NORTH CAROLINA NEED BASED FINANCIAL AID**
4 **PROGRAM FUNDS FOR STUDENTS ATTENDING HISTORICALLY**
5 **BLACK UNIVERSITIES OR NORTH CAROLINA'S HISTORICALLY**
6 **AMERICAN INDIAN UNIVERSITY**

7 **SECTION 11.24.(a)** Notwithstanding any other provision of this act, the
8 management flexibility reduction for The University of North Carolina Operating Budget shall
9 be increased by five million dollars (\$5,000,000) in recurring funds.

10 **SECTION .11.24(b)** Notwithstanding any other provision of this act, the sum of
11 five million dollars (\$5,000,000) shall be used to increase the recurring funds appropriated by
12 this act to The University of North Carolina Need-Based Financial Aid Program and shall be
13 allocated as follows:

- 14 (1) \$2,500,000 shall be used to provide financial assistance for students
15 attending Elizabeth City State University.
- 16 (2) \$2,500,000 shall be used to provide financial assistance for students
17 attending any of the other Historically Black Colleges and Universities or
18 attending North Carolina's Historically American Indian University.

19 And further moves to amend the bill on page 2, line 33, by decreasing the amount on that line
20 by \$5,000,000;

22 And further moves to amend the bill on page 2, line 34 by increasing the amount on that line by
23 \$5,000,000;
