"SECTION 17.1.(a) The Special Investigations Unit, the Financial Crimes Unit, and 10 additional agents of the State Bureau of Investigation to be designated by the Attorney General are hereby transferred from the State Bureau of Investigation and shall be relocated elsewhere within the Department of Justice as determined by the Attorney General. The

remainder of the State Bureau of Investigation is hereby transferred to the"; and

> on page 189, line 45, by inserting immediately after that line the following new section to read: "LEAVE SPECIAL INVESTIGATIONS UNIT, FINANCIAL CRIMES UNIT, AND TEN ADDITIONAL SBI AGENTS WITH THE DEPARTMENT OF JUSTICE

> **SECTION 17.1A.(a)** Notwithstanding anything in this act or in the N.C. House of Representatives Appropriations Committee Report on the Continuation, Expansion, and Capital Budgets for Senate Bill 744, dated June 11, 2014 to the contrary, the Special Investigations Unit, the Financial Crimes Unit, and 10 additional agents of the State Bureau of Investigation to be designated by the Attorney General shall be transferred from the State Bureau of Investigation and shall be relocated elsewhere within the Department of Justice as determined by the Attorney General. Accordingly, there shall be no reduction of two million four hundred forty-two thousand fifty-nine dollars (\$2,442,059) and 28 FTE to the Department of Justice, and no increase of a corresponding amount of funds and FTE in the Department of Public Safety, which would have occurred if the Special Investigations Unit, the Financial Crimes Unit, and 10 additional agents had been transferred to the Department of Public Safety.

> SECTION 17.1A.(b) The 10 agents of the State Bureau of Investigation that remain in the Department of Justice pursuant to subsection (a) of this section shall have all of the statutory and common law powers that State Bureau of Investigation agents who are transferred to the Department of Public Safety possess."; and
