4 LEADERSHIP AND MEMBERSHIP TO THOSE WHO SUPPORT ITS MISSION AND  
5 GOALS AND TO PROHIBIT CONSTITUENT INSTITUTIONS AND ";

8 by rewriting those lines to read:  
9 "(b) To the extent allowed by State and federal law, and consistent with the constituent  
10 institution's equal opportunity policies, a religious or political student organization may, in  
11 conformity with the organization's established written doctrines expressing the organization's  
12 faith or mission: (i) determine that only persons professing the faith or mission of the  
13 organization as established in its written doctrines, and comporting themselves in conformity  
14 with those written doctrines, are qualified to serve as leaders of that organization, and (ii) limit  
15 membership and participation in the organization to those students who, upon individual  
16 inquiry, affirm that they support the organization's goals and agree with its faith or mission as  
17 established in its written doctrines.";

19 and on page 1, line 32 through page 2, line 2,  
20 by rewriting those lines to read:  
21 "(b) To the extent allowed by State and federal law, and consistent with the community  
22 college's equal opportunity policies, a religious or political student organization may, in  
23 conformity with the organization's established written doctrines expressing the organization's  
24 faith or mission: (i) determine that only persons professing the faith or mission of the  
25 organization as established in its written doctrines, and comporting themselves in conformity  
26 with those written doctrines, are qualified to serve as leaders of that organization, and (ii) limit  
27 membership and participation in the organization to those students who, upon individual  
28 inquiry, affirm that they support the organization's goals and agree with its faith or mission as  
29 established in its written doctrines.".
