## 12 "PART VII. AMEND COMPLIANCE BOUNDARY PROVISIONS

SECTION 12.(a) G.S. 143-215.1 reads as rewritten:

14 "§ 143-215.1. Control of sources of water pollution; permits required.

16 (i) Any person subject to the requirements of this section who is required to obtain an individual permit from the Commission for a disposal system under the authority of 17 18 G.S. 143-215.1 or Chapter 130A of the General Statutes shall have a compliance boundary as may be established by rule or permit for various categories of disposal systems and beyond 19 which groundwater quality standards may not be exceeded. The location of the compliance 20 boundary shall be established at the property boundary, except as otherwise established by the 21 Commission. Multiple contiguous properties under common ownership and permitted for use 22 as a disposal system shall be treated as a single property with regard to determination of a 23 24 compliance boundary under this subsection. boundary. Nothing in this subsection shall be 25 interpreted to require a revision to an existing compliance boundary previously approved by 26 rule or permit.

27 (j) When operation of a disposal system permitted under this section results in an
 28 exceedance of the groundwater quality standards adopted in accordance with G.S. 143-214.1,
 29 the Commission shall require that the exceedances within the compliance boundary be
 30 remedied through cleanup, recovery, containment, or other response only when any of the
 31 following conditions occur:

| 13 | SECTION 12.(c) The Environmental Management Commission shall review the                          |
| 14 | compliance boundary and corrective action provisions of Subchapter 2L of Title 15A of the        |
| 15 | North Carolina Administrative Code for clarity and internal consistency. The Commission          |
| 16 | shall report the results of its review, including any recommendations, to the Environmental      |
| 17 | Review Commission no later than December 1, 2014."; and  |
