2 AN ACT TO REMOVE PROHIBITIONS ON CARRYING CONCEALED FIREARMS BY
3 CERTAIN DEPARTMENT OF PUBLIC SAFETY EMPLOYEES AND
4 ADMINISTRATIVE LAW JUDGES; TO INCREASE THE PENALTY FOR CARRYING
5 A CONCEALED FIREARM; TO INCREASE THE PENALTY FOR GIVING OR
6 SELLING A CELL PHONE TO AN INMATE AND TO MAKE POSSESSION OF A
7 CELL PHONE BY AN INMATE UNLAWFUL; TO AMEND THE OFFENSE OF
8 MAKING THREATS AGAINST OR ASSAULTING LEGISLATIVE, EXECUTIVE, OR
9 COURT OFFICERS; TO CREATE AN OFFENSE WHEN AN INMATE SOLICITS
10 ANOTHER TO COMMIT A CRIMINAL OFFENSE; TO INCREASE PENALTIES FOR
11 CERTAIN VIOLATIONS OF THE AMUSEMENT DEVICE SAFETY ACT; TO
12 PROPERLY IMPLEMENT CURRENT EXPUNCTION PROVISIONS; TO ADD
13 QUALIFIED RETIRED CORRECTIONAL OFFICERS TO OFFICERS EXEMPT FROM
14 CONCEALED CARRY COURSE; TO CONFORM STATE LAW WITH THE UNITED
15 STATES SUPREME COURT DECISION IN HALL V. FLORIDA; TO ADD THE
16 UNFAIR USE OF CRIMINAL RECORD INFORMATION TO THE CONSUMER
17 PROTECTION LAWS; TO DIRECT MERGERS AT THE DEPARTMENT OF PUBLIC
18 SAFETY; AND TO AUTHORIZE REMOTE VIDEO TESTIMONY BY FORENSIC
19 AND CHEMICAL ANALYSTS, AS RECOMMENDED BY THE LEGISLATIVE
20 RESEARCH COMMISSION'S COMMITTEE ON JUDICIAL EFFICIENCY AND
21 EFFECTIVE ADMINISTRATION OF JUSTICE.

22 The General Assembly of North Carolina enacts:

23
24 **PART I. REMOVE PROHIBITIONS ON CARRYING CONCEALED FIREARMS FOR**
25 **CERTAIN DEPARTMENT OF PUBLIC SAFETY EMPLOYEES AND INCREASE**
26 **PENALTY FOR CARRYING CONCEALED WEAPON THAT IS A FIREARM**

27 SECTION 1.1. G.S. 14-269 reads as rewritten:

28 "§ 14-269. Carrying concealed weapons.

29 ...

30 (b) This prohibition shall not apply to the following persons:

31 ...

(7) A person employed by the Department of Public Safety who has been designated in writing by the Secretary of the Department, who has a concealed handgun permit issued in accordance with Article 54B of this Chapter or considered valid under G.S. 14-415.24, and has in the person's possession written proof of the designation by the Secretary of the Department, provided that the person shall not carry a concealed weapon at any time while consuming alcohol or an unlawful controlled substance or while alcohol or an unlawful controlled substance remains in the person's body.

...."

SECTION 1.2. G.S. 14-269(c) reads as rewritten:

"(c) Any person violating the provisions of subsection (a) of this section shall be guilty of a Class 2 misdemeanor. Any person violating the provisions of subsection (a1) of this section shall be guilty of a ~~Class 2 misdemeanor~~ Class A1 misdemeanor for the first offense. ~~A offense and a Class H felony for a second or subsequent offense is punishable as a Class I felony offense.~~ A violation of subsection (a1) of this section punishable under G.S. 14-415.21(a) is not punishable under this section."

SECTION 1.3. G.S. 14-415.27 reads as rewritten:

"§ 14-415.27. Expanded permit scope for certain persons.

Notwithstanding G.S. 14-415.11(c), any of the following persons who has a concealed handgun permit issued pursuant to this Article or that is considered valid under G.S. 14-415.24 is not subject to the area prohibitions set out in G.S. 14-415.11(c) and may carry a concealed handgun in the areas listed in G.S. 14-415.11(c) unless otherwise prohibited by federal law:

- (1) A district attorney.
- (2) An assistant district attorney.
- (3) An investigator employed by the office of a district attorney.
- (4) A North Carolina district or superior court judge.
- (5) A magistrate.
- (6) A person who is elected and serving as a clerk of court.
- (7) A person who is elected and serving as a register of deeds.
- (8) A person employed by the Department of Public Safety who has been designated in writing by the Secretary of the Department and who has in the person's possession written proof of the designation.
- (9) Any person who is an administrative law judge described in Article 60 of Chapter 7A of the General Statutes, and who has a concealed handgun permit issued in accordance with Article 54B of this Chapter or considered valid under G.S. 14-415.24, provided that the person shall not carry a concealed weapon at any time while consuming alcohol or an unlawful controlled substance or while alcohol or an unlawful controlled substance remains in the person's body."

SECTION 1.4. Section 1.2 of this Part is effective December 1, 2014, and applies to offenses occurring on or after that date. The remainder of this Part is effective when this act becomes law.

PART II. INCREASE PENALTY FOR GIVING OR SELLING A CELL PHONE TO AN INMATE/MAKE IT UNLAWFUL FOR STATE INMATE TO POSSESS A CELL PHONE/INCREASE PENALTY FOR INMATE OF LOCAL CONFINEMENT FACILITY TO POSSESS CELL PHONE

SECTION 2.1. G.S. 14-258.1 reads as rewritten:

"§ 14-258.1. Furnishing poison, controlled substances, deadly weapons, cartridges, ammunition or alcoholic beverages to inmates of charitable, mental or penal

1 institutions or local confinement facilities; furnishing tobacco products or
2 mobile phones to inmates.

3 ...

4 (d) Any person who knowingly gives or sells a mobile telephone or other wireless
5 communications device, or a component of one of those devices, to an inmate in the custody of
6 the Division of Adult Correction of the Department of Public Safety or to an inmate in the
7 custody of a local confinement facility, or any person who knowingly gives or sells any such
8 device or component to a person who is not an inmate for delivery to an inmate, is guilty of a
9 ~~Class 1 misdemeanor.~~ Class H felony.

10 (e) Any inmate of a local confinement facility who possesses any tobacco product, as
11 defined in G.S. 148-23.1, other than for authorized religious purposes, ~~or who possesses a~~
12 ~~mobile telephone or other wireless communications device or a component of one of those~~
13 ~~devices,~~ is guilty of a Class 1 misdemeanor.

14 (f) Any inmate in the custody of the Division of Adult Correction of the Department of
15 Public Safety or an inmate of a local confinement facility who possesses a mobile telephone or
16 other wireless communication device or a component of one of those devices is guilty of a
17 Class H felony."

18 **SECTION 2.2.** This Part becomes effective December 1, 2014, and applies to
19 offenses committed on or after that date.

20 21 **PART III. ASSAULT ON A LEGISLATIVE, EXECUTIVE, OR COURT** 22 **OFFICIAL/THREATS/SOLICITATION BY AN INMATE**

23 **SECTION 3.1.** G.S. 14-16.6(a) reads as rewritten:

24 "(a) Any person who assaults any legislative officer, executive officer, or court officer,
25 or assaults another person as retaliation against any legislative officer, executive officer, or
26 court officer because of the exercise of that officer's duties, or any person who makes a violent
27 attack upon the residence, office, temporary accommodation or means of transport of any one
28 of those officers or persons in a manner likely to endanger the ~~officer,~~ officer or person, shall
29 be guilty of a felony and shall be punished as a Class I felon."

30 **SECTION 3.2.** G.S. 14-16.7(a) reads as rewritten:

31 **"§ 14-16.7. Threats against executive, legislative, or court officers.**

32 (a) Any person who knowingly and willfully makes any threat to inflict serious bodily
33 injury upon or to kill any legislative officer, executive officer, or court officer, or who
34 knowingly and willfully makes any threat to inflict serious bodily injury upon or kill any other
35 person as retaliation against any legislative officer, executive officer, or court officer because of
36 the exercise of that officer's duties, shall be guilty of a felony and shall be punished as a Class I
37 felon.

38 (b) Any person who knowingly and willfully deposits for conveyance in the mail any
39 letter, writing, or other document containing a threat to ~~inflict serious bodily injury upon or to~~
40 ~~kill any legislative officer, executive officer, or court officer,~~ commit an offense described in
41 subsection (a) of this section shall be guilty of a felony and shall be punished as a Class I
42 felon."

43 **SECTION 3.4.** This Part becomes effective December 1, 2014, and applies to
44 offenses committed on or after that date.

45 46 **PART IV. AMUSEMENT DEVICE PENALTIES**

47 **SECTION 4.1.** G.S. 95-111.13 reads as rewritten:

48 **"§ 95-111.13. Violations; civil penalties; appeal; criminal penalties.**

49 (a) Any person who violates G.S. 95-111.7(a) or (b) (Operation without certificate;
50 operation not in accordance with Article or rules and regulations) or G.S. 95-111.8 (Location
51 notice) shall be is subject to a civil penalty not to exceed ~~two hundred fifty dollars (\$250.00)~~

1 two thousand five hundred dollars (\$2,500) for each rule, regulation, or section of this Article
2 violated and for each day each device is so operated or used.

3 (b) Any person who violates G.S. 95-111.7(c) (Operation after refusal to issue or after
4 revocation of certificate) or G.S. 95-111.10(c) (Reports required) or G.S. 95-111.12 (Liability
5 insurance) ~~shall be is~~ subject to a civil penalty not to exceed ~~five hundred dollars (\$500.00)~~ five
6 thousand dollars (\$5,000) for each day each device is so operated or used.

7 ~~(e) Any person who violates G.S. 95-111.8 (Location notice) shall be subject to a civil~~
8 ~~penalty not to exceed five hundred dollars (\$500.00) for each day any device is operated or~~
9 ~~used without the location notice having been provided.~~

10 (d) Any person who violates the provisions of G.S. 95-111.10(d) (Reports required) or
11 knowingly permits the operation of an amusement device in violation of G.S. 95-111.11(a)
12 (Operator requirements) ~~shall be is~~ subject to a civil penalty not to exceed ~~five hundred dollars~~
13 ~~(\$500.00)~~ five thousand dollars (\$5,000) for each day each device is so operated or used.

14 (e) Any person who violates G.S. 95-111.9 (Operation of unsafe device) or
15 G.S. 95-111.11(b) (Operation of an amusement device while impaired) ~~shall be is~~ subject to a
16 civil penalty not to exceed ~~one thousand dollars (\$1,000)~~ ten thousand dollars (\$10,000) for
17 each day each device is so operated or used.

18 (f) In determining the amount of any penalty ordered under authority of this section, the
19 Commissioner shall give due consideration to the appropriateness of the penalty with respect to
20 ~~the size of the business of the person~~ annual gross volume of the business being charged, the
21 gravity of the violation, the good faith of the ~~person~~ person, and the record of previous
22 violations.

23 (g) The determination of the amount of the penalty by the Commissioner ~~shall be is~~
24 final, unless within 15 days after receipt of notice thereof by certified mail with return receipt,
25 by signature confirmation as provided by the U.S. Postal Service, by a designated delivery
26 service authorized pursuant to 26 U.S.C. § 7502(f)(2) with delivery receipt, or via hand
27 delivery, the person charged with the violation takes exception to the determination, in which
28 event final determination of the penalty shall be made in an administrative proceeding and in a
29 judicial proceeding pursuant to Chapter 150B of the General Statutes, the Administrative
30 Procedure Act.

31 (h) The Commissioner may file in the office of the clerk of the superior court of the
32 county wherein the person, against whom a civil penalty has been ordered, resides, or if a
33 corporation is involved, in the county wherein the corporation maintains its principal place of
34 business, or in the county wherein the violation occurred, a certified copy of a final order of the
35 Commissioner unappealed from, or of a final order of the Commissioner affirmed upon appeal.
36 Whereupon, the clerk of said court shall enter judgment in accordance therewith and notify the
37 parties. Such judgment shall have the same effect, and all proceedings in relation thereto shall
38 thereafter be the same, as though said judgment had been rendered in a suit duly heard and
39 determined by the superior court of the General Court of Justice.

40 (i) Any person who willfully violates any provision of this ~~Article, and the violation~~
41 ~~causes the death of any person, shall be~~ Article is guilty of a Class 2 misdemeanor, which may
42 include a fine of not more than ten thousand dollars (\$10,000); except that if the conviction is
43 for a violation committed after a first conviction of such person, a provision of this Article, the
44 person shall be is guilty of a Class 1 misdemeanor, which may include a fine of not more than
45 twenty thousand dollars (\$20,000). Any person who willfully violates any provision of this
46 Article, and the violation causes the serious injury or death of any person, is guilty of a Class E
47 felony, which may include a fine of not more than fifty thousand dollars (\$50,000). This
48 subsection shall not prevent any prosecuting officer of the State of North Carolina from
49 proceeding against such person on a prosecution charging any degree of willful or culpable
50 homicide."

1 **SECTION 4.2.** This Part becomes effective December 1, 2014, and applies to
2 offenses and violations committed on or after that date.

3
4 **PART V. PROPER IMPLEMENTATION OF EXPUNCTION LAWS**

5 **SECTION 5.1.** G.S. 15A-145.5(f) reads as rewritten:

6 "(f) Any other applicable State or local government agency shall expunge from its
7 records entries made as a result of the conviction ordered expunged under this section upon
8 receipt from the petitioner of an order entered pursuant to this section. The agency shall also
9 vacate any administrative actions taken against a person whose record is expunged under this
10 section as a result of the charges or convictions expunged. A person whose administrative
11 action has been vacated by an occupational licensing board pursuant to an expunction under
12 this section may then reapply for licensure and must satisfy the board's then current education
13 and preliminary licensing requirements in order to obtain licensure. This subsection shall not
14 apply to the Department of Justice for DNA records and samples stored in the State DNA
15 Database and the State DNA ~~Databank~~ or to fingerprint records ~~Databank~~."

16 **SECTION 5.2.** This Part is effective when it becomes law and applies to
17 expunctions issued pursuant to G.S. 15A-145.5 before, on, or after that date.

19 **PART VI. DEPARTMENT OF PUBLIC SAFETY MERGERS**

20
21 **TRANSFER THE SBI AND THE ALCOHOL LAW ENFORCEMENT SECTION**

22 **SECTION 6.1.(a)** The State Bureau of Investigation is hereby transferred to the
23 Department of Public Safety as a new section within the Law Enforcement Division. This
24 transfer shall have all of the elements of a Type I transfer, as described in G.S. 143A-6.

25

1 terminate a volunteer relationship if that employee, contractor, or volunteer refuses to consent

5 The custody order shall be in writing and shall direct a law enforcement officer or other
6 authorized person to assume custody of the juvenile and to make due return on the order. The
7 official executing the order shall give a copy of the order to the juvenile's parent, guardian, or
8 custodian. If the order is for nonsecure custody, the official executing the order shall also give a
9 copy of the petition and order to the person or agency with whom the juvenile is being placed.
10 If the order is for secure custody, copies of the petition and custody order shall accompany the
11 juvenile to the detention facility or holdover facility of the jail. A message of ~~the Division of~~
12 ~~Criminal Information, State Bureau of Investigation,~~ the Department of Public Safety stating
13 that a juvenile petition and secure custody order relating to a specified juvenile are on file in a
14 particular county shall be authority to detain the juvenile in secure custody until a copy of the
15 juvenile petition and secure custody order can be forwarded to the juvenile detention facility.
16 The copies of the juvenile petition and secure custody order shall be transmitted to the
17 detention facility no later than 72 hours after the initial detention of the juvenile.

18 An officer receiving an order for custody which is complete and regular on its face may
19 execute it in accordance with its terms and need not inquire into its regularity or continued
20 validity, nor does the officer incur criminal or civil liability for its execution."

21 **SECTION 6.1.(t)** G.S. 8-58.20(c) reads as rewritten:

22 "(c) The analyst who analyzes the forensic sample and signs the report shall complete an
23 affidavit on a form developed by the ~~State Bureau of Investigation,~~ State Crime Laboratory. In
24 the affidavit, the analyst shall state (i) that the person is qualified by education, training, and
25 experience to perform the analysis, (ii) the name and location of the laboratory where the
26 analysis was performed, and (iii) that performing the analysis is part of that person's regular
27 duties. The analyst shall also aver in the affidavit that the tests were performed pursuant to the
28 accrediting body's standards for that discipline and that the evidence was handled in accordance
29 with established and accepted procedures while in the custody of the laboratory. The affidavit
30 shall be sufficient to constitute prima facie evidence regarding the person's qualifications. The
31 analyst shall attach the affidavit to the laboratory report and shall provide the affidavit to the
32 investigating officer and the district attorney in the prosecutorial district in which the criminal
33 charges are pending. An affidavit by a forensic analyst sworn to and properly executed before
34 an official authorized to administer oaths is admissible in evidence without further
35 authentication in any criminal proceeding with respect to the forensic analysis administered and
36 the procedures followed."

37 **SECTION 6.1.(u)** G.S. 14-16.9 reads as rewritten:

38 **"§ 14-16.9. Officers-elect to be covered.**

39 Any person who has been elected to any office covered by this Article but has not yet taken
40 the oath of office shall be considered to hold the office for the purpose of this Article and
41 ~~G.S. 114-15~~ G.S. 143B-919."

42 **SECTION 6.1.(v)** G.S. 14-132(c)(3) reads as rewritten:

43 "(3) Designated by the ~~Attorney General~~ Secretary of Public Safety in accordance
44 with ~~G.S. 114-20.1~~ G.S. 143B-987."

 9 State Employees' Retirement System of North Carolina established
 10 under Article 1 of Chapter 135 of the General Statutes.

 12 receiving a firearm."

 30 of 18.

31 b. Significant limitations in adaptive functioning. – Significant
 32 limitations in two or more of the following adaptive skill areas:
 33 communication, self-care, home living, social skills, community use,
 34 self-direction, health and safety, functional academics, leisure skills
 35 and work skills.

36 c. Significantly subaverage general intellectual functioning. – An
 37 intelligence quotient of 70 or below.

38 (2) The defendant has the burden of proving significantly subaverage general
 39 intellectual functioning, significant limitations in adaptive functioning, and
 40 that ~~mental retardation~~ intellectual disability was manifested before the age
 41 of 18. An intelligence quotient of 70 or below on an individually
 42 administered, scientifically recognized standardized intelligence quotient test
 43 administered by a licensed psychiatrist or psychologist is evidence of
 44 significantly subaverage general intellectual functioning; however, it is not
 45 sufficient, without evidence of significant limitations in adaptive functioning
 46 and without evidence of manifestation before the age of 18, to establish that
 47 the defendant is ~~mentally retarded~~ has an intellectual disability. An
 48 intelligence quotient of 70, as described in this subdivision, is approximate
 49 and a higher score resulting from the application of the standard error of
 50 measurement to an intelligence quotient of 70 shall not preclude the
 51 defendant from being able to present additional evidence of intellectual

1 disability, including testimony regarding adaptive deficits. Accepted clinical
2 standards for diagnosing significant limitations in intellectual functioning
3 and adaptive behavior shall be applied in the determination of intellectual
4 disability.

5 (b) Notwithstanding any provision of law to the contrary, no defendant ~~who is mentally~~
6 ~~retarded with an intellectual disability~~ shall be sentenced to death.

7 (c) Upon motion of the defendant, supported by appropriate affidavits, the court may
8 order a pretrial hearing to determine if the defendant ~~is mentally retarded.~~ has an intellectual
9 disability. The court shall order such a hearing with the consent of the State. The defendant has
10 the burden of production and persuasion to demonstrate ~~mental retardation~~ intellectual
11 disability by clear and convincing evidence. If the court determines that the defendant to be
12 ~~mentally retarded,~~ has an intellectual disability, the court shall declare the case noncapital, and
13 the State may not seek the death penalty against the defendant.

14 (d) The pretrial determination of the court shall not preclude the defendant from raising
15 any legal defense during the trial.

16 (e) If the court does not find that the defendant to be mentally retarded ~~has an~~
17 intellectual disability in the pretrial proceeding, upon the introduction of evidence ~~of the~~
18 ~~defendant's mental retardation~~ raising the issue of intellectual disability during the sentencing
19 hearing, the court shall submit a special issue to the jury as to whether the defendant ~~is mentally~~
20 ~~retarded~~ has an intellectual disability as defined in this section. This special issue shall be
21 considered and answered by the jury prior to the consideration of aggravating or mitigating
22 factors and the determination of sentence. If the jury determines that the defendant to be

48 (1) The cost to repair damage caused by the violation is in excess of one
49 thousand dollars (\$1,000).

50 (2) The person has two or more prior convictions for violation of this section.

1 (c) If a person is convicted of five or more violations of this section in a single session
2 of district court or in a single week of superior court, and at least five of the offenses occurred
3 within a 60-day period, the court shall consolidate the offenses for judgment and the
4 consolidated offenses shall be punishable as a Class I felony.

5 (d) As used in this section, "graffiti vandalism" means to unlawfully write or scribble
6 on, mark, paint, deface, besmear, or injure the walls of (i) any real property, whether public or
7 private, including cemetery tombstones and monuments, (ii) any public building or facility as
8 defined in G.S. 14-132, or (iii) any statue or monument situated in any public place, by any
9 type of pen, paint, or marker regardless of whether the pen or marker contains permanent ink,
10 paint, or spray paint."

11 **SECTION 9.2.** This Part becomes effective December 1, 2014, and applies to
12 offenses committed on or after that date.

13 **PART X. UNFAIR USE OF CRIMINAL RECORD INFORMATION**

14 **SECTION 10.1.** Chapter 75 of the General Statutes is amended by adding a new

25 individual's photograph."

28 **PART XI. REMOTE VIDEO TESTIMONY BY FORENSIC AND CHEMICAL** 29 **ANALYSTS**

32 **"§ 15A-1225.3. Forensic analyst remote testimony.**

33 (a) Definitions. – The following definitions apply to this section:

36 proceeding conducted under Subchapter II of Chapter 7B of the General
37 Statutes where a juvenile is alleged to have committed an offense that would
38 be a criminal offense if committed by an adult.

39 (2) Remote testimony. – A method by which a forensic analyst testifies from a
40 location other than the location where the hearing or trial is being conducted
41 and outside the physical presence of a party or parties.

42 (b) Remote Testimony Authorized. – In any criminal proceeding, the testimony of an
43 analyst regarding the results of forensic testing admissible pursuant to G.S. 8-58.20, and
44 reported by that analyst, shall be permitted by remote testimony if all of the following occur:

45 (1) The State has provided a copy of the report to the attorney of record for the
46 defendant, or to the defendant if that person has no attorney, as required by
47 G.S. 8-58.20(d).

48 (2) The State notifies the attorney of record for the defendant, or the defendant if
49 that person has no attorney, at least 15 business days before the proceeding
50
51

1 at which the evidence would be used of its intention to introduce the
2 testimony regarding the results of forensic testing into evidence using remote
3 testimony.

- 4 (3) The defendant's attorney of record, or the defendant if that person has no
5 attorney, fails to file a written objection with the court, with a copy to the
6 State, at least five business days before the proceeding at which the
7 testimony will be presented that the defendant objects to the introduction of
8 the remote testimony.

9 If the defendant's attorney of record, or the defendant if that person has no attorney, fails to
10 file a written objection as provided in this subsection, then the analyst shall be allowed to
11 testify by remote testimony.

12 (c) Testimony. – The method used for remote testimony authorized by this section shall
13 allow the trier of fact and all parties to observe the demeanor of the analyst as the analyst
14 testifies in a similar manner as if the analyst were testifying in the location where the hearing or
15 trial is being conducted. The court shall ensure that the defendant's attorney, or the defendant if
16 that person has no attorney, has a full and fair opportunity for examination and
17 cross-examination of the analyst.

18 (d) Nothing in this section shall preclude the right of any party to call any witness."

19 **SECTION 11.2.** G.S. 20-139.1 is amended by adding a new subsection to read:

20 "(c5) The testimony of an analyst regarding the results of a chemical analysis of blood or
21 urine admissible pursuant to subsection (c1) of this section, and reported by that analyst, shall
22 be permitted by remote testimony, as defined in G.S. 15A-1225.3, in all administrative
23 hearings, and in any court, if all of the following occur:

24 (1) The State has provided a copy of the report to the attorney of record for the
25 defendant, or to the defendant if that person has no attorney, as required by
26 subsections (c1) and (c3) of this section.

27 (2) The State notifies the attorney of record for the defendant, or the defendant if
28 that person has no attorney, at least 15 business days before the proceeding
29 at which the evidence would be used of its intention to introduce the
30 testimony regarding the chemical analysis into evidence using remote
31 testimony.

42 manner as if the analyst were testifying in the location where the hearing or trial is being
43 conducted. The court shall ensure that the defendant's attorney, or the defendant if that person
44 has no attorney, has a full and fair opportunity for examination and cross-examination of the
45 analyst.

46 Nothing in this section shall preclude the right of any party to call any witness."

47 **SECTION 11.3.** This section becomes effective December 1, 2014, and applies to
48 testimony admitted on or after that date.

50 **PART XII. EFFECTIVE DATE**

1 **SECTION 12.** Except as otherwise provided, this act is effective when it becomes
2 law.
