4 "SECTION 3.(g) G.S. 130A-26.1(g) reads as rewritten:

5 "(g) Any person who knowingly and willfully does any of the following shall be guilty
6 of a Class I felony, which may include a fine not to exceed one hundred thousand dollars
7 (\$100,000) per day of violation, provided that the fine shall not exceed a cumulative total of
8 five hundred thousand dollars (\$500,000) for each period of 30 days during which a violation
9 continues:

- 10 (1) Transports or causes to be transported hazardous waste without a manifest as
11 required under G.S. 130A-294(c).
- 12 (2) Transports hazardous waste without a United States Environmental
13 Protection Agency identification number as required by rules promulgated
14 under G.S. 130A-294(c).
- 15 (3) Omits material information or makes any false material statement or
16 representation in any application, label, manifest, record, report, permit, or
17 other document filed, maintained, or used for purposes of compliance with
18 rules promulgated under G.S. 130A-294(c).
- 19 (4) Generates, stores, treats, transports, disposes of, exports, or otherwise
20 handles any hazardous waste or any used oil burned for energy recovery and
21 who knowingly destroys, alters, conceals, or fails to file any record,
22 application, manifest, report, or other document required to be maintained or
23 filed for purposes of compliance with rules promulgated under G.S.
24 130A-294(c).
- 25 (5) Provides false information or fails to provide information relevant to a
26 decision by the Department as to whether or not to enter into a brownfields
27 agreement under Part 5 of Article 9 of this Chapter.
- 28 (6) Provides false information or fails to provide information required by a
29 brownfields agreement under Part 5 of Article 9 of this Chapter.
- 30 (7) Provides false information relevant to a decision by the Department pursuant
31 to:
