10 **SECTION 14.(a)** G.S. 160A-20.1(b) reads as rewritten:

11 '(b) Contractors Must Use E-Verify. – No city may enter into a contract subject to G.S.
12 143-129 unless the contractor and the contractor's subcontractors comply with the requirements
13 of Article 2 of Chapter 64 of the General Statutes.'

14 **SECTION 14.(b)** G.S. 153A-449(b) reads as rewritten:

15 '(b) Contractors Must Use E-Verify. – No county may enter into a contract subject to
16 G.S. 143-129 unless the contractor and the contractor's subcontractors comply with the
17 requirements of Article 2 of Chapter 64 of the General Statutes.'

18 **SECTION 14.(c)** This section becomes effective October 1, 2014, and applies to
19 contracts entered into on or after that date.

23 becomes law."


