1 moves to amend the bill on page 1, line 3 by rewriting the line to read:

3 "PROGRAM WITH A CHARTER SCHOOL AND TO REQUIRE SALARY DISCLOSURES
4 IN CONTRACTS ENTERED INTO BY BOARDS OF DIRECTORS OF CHARTER
5 SCHOOLS.";

7 And on page 2, lines 19 through 21 by rewriting the lines to read:

9 "**SECTION 8.5.** G.S. 115C-238.29F(e) reads as rewritten:

10 "(e) ~~Employees.~~ Employees and Contracted Services. –

11 (1) An employee of a charter school is not an employee of the local school
12 administrative unit in which the charter school is located. The board of
13 directors of a charter school may discharge teachers and nonlicensed
14 employees.

15 a. Teachers. – The charter school's board of directors shall employ and
16 contract with necessary teachers to perform the particular service for
17 which they are employed in the school; at least fifty percent (50%) of
18 these teachers shall hold teacher licenses. All teachers who are
19 teaching in the core subject areas of mathematics, science, social
20 studies, and language arts shall be college graduates.

21 b. Non-licensed Employees. – The board also may employ necessary
22 employees who are not required to hold teacher licenses to perform
23 duties other than teaching and may contract for other services. ~~The~~
24 ~~board may discharge teachers and nonlicensed employees.~~

25 c. Contracted Services. – Any contract for personnel services entered
26 into by a board of directors of a charter school shall require as a term
27 of the contract the disclosure of personnel records of individuals
28 hired pursuant to the contract. The disclosure of these personnel
29 records shall be consistent with the disclosure requirements of
30 Article 21A of this Chapter.
