1 A JOINT RESOLUTION PROVIDING FOR ADJOURNING THE 2013 REGULAR
2 SESSION OF THE GENERAL ASSEMBLY TO A DATE CERTAIN AND LIMITING
3 THE MATTERS THAT MAY BE CONSIDERED UPON RECONVENING,
4 PROVIDING FOR A SUBSEQUENT ADJOURNMENT TO A DATE CERTAIN AND
5 LIMITING THE MATTERS THAT MAY BE CONSIDERED UPON RECONVENING,
6 AND PROVIDING FOR ADJOURNMENT SINE DIE OF THE 2013 REGULAR
7 SESSION OF THE GENERAL ASSEMBLY.

8 Be it resolved by the Senate, the House of Representatives concurring:

9 **SECTION 1.** When the Senate and the House of Representatives adjourn on
10 Saturday, August 2, 2014, they stand adjourned to reconvene on Thursday, August 14, 2014, at
11 12:00 noon.

12 **SECTION 2.** During the Regular Session that reconvenes on Thursday, August 14,
13 2014, only the following matters may be considered:

- 14 (1) Bills returned by the Governor with his objections under Section 22 of
15 Article II of the Constitution of North Carolina, but solely for the purpose of
16 considering overriding of the veto upon reconsideration of the bill.
- 17 (2) Bills relating to claims or orders in litigation to which the State, its
18 instrumentalities, or its officers are parties.
- 19 (3) Bills in which the General Assembly makes an appointment or appointments
20 to public office and which contain no other matter.
- 21 (4) Bills relating to coal ash management.
- 22 (5) Bills relating to environmental and natural resources laws.
- 23 (6) Bills relating to regulatory and administrative reforms.
- 24 (7) Bills relating to health benefit plan coverage for the screening, diagnosis,
25 and treatment of autism spectrum disorder.
- 26 (8) Bills relating to technical and other changes to revenue laws.
- 27 (9) Bills relating to the confidentiality of unemployment compensation
28 information.

29 **SECTION 3.** When the Senate and the House of Representatives adjourn on
30 Friday, August 15, 2014, they stand adjourned to reconvene on Monday, November 17, 2014,
31 at 6:00 p.m.

32 **SECTION 4.** During the Regular Session that reconvenes on Monday, November
33 17, 2014, only the following matters may be considered:

- 34 (1) Bills related to the structure, operation, and funding of Medicaid.

- 1 (2) Bills relating to claims or orders in litigation to which the State, its
2 instrumentalities, or its officers are parties.
3 (3) Confirmations pursuant to G.S. 7A-45.1(a10) if it becomes law.
4 (4) A joint resolution adjourning the 2013 Regular Session of the General
5 Assembly sine die.
