1 moves to amend the bill on page 1, lines 4-5, by rewriting the lines to read:  
2 "SCHOOL YEAR, TO CLARIFY THE QUARTER-CENT LOCAL OPTION SALES TAX  
3 AUTHORITY FOR PUBLIC EDUCATION, AND TO ENSURE THAT THE BASE  
4 BUDGET INCLUDES ADM ADJUSTMENTS FOR PUBLIC SCHOOLS.";

6 And further moves to amend the bill on page 2, lines 26-27, by deleting the lines and  
7 substituting the following:

8 "SECTION 3. G.S. 143C-1-1(d)(1c), as enacted by Section 6.4(b) of S.L.  
9 2014-100, reads as rewritten:

10 "(1c) Base Budget. – That part of the recommended State budget that provides the  
11 baseline for the next biennium. The base budget for each State agency shall  
12 be the authorized budget for that agency with adjustments only for the  
13 following:

- 14 a. Annualization of programs and positions.
- 15 b. Reductions to adjust for items funded with nonrecurring funds during  
16 the prior fiscal biennium.
- 17 c. Increases to adjust for nonrecurring reductions during the prior fiscal  
18 biennium.
- 19 d. Adjustments for federal payroll tax changes.
- 20 e. Rate increases in accordance with the terms of existing leases of real  
21 property.
- 22 f. Adjustments to receipt projections, made in accordance with  
23 G.S. 143C-3-5(b)(2)c.
- 24 g. Reconciliation of intragovernmental and intergovernmental transfers.
- 25 h. Enrollment adjustments for public schools."

26 **SECTION 4.** Sections 1 and 2 of this act become effective only if House Bill 1224,  
27 2013 Regular Session, becomes law.";


