1 A HOUSE RESOLUTION TO ESTABLISH THE PROCEDURE FOR NOMINATING AND  
2 ELECTING MEMBERS OF THE BOARD OF GOVERNORS OF THE UNIVERSITY OF  
3 NORTH CAROLINA.

4 Be it resolved by the House of Representatives:

5 **SECTION 1.** The following procedures for nominating and electing members of  
6 the Board of Governors of The University of North Carolina (hereinafter the "Board of  
7 Governors") are adopted:

8 **I. COMMITTEE RESPONSIBILITIES.**

9 1. It is the duty of the University Board of Governors Nominating Committee  
10 (hereinafter the "Committee") to conduct a process for nominating and electing persons for  
11 each opening on the Board of Governors to which the House of Representatives is to elect  
12 members.

13 2. The Committee shall receive nominations for election to the Board of Governors  
14 from Monday, February 16, 2015, through Friday, February 20, 2015. In 2015, the total number  
15 of open positions is eight. Each Representative may nominate up to two persons. In order for a  
16 person to have standing as a nominee, that person must be formally nominated by a member of  
17 the House of Representatives. Only a written nomination that includes all the requested  
18 information, which is submitted on a form provided by the Chair of the Committee for that  
19 purpose, and that is received in the Office of the House Principal Clerk on or after Monday,  
20 February 16, 2015, and no later than 5:00 P.M. on Friday, February 20, 2015, shall constitute a  
21 formal nomination. Delivery to the Office of the House Principal Clerk by facsimile  
22 transmission or e-mail transmission shall not constitute a formal nomination of a candidate. An  
23 individual is not eligible for nomination by a member of the House of Representatives if he or  
24 she was nominated for election to the Board of Governors by a member of the Senate during  
25 the 2015 Session.

26 3. Notwithstanding G.S. 138A-22, every person who has been formally nominated  
27 shall file a completed North Carolina State Ethics Commission Statement of Economic Interest  
28 with the North Carolina State Ethics Commission. In order for a nomination to be complete and  
29 eligible for consideration, the Statement of Economic Interest must be received by the North  
30 Carolina State Ethics Commission no later than 5:00 P.M. on Friday, February 20, 2015.

31 4. On or after February 20, 2015, the Committee shall list all proposed nominees.  
32 The Committee shall screen the nominees as to their qualifications, experience, and statutory  
33 suitability. The Committee may screen nominees by interviewing or by soliciting written  
34 information or by both means. On completion of the screening process, the Committee shall  
35 conduct a vote to ensure that the slate of legally qualified candidates lists 16 candidates if 16 or  
36 more have been nominated.

1           5. Each nominee shall confirm his or her willingness to serve if elected. Any  
2 nominee may withdraw without the approval of the sponsor.

3           6. The Committee's nominees shall be placed before and recommended to the House  
4 of Representatives for election.

## 5           **II. ELECTIONS IN THE HOUSE OF REPRESENTATIVES.**

6           1. A ballot shall be prepared under the supervision of the Chair of the Committee for  
7 the use of the House of Representatives. The ballot shall include 16 legally qualified candidates  
8 if 16 or more have been nominated.

9           2. The names of the nominees shall be arranged on the ballot by alphabetical order  
10 and shall list only the names of those nominees recommended by the Committee.

11           3. The House of Representatives shall hold its election no later than the beginning of  
12 the daily session on Thursday, March 19, 2015. Before the voting begins, the Speaker of the  
13 House shall explain the voting rules, which are:

14           (a) No nomination shall be received from the floor.

15           (b) In order to be elected, a nominee must receive the votes of a majority of all  
16 members present and voting.

17           (c) Each member present and voting shall vote for as many nominees as there  
18 are positions to be filled and any ballot not so marked shall be deemed void.

19           (d) If fewer than eight nominees receive the votes of a majority of all members  
20 present and voting, a runoff to fill the open position or positions shall be  
21 conducted among the nominees who were not elected but who received the  
22 highest numbers of votes cast, and the number of nominees eligible to be  
23 voted on in the runoff shall be twice the number of positions to be filled.

24           (e) If there is a tie for the last position between two nominees who are eligible  
25 for the next runoff, both nominees shall be included in the next runoff  
26 balloting, even though there would be more than two nominees per available  
27 position.

28           (f) If more than eight nominees receive the votes of a majority of all members  
29 present and voting, then the eight nominees receiving the highest numbers of  
30 votes shall be deemed to have been chosen.

31           4. The members of the House of Representatives shall proceed to mark their ballots  
32 for eight persons for four-year terms. Every ballot shall be signed by the member of the House  
33 of Representatives casting it, and no unsigned ballots shall be counted.

34           5. The Chair of the Committee is responsible for canvassing the vote and declaring  
35 the results and may designate members of the Committee to assist. All ballots shall be retained  
36 by the House Principal Clerk as part of the permanent records of the House of Representatives  
37 and shall be open for immediate public inspection upon adjournment of that day's session.

38           6. When the Chair of the Committee has determined that the House of  
39 Representatives has chosen eight persons to serve as members of the Board of Governors for  
40 terms of four years, the Speaker of the House of Representatives shall entertain a motion for the  
41 simultaneous election of those persons by the House of Representatives to the indicated  
42 positions and for the indicated terms. The vote shall then be called electronically. If a majority  
43 of those voting shall vote "aye" and it is orally confirmed, those eight persons named in the  
44 motion shall be declared to have been elected to the Board of Governors by the House of  
45 Representatives.

46           7. The results of the election in the House of Representatives shall then be sent by  
47 Special Messenger to the Senate.

## 48           **III. NOTIFICATION OF ELECTION RESULTS.**

49           When the election process is complete, the Chair of the Committee shall notify the  
50 Secretary of the Board of Governors of The University of North Carolina of the names of the

1 persons elected by the House of Representatives and the term for which each person was  
2 elected.

3           **SECTION 2.** As used in this resolution, the term "Chair" means the Chair of the  
4 University Board of Governors Nominating Committee.

5           **SECTION 3.** This resolution is effective upon adoption.
