representatives and persons inspecting the files forms shall maintain the confidentiality of the
files. forms. Upon transfer of a";

and on page 2, lines 47-48, by adding between the lines a new section to read:
"**SECTION 4.5.** G.S. 115C-390.2 is amended by adding a new subsection to read:
"(1) Board policies shall state that absences under G.S. 130A-440 shall not be suspensions.
A student subject to an absence under G.S. 130A-440 shall be provided the following:
(1) The opportunity to take textbooks home for the duration of the absence.
(2) Upon request, the right to receive all missed assignments and, to the extent
practicable, the materials distributed to students in connection with the
assignment.
