The General Assembly of North Carolina enacts:			
SECTION 1. Article 3 of Chapter 143 of the General Statutes is amended by			
adding a new section to read:			
"§ 143-59.5. Contracts with vendors that hire former State employees.			
(a) Ineligible Vendors. – The Secretary of Administration and other entities to which			
this Article applies shall not contract for goods or services with a vendor that employs or			
contracts with a person who is a former State employee and uses that person in the			
administration of a contract with the State.			
(b) Vendor Certification. – The Secretary of Administration shall require each vendor			
submitting a bid or contract to certify that the vendor will not use a former State employee in			
the administration of a contract with the State in violation of the provisions of subsection (a) of			
this section.			
(c) Mutual Waiver. – Subsection (a) of this section shall not apply if the Secretary of			
Administration or the contracting entity to which this Article applies and the vendor agree in			
writing.
