Short Title: State and Local Gov. Transparency Act. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT TO MAKE STATE AND LOCAL GOVERNMENTS MORE TRANSPARENT.
3 The General Assembly of North Carolina enacts:

4 SECTION 1. Chapter 132 of the General Statutes is amended by adding a new
5 section to read:

6 "**§ 132-11. State and local government transparency.**

7 (a) Every agency of North Carolina government and its subdivisions that have an
8 Internet Web site must post on its Web site for the current calendar or fiscal year all of the
9 following information:

- 10 (1) The contact information, including the phone number and e-mail address, for
11 all elected and appointed officials, the chief administrator, the head
12 administrator for each department, the person charged with receiving
13 requests for public records under this Chapter, and the legislative liaison, if
14 any.
- 15 (2) Pursuant to Article 33C of Chapter 143 of the General Statutes, notice of any
16 regular or special meeting, the agenda of any regular or special meeting, and
17 the minutes from any regular or special meeting.
- 18 (3) The procedure for requesting public records.
- 19 (4) The annual budget.
- 20 (5) The procedures required to apply for any permits, licenses, or public
21 benefits.
- 22 (6) Any financial audit, audit schedule, or special project report, including
23 without limitation the comprehensive annual financial report, performance
24 audits.
- 25 (7) The current salary, as defined in G.S. 126-23(b) of all employees.
- 26 (8) All contracts with registered lobbyists and the amount paid to each lobbyist.
- 27 (9) A detailed list of all taxes and fees imposed by the agency of North Carolina
28 government or the political subdivision.
- 29 (10) A detailed list of all expenditures made by the agency of North Carolina
30 government or the political subdivision.
- 31 (11) All statutes and rules governing the award of contracts.
- 32 (12) All bids and contracts for purchase in the amount of twenty-five thousand
33 dollars (\$25,000) or more.
- 34 (13) A report on all incentives, whether in the form of cash, tax credits,
35 infrastructure, or other things of value, actually given or distributed during
36 the calendar year. The report shall be updated no later than March 1 of each

1 year for the preceding calendar year and shall be submitted to the Local
2 Government Commission.

3 (b) The information required to be posted under subsection (a) must be easily accessible
4 and searchable.

5 (c) The postings required by this section are in addition to any other posting
6 requirements required by law or ordinance.

7 (d) If an agency of North Carolina government or the political subdivision fails to
8 comply with this section, the failure shall be considered a denial of access to public records and
9 the procedures and remedies provided for in G.S. 132-9 shall apply."

10 **SECTION 2.** G.S. 132-11(a), as enacted in Section 1 of this act, is rewritten to
11 read:

12 "**§ 132-11. State and local government transparency.**

13 (a) Every agency of North Carolina government and its subdivisions that have an
14 Internet website must post on its website for the current calendar or fiscal year-year, and the
15 four years immediately before that calendar or fiscal year, all of the following information:

17 **SECTION 3.** Section 1 of this act becomes effective December 1, 2015. Section 2
18 of this act becomes effective December 1, 2016. The remainder of this act is effective when it
19 becomes law.
