Short Title: General Assembly/L.A. Pay. (Public) Representative Baskerville. Sponsors: Referred to: A BILL TO BE ENTITLED AN ACT PROVIDING THAT EACH GENERAL ASSEMBLY MEMBER IS ENTITLED TO A FULL-TIME LEGISLATIVE ASSISTANT OR CLERK WHO IS A PERMANENT DIRECTING LEGISLATIVE EMPLOYEE. THE LEGISLATIVE **SERVICES** COMMISSION TO GRANT TO THOSE EMPLOYEES THE SAME BENEFITS AND PRIVILEGES AS OTHER PERMANENT LEGISLATIVE EMPLOYEES. AND APPROPRIATING FUNDS FOR THAT PURPOSE. The General Assembly of North Carolina enacts: **SECTION 1.(a)** G.S. 120-32(1) reads as rewritten: Determine the number, titles, classification, functions, compensation, and "(1)other conditions of employment of the joint legislative service employees of the General Assembly, including but not limited to the following departments: Legislative Services Officer and personnel. a. Electronic document writing system. b. Proofreaders. c. d. Legislative printing. Enrolling clerk and personnel. e. f. Library. Research and bill drafting. g. Printed bills. h. i. Disbursing and supply. Program evaluation. j. Full-time legislative assistants and clerks assigned to members of the k. General Assembly for the entire term of office. Temporary employees of the General Assembly are exempt from the provisions of G.S. 135-3(8)c., as to compensation earned in that status." **SECTION 1.(b)** Article 7 of Chapter 120 of the General Statutes is amended by adding a new section to read: "§ 120-32.7. Members entitled to full-time legislative support staff assistance.

Each member of the General Assembly is entitled to have during the entire term of the member's office one legislative assistant or clerk who is a permanent full-time legislative employee."

**SECTION 2.** The Legislative Services Commission shall do all of the following in implementing the provisions of this act:



**SECTION 3.** There is appropriated from the General Fund to the General Assembly the sum of one million four hundred thousand dollars (\$1,400,000) for the 2015-2016 fiscal year and the sum one million four hundred thousand dollars (\$1,400,000) for the 2016-2017 fiscal year to carry out the purposes of this act.

**SECTION 4.** This act becomes effective July 1, 2015.
