1 A BILL TO BE ENTITLED  
2 AN ACT TO REORGANIZE, CLARIFY, AND MODERNIZE STATUTES REGARDING  
3 LOCAL PLANNING AND DEVELOPMENT REGULATION.

4 Whereas, the statutes authorizing planning and development regulation by North  
5 Carolina local governments were initially enacted in the early 20th century to address needs  
6 that have evolved significantly since that time; and

7 Whereas, numerous statutes have been added and changes have been made to  
8 original statutes using the original structure that is no longer appropriate for the range of  
9 statutes now authorized; and

10 Whereas, antiquated and confusing language continued in many of the planning and  
11 development regulation statutes and they lack the clarity needed in the 21st century; and

12 Whereas, other than collecting these statutes into Article 19 of Chapter 160A of the  
13 General Statutes in 1971 and Article 18 of Chapter 153A of the General Statutes in 1973, no  
14 comprehensive reorganization and recodification of North Carolina's planning and development  
15 regulation statutes has been undertaken; and

16 Whereas, the parallel system of city and county authority has led to inadvertent and  
17 unintended differences in the wording of the planning and development regulation statutes over  
18 time; and

19 Whereas, coherent organization, clarification, modernization, and incorporation of  
20 key common law principles into the planning and development regulation statutes provides  
21 clarity and uniformity for all who use and are affected by local planning and development  
22 regulations and will make the statutes and local regulations easier to follow, simpler to find,  
23 and consistent with 21st century business and government needs; and

24 Whereas, there is a need for policy neutral or consensus amendments that modernize  
25 the planning and development regulation statutes in a manner that does not eliminate, diminish,  
26 enlarge, or expand the powers currently exercised by cities and counties.

27 The General Assembly of North Carolina enacts:

28 **SECTION 1.** Article 18 of Chapter 153A of the General Statutes is repealed.

29 **SECTION 2.** Article 19 of Chapter 160A of the General Statutes is repealed.

30 **SECTION 3.** The General Statutes are amended by adding a new Chapter to read:

31 **"Chapter 160D.**

32 **"Local Planning and Development Regulation.**

33 **"Article 1.**

34 **"General Provisions.**

35 **"§ 160D-1-1. Application.**



1       (a) The provisions of this Article shall apply to all ordinances and programs adopted  
2 pursuant to this Chapter or applicable local acts. To the extent there are contrary provisions in  
3 local charters or acts, G.S. 160D-1-12 is applicable unless this Chapter expressly provides  
4 otherwise. The definitions and procedures of this Article also apply to any other local ordinance  
5 that substantially affects land use and development.

6       (b) The provisions of this Article are supplemental to specific provisions included in  
7 other Articles of this Chapter. To the extent there are conflicts between the provisions of this  
8 Article and the provisions of other Articles of this Chapter, the more specific provisions shall  
9 control.

10       (c) Local governments may apply any of the definitions and procedures authorized by  
11 this Chapter to any ordinance adopted under the general police power of cities and counties,  
12 Article 8 of Chapter 160A of the General Statutes and Article 6 of Chapter 153A of the General  
13 Statutes respectively, and may employ any organizational structure, board, commission, or  
14 staffing arrangement authorized by this Chapter to any or all aspects of those ordinances.

15 **"§ 160-1-2. Definitions.**

16       Unless otherwise specifically provided, or unless otherwise clearly required by the context,  
17 the words and phrases defined in this section shall have the meaning indicated when used in  
18 this Chapter.

- 19       (1) "Administrative decision" means decisions made in the implementation,  
20 administration, or enforcement of development regulations that involve the  
21 determination of facts and application of objective standards set forth in this  
22 Chapter or local government ordinances. These are sometimes referred to as  
23 "ministerial" decisions or "administrative determinations."  
24       (2) "Administrative hearing" means a proceeding for the purpose of gathering  
25 facts needed to make an administrative decision.  
26       (3) "Bona fide farm purposes" means those agricultural activities set forth in  
27 G.S. 160D-9-3.  
28       (4) "Charter" shall have the same meaning as set forth in G.S. 160A-1(2).  
29       (5) "City" shall have the same meaning as set forth in G.S. 160A-1(2).  
30       (6) "Comprehensive plan" means those plans that have been officially adopted  
31 by the governing board pursuant to G.S. 160D-5-1.  
32       (7) "Conditional zoning" means a zoning map amendment with site specific  
33 conditions incorporated into the zoning map amendment.  
34       (8) "County" means any one of the counties listed in G.S. 153A-10.  
35       (9) "Decision-making board" means a governing board, planning board, board  
36 of adjustment, historic district board, or other board assigned to make  
37 quasi-judicial decisions under this Chapter.  
38       (10) "Determination" means a written, final and binding order, requirement, or  
39 determination regarding an administrative decision.  
40       (11) "Developer" means a person, including a governmental agency or  
41 redevelopment authority, who undertakes any development and who is the  
42 landowner of the property to be developed or who has been authorized by  
43 the landowner to undertake development on that property.  
44       (12) "Development approval" means a permit or other administrative or  
45 quasi-judicial written approval pursuant to an ordinance adopted under this  
46 Chapter that is required prior to commencing development or undertaking a  
47 specific project or development proposal. Development approvals include  
48 plat approvals issued pursuant to Article 8 of this Chapter and development  
49 agreements entered into pursuant to Article 10 of this Chapter. It also  
50 includes building permits issued pursuant to Article 11 of this Chapter.

- 1           (13) "Development regulation" means a unified development ordinance, zoning  
2 ordinance, subdivision ordinance, erosion and sedimentation control  
3 ordinance, floodplain or flood damage prevention ordinance, mountain ridge  
4 protection ordinance, stormwater control ordinance, wireless  
5 telecommunication facility ordinance, historic preservation or landmark  
6 ordinance, State Building Code, housing code, or any other ordinance  
7 adopted pursuant to this Chapter or a local act or charter that regulates land  
8 use or development.
- 9           (14) "Dwelling" means any building, structure, manufactured home or mobile  
10 home, or part thereof, used and occupied for human habitation or intended to  
11 be so used, and includes any outhouses and appurtenances belonging thereto  
12 or usually enjoyed therewith, except that for the purposes of Article 12 of  
13 this Chapter, it does not include any manufactured home, mobile home, or  
14 recreational vehicle, if used solely for a seasonal vacation purpose.
- 15           (15) "Evidentiary hearing" means a hearing to gather competent, material, and  
16 substantial evidence in order to make findings for a quasi-judicial decision  
17 required by an ordinance adopted under this Chapter.
- 18           (16) "Governing board" means the city council or board of county  
19 commissioners. The term is interchangeable with the terms "board of  
20 aldermen" and "boards of commissioners" and shall mean any governing  
21 board without regard to the terminology employed in charters, local acts,  
22 other portions of the General Statutes, or local customary usage.
- 23           (17) "Impact mitigation" means the dedication or provision of land, interests in  
24 land, construction of physical improvements and facilities, or payment for  
25 the cost of providing land, improvements, or facilities to address the impacts  
26 of proposed development, as expressly authorized by this Chapter.
- 27           (18) "Landowner" or "owner" means the holder of the title in fee simple interest  
28 as shown in the county tax records unless the context expressly provides  
29 otherwise. The landowner may authorize a person holding a valid option,  
30 lease, or contract to purchase to act as his or her agent or representative.
- 31           (19) "Legislative decision" means the adoption, amendment, or repeal of an  
32 ordinance under this Chapter or an applicable local act. It also includes the  
33 decision to approve, amend, or rescind a development agreement under  
34 Article 10 of this Chapter.
- 35           (20) "Legislative hearing" means a hearing to solicit public comment on a  
36 proposed legislative decision.
- 37           (21) "Local act" shall have the same meaning as set forth in G.S. 160A-1(2).
- 38           (22) "Local government" means a city or county.
- 39           (23) "Manufactured home" or "mobile home" means a structure as defined in  
40 G.S. 143-145(7).
- 41           (24) "Permit" means an administrative or quasi-judicial written approval required  
42 prior to commencing development or undertaking a specific activity, project  
43 or development proposal. A permit includes, but is not limited to, a building  
44 permit, zoning permit, site plan approval, subdivision approval, special use  
45 permit, certificate of appropriateness, or variance.
- 46           (25) "Person" means an individual, partnership, firm, association, joint venture,  
47 public or private corporation, trust, estate, commission, board, public or  
48 private institution, utility, cooperative, interstate body, the State of North  
49 Carolina and its agencies and political subdivisions, or other legal entity.
- 50           (26) "Planning board" means any board established pursuant to G.S. 160D-3-1.

- 1           (27) "Property" means all real property subject to land-use regulation by a local  
2 government and includes any improvements or structures customarily  
3 regarded as a part of real property.
- 4           (28) "Quasi-judicial decision" means a decision involving the finding of facts  
5 regarding a specific application of an ordinance and that requires the  
6 exercise of discretion when applying the standards of the ordinance.  
7 Quasi-judicial decisions include, but are not limited to, decisions involving  
8 variances, special use permits, certificates of appropriateness, and appeals of  
9 administrative determinations. Decisions on the approval of subdivision  
10 plats and site plans are quasi-judicial in nature if the ordinance authorizes a  
11 decision-making board to approve or deny the application based not only  
12 upon whether the application complies with the specific requirements set  
13 forth in the ordinance, but also on whether the application complies with one  
14 or more generally stated standards requiring a discretionary decision on the  
15 findings to be made by the decision-making board.
- 16           (29) "Site plan" means a scaled drawing showing the relationship between lot  
17 lines and the existing or proposed uses, buildings, or structures on the lot,  
18 including, but not limited to, site-specific details such as building areas,  
19 building height and floor area, setbacks from lot lines and street rights-  
20 of-way, intensities, densities, utility lines and locations, parking areas, access  
21 points, roads, and stormwater control facilities required to show compliance  
22 with all legally required development regulations that are applicable to a  
23 project and the site plan review. A local development regulation may require  
24 a site plan to include other supporting materials and text regarding proposed  
25 development of the site. A site plan approval based solely upon application  
26 of objective standards is an administrative decision and a site plan approval  
27 based in whole or in part upon the application of standards involving  
28 judgment and discretion is a quasi-judicial decision.
- 29           (30) "Special use permit" means a permit issued to authorize development or land  
30 uses in a particular zoning district upon presentation of competent, material,  
31 and substantial evidence establishing compliance with one or more general  
32 standards requiring that judgment and appropriate discretion be exercised as  
33 well as compliance with specific ordinance standards. This definition  
34 includes permits previously referred to as "conditional use permits" or  
35 "special exceptions."
- 36           (31) "Subdivision" means the division of land for the purpose of sale or  
37 development as specified in G.S. 160D-8-2.
- 38           (32) "Subdivision regulation" means a subdivision ordinance authorized by  
39 Article 8 of this Chapter or the subdivision portion of a unified development  
40 ordinance.
- 41           (33) "Vested right" means the right to undertake and complete the development  
42 and use of property under the terms and conditions of an approval secured as  
43 specified in G.S. 160D-1-8 or under common law.
- 44           (34) "Zoning map amendment" or "rezoning" means an amendment to a zoning  
45 ordinance to change the zoning district that is applied to a specified property  
46 or properties. It does not include the initial adoption of a zoning map by a  
47 local government, but it does include the initial application of zoning when  
48 land is added to the territorial jurisdiction of a local government that has  
49 previously adopted zoning regulations. It includes the application of an  
50 overlay zoning district or a conditional zoning district.

1           (35) "Zoning regulation" means a zoning ordinance authorized by Article 7 of  
2           this Chapter or the zoning portion of a unified development ordinance.

3 **"§ 160D-1-3. Unified development ordinance.**

4           A local government may elect to combine any of the ordinances authorized by this Chapter  
5 into a unified ordinance. Unless expressly provided otherwise, a local government may apply  
6 any of the definitions and procedures authorized by law to any or all aspects of the unified  
7 ordinance and may employ any organizational structure, board, commission, or staffing  
8 arrangement authorized by law to any or all aspects of the ordinance. Inclusion of an ordinance  
9 authorized by this Chapter or local act in a unified development ordinance does not expand,  
10 diminish, or alter the scope of authority for those ordinance provisions.

11 **"§ 160D-1-4. Development approvals run with the land.**

12           Unless provided otherwise by law, all rights, privileges, benefits, burdens, and obligations  
13 created by development approvals made pursuant to this Chapter attach to and run with the  
14 land.

15 **"§ 160D-1-5. Maps.**

16           (a) Zoning Map. Zoning district boundaries and any other boundaries included within a  
17 map that is part of a development regulation adopted pursuant to this Chapter shall be drawn on  
18 a map that is adopted or incorporated within a duly adopted development regulation. Zoning  
19 district maps that are so adopted shall be maintained in the office of the local government clerk  
20 or such other office as specified in the development ordinance. The maps may be in paper or a  
21 digital format approved by the local government.

22           (b) Incorporation by Reference. Ordinances adopted pursuant to this Chapter may  
23 reference or incorporate by reference maps, flood insurance rate maps, and watershed boundary  
24 maps officially adopted or promulgated by state and federal agencies. An ordinance text or  
25 zoning map may reference a specific officially adopted map or may incorporate by reference  
26 the most recent officially adopted version of such maps. When zoning district boundaries are  
27 based on these maps, the ordinance may provide that the zoning district boundaries are  
28 automatically amended to remain consistent with changes in the promulgated state or federal  
29 maps, provided a copy of the currently effective version of any incorporated map shall be  
30 maintained for public inspection in the office of the local government clerk.

31           (c) Copies. Copies of the zoning district map reproduced by any method of  
32 reproduction that gives legible and permanent copies, when certified by the local government  
33 clerk in accordance with G.S. 160A-79 or G.S. 153A-50, shall be admissible in evidence in all  
34 courts and shall have the same force and effect as would the original map.

35 **"§ 160D-1-6. Refund of illegal fees.**

36           If a local government is found to have illegally imposed a tax, fee, or monetary contribution  
37 for development or a development permit not specifically authorized by law, the local  
38 government shall return the tax, fee, or monetary contribution plus interest of six percent (6%)  
39 per annum to the person who made the payment or as directed by a court if the person making  
40 the payment is no longer in existence.

41 **"§ 160D-1-7. Moratoria.**

42           (a) Authority. As provided in this section, local governments may adopt temporary  
43 moratoria on any development approval required by law, except for the purpose of developing  
44 and adopting new or amended plans or ordinances governing residential uses. The duration of  
45 any moratorium shall be reasonable in light of the specific conditions that warrant imposition of  
46 the moratorium and may not exceed the period of time necessary to correct, modify, or resolve  
47 such conditions.

48           (b) Hearing Required. Except in cases of imminent and substantial threat to public  
49 health or safety, before adopting an ordinance imposing a development moratorium with a  
50 duration of 60 days or any shorter period, the governing board shall hold a legislative hearing  
51 and shall publish a notice of the hearing in a newspaper having general circulation in the area

1 not less than seven days before the date set for the hearing. A development moratorium with a  
2 duration of 61 days or longer, and any extension of a moratorium so that the total duration is 61  
3 days or longer, is subject to the notice and hearing requirements of G.S. 160D-6-1.

4 (c) Exempt Projects. Absent an imminent threat to public health or safety, a  
5 development moratorium adopted pursuant to this section shall not apply to any project for  
6 which a valid building permit issued pursuant to G.S. 160D-11-8 is outstanding, to any project  
7 for which a special use permit application has been accepted as complete, to development set  
8 forth in a site-specific or phased vesting plan approved pursuant to G.S. 160D-1-8, to  
9 development for which substantial expenditures have already been made in good faith reliance  
10 on a prior valid development approval, or to preliminary or final subdivision plats that have  
11 been accepted for review by the local government prior to the call for a hearing to adopt the  
12 moratorium. Any preliminary subdivision plat accepted for review by the local government  
13 prior to the call for a legislative hearing, if subsequently approved, shall be allowed to proceed  
14 to final plat approval without being subject to the moratorium.

15 (d) Required Statements. Any ordinance establishing a development moratorium must  
16 include at the time of adoption each of the following:

17 (1) A clear statement of the problems or conditions necessitating the moratorium  
18 and what courses of action, alternative to a moratorium, were considered by  
19 the local government and why those alternative courses of action were not  
20 deemed adequate.

21 (2) A clear statement of the development approvals subject to the moratorium  
22 and how a moratorium on those approvals will address the problems or  
23 conditions leading to imposition of the moratorium.

24 (3) A date for termination of the moratorium and a statement setting forth why  
25 that duration is reasonably necessary to address the problems or conditions  
26 leading to imposition of the moratorium.

27 (4) A clear statement of the actions, and the schedule for those actions, proposed  
28 to be taken by the local government during the duration of the moratorium to  
29 address the problems or conditions leading to imposition of the moratorium.

30 (e) Limit on Renewal or Extension. No moratorium may be subsequently renewed or  
31 extended for any additional period unless the local government shall have taken all reasonable  
32 and feasible steps proposed to be taken in its ordinance establishing the moratorium to address  
33 the problems or conditions leading to imposition of the moratorium and unless new facts and  
34 conditions warrant an extension. Any ordinance renewing or extending a development  
35 moratorium must include, at the time of adoption, the findings set forth in subdivisions (1)  
36 through (4) of this subsection, including what new facts or conditions warrant the extension.

37 (f) Expedited Judicial Review. Any person aggrieved by the imposition of a  
38 moratorium on development approvals required by law may apply to the General Court of  
39 Justice for an order enjoining the enforcement of the moratorium. Actions brought pursuant to  
40 this section shall be scheduled for immediate hearing, and subsequent proceedings in those  
41 actions shall be accorded priority by the trial and appellate courts. In such actions, the local  
42 government shall have the burden of showing compliance with the procedural requirements of  
43 this subsection.

44 **"§ 160D-1-8. Vested rights.**

45 (a) Findings. The General Assembly recognizes that local government approval of  
46 land-use development typically follows significant landowner investment in site evaluation,  
47 planning, development costs, consultant fees, and related expenses. The General Assembly  
48 finds that it is necessary and desirable to provide for the establishment of certain vested rights  
49 in order to ensure reasonable certainty, stability, and fairness in the land-use planning process,  
50 secure the reasonable expectations of landowners, and foster cooperation between the public  
51 and private sectors in the area of land-use planning.

1        The ability of a landowner to obtain a vested right after local government approval of a site  
2 specific vesting plan or a phased vesting plan will preserve the prerogatives and authority of  
3 local elected officials with respect to land-use matters. There will be ample opportunities for  
4 public participation, and the public interest will be served. These provisions will strike an  
5 appropriate balance between private expectations and the public interest, while protecting the  
6 public health, safety, and welfare.

7        (b) Permit Choice.

8            (1) If an application is submitted for a development approval required pursuant  
9 to this Chapter and a rule or ordinance changes between the time the  
10 application was submitted and a decision is made, the applicant may choose  
11 which version of the rule or ordinance will apply to the application.

12            (2) This section applies to all development approvals issued by the State and by  
13 local governments, except this section shall not apply to any development  
14 approval issued pursuant to a zoning regulation authorized by Article 7 of  
15 this Chapter.

16        (c) Vested Right.

17            (1) Process when common law vested right is claimed. A person claiming a  
18 common law vested right may submit information to substantiate that claim  
19 to the zoning administrator or other officer designated by a development  
20 regulation, who shall make an initial determination as to the existence of the  
21 vested right. The zoning administrator's or officer's determination may be  
22 appealed under G.S. 160D-4-5. On appeal the determination shall be  
23 considered a question of law subject to de novo review.

24            (2) Local development permits. Amendments in local development regulations  
25 shall not be applicable or enforceable without consent of the owner with  
26 regard to development that has been authorized by local development  
27 approvals issued pursuant to this Chapter prior to the enactment of the  
28 ordinance making the change or changes so long as the approvals remain  
29 valid and unexpired pursuant to G.S. 160D-4-3. The scope of development  
30 vested by this subsection is limited to the development specifically  
31 authorized by a valid local development approval. If multiple development  
32 approvals are required for proposed development, the vesting pursuant to  
33 this subsection only affects amendments to ordinances under which final  
34 approval has been secured and does not affect amendments to ordinances  
35 under which approval is required but not yet secured at the time of ordinance  
36 amendment.

37            (3) Site-specific and phased vesting plans. A vested right shall be deemed  
38 established with respect to any property upon the valid approval of a  
39 site-specific or a phased vesting plan. Notice and hearing is required for  
40 approval of a vesting plan. If the vesting plan is based on an approval that is  
41 quasi-judicial, an evidentiary hearing shall be held; otherwise, a legislative  
42 hearing shall be held. Such vested right shall confer upon the landowner the  
43 right to undertake and complete the development and use of the property  
44 under the terms and conditions of the site-specific or the phased vesting plan  
45 including any applicable amendments. A local government may approve a  
46 site-specific or a phased vesting plan upon such terms and conditions as may  
47 reasonably be necessary to protect the public health, safety, and welfare.  
48 Such conditional approval shall result in a vested right, although failure to  
49 abide by such terms and conditions will result in a forfeiture of vested rights.  
50 A local government shall not require a landowner to waive his vested rights  
51 as a condition of developmental approval. A site-specific vesting plan or a

1 phased vesting plan shall be deemed approved upon the effective date of the  
2 local government's decision approving the plan or such other date as  
3 determined by the governing board upon approval. An approved site-specific  
4 or phased vesting plan and its conditions may be amended with the approval  
5 of the owner and the local government. Any substantial modification must  
6 be reviewed and approved in the same manner as the original approval.  
7 Minor modifications may be approved by staff, if such are defined and  
8 authorized by local ordinance.

9 (4) Development agreements. A vested right is established under a development  
10 agreement approved under Article 10 of this Chapter.

11 (5) Interrelated nature of vested rights. Vested rights established under these  
12 subsections are not mutually exclusive. The establishment of a vested right  
13 under one subsection does not preclude vesting under one or more other  
14 subsections.

15 (d) Duration and Termination of Site-Specific and Phased Vesting Plans.

16 (1) A right which has been vested for a site-specific vesting plan as provided for  
17 in this section shall remain vested for a period of two years. This vesting  
18 shall not be extended by any amendments or modifications to a site-specific  
19 vesting plan unless expressly provided by the local government.

20 (2) Notwithstanding the provisions of subdivision (1) of this subsection, a local  
21 government may provide that rights regarding a site-specific vesting plan  
22 shall be vested for a period exceeding two years but not exceeding five  
23 years, where if warranted by the size and phasing of development, the level  
24 of investment, the need for the development, economic cycles, and market  
25 conditions or other considerations. This determination shall be in the  
26 discretion of the local government.

27 (3) Notwithstanding the provisions of subdivision (1) and subdivision (2) of this  
28 subsection, the local government may provide by ordinance that approval by  
29 a local government of a phased vesting plan shall vest the zoning  
30 classification or classifications so approved for a period not to exceed five  
31 years. The document that triggers such vesting shall be so identified at the  
32 time of its approval. The local government still may require the landowner to  
33 submit a site-specific vesting plan for approval by the local government with  
34 respect to each phase or phases in order to obtain final approval to develop  
35 within the restrictions of the vested zoning classification or classifications.  
36 Nothing in this section shall be construed to require a local government to  
37 adopt an ordinance providing for vesting of rights upon approval of a phased  
38 vesting plan.

39 (4) Following approval or conditional approval of a site-specific or a phased  
40 vesting plan, nothing in this section shall exempt such a plan from  
41 subsequent reviews and approvals by the local government to ensure  
42 compliance with the terms and conditions of the original approval, provided  
43 that such reviews and approvals are not inconsistent with the original  
44 approval. Nothing in this section shall prohibit the local government from  
45 revoking the original approval for failure to comply with applicable terms  
46 and conditions of the approval or the local development regulations.

47 (5) Upon issuance of a building permit, the provisions of G.S. 160D-11-9 and  
48 G.S. 160D-11-13 shall apply, except that the permit shall not expire or be  
49 revoked because of the running of time while a vested right under this  
50 section is outstanding.



- 1           (6) A right which has been vested as provided in this section shall terminate at  
2           the end of the applicable vesting period with respect to buildings and uses  
3           for which no valid building permit applications have been filed.
- 4           (e) Subsequent Changes in Development Regulation Not Applicable to Site-Specific  
5           and Phased Vesting Plans; Exceptions.
- 6           (1) A vested right, once established as provided for in this section, precludes any  
7           action by a local government which would change, alter, impair, prevent,  
8           diminish, or otherwise delay the development or use of the property as set  
9           forth in an approved site-specific or phased vesting plan, except:
- 10           a. With the written consent of the affected landowner;  
11           b. Upon findings, after notice and an evidentiary hearing, that natural or  
12           man-made hazards on or in the immediate vicinity of the property, if  
13           uncorrected, would pose a serious threat to the public health and  
14           safety if the project were to proceed as contemplated in the  
15           site-specific or the phased vesting plan;  
16           c. To the extent that the affected landowner receives compensation for  
17           all costs, expenses, and other losses incurred by the landowner,  
18           including, but not limited to, all fees paid in consideration of  
19           financing, and all architectural, planning, marketing, legal, and other  
20           consultant's fees incurred after approval by the local government,  
21           together with interest as is provided in G.S. 160D-1-6. Compensation  
22           shall not include any diminution in the value of the property which is  
23           caused by such action;  
24           d. Upon findings, after notice and an evidentiary hearing, that the  
25           landowner or his representative intentionally supplied inaccurate  
26           information or made material misrepresentations which made a  
27           difference in the approval by the local government of the site-specific  
28           or the phased vesting plan; or  
29           e. Upon the enactment or promulgation of a State or federal law or  
30           regulation that precludes development as contemplated in the  
31           site-specific or the phased vesting plan, in which case the local  
32           government may modify the affected provisions, upon a finding that  
33           the change in State or federal law has a fundamental effect on the  
34           plan, after notice and an evidentiary hearing.
- 35           (2) The establishment of a vested right under a site-specific or a phased vesting  
36           plan shall not preclude the application of overlay zoning which imposes  
37           additional requirements but does not affect the allowable type or intensity of  
38           use, or ordinances or regulations which are general in nature and are  
39           applicable to all property subject to land-use regulation by a local  
40           government, including, but not limited to, building, fire, plumbing,  
41           electrical, and mechanical codes. Otherwise applicable new regulations shall  
42           become effective with respect to property which is subject to a site-specific  
43           or a phased vesting plan upon the expiration or termination of the vested  
44           rights period provided for in this section.
- 45           (3) Notwithstanding any provision of this section, the establishment of a vested  
46           right under a site-specific or a phased vesting plan shall not preclude,  
47           change, or impair the authority of a local government to adopt and enforce  
48           ordinance provisions governing nonconforming situations or uses.
- 49           (f) Miscellaneous Provisions.
- 50           (1) A vested right obtained under this section is not a personal right but shall  
51           attach to and run with the applicable property. After approval of a

1 site-specific or a phased vesting plan, all successors to the original  
2 landowner shall be entitled to exercise such rights.

3 (2) Nothing in this section shall preclude judicial determination, based on  
4 common law principles or other statutory provisions, that a vested right  
5 exists in a particular case or that a compensable taking has occurred. Except  
6 as expressly provided in this section, nothing in this section shall be  
7 construed to alter the existing common law.

8 (3) In the event a local government fails to adopt an ordinance setting forth what  
9 constitutes a site-specific vesting plan triggering a vested right, a landowner  
10 may establish a vested right upon the approval of a permit, or otherwise may  
11 seek appropriate relief from the Superior Court Division of the General  
12 Court of Justice.

13 (g) Definitions. For the purposes of this section:

14 (1) "Site-specific vesting plan" means a plan that has been submitted to a local  
15 government by a landowner pursuant to this section describing with  
16 reasonable certainty the type and intensity of use for a specific parcel or  
17 parcels of property. Such plan may be in the form of, but not limited to, any  
18 of the following plans or approvals: A planned unit development plan, a  
19 subdivision plat, a site plan, a preliminary or general development plan, a  
20 special use permit, a conditional zoning, or any other development approval  
21 as may be used by a local government. Unless otherwise expressly provided  
22 by the local government, such a plan shall include the approximate  
23 boundaries of the site; significant topographical and other natural features  
24 affecting development of the site; the approximate location on the site of the  
25 proposed buildings, structures, and other improvements; the approximate  
26 dimensions, including height, of the proposed buildings and other structures;  
27 and the approximate location of all existing and proposed infrastructure on  
28 the site, including water, sewer, roads, and pedestrian walkways. What  
29 constitutes a site-specific vesting plan shall be finally determined by the  
30 local government pursuant to an ordinance, and the document that triggers  
31 vesting shall be so identified at the time of its approval. At a minimum, the  
32 ordinance shall designate a vesting point earlier than the issuance of a  
33 building permit. A variance shall not constitute a "site-specific vesting plan,"  
34 and approval of a site-specific vesting plan with the condition that a variance  
35 be obtained shall not confer a vested right unless and until the necessary  
36 variance is obtained. If a sketch plan or other document fails to describe with  
37 reasonable certainty the type and intensity of use for a specified parcel or  
38 parcels of property, it may not constitute a site-specific vesting plan.

39 (2) "Phased vesting plan" means a plan which has been submitted to a local  
40 government by a landowner or developer for phased development which  
41 shows the type and intensity of use for a specific parcel or parcels with a  
42 lesser degree of certainty than a site-specific vesting plan.

43 **§ 160D-1-9. Conflicts of interest.**

44 (a) Governing Board. A governing board member shall not vote on any legislative  
45 decision regarding an ordinance adopted pursuant to this Chapter where the outcome of the  
46 matter being considered is reasonably likely to have a direct, substantial, and readily  
47 identifiable financial impact on the member. A governing board member shall not vote on a  
48 zoning map amendment if the landowner of the property subject to the petition or the applicant  
49 is a person with whom the member has a close familial, business, or other associational  
50 relationship.

1       **(b) Appointed Boards.** Members of appointed boards providing advice to the governing  
2 board shall not vote on recommendations regarding any legislative decision regarding an  
3 ordinance adopted pursuant to this Chapter where the outcome of the matter being considered is  
4 reasonably likely to have a direct, substantial, and readily identifiable financial impact on the  
5 member. An appointed board member shall not vote on a zoning map amendment if the  
6 landowner of the property subject to the petition or the applicant is a person with whom the  
7 member has a close familial, business, or other associational relationship.

8       **(c) Administrative Staff.** No staff member shall make a final decision on an  
9 administrative decision required by this Chapter if the outcome of that decision would have a  
10 direct, substantial, and readily identifiable financial impact on the staff member or if the  
11 applicant or other person subject to that decision is a person with whom the staff member has a  
12 close familial, business, or other associational relationship. If a staff member has a conflict of  
13 interest under this section, the decision shall be assigned to the supervisor of the staff person or  
14 such other staff person as may be designated by the ordinance.

15       No staff member shall be financially interested or employed by a business that is financially  
16 interested in a development subject to regulation under this Chapter unless the staff member is  
17 the owner of the land or building involved. No staff member or other individual or an employee  
18 of a company contracting with a local government to provide staff support shall engage in any  
19 work that is inconsistent with his or her duties or with the interest of the local government, as  
20 determined by the local government.

21       **(d) Quasi-Judicial Decisions.** A member of any board exercising quasi-judicial  
22 functions pursuant to this Chapter shall not participate in or vote on any quasi-judicial matter in  
23 a manner that would violate affected persons' constitutional rights to an impartial decision  
24 maker. Impermissible violations of due process include, but are not limited to, a member  
25 having a fixed opinion prior to hearing the matter that is not susceptible to change, undisclosed  
26 ex parte communications, a close familial, business, or other associational relationship with an  
27 affected person, or a financial interest in the outcome of the matter. If an objection is raised to a  
28 member's participation and that member does not recuse himself or herself, the remaining  
29 members shall by majority vote rule on the objection.

30 **"§ 160D-1-10. Validation of certain city ordinances.**

31       Any city ordinance regularly adopted prior to January 1, 1972, under authority of general  
32 laws revised and reenacted in this Chapter, Article 19 of Chapter 160A of the General Statutes,  
33 or under authority of any city charter, or local act is validated with respect to its application  
34 within the corporate limits of the city and as to its application within the extraterritorial  
35 jurisdiction of the city. Such an ordinance, and any city ordinance adopted since January 1,  
36 1972, under authority of general laws revised and reenacted in Article 19 of Chapter 160A of  
37 the General Statutes, are hereby validated, notwithstanding the fact that such ordinances were  
38 not recorded pursuant to previously effective G.S. 160A-360(b) or G.S. 160A-364 and  
39 notwithstanding the fact that the adopting city council did not also adopt an ordinance defining  
40 or delineating by specific description the areas within its extraterritorial jurisdiction pursuant to  
41 previously effective G.S. 160A-360; provided that this act shall be deemed to validate  
42 ordinances of cities in Mecklenburg County only with respect to their application within the  
43 corporate limits of such cities.

44 **"§ 160D-1-11. Construction.**

45       G.S. 153A-4 and G.S. 160A-4 are applicable to this Chapter.

46 **"§ 160D-1-12. General laws supplementary.**

47       G.S. 153A-3 and G.S. 160A-3 are applicable to this Chapter. Nothing in this Chapter  
48 repeals or amends a charter or local act in effect as of January 1, 2016, or any portion of such  
49 an act, unless this Chapter or a subsequent enactment of the General Assembly clearly shows a  
50 legislative intent to repeal or supersede that charter or local act.

51 **"§ 160D-1-13. References deemed amended to conform to Chapter.**

1 Whenever a reference is made in another section of the General Statutes or any local act, or  
2 any local government ordinance, resolution, or order, to a portion of Article 19 of Chapter  
3 160A of the General Statutes or Article 18 of Chapter 153A of the General Statutes that is  
4 repealed or superseded by this Chapter, the reference shall be deemed amended to refer to that  
5 portion of this Chapter that most nearly corresponds to the repealed or superseded portion of  
6 Article 19 of Chapter 160A of the General Statutes or Article 18 of Chapter 153A of the  
7 General Statutes.

8 **"§ 160D-1-14. Effect on prior laws.**

9 The enactment of this Chapter shall not require the re adoption of any local government  
10 ordinance enacted pursuant to laws that were in effect before July 1, 2016, and are restated or  
11 revised herein. The provisions of this Chapter shall not affect any act heretofore done, any  
12 liability incurred, any right accrued or vested, or any suit or prosecution begun or cause of  
13 action accrued as of July 1, 2016.

14 "Article 2.

15 "Planning and Development Regulation Jurisdiction.

16 **"§ 160D-2-1. Planning and development regulation jurisdiction.**

17 (a) All of the powers granted by this Chapter may be exercised by any city within its  
18 corporate limits and within any extraterritorial area established pursuant to G.S. 160D-2.

19 (b) All of the powers granted by this Chapter may be exercised throughout the county  
20 except in areas subject to municipal jurisdiction.

21 **"§ 160D-2-2. Municipal extraterritorial jurisdiction.**

22 (a) Geographic Scope. Any city may exercise the powers granted to cities under this  
23 Chapter within a defined area extending not more than one mile beyond its contiguous  
24 corporate limits. In addition and subject to subsection (c) of this section, a city of 10,000 or  
25 more population but less than 25,000 may exercise these powers over an area extending not  
26 more than two miles beyond its limits, and a city of 25,000 or more population may exercise  
27 these powers over an area extending not more than three miles beyond its limits. In determining  
28 the population of a city for the purposes of this Chapter, the city council and the board of  
29 county commissioners may use the most recent annual estimate of population as certified by the  
30 Secretary of the North Carolina Department of Administration. Pursuant to G.S. 160A-58.4,  
31 extraterritorial municipal planning and development regulation may be extended only from the  
32 primary corporate boundary of a city and not from the boundary of satellite areas of the city.

33 (b) City Authority in the Extraterritorial Area. A city may not exercise any power  
34 conferred by this Chapter in its extraterritorial jurisdiction that it is not exercising within its  
35 corporate limits. A city shall exercise in its extraterritorial area all powers conferred by this  
36 Chapter that it is exercising within its corporate limits unless a county by mutual agreement has  
37 agreed to exercise those powers in that extraterritorial area.

38 (c) County Approval of City Jurisdiction. No city may extend its extraterritorial powers  
39 into any area for which the county has adopted and is enforcing county zoning and subdivision  
40 regulations. However, the city may do so where the county is not exercising both of these  
41 powers, or when the city and the county have agreed upon the area within which each will  
42 exercise the powers conferred by this Chapter. No city may extend its extraterritorial powers  
43 beyond one mile from its corporate limits without the approval of the board or boards of county  
44 commissioners with jurisdiction over the area.

45 (d) Notice of Proposed Jurisdiction Change. Any municipality proposing to exercise  
46 extraterritorial jurisdiction under this Chapter shall notify the owners of all parcels of land  
47 proposed for addition to the area of extraterritorial jurisdiction, as shown on the county tax  
48 records. The notice shall be sent by first-class mail to the last addresses listed for affected  
49 property owners in the county tax records. The notice shall inform the landowner of the effect  
50 of the extension of extraterritorial jurisdiction, of the landowner's right to participate in a  
51 legislative hearing prior to adoption of any ordinance extending the area of extraterritorial

1 jurisdiction, as provided in G.S. 160D-6-1, and the right of all residents of the area to apply to  
2 the board of county commissioners to serve as a representative on the planning board and the  
3 board of adjustment, as provided in G.S. 160D-3-3. The notice shall be mailed at least 30 days  
4 prior to the date of the hearing. The person or persons mailing the notices shall certify to the  
5 city council that the notices were sent by first-class mail, and the certificate shall be deemed  
6 conclusive in the absence of fraud.

7 (e) Boundaries. Any council exercising extraterritorial jurisdiction under this Chapter  
8 shall adopt an ordinance specifying the areas to be included based upon existing or projected  
9 urban development and areas of critical concern to the city, as evidenced by officially adopted  
10 plans for its development. A single jurisdictional boundary shall be applicable for all powers  
11 conferred in this Chapter. Boundaries shall be defined, to the extent feasible, in terms of  
12 geographical features identifiable on the ground. A council may, in its discretion, exclude from  
13 its extraterritorial jurisdiction areas lying in another county, areas separated from the city by  
14 barriers to urban growth, or areas whose projected development will have minimal impact on  
15 the city. The boundaries specified in the ordinance shall at all times be drawn on a map, set  
16 forth in a written description, or shown by a combination of these techniques. This delineation  
17 shall be maintained in the manner provided in G.S. 160A-22 for the delineation of the corporate  
18 limits and shall be recorded in the office of the register of deeds of each county in which any  
19 portion of the area lies.

20 Where the extraterritorial jurisdiction of two or more cities overlaps, the jurisdictional  
21 boundary between them shall be a line connecting the midway points of the overlapping area  
22 unless the city councils agree to another boundary line within the overlapping area based upon  
23 existing or projected patterns of development.

24 (f) County Authority Within City Jurisdiction. The county may on request of the city  
25 council exercise any or all these powers in any or all areas lying within the city's corporate  
26 limits or within the city's specified area of extraterritorial jurisdiction.

27 (g) Transfer of Jurisdiction. When a city annexes, or a new city is incorporated in, or a  
28 city extends its jurisdiction to include, an area that is currently being regulated by the county,  
29 the county development regulations and powers of enforcement shall remain in effect until (i)  
30 the city has adopted such development regulations, or (ii) a period of 60 days has elapsed  
31 following the annexation, extension, or incorporation, whichever is sooner. Prior to the transfer  
32 of jurisdiction, the city may hold hearings and take any other measures consistent with  
33 G.S. 160D-2-4 that may be required in order to adopt and apply its development regulations for  
34 the area at the same time it assumes jurisdiction.

35 When a city relinquishes jurisdiction over an area that it is regulating under this Chapter to  
36 a county, the city development regulations and powers of enforcement shall remain in effect  
37 until (i) the county has adopted such development regulation, or (ii) a period of 60 days has  
38 elapsed following the action by which the city relinquished jurisdiction, whichever is sooner.  
39 Prior to the transfer of jurisdiction, the county may hold hearings and take other measures  
40 consistent with G.S. 160D-2-4 that may be required in order to adopt and apply its development  
41 regulations for the area at the same time it assumes jurisdiction.

42 (h) Process for Local Government Approval. When a local government is granted  
43 powers by this section subject to the request, approval, or agreement of another local  
44 government, the request, approval, or agreement shall be evidenced by a formally adopted  
45 resolution of the governing board of the local government. Any such request, approval, or  
46 agreement can be rescinded upon two years' written notice to the other governing boards  
47 concerned by repealing the resolution. The resolution may be modified at any time by mutual  
48 agreement of the governing boards concerned.

49 (i) Local Acts. Nothing in this section shall repeal, modify, or amend any local act  
50 which defines the boundaries of a city's extraterritorial jurisdiction by metes and bounds or  
51 courses and distances.

1       (j) Effect on Vested Rights. Whenever a city or county, pursuant to this section,  
2 acquires jurisdiction over a territory that theretofore has been subject to the jurisdiction of  
3 another local government, any person who has acquired vested rights in the surrendering  
4 jurisdiction may exercise those rights as if no change of jurisdiction had occurred. The city or  
5 county acquiring jurisdiction may take any action regarding such a permit, certificate, or other  
6 evidence of compliance that could have been taken by the local government surrendering  
7 jurisdiction pursuant to its ordinances and regulations. Except as provided in this subsection,  
8 any building, structure, or other land use in a territory over which a city or county has acquired  
9 jurisdiction is subject to the ordinances and regulations of the city or county.

10 **"§ 160D-2-3. Split jurisdiction.**

11 If an individual parcel of land lies within the planning and development regulation  
12 jurisdiction of more than one local government, for the purposes of this Chapter, the local  
13 governments may, by mutual agreement, pursuant to Article 20 of Chapter 160A of the General  
14 Statutes and with the written consent of the landowner, assign exclusive planning and  
15 development regulation jurisdiction under this Chapter for the entire parcel to any one of those  
16 local governments. Such a mutual agreement shall only be applicable to development  
17 regulations and shall not affect taxation or other nonregulatory matters. The mutual agreement  
18 shall be evidenced by a resolution formally adopted by each governing board and recorded with  
19 the register of deeds in the county where the property is located within 14 days of the adoption  
20 of the last required resolution.

21 **"§ 160D-2-4. Pending jurisdiction.**

22 After consideration of a change in local government jurisdiction has been formally  
23 proposed, the local government that is potentially receiving jurisdiction may receive and  
24 process any application for development approvals that would be required in that local  
25 government if the jurisdiction is changed. No final decisions shall be made on any development  
26 approval prior to the actual transfer of jurisdiction. Acceptance of jurisdiction and development  
27 approvals may be made concurrently.

28 "Article 3.

29 "Boards and Organizational Arrangements.

30 **"§ 160D-3-1. Planning boards.**

31 (a) Composition. A local government may by ordinance provide for the appointment  
32 and compensation of a planning board or may designate one or more boards or commissions to  
33 perform the duties of a planning board. A planning board established pursuant to this section  
34 may include, but shall not be limited to, one or more of the following:

35 (1) A planning board of any size (with not fewer than three members) or  
36 composition deemed appropriate, organized in any manner deemed  
37 appropriate.

38 (2) A joint planning board created by two or more local governments pursuant  
39 to Part 1 of Article 20 of Chapter 160A of the General Statutes.

40 (b) Duties. A planning board may be assigned the following powers and duties:

41 (1) Prepare, review, maintain, monitor, and periodically update and recommend  
42 to the governing board a comprehensive plan, and such other plans as  
43 deemed appropriate, and conduct ongoing related research, data collection,  
44 mapping, and analysis.

45 (2) Facilitate and coordinate citizen engagement and participation in the  
46 planning process.

47 (3) Develop and recommend policies, ordinances, administrative procedures,  
48 and other means for carrying out plans in a coordinated and efficient  
49 manner.

- 1           (4) Advise the governing board concerning the implementation of plans,  
2           including, but not limited to, review and comment on all zoning text and  
3           map amendments as required by G.S. 160D-6-4.
- 4           (5) Exercise any functions in the administration and enforcement of various  
5           means for carrying out plans that the governing board may direct.
- 6           (6) Provide a preliminary forum for review of quasi-judicial decisions, provided  
7           that no part of the forum or recommendation be used as a basis for the  
8           deciding board.
- 9           (7) Perform any other related duties that the governing board may direct.

10 **"§ 160D-3-2. Boards of adjustment.**

11           (a) Composition. A local government may by ordinance provide for the appointment  
12 and compensation of a board of adjustment consisting of five or more members, each to be  
13 appointed for three years. In appointing the original members or in the filling of vacancies  
14 caused by the expiration of the terms of existing members, the governing board may appoint  
15 certain members for less than three years so that the terms of all members shall not expire at  
16 the same time. The governing board may appoint and provide compensation for alternate  
17 members to serve on the board in the absence or temporary disqualification of any regular  
18 member or to fill a vacancy pending appointment of a member. Alternate members shall be  
19 appointed for the same term, at the same time, and in the same manner as regular members.  
20 Each alternate member serving on behalf of any regular member has all the powers and duties  
21 of a regular member.

22           (b) Duties. The board shall hear and decide all matters upon which it is required to pass  
23 under any statute or ordinance adopted under this Chapter. The ordinance may designate a  
24 planning board or governing board to perform any of the duties of a board of adjustment  
25 in addition to its other duties and may create and designate specialized boards to hear  
26 technical appeals. If any board other than the board of adjustment is assigned decision-making  
27 authority for any quasi-judicial matter, that board shall comply with all of the procedures and  
28 the process applicable to a board of adjustment in making quasi-judicial decisions.

29 **"§ 160D-3-3. Extraterritorial representation on planning boards and boards of**  
30 **adjustment.**

31           (a) Proportional Representation. When a city elects to exercise extraterritorial powers  
32 under this Chapter, it shall provide a means of proportional representation based on population  
33 for residents of the extraterritorial area to be regulated. The population estimates for this  
34 calculation shall be updated no less frequently than after each decennial census. Representation  
35 shall be provided by appointing at least one resident of the entire extraterritorial planning and  
36 development regulation area to the planning board, the board of adjustment, and appearance  
37 commission.

38           (b) Appointment. Membership of joint municipal-county planning agencies or boards of  
39 adjustment may be appointed as agreed by counties and municipalities. The extraterritorial  
40 representatives on a city planning board, board of adjustment, and appearance commission shall  
41 be appointed by the board of county commissioners with jurisdiction over the area. When  
42 selecting a new representative to the planning board or to the board of adjustment as a result of  
43 an extension of the extraterritorial jurisdiction of a city, the board of county commissioners  
44 shall hold a legislative hearing on the selection. A notice of the hearing shall be given once a  
45 week for two successive calendar weeks in a newspaper having general circulation in the area.  
46 The board of county commissioners shall select appointees only from those who apply at or  
47 before the hearing. The county shall make the appointments within 90 days following the  
48 hearing. Once a city provides proportional representation, no power available to a city under  
49 this Chapter shall be ineffective in its extraterritorial area solely because county appointments  
50 have not yet been made. If there is an insufficient number of qualified residents of the  
51 extraterritorial area to meet membership requirements, the board of county commissioners may

1 appoint as many other residents of the county as necessary to make up the requisite number.  
2 When the extraterritorial area extends into two or more counties, each board of county  
3 commissioners concerned shall appoint representatives from its portion of the area, as specified  
4 in the ordinance. If a board of county commissioners fails to make these appointments within  
5 90 days after receiving a resolution from the city council requesting that they be made, the city  
6 council may make them.

7 (c) Voting Rights. If the ordinance so provides, the outside representatives may have  
8 equal rights, privileges, and duties with the other members of the board to which they are  
9 appointed, regardless of whether the matters at issue arise within the city or within the  
10 extraterritorial area; otherwise they shall function only with respect to matters within the  
11 extraterritorial area.

12 **"§ 160D-3-4. Historic preservation commission.**

13 (a) Composition. Before it may designate one or more landmarks or historic districts  
14 pursuant to Part 4 of Article 9 of this Chapter, the governing board shall establish a historic  
15 preservation commission. The governing board shall determine the number of the members of  
16 the commission, which shall be at least three, and the length of their terms, which shall be no  
17 greater than four years. A majority of the members of such a commission shall have  
18 demonstrated special interest, experience, or education in history, architecture, archaeology, or  
19 related fields. All the members shall reside within the planning and development regulation  
20 jurisdiction of the local government as established pursuant to this Chapter. The commission  
21 may appoint advisory bodies and committees as appropriate. Members of the commission may  
22 be reimbursed for actual expenses incidental to the performance of their duties within the limits  
23 of any funds available to the commission but shall serve without pay unless otherwise provided  
24 in the ordinance establishing the commission.

25 In lieu of establishing a historic preservation commission, a local government may  
26 designate as its historic preservation commission (i) a separate historic districts commission or  
27 a separate historic landmarks commission established pursuant to this Chapter to deal only with  
28 historic districts or landmarks respectively, (ii) a planning board established pursuant to this  
29 Chapter, or (iii) a community appearance commission established pursuant to this Chapter. In  
30 order for a commission or board other than the preservation commission to be designated, at  
31 least three of its members shall have demonstrated special interest, experience, or education in  
32 history, architecture, or related fields. At the discretion of the local government the ordinance  
33 may also provide that the preservation commission may exercise within a historic district any  
34 or all of the powers of a planning board or a community appearance commission.

35 Local governments may establish or designate a joint preservation commission. If a joint  
36 commission is established or designated, it shall have the same composition as specified by this  
37 section and the local governments involved shall determine the residence requirements of  
38 members of the joint preservation commission.

39 (b) Duties. The historic preservation commission shall have the duties specified in  
40 G.S. 160D-9-42.

41 **"§ 160D-3-5. Appearance commission.**

42 (a) Composition. Each local government may by ordinance create a special  
43 commission, to be known as the appearance commission. The commission shall consist of not  
44 less than seven nor more than 15 members, to be appointed by the governing board for such  
45 terms, not to exceed four years, as the governing board may by ordinance provide. All members  
46 shall be residents of the local government's area of planning and development regulation  
47 jurisdiction at the time of appointment. Where possible, appointments shall be made in such a  
48 manner as to maintain on the commission at all times a majority of members who have had  
49 special training or experience in a design field, such as architecture, landscape design,  
50 horticulture, city planning, or a related field. Members of the commission may be reimbursed  
51 for actual expenses incidental to the performance of their duties within the limits of any funds



1 available to the commission, but shall serve without pay unless otherwise provided in the  
2 ordinance establishing the commission. Membership of the commission is an office that may be  
3 held concurrently with any other elective or appointive office pursuant to Article VI, Sec. 9, of  
4 the Constitution.

5 Local governments may establish a joint appearance commission. If a joint appearance  
6 commission is established, it shall have the same composition as specified by this section, and  
7 the local governments involved shall determine the residence requirements for members of the  
8 joint appearance commission.

9 (b) Duties. The community appearance commission shall have the duties specified in  
10 G.S. 160D-9-60.

11 **"§ 160D-3-6. Housing appeals board.**

12 (a) Composition. The governing board may by ordinance provide for the creation and  
13 organization of a housing appeals board. Instead of establishing a housing appeals board, a  
14 local government may designate the board of adjustment as its housing appeals board. The  
15 housing appeals board, if created, shall consist of five members to serve for three-year  
16 staggered terms.

17 (b) Duties. The housing appeals board shall have the duties specified in  
18 G.S. 160D-12-8.

19 **"§ 160D-3-7. Other advisory boards.**

20 A local government may by ordinance establish additional advisory boards as deemed  
21 appropriate. The ordinance establishing such boards shall specify the composition and duties of  
22 such boards.

23 **"§ 160D-3-8. Rules of procedure.**

24 Rules of procedure that are consistent with the provisions of this Chapter may be adopted  
25 by the governing board for any or all boards created under this Article. In the absence of action  
26 by the governing board, each board created under this Article is authorized to adopt its own  
27 rules of procedure that are consistent with the provisions of this Chapter. A copy of any  
28 adopted rules of procedure shall be maintained by the local government clerk and posted on the  
29 local government Web site if one exists. Each board shall keep minutes of its proceedings.

30 **"§ 160D-3-9. Oath of office.**

31 All members appointed to boards under this Article shall, before entering their duties,  
32 qualify by taking an oath of office as required by G.S. 153A-26 and G.S. 160A-61.

33 "Article 4.

34 "Administration, Enforcement, and Appeals.

35 **"§ 160D-4-1. Application.**

36 (a) The provisions of this Article shall apply to all ordinances adopted pursuant to this  
37 Chapter. Local governments may apply any of the definitions and procedures authorized by this  
38 Article to ordinances adopted under the general police power of cities and counties, Article 8  
39 of Chapter 160A of the General Statutes and Article 6 of Chapter 153A of the General Statutes,  
40 respectively, and may employ any organizational structure, board, commission, or staffing  
41 arrangement authorized by this Article to any or all aspects of those ordinances.

42 (b) The provisions of this Article are supplemental to specific provisions included in  
43 other Articles of this Chapter. To the extent there is a conflict between the provisions of this  
44 Article and other Articles, the more specific provision shall control.

45 **"§ 160D-4-2. Administrative staff.**

46 (a) Authorization. Local governments may appoint administrators, inspectors,  
47 enforcement officers, planners, technicians, and other staff to develop, administer, and enforce  
48 ordinances authorized by this Chapter.

49 (b) Duties. Duties assigned to staff may include, but are not limited to: drafting and  
50 implementing plans and ordinances to be adopted pursuant to this Chapter; determining  
51 whether permit applications are complete; receipt and processing applications for permits;

1 providing notices of applications and hearings; making permit decisions and determinations  
2 regarding ordinance implementation; determining whether permit applications meet applicable  
3 standards as established by law and local ordinance; conducting inspections; issuing or denying  
4 certificates of compliance or occupancy; enforcing ordinances, including issuing notices of  
5 violation and orders to correct violations and bringing judicial actions against actual or  
6 threatened violations; keeping adequate records; and any other actions that may be required in  
7 order adequately to enforce the laws and development regulations under their jurisdiction. A  
8 development regulation may require that designated staff members take an oath of office. The  
9 local government shall have the authority to enact ordinances, procedures, and fee schedules  
10 relating to the administration and the enforcement of this Chapter.

11 (c) **Alternative Staff Arrangements.** A local government may enter into contracts with  
12 another city, county, or combination thereof under which the parties agree to create a joint staff  
13 for the enforcement of State and local laws specified in the agreement. The governing boards of  
14 the contracting parties may make any necessary appropriations for this purpose.

15 In lieu of joint staff, a governing board may designate staff from any other city or county to  
16 serve as a member of its staff with the approval of the governing board of the other city or  
17 county. A staff member if designated from another city or county under this section, shall,  
18 while exercising the duties of the position, be considered an agent of the local government. The  
19 governing board of one local government may request the governing board of a second local  
20 government to direct one or more of the second local government's staff members to exercise  
21 their powers within part or all of the first local government's jurisdiction, and they shall  
22 thereupon be empowered to do so until the first local government officially withdraws its  
23 request in the manner provided in G.S. 160D-2-2.

24 A local government may contract with an individual, company, council of governments,  
25 regional planning agency, metropolitan planning organization, or rural planning agency to  
26 designate an individual who is not a city or county employee to work under the supervision of  
27 the local government to exercise the functions authorized by this section. The local government  
28 shall have the same potential liability, if any, for inspections conducted by an individual who is  
29 not an employee of the local government as it does for an individual who is an employee of the  
30 local government. The company or individual with whom the local government contracts shall  
31 have errors and omissions and other insurance coverage acceptable to the local government.

32 (d) **Financial Support.** The local government may appropriate for the support of the  
33 staff any funds that it deems necessary. It shall have power to fix reasonable fees for issuance  
34 of permits, inspections, and other services of the staff.

35 **"§ 160D-4-3. Permits and determinations.**

36 (a) **Permits.** No person shall commence or proceed with the construction,  
37 reconstruction, alteration, repair, movement to another site, removal, or demolition of any  
38 building or structure or initiate or change the use of land without first securing any required  
39 permits, site plan, or development approvals from the local government with jurisdiction over  
40 the site of the development. The developer shall secure all permits required by any State or  
41 local laws applicable to the development prior to the initiation of work. A permit shall be in  
42 writing and shall contain a provision that the development shall comply with all applicable  
43 State and local laws. A local government may issue permits in print or electronic form. Any  
44 permit issued exclusively in electronic form shall be locked from further editing once issued.  
45 Applications for permits and development approvals may be made by the landowner, a lessee  
46 or person holding an option or contract to purchase that land, or an authorized agent of the  
47 landowner.

48 (b) **Determinations and Notice of Determinations.** An ordinance enacted under the  
49 authority of this Chapter shall designate the staff member or members charged with making  
50 decisions under the ordinance. As used in this Article, "decision" includes any final and binding  
51 order, requirement, or determination.

1        The officer making the decision shall give written notice to the owner of the property that is  
2 the subject of the decision, to the party who sought the decision, if different from the owner,  
3 and to any known tenant subject to the decision. The written notice shall clearly indicate that it  
4 is final and binding and shall be delivered by personal delivery, electronic mail, or by first-class  
5 mail.

6        It shall be conclusively presumed that all persons with standing to appeal have constructive  
7 notice of the decision from the date a sign providing notice that a decision has been made is  
8 prominently posted on the property that is the subject of the decision, provided the sign remains  
9 on the property for at least 10 days. The sign shall contain the words "Zoning Decision" or  
10 "Subdivision Decision" or similar language for other determinations in letters at least six inches  
11 high and shall identify the means to contact a local government staff member for information  
12 about the decision. Posting of signs is not the only form of constructive notice. Any such  
13 posting shall be the responsibility of the landowner, applicant, or person who sought the  
14 decision. Verification of the posting shall be provided to the staff member responsible for the  
15 decision. Absent an ordinance provision to the contrary, posting of signs shall not be required.

16        (c) Duration of Development Approval. Unless a different period is specified by this  
17 Chapter or other specific applicable law or a longer period is provided by local ordinance, a  
18 development approval issued pursuant to this Chapter shall expire one year after the date of  
19 issuance if the work or activity authorized by the development approval has not been  
20 substantially commenced. Local ordinances may provide for development approvals of shorter  
21 duration for temporary land uses, special events, temporary signs, and similar development.  
22 Unless provided otherwise by this Chapter or other specific applicable law or a longer period is  
23 provided by local ordinance, if the work or activity is discontinued for a period of 12 months  
24 after commencement, the development approval shall immediately expire. The time periods set  
25 out in this subsection shall be tolled during the pendency of any appeal. No work or activity  
26 authorized by any development approval that has expired shall thereafter be performed until a  
27 new development approval has been secured.

28        (d) Changes. After a development approval has been issued, no deviations from the  
29 terms of the application or the development approval shall be made until written approval of  
30 proposed changes or deviations has been obtained. A local government may define by  
31 ordinance minor modifications to development approvals that can be exempted or  
32 administratively approved. The local government shall follow the same development review  
33 and approval process required for issuance of the development approval in the review and  
34 approval of any major modification of that approval.

35        (e) Inspections. Administrative staff may inspect work undertaken pursuant to a  
36 development approval to assure that the work is being done in accordance with applicable State  
37 and local laws and of the terms of the approval. In exercising this power, staff are authorized to  
38 enter any premises within the planning and development regulation jurisdiction of the local  
39 government at all reasonable hours for the purposes of inspection or other enforcement action,  
40 upon presentation of proper credentials to the extent constitutionally permissible.

41        (f) Revocation of Development Approvals. Development approvals may be revoked by  
42 the local government issuing the development approval by notifying the holder in writing  
43 stating the reason for the revocation. The local government shall follow the same development  
44 review and approval process required for issuance of the development approval, including any  
45 required notice or hearing, in the review and approval of any revocation of that approval.  
46 Development approvals shall be revoked for any substantial departure from the approved  
47 application, plans, or specifications; for refusal or failure to comply with the requirements of  
48 any applicable local development regulation or any State law enforced by the local  
49 government; or for false statements or misrepresentations made in securing the approval. Any  
50 development approval mistakenly issued in violation of an applicable State or local law may  
51 also be revoked. The revocation of a development approval by a staff member may be appealed

1 pursuant to G.S. 160D-4-5. If an appeal is filed regarding an ordinance adopted by a local  
2 government pursuant to this Chapter, the provisions of G.S. 160D-4-5(e) regarding stays shall  
3 be applicable.

4 (g) Certificate of Occupancy. A local government may, upon completion of work or  
5 activity undertaken pursuant to a development approval, make final inspections and issue a  
6 certificate of compliance or occupancy if staff finds that the completed work complies with all  
7 applicable State and local laws and with the terms of the approval. No building, structure, or  
8 use of land that is subject to a building permit required by Article 11 of this Chapter shall be  
9 occupied or used until a certificate of occupancy or temporary certificate pursuant to  
10 G.S. 160D-11-14 has been issued.

11 **"§ 160D-4-4. Enforcement.**

12 (a) Notices of Violation. When staff determines work or activity has been undertaken in  
13 violation of an ordinance adopted pursuant to this Chapter or other local development  
14 regulation or any State law enforced by the local government or in violation of the terms of a  
15 development approval, a written notice of violation may be issued. The notice of violation shall  
16 be delivered to the holder of the development approval or to the landowner of the property  
17 involved if the landowner is not the holder of the development approval, by personal delivery,  
18 electronic delivery, or first-class mail and may be provided by similar means to the occupant of  
19 the property or the person undertaking the work or activity. The notice of violation may be  
20 posted on the property. The person providing the notice of violation shall certify to the local  
21 government that the notice was provided, and the certificate shall be deemed conclusive in the  
22 absence of fraud. Except as provided by G.S. 160D-11-23 and G.S. 160D-12-6, a notice of  
23 violation may be appealed to the board of adjustment pursuant to G.S. 160D-4-5.

24 (b) Stop Work Orders. Whenever any work or activity subject to regulation pursuant to  
25 this Chapter or other applicable local development regulation or any State law enforced by the  
26 local government is undertaken in substantial violation of any State or local law, or in a manner  
27 that endangers life or property, staff may order the specific part of the work or activity that is in  
28 violation, or presents such a hazard, to be immediately stopped. The order shall be in writing,  
29 directed to the person doing the work or activity, and shall state the specific work or activity to  
30 be stopped, the reasons therefor, and the conditions under which the work or activity may be  
31 resumed. A copy of the order shall be delivered to the holder of the development approval and  
32 to the owner of the property involved if that person is not the holder of the development  
33 approval, by personal delivery, electronic delivery, or first-class mail. The person or persons  
34 delivering the stop work order shall certify to the local government that the order was  
35 delivered, and that certificate shall be deemed conclusive in the absence of fraud. Except as  
36 provided by G.S. 160D-11-23 and G.S. 160D-12-6, a stop work order may be appealed  
37 pursuant to G.S. 160D-4-5. No further work or activity shall take place in violation of a stop  
38 work order pending a ruling on the appeal. Violation of a stop work order shall constitute a  
39 Class 1 misdemeanor.

40 (c) Remedies. Subject to the provisions of the ordinance, any ordinance adopted  
41 pursuant to authority conferred by this Chapter may be enforced by any remedy provided by  
42 G.S. 160A-175 or G.S. 153A-123. If a building or structure is erected, constructed,  
43 reconstructed, altered, repaired, converted, or maintained, or any building, structure or land is  
44 used or developed in violation of this Chapter or of any ordinance or other regulation made  
45 under authority of this Chapter, the local government, in addition to other remedies, may  
46 institute any appropriate action or proceedings to prevent the unlawful erection, construction,  
47 reconstruction, alteration, repair, conversion, maintenance, use, or development; to restrain,  
48 correct, or abate the violation; to prevent occupancy of the building, structure, or land; or to  
49 prevent any illegal act, conduct, business, or use in or about the premises.

50 In case any building, structure, site, area, or object designated as a historic landmark or  
51 located within a historic district designated pursuant to this Chapter is about to be demolished

1 whether as the result of deliberate neglect or otherwise, materially altered, remodeled, removed,  
2 or destroyed, except in compliance with the ordinance or other provisions of this Chapter, the  
3 local government, the historic preservation commission, or other party aggrieved by such action  
4 may institute any appropriate action or proceedings to prevent such unlawful demolition,  
5 destruction, material alteration, remodeling, or removal, to restrain, correct or abate such  
6 violation, or to prevent any illegal act or conduct with respect to such building, structure, site,  
7 area, or object. Such remedies shall be in addition to any others authorized by this Chapter for  
8 violation of an ordinance.

9 **"§ 160D-4-5. Appeals of administrative decisions.**

10 (a) Appeals. Except as provided in subsection (b), appeals of decisions made by the  
11 staff under this Chapter shall be made to the board of adjustment unless a different board is  
12 provided or authorized otherwise by statute or an ordinance adopted pursuant to this Chapter. If  
13 this function of the board of adjustment is assigned to any other board pursuant to  
14 G.S. 160D-3-2(b), that board shall comply with all of the procedures and processes applicable  
15 to a board of adjustment hearing appeals. Appeal of a decision made pursuant to an erosion and  
16 sedimentation control ordinance, a stormwater control ordinance, or a provision of the housing  
17 code shall not be made to the board of adjustment unless required by a local government  
18 ordinance or code provision.

19 (b) Judicial Appeals. A party with standing is not required to exhaust the remedy in  
20 subsection (a) of this section before bringing a separate original civil action to challenge the  
21 validity of an ordinance or regulation or to raise constitutional claims.

22 (c) Standing. Any person who has standing under G.S. 160D-14-2 or the local  
23 government may appeal an administrative decision to the board. An appeal is taken by filing a  
24 notice of appeal with the local government clerk or such other government official as may be  
25 designated by the ordinance. The notice of appeal shall state the grounds for the appeal.

26 (d) Time to Appeal. The landowner or other party shall have 30 days from receipt of the  
27 written notice of the decision within which to file an appeal. Any other person with standing to  
28 appeal shall have 30 days from receipt from any source of actual or constructive notice of the  
29 decision within which to file an appeal. In the absence of evidence to the contrary, notice given  
30 by first-class mail shall be deemed received on the third business day following deposit of the  
31 notice for mailing with the United States Post Office.

32 (e) Record of Decision. The official who made the decision shall transmit to the board  
33 all documents and exhibits constituting the record upon which the decision appealed from is  
34 taken. The official shall also provide a copy of the record to the appellant and to the owner of  
35 the property that is the subject of the appeal if the appellant is not the owner.

36 (f) Stays. An appeal of a notice of violation or other enforcement order stays  
37 enforcement of the action appealed from unless the official who made the decision certifies to  
38 the board after notice of appeal has been filed that because of the facts stated in an affidavit, a  
39 stay would cause imminent peril to life or property or because the violation is transitory in  
40 nature, a stay would seriously interfere with enforcement of the ordinance. In that case,  
41 enforcement proceedings shall not be stayed except by a restraining order, which may be  
42 granted by a court. If enforcement proceedings are not stayed, the appellant may file with the  
43 official a request for an expedited hearing of the appeal, and the board shall meet to hear the  
44 appeal within 15 days after such a request is filed. Notwithstanding the foregoing, appeals of  
45 decisions granting a development approval or otherwise affirming that a proposed use of  
46 property is consistent with the ordinance shall not stay the further review of an application for  
47 development approval to use such property; in these situations the appellant or local  
48 government may request and the board may grant a stay of a final decision of development  
49 approval applications, including building permits affected by the issue being appealed.

50 (g) Alternative Dispute Resolution. The parties to an appeal that has been made under  
51 this section may agree to mediation or other forms of alternative dispute resolution. The

1 ordinance may set standards and procedures to facilitate and manage such voluntary alternative  
2 dispute resolution.

3 **"§ 160D-4-6. Quasi-judicial procedure.**

4 (a) Process Required. Quasi-judicial procedures shall be followed by boards  
5 determining appeals of administrative decisions, special use permits, certificates of  
6 appropriateness, variances, or any other quasi-judicial decision.

7 (b) Notice of Hearing. Notice of evidentiary hearings conducted pursuant to this  
8 Chapter shall be mailed to the person or entity whose appeal, application, or request is the  
9 subject of the hearing; to the owner of the property that is the subject of the hearing if the  
10 owner did not initiate the hearing; to the owners of all parcels of land abutting the parcel of  
11 land that is the subject of the hearing; and to any other persons entitled to receive notice as  
12 provided by the local development regulation. In the absence of evidence to the contrary, the  
13 local government may rely on the county tax listing to determine owners of property entitled to  
14 mailed notice. The notice must be deposited in the mail at least 10 days, but not more than 25  
15 days, prior to the date of the hearing. Within that same time period, the local government shall  
16 also prominently post a notice of the hearing on the site that is the subject of the hearing or on  
17 an adjacent street or highway right-of-way.

18 (c) Administrative Materials. The administrator or staff to the board shall transmit to  
19 the board all applications, reports, and written materials relevant to the quasi-judicial matter  
20 being considered. The administrative materials may be presented at the hearing or distributed to  
21 the members of the board prior to the hearing. A copy of the administrative materials shall be  
22 provided to the appellant or applicant and to the landowner if that person is not the appellant or  
23 applicant at the same time it is submitted to the board. The administrative materials shall  
24 become a part of the hearing record. The administrative materials may be provided in written or  
25 electronic form. Any objections to inclusion or exclusion of administrative materials shall be  
26 made at the hearing.

27 (d) Presentation of Evidence. The applicant, the local government, and any person who  
28 would have standing to appeal the decision under G.S. 160D-14-2(d) shall have the right to  
29 present evidence and participate as a party at the evidentiary hearing. Objections regarding  
30 jurisdictional issues, including but not limited to, the timeliness of an appeal or the standing of  
31 a party, may be made to the board. The board shall determine such objections, and these rulings  
32 are subject to judicial review pursuant to G.S. 160D-14-2. Objections based on jurisdictional  
33 issues may be raised for the first time on judicial review.

34 (e) Appearance of Official, New Issues. The official who made the decision, or the  
35 person currently occupying that position if the decision-maker is no longer employed by the  
36 local government, shall be present at the evidentiary hearing as a witness. The board shall not  
37 be limited at the hearing to matters stated in a notice of appeal. If any party or the local  
38 government would be unduly prejudiced by the presentation of matters not presented in the  
39 notice of appeal, the board shall continue the hearing.

40 (f) Oaths. The chair of the board or any member acting as chair and the clerk to the  
41 board are authorized to administer oaths to witnesses in any matter coming before the board.  
42 Any person who, while under oath during a proceeding before the board determining a  
43 quasi-judicial matter, willfully swears falsely is guilty of a Class 1 misdemeanor.

44 (g) Subpoenas. The board making a quasi-judicial decision under this Chapter through  
45 the chair, or in the chair's absence anyone acting as chair, may subpoena witnesses and compel  
46 the production of evidence. To request issuance of a subpoena, persons with standing under  
47 G.S. 160D-14-2(d) may make a written request to the chair explaining why it is necessary for  
48 certain witnesses or evidence to be compelled. The chair shall issue requested subpoenas he or  
49 she determines to be relevant, reasonable in nature and scope, and not oppressive. The chair  
50 shall rule on any motion to quash or modify a subpoena. Decisions regarding subpoenas made  
51 by the chair may be immediately appealed to the full board. If a person fails or refuses to obey

1 a subpoena issued pursuant to this subsection, the board or the party seeking the subpoena may  
2 apply to the General Court of Justice for an order requiring that its subpoena be obeyed, and the  
3 court shall have jurisdiction to issue these orders after notice to all proper parties.

4 (h) Appeals in Nature of Certiorari. When hearing an appeal pursuant to  
5 G.S. 160D-9-47(e) or any other appeal in the nature of certiorari, the hearing shall be based on  
6 the record below and the scope of review shall be as provided in G.S. 160D-14-2(k).

7 (i) Voting. The concurring vote of four-fifths of the board shall be necessary to grant a  
8 variance. A majority of the members shall be required to decide any other quasi-judicial matter  
9 or to determine an appeal made in the nature of certiorari. For the purposes of this subsection,  
10 vacant positions on the board and members who are disqualified from voting on a quasi-judicial  
11 matter under G.S. 160D-1-9(d) shall not be considered members of the board for calculation of  
12 the requisite majority if there are no qualified alternates available to take the place of such  
13 members.

14 (j) Decisions. The board shall determine contested facts and make its decision within a  
15 reasonable time. When hearing an appeal, the board may reverse or affirm, wholly or partly, or  
16 may modify the decision appealed from and shall make any order, requirement, decision, or  
17 determination that ought to be made. The board shall have all the powers of the official who  
18 made the decision. Every quasi-judicial decision shall be based upon competent, material, and  
19 substantial evidence in the record. Each quasi-judicial decision shall be reduced to writing,  
20 reflect the board's determination of contested facts and their application to the applicable  
21 standards, and be approved by the board and signed by the chair or other duly authorized  
22 member of the board. A quasi-judicial decision is effective upon filing the written decision with  
23 the clerk to the board or such other office or official as the ordinance specifies. The decision of  
24 the board shall be delivered within a reasonable time by personal delivery, electronic mail, or  
25 by first-class mail to the applicant, property owner, and to any person who has submitted a  
26 written request for a copy prior to the date the decision becomes effective. The person required  
27 to provide notice shall certify to the local government that proper notice has been made, and the  
28 certificate shall be deemed conclusive in the absence of fraud.

29 (k) Judicial Review. Every quasi-judicial decision shall be subject to review by the  
30 superior court by proceedings in the nature of certiorari pursuant to G.S. 160D-14-2.

31 "Article 5.

32 "Planning.

33 **"§ 160D-5-1. Plans.**

34 (a) Preparation Of Plans And Studies. As a condition of adopting and applying zoning  
35 regulations under this Chapter, a local government shall adopt and reasonably maintain a  
36 comprehensive plan that sets forth goals, policies, and programs intended to guide the present  
37 and future physical, social, and economic development.

38 A comprehensive plan is intended to guide coordinated, efficient, and orderly development  
39 within the planning and development regulation jurisdiction based on an analysis of present and  
40 future needs. Planning analysis may address inventories of existing conditions and assess future  
41 trends regarding demographics, economic, environmental, and cultural factors. The planning  
42 process shall include opportunities for citizen engagement in plan preparation and adoption.

43 (b) Contents. A comprehensive plan may among other topics address any of the  
44 following:

45 (1) Issues and opportunities facing the local government, including  
46 consideration of trends, the values expressed by citizens, community vision,  
47 and guiding principles for growth and development.

48 (2) The pattern of desired growth and development and civic design, including  
49 the location, distribution, and characteristics of future land uses, urban form,  
50 utilities, and transportation networks.

- 1           (3) Employment opportunities, economic development, and community  
2           development.
- 3           (4) Acceptable levels of public services and infrastructure to support  
4           development, including water, waste disposal, utilities, emergency services,  
5           transportation, education, recreation, community facilities, and other public  
6           services, including plans and policies for provision of and financing for  
7           public infrastructure.
- 8           (5) Housing with a range of types and affordability to accommodate persons and  
9           households of all types and income levels.
- 10          (6) Recreation and open spaces.
- 11          (7) Mitigation of natural hazards such as flooding, winds, wildfires, and  
12          unstable lands.
- 13          (8) Protection of the environment and natural resources, including agricultural  
14          resources, mineral resources, and water and air quality.
- 15          (9) Protection of significant architectural, scenic, cultural, historical, or  
16          archaeological resources.
- 17          (10) Analysis and evaluation of implementation measures, including regulations,  
18          public investments, and educational programs.

19          (c) Adoption and Effect of Plans. Plans shall be adopted by the governing board with  
20          the advice and consultation of the planning board. Adoption and amendment of a  
21          comprehensive plan shall follow the process mandated for zoning text amendments set by  
22          G.S. 160D-6-1. Plans adopted under this Chapter shall be advisory in nature without  
23          independent regulatory effect. Plans adopted under this Chapter may be undertaken and  
24          adopted as part of or in conjunction with plans required under other statutes, including, but not  
25          limited to, the plans required by G.S. 113A-110. Plans adopted under this Chapter shall be  
26          advisory in nature without independent regulatory effect. Plans adopted pursuant to this section  
27          shall be considered by the planning board and governing board when considering proposed  
28          amendments to zoning ordinances as required by G.S. 160D-6-4 and G.S. 160D-6-5.

29          **"§ 160D-5-2. Grants, contracts, and technical assistance.**

30          (a) Grants and Services. A local government may accept, receive, and disburse in  
31          furtherance of its functions any funds, grants, and services made available by the federal  
32          government and its agencies, the State government and its agencies, any local government and  
33          its agencies, and any private and civic sources. A local government may enter into and carry  
34          out contracts with the State and federal governments or any agencies thereof under which  
35          financial or other planning assistance is made available to the local government and may agree  
36          to and comply with any reasonable conditions that are imposed upon such assistance.

37          (b) Contracts. Any local government may enter into and carry out contracts with any  
38          other city, county, regional council, planning agency, or private consultant under which it  
39          agrees to furnish technical planning assistance to the other local government or planning  
40          agency. Any local government may enter into and carry out contracts with any other city,  
41          county, or regional council or planning agency under which it agrees to pay the other local  
42          government for technical planning assistance.

43          (c) Appropriations, Compensation, and Financing. A local government is authorized to  
44          make appropriations that may be necessary to carry out activities or contracts authorized by this  
45          Article or to support, and compensate members of any board that it may create pursuant to this  
46          Chapter, and to levy taxes for these purposes as a necessary expense.

47          **"§ 160D-5-3. Coordination of planning.**

48          A local government may undertake any of the planning activities authorized by this Article  
49          in coordination with other local governments, State agencies, or regional agencies created  
50          under Article 19 of Chapter 153A of the General Statutes or Article 20 of Chapter 160A of the  
51          General Statutes.



1 "Article 6.

2 "Process for Adoption of Development Regulations.

3 **"§ 160D-6-1. Procedure for adopting, amending, or repealing ordinances.**

4 (a) Hearing with Published Notice. Before adopting, amending, or repealing any  
5 ordinance authorized by this Chapter, the governing board shall hold a legislative hearing. A  
6 notice of the hearing shall be given once a week for two successive calendar weeks in a  
7 newspaper having general circulation in the area. The notice shall be published the first time  
8 not less than 10 days nor more than 25 days before the date scheduled for the hearing. In  
9 computing such period, the day of publication is not to be included but the day of the hearing  
10 shall be included.

11 (b) Notice to Military Bases. If the adoption or modification of the ordinance would  
12 result in changes to the zoning map or would change or affect the permitted uses of land  
13 located five miles or less from the perimeter boundary of a military base, the local government  
14 shall provide written notice of the proposed changes by certified mail, return receipt requested,  
15 to the commander of the military base not less than 10 days nor more than 25 days before the  
16 date scheduled for the hearing. If the military provides comments or analysis regarding the  
17 compatibility of the proposed ordinance or amendment with military operations at the base, the  
18 governing board of the local government shall take the comments and analysis into  
19 consideration before making a final determination on the ordinance.

20 **"§ 160D-6-2. Notice of hearing on proposed zoning map amendments.**

21 (a) Mailed Notice. The ordinance shall provide for the manner in which zoning  
22 regulations and the boundaries of zoning districts shall be determined, established, and  
23 enforced, and from time to time amended, supplemented, or changed, in accordance with the  
24 provisions of this Chapter. The procedures adopted pursuant to this section shall provide that  
25 whenever there is a zoning map amendment, the owner of that parcel of land, and the owners of  
26 all parcels of land abutting that parcel of land, shall be mailed a notice of the legislative hearing  
27 on the proposed amendment by first-class mail at the last addresses listed for such owners on  
28 the county tax abstracts. This notice must be deposited in the mail at least 10 days but not more  
29 than 25 days prior to the date of the hearing. If the zoning map amendment is being proposed in  
30 conjunction with an expansion of municipal extraterritorial planning and development  
31 regulation jurisdiction under G.S. 160D-2-2, a single hearing on the zoning map amendment  
32 and the boundary amendment may be held. In this instance the initial notice of the zoning map  
33 amendment hearing may be combined with the boundary hearing notice and the combined  
34 hearing notice mailed at least 30 days prior to the hearing.

35 Except for a government-initiated zoning map amendment, when an application is filed to  
36 request a zoning map amendment and that application is not made by the landowner or  
37 authorized agent, the applicant shall certify to the local government that the owner of the parcel  
38 of land as shown on the county tax listing has received actual notice of the proposed  
39 amendment and a copy of the notice of the hearing. Actual notice shall be provided in any  
40 manner permitted under G.S. 1A-1, Rule 4(j). If notice cannot with due diligence be achieved  
41 by personal delivery, certified mail, or by a designated delivery service authorized pursuant to  
42 26 U.S.C. § 7502(f)(2), notice may be given by publication consistent with G.S. 1A-1, Rule  
43 4(j1). The person or persons required to provide notice shall certify to the local government that  
44 actual notice has been provided, and such certificate shall be deemed conclusive in the absence  
45 of fraud.

46 (b) Option for Large-Scale Zoning Map Amendments. The first-class mail notice  
47 required under subsection (a) of this section shall not be required if the zoning map amendment  
48 directly affects more than 50 properties, owned by at least 50 different property owners, and the  
49 local government elects to use the expanded published notice provided for in this subsection. In  
50 this instance, a local government may elect to make the mailed notice provided for in  
51 subsection (a) of this section, or as an alternative, elect to publish notice of the hearing as

1 required by G.S. 160D-6-1, provided that each advertisement shall not be less than one-half of  
2 a newspaper page in size. The advertisement shall only be effective for property owners who  
3 reside in the area of general circulation of the newspaper which publishes the notice. Property  
4 owners who reside outside of the newspaper circulation area, according to the address listed on  
5 the most recent property tax listing for the affected property, shall be notified according to the  
6 provisions of subsection (a) of this section.

7 (c) Posted Notice. When a zoning map amendment is proposed, the local government  
8 shall prominently post a notice of the hearing on the site proposed for the amendment or on an  
9 adjacent public street or highway right-of-way. When multiple parcels are included within a  
10 proposed zoning map amendment, a posting on each individual parcel is not required, but the  
11 local government shall post sufficient notices to provide reasonable notice to interested  
12 persons.

13 (d) Optional Communication Requirements. When a zoning map amendment is  
14 proposed, a zoning regulation may require communication by the person proposing the map  
15 amendment to neighboring landowners and residents and may require the person proposing the  
16 zoning map amendment to report on any meeting with neighboring landowners and residents.

17 **"§ 160D-6-3. Protest petitions for proposed municipal zoning map amendments.**

18 (a) Protests to Zoning Map Amendments. In case of a qualified protest against a city  
19 zoning map amendment within a city's planning and development regulation jurisdiction, that  
20 amendment shall not become effective except by favorable vote of three-fourths of all the  
21 members of the city's governing board. For the purposes of this subsection, vacant positions on  
22 the governing board and members who are excused from voting under G.S. 160D-1-9 shall not  
23 be considered "members of the governing board" for calculation of the requisite supermajority.

24 (b) Qualifying Area. To qualify as a protest under this section, the petition must be  
25 signed by the landowners of either (i) twenty percent (20%) or more of the area included in the  
26 proposed change or (ii) five percent (5%) of a 100-foot-wide buffer extending along the entire  
27 boundary of each discrete or separate area proposed to be rezoned. A street right-of-way shall  
28 not be considered in computing the 100-foot buffer area as long as that street right-of-way is  
29 100 feet wide or less. When less than an entire parcel of land is subject to the proposed zoning  
30 map amendment, the 100-foot buffer shall be measured from the property line of that parcel.

31 (c) Amendments Not Subject to Protest. The foregoing provisions concerning protests  
32 shall not be applicable to any amendment which initially zones property added to the territorial  
33 coverage of the ordinance as a result of annexation or otherwise, or to an amendment to an  
34 adopted conditional district if the amendment does not change the types of uses that are  
35 permitted within the district or increase the approved density for residential development, or  
36 increase the total approved size of nonresidential development, or reduce the size of any buffers  
37 or screening approved for the conditional district.

38 (d) Procedure for Protests. No protest against any amendment to a zoning map shall be  
39 valid under this section unless it:

40 (1) Is in writing;

41 (2) Is signed by the landowners of the qualifying properties;

42 (3) States that it protests the proposed zoning map amendment; and

43 (4) Is filed with the city clerk in sufficient time to allow the city at least two  
44 normal work days, excluding Saturdays, Sundays, and legal holidays, before  
45 the date of the first legislative hearing on the proposed amendment to  
46 determine the sufficiency and accuracy of the petition.

47 When property is owned by multiple persons, a corporation, partnership, association, or other  
48 similar form of ownership, the protest must be signed by the person or persons whose  
49 signatures would be necessary to transfer an interest in the property.

50 The ordinance may require that all protest petitions be on a form prescribed by the city, and  
51 such form may prescribe any reasonable information deemed necessary to permit the city to

1 determine the sufficiency and accuracy of the petition. A person who has signed a protest  
2 petition may withdraw his or her name from the petition at any time prior to the vote on the  
3 proposed zoning amendment. Only those protest petitions that meet the qualifying standards set  
4 forth in this section at the time of the vote on the zoning amendment shall trigger the  
5 supermajority voting requirement.

6 **"§ 160D-6-4. Planning board review and comment.**

7 (a) Initial Zoning. In order to exercise zoning powers conferred by this Chapter for the  
8 first time, a local government shall create or designate a planning board under the provisions of  
9 this Article or of a special act of the General Assembly. The planning board shall prepare or  
10 shall review and comment upon a proposed zoning regulation, including the full text of such  
11 regulation and maps showing proposed district boundaries. The planning board may hold  
12 public meetings and legislative hearings in the course of preparing the regulation. Upon  
13 completion, the planning board shall make a written recommendation regarding adoption of the  
14 regulation to the governing board. The governing board shall not hold its required hearing or  
15 take action until it has received a recommendation regarding the regulation from the planning  
16 board. Following its required hearing, the governing board may refer the regulation back to the  
17 planning board for any further recommendations that the board may wish to make prior to final  
18 action by the governing board in adopting, modifying and adopting, or rejecting the regulation.

19 (b) Zoning Amendments. Subsequent to initial adoption of a zoning regulation, all  
20 proposed amendments to the zoning regulation or zoning map shall be submitted to the  
21 planning board for review and comment. If no written report is received from the planning  
22 board within 30 days of referral of the amendment to that board, the governing board may act  
23 on the amendment without the planning board report. The governing board is not bound by the  
24 recommendations, if any, of the planning board.

25 (c) Review of Other Ordinances and Actions. Any development regulation other than a  
26 zoning regulation that is proposed to be adopted pursuant to this Chapter may be referred to the  
27 planning board for review and comment. Any development regulation other than a zoning  
28 regulation may provide that future proposed amendments of that ordinance be submitted to the  
29 planning board for review and comment. Any other action proposed to be taken pursuant to this  
30 Chapter may be referred to the planning board for review and comment.

31 (d) Plan Consistency. When conducting a review of proposed zoning text or map  
32 amendments pursuant to this section, the planning board shall advise and comment on whether  
33 the proposed action is consistent with any comprehensive plan that has been adopted and any  
34 other officially adopted plan that is applicable. The planning board shall provide a written  
35 recommendation to the governing board that addresses plan consistency and other matters as  
36 deemed appropriate by the planning board, but a comment by the planning board that a  
37 proposed amendment is inconsistent with the comprehensive plan shall not preclude  
38 consideration or approval of the proposed amendment by the governing board. If a zoning map  
39 amendment qualifies as a "large-scale rezoning" under G.S. 160D-6-2(b), the planning board  
40 statement describing plan consistency may address the overall rezoning and describe how the  
41 analysis and polices in the relevant adopted plans were considered in the recommendation  
42 made.

43 (e) Separate Board Required. Notwithstanding the authority to assign duties of the  
44 planning board to the governing board as provided by this Chapter, the review and comment  
45 required by this section shall not be assigned to the governing board and must be performed by  
46 a separate board.

47 **"§ 160D-6-5. Governing board statement.**

48 (a) Plan Consistency. When adopting or rejecting any zoning text or map amendment,  
49 the governing board shall approve a statement describing whether its action is consistent with  
50 an adopted comprehensive plan and any other applicable adopted plan, and briefly explain why  
51 the board considers the action taken to be in the public interest. That statement is not subject to

1 judicial review. If a zoning map amendment qualifies as a "large-scale rezoning" under  
2 G.S. 160D-6-2(b), the governing board statement describing plan consistency may address the  
3 overall rezoning and describe how the analysis and polices in the relevant adopted plans were  
4 considered in the action taken.

5 (b) Reasonableness. When adopting or rejecting any petition for a zoning map  
6 amendment, the governing board shall approve a statement analyzing the reasonableness of the  
7 proposed amendment. This statement of reasonableness may consider, among other factors, the  
8 size, physical conditions, and other attributes of the tract; the benefits and detriment to the  
9 landowner, the neighbors, and the surrounding community; and the relationship between the  
10 current actual and permissible development on the tract and adjoining areas and the  
11 development that would be permissible under the proposed amendment. If a zoning map  
12 amendment qualifies as a "large-scale rezoning" under G.S. 160D-6-2(b), the governing board  
13 statement on reasonableness may address the overall rezoning.

14 (c) Single Statement. The statement of reasonableness and plan consistency statement  
15 required by this section may be approved as a single statement.

16 "Article 7.

17 "Zoning Regulation

18 "**§ 160D-7-1. Purposes.**

19 Zoning regulations shall be made in accordance with a comprehensive plan and shall be  
20 designed to promote the public health, safety, and general welfare. To that end, the regulations  
21 may address, among other things, the following public purposes: to provide adequate light and  
22 air; to prevent the overcrowding of land; to avoid undue concentration of population; to lessen  
23 congestion in the streets; to secure safety from fire, panic, and dangers; to facilitate the efficient  
24 and adequate provision of transportation, water, sewerage, schools, parks, and other public  
25 requirements; to protect the character of neighborhoods and the community; and to promote the  
26 health, safety, or the general welfare of the community. The regulations shall be made with  
27 reasonable consideration, among other things, as to the character of the district and its peculiar  
28 suitability for particular uses, and with a view to conserving the value of buildings and  
29 encouraging the most appropriate use of land throughout such city.

30 "**§ 160D-7-2. Grant of power.**

31 A local government may adopt zoning ordinances. A zoning regulation may regulate and  
32 restrict the height, number of stories and size of buildings and other structures; the percentage  
33 of lots that may be occupied; the size of yards, buffers, courts, and other open spaces; the  
34 density of population; and the location and use of buildings, structures, land, landscaping,  
35 parking, and signage. A local government may regulate development, including floating homes,  
36 over estuarine waters and over lands covered by navigable waters owned by the State pursuant  
37 to G.S. 146-12. The zoning regulation may provide density credits or severable development  
38 rights for dedicated rights-of-way pursuant to G.S. 136-66.10 or G.S. 136-66.11. Where  
39 appropriate and consistent with the limitations of G.S. 160D-8-4(c), a zoning regulation may  
40 include requirements that street and utility rights-of-way be dedicated to the public, that  
41 provision be made of recreational space and facilities, and that performance guarantees be  
42 provided.

43 "**§ 160D-7-3. Zoning districts.**

44 (a) Types of Zoning Districts. A local government may divide its territorial jurisdiction  
45 into zoning districts of any number, shape, and area deemed best suited to carry out the  
46 purposes of this Article. Within those districts it may regulate and restrict the erection,  
47 construction, reconstruction, alteration, repair or use of buildings, structures, or land. Zoning  
48 districts may include, but shall not be limited to:

- 49 (1) Conventional districts, in which a variety of uses are allowed as permitted  
50 uses or uses by right and that may also include uses permitted only with a  
51 special use permit;

- 1           (2)    Conditional districts, in which site plans or individualized development  
2           conditions are imposed;  
3           (3)    Form-based districts, which address the physical form, mass, and density of  
4           structures, public spaces, and streetscapes; and  
5           (4)    Overlay districts, in which different requirements are imposed on certain  
6           properties within one or more underlying conventional, conditional, or  
7           form-based districts.

8           (b)    Conditional Districts. Property may be placed in a conditional district only in  
9           response to a petition by all owners of the property to be included. Specific conditions may be  
10          proposed by the petitioner or the local government or its agencies, but only those conditions  
11          mutually approved by the local government and the petitioner may be incorporated into the  
12          zoning regulations. Conditions and site-specific standards imposed in a conditional district shall  
13          be limited to those that address the conformance of the development and use of the site to local  
14          government ordinances, plans adopted pursuant to G.S. 160D-5-1, or the impacts reasonably  
15          expected to be generated by the development or use of the site. The ordinance may provide that  
16          defined minor modifications in conditional district standards that do not involve a change in  
17          uses permitted or the density of overall development permitted may be reviewed and approved  
18          administratively. Any other modification of the conditions and standards in a conditional  
19          district shall follow the same process for approval as are applicable to zoning map  
20          amendments. If multiple parcels of land are subject to a conditional zoning, the owners of  
21          individual parcels may apply for modification of the conditions so long as the modification  
22          would not result in other properties failing to meet the terms of the conditions. Any  
23          modifications approved shall only be applicable to those properties whose owners petition for  
24          the modification.

25          (c)    Uniformity Within Districts. Except as authorized by the foregoing, all regulations  
26          shall be uniform for each class or kind of building throughout each district, but the regulations  
27          in one district may differ from those in other districts.

28          (d)    Standards Applicable Regardless Of District. A zoning regulation or unified  
29          development ordinance may also include development standards that apply uniformly  
30          jurisdiction-wide rather than being applicable only in particular zoning districts.

31          "**§ 160D-7-4. Incentives.**

32          (a)    Energy Efficiency and Sustainable Development. For the purpose of reducing the  
33          amount of energy consumption by new development, local governments may adopt ordinances  
34          to grant a density bonus, make adjustments to otherwise applicable development requirements,  
35          or provide other incentives within its planning and development regulation jurisdiction, if the  
36          person agrees to construct new development or reconstruct existing development in a manner  
37          that the local government determines, based on generally recognized standards established for  
38          such purposes, makes a significant contribution to the reduction of energy consumption and  
39          increased use of sustainable design principles.

40          In order to encourage construction that uses sustainable design principles and to improve  
41          energy efficiency in buildings, a local government may charge reduced building permit fees or  
42          provide partial rebates of building permit fees for buildings that are constructed or renovated  
43          using design principles that conform to or exceed one or more of the following certifications or  
44          ratings:

- 45               (1)    Leadership in Energy and Environmental Design (LEED) certification or  
46               higher rating under certification standards adopted by the U.S. Green  
47               Building Council.  
48               (2)    A One Globe or higher rating under the Green Globes program standards  
49               adopted by the Green Building Initiative.

- 1           (3)    A certification or rating by another nationally recognized certification or  
2           rating system that is equivalent or greater than those listed in subdivisions  
3           (1) and (2) of this subsection.
- 4       (b)    Affordable Housing.
- 5           (1)    For the purpose of increasing the availability of housing for persons of low  
6           or moderate income, and thereby promoting the public safety and welfare,  
7           the governing board may provide for density bonuses in one or more zoning  
8           districts in which residential uses are permitted or provide other incentives to  
9           a developer of housing within the planning and development regulation  
10          jurisdiction of the local government if the developer agrees to provide a  
11          specified amount or percentage of the total proposed housing units within  
12          the development for persons and families of low and moderate income. The  
13          size of the density bonus may vary with the percentage of housing units  
14          constructed within the development for persons or families of low or  
15          moderate income. In lieu of requiring the provision of a specified amount or  
16          percentage of affordable housing, a governing board may provide density  
17          bonuses or other incentives to developers in exchange for an alternative to  
18          construction of housing units, such as donation of land, provision of funding  
19          for affordable housing, or the developer's participation in joint efforts with  
20          housing authorities, community housing trusts, or other nonprofit  
21          organizations to create affordable housing.
- 22          (2)    The governing board may provide for the enforcement of a developer's  
23          commitment to provide low and moderate income housing by ordinance or  
24          through the adoption of rules and regulations. Such ordinance or rules and  
25          regulations may require the developer to record restrictive covenants  
26          applicable to the property, to convey real estate interests in the property, to  
27          enter into binding contracts satisfactory to the local government, or to take  
28          other lawful action prescribed by the local government. The local  
29          government may prescribe the period of time during which the developer's  
30          commitment shall be binding.
- 31          (3)    When used in this section, the following terms have the meanings indicated:
- 32           a.    "Density bonus" means an increase in the number of housing units  
33           allowed on the tract of land upon which the development is located,  
34           when compared to the maximum number of housing units which  
35           would be allowed on the tract of land in the absence of the density  
36           bonus. It may also include increases in permitted square footage or  
37           floor area ratios.
- 38           b.    "Low and moderate income" has the meaning prescribed by the  
39           regulations of the United States Department of Housing and Urban  
40           Development applicable to the local government. In the absence of  
41           such regulations, the term "low and moderate income" shall have the  
42           meaning prescribed by the governing board by ordinance or  
43           resolution. The term "low and moderate" shall also be construed to  
44           mean low or moderate income.

45    **§ 160D-7-5. Quasi-judicial zoning decisions.**

46       (a)    Provisions of Ordinance. – The zoning regulation or unified development ordinance  
47       may provide that the board of adjustment, planning board, or governing board hear and decide  
48       quasi-judicial zoning decisions. The board shall follow quasi-judicial procedures as specified in  
49       G.S. 160D-4-6 when making any quasi-judicial decision.

50       (b)    Appeals. – Except as otherwise provided by this Chapter, the board of adjustment  
51       shall hear and decide appeals from staff decisions regarding administration and enforcement of

1 the zoning or unified development ordinance and may hear appeals arising out of any other  
2 ordinance that regulates land use or development. The provisions of G.S. 160D-4-5 and  
3 G.S. 105-4-6 are applicable to these appeals.

4 (c) Special Use Permits. – The ordinance may provide that the board of adjustment,  
5 planning board, or governing board hear and decide special use permits in accordance with  
6 standards and procedures specified in the ordinance. Reasonable and appropriate conditions  
7 may be imposed upon these permits. The ordinance may provide that defined minor  
8 modifications to special use permits that do not involve a change in uses permitted or the  
9 density of overall development permitted may be reviewed and approved administratively. Any  
10 other modification or revocation of a special use permit shall follow the same process for  
11 approval as is applicable to the approval of a special use permit. If multiple parcels of land are  
12 subject to a special use permit, the owners of individual parcels may apply for permit  
13 modification so long as the modification would not result in other properties failing to meet the  
14 terms of the special use permit or regulations. Any modifications approved shall only be  
15 applicable to those properties whose owners apply for the modification. The ordinance may  
16 require that special use permits be recorded with the Register of Deeds.

17 (d) Variances. – When unnecessary hardships would result from carrying out the strict  
18 letter of a zoning regulation, the board of adjustment shall vary any of the provisions of the  
19 zoning regulation upon a showing of all of the following:

20 (1) Unnecessary hardship would result from the strict application of the  
21 regulation. It shall not be necessary to demonstrate that, in the absence of the  
22 variance, no reasonable use can be made of the property.

23 (2) The hardship results from conditions that are peculiar to the property, such  
24 as location, size, or topography. Hardships resulting from personal  
25 circumstances, as well as hardships resulting from conditions that are  
26 common to the neighborhood or the general public, may not be the basis for  
27 granting a variance.

28 (3) The hardship did not result from actions taken by the applicant or the  
29 property owner. The act of purchasing property with knowledge that  
30 circumstances exist that may justify the granting of a variance shall not be  
31 regarded as a self-created hardship.

32 (4) The requested variance is consistent with the spirit, purpose, and intent of  
33 the ordinance, such that public safety is secured, and substantial justice is  
34 achieved.

35 No change in permitted uses may be authorized by variance. Appropriate conditions may be  
36 imposed on any variance, provided that the conditions are reasonably related to the variance.  
37 Any other ordinance that regulates land use or development may provide for variances  
38 consistent with the provisions of this subsection.

39 **"§ 160D-7-6. Zoning conflicts with other development standards.**

40 When regulations made under authority of this Article require a greater width or size of  
41 yards or buffers, or require a lower height of a building or fewer number of stories, or require a  
42 greater percentage of a lot to be left unoccupied, or impose other higher standards than are  
43 required in any other statute or local ordinance or regulation, the regulations made under  
44 authority of this Article shall govern. When the provisions of any other statute or local  
45 ordinance or regulation require a greater width or size of yards or buffers, or require a lower  
46 height of a building or a fewer number of stories, or require a greater percentage of a lot to be  
47 left unoccupied, or impose other higher standards than are required by the regulations made  
48 under authority of this Article, the provisions of that statute or local ordinance or regulation  
49 shall govern.

50 **"§ 160D-7-7. Other statutes not repealed.**

1 This Article shall not repeal any zoning act or city or county planning act, local or general,  
2 now in force, except those that are repugnant to or inconsistent herewith. This Article shall be  
3 construed to be an enlargement of the duties, powers, and authority contained in other laws  
4 authorizing the appointment and proper functioning of planning commissions or zoning  
5 commissions by any local government.

6 "Article 8.

7 "Subdivision Regulation.

8 "**§ 160D-8-1. Authority.**

9 A local government may by ordinance regulate the subdivision of land within its planning  
10 and development regulation jurisdiction. In addition to final plat approval, the ordinance may  
11 include provisions for review and approval of sketch plans and preliminary plats. The  
12 regulation may provide for different review procedures for different classes of subdivisions.  
13 Decisions on approval or denial of preliminary or final plats may be made only on the basis of  
14 standards explicitly set forth in the subdivision or unified development ordinance. Whenever  
15 the regulation includes criteria for decisions that require application of discretion, those criteria  
16 must provide adequate guiding standards, and the quasi-judicial procedures set forth in  
17 G.S. 160D-4-6 must be followed.

18 "**§ 160D-8-2. Applicability.**

19 (a) For the purpose of this Article, subdivision regulations shall be applicable to all  
20 divisions of a tract or parcel of land into two or more lots, building sites, or other divisions  
21 when any one or more of those divisions is created for the purpose of sale or building  
22 development (whether immediate or future) and shall include all divisions of land involving the  
23 dedication of a new street or a change in existing streets; but the following shall not be included  
24 within this definition nor be subject to the regulations authorized by this Article:

- 25 (1) The combination or recombination of portions of previously subdivided and  
26 recorded lots where the total number of lots is not increased and the resultant  
27 lots are equal to or exceed the standards of the local government as shown in  
28 its subdivision regulations.
- 29 (2) The division of land into parcels greater than 10 acres where no street  
30 right-of-way dedication is involved.
- 31 (3) The public acquisition by purchase of strips of land for the widening or  
32 opening of streets or for public transportation system corridors.
- 33 (4) The division of a tract in single ownership whose entire area is no greater  
34 than two acres into not more than three lots, where no street right-of-way  
35 dedication is involved and where the resultant lots are equal to or exceed the  
36 standards of the local government, as shown in its subdivision regulations.

37 (b) A local government may provide for expedited review of specified classes of  
38 subdivisions.

39 "**§ 160D-8-3. Review process, filing, and recording of subdivision plats.**

40 (a) Any subdivision regulation adopted pursuant to this Article shall contain provisions  
41 setting forth the procedures and standards to be followed in granting or denying approval of a  
42 subdivision plat prior to its registration.

43 (b) A subdivision regulation shall provide that the following agencies be given an  
44 opportunity to make recommendations concerning an individual subdivision plat before the plat  
45 is approved:

- 46 (1) The district highway engineer as to proposed State streets, State highways,  
47 and related drainage systems.
- 48 (2) The county health director or local public utility, as appropriate, as to  
49 proposed water or sewerage systems.
- 50 (3) Any other agency or official designated by the governing board.



1       (c)     The subdivision regulation may provide that final decisions on preliminary plats and  
2 final plats are to be made by:

3           (1)     The governing board,

4           (2)     The governing board on recommendation of a designated body, or

5           (3)     A designated planning board, technical review committee of local  
6 government staff members, or other designated body or staff person.

7       If the final decision on a subdivision plat is administrative, the decision may be assigned to  
8 a staff person or committee comprised entirely of staff persons. If the final decision on a  
9 subdivision plat is quasi-judicial, the decision shall be assigned to the governing board, the  
10 planning board, or other appointed board, and the procedures set forth in G.S. 160D-4-6 shall  
11 apply.

12       (d)     After the effective date that a subdivision regulation is adopted, no subdivision local  
13 government's planning and development regulation jurisdiction shall be filed or recorded until  
14 it shall have been submitted to and approved by the governing board or appropriate body, as  
15 specified in the subdivision ordinance, and until this approval shall have been entered on the  
16 face of the plat in writing by an authorized representative of the local government. The Review  
17 Officer, pursuant to G.S. 47-30.2, shall not certify a subdivision plat that has not been approved  
18 in accordance with these provisions nor shall the clerk of superior court order or direct the  
19 recording of a plat if the recording would be in conflict with this section.

20       **"§ 160D-8-4. Contents and requirements of ordinance.**

21       (a)     Purposes. A subdivision regulation may provide for the orderly growth and  
22 development of the local government; for the coordination of transportation networks and  
23 utilities within proposed subdivisions with existing or planned streets and highways and with  
24 other public facilities; and for the distribution of population and traffic in a manner that will  
25 avoid congestion and overcrowding and will create conditions that substantially promote public  
26 health, safety, and the general welfare.

27       (b)     Plats. The regulation may require a plat be prepared, approved, and recorded  
28 pursuant to the provisions of the regulation whenever any subdivision of land takes place. The  
29 regulation may include requirements that plats show sufficient data to determine readily and  
30 reproduce accurately on the ground the location, bearing, and length of every street and alley  
31 line, lot line, easement boundary line, and other property boundaries, including the radius and  
32 other data for curved property lines, to an appropriate accuracy and in conformance with good  
33 surveying practice.

34       (c)     Impact Mitigation Measures.

35           (1)     Scope of impact mitigation. The nature and extent of impact mitigation  
36 required by a development regulation shall be rationally related to and no  
37 greater than an amount roughly proportional to the impacts reasonably  
38 expected to be generated by the proposed development. Only those impact  
39 mitigation measures expressly authorized by law may be required.

40           (2)     Transportation and utilities. The regulation may provide for the dedication of  
41 rights-of-way or easements for street and utility purposes, including the  
42 dedication of rights-of-way pursuant to G.S. 136-66.10 or G.S. 136-66.11,  
43 and the construction of such transportation facilities and utilities.

44                 The regulation may provide that, in lieu of required street construction,  
45 funds provided to the city may be used for the construction of roads to serve  
46 the occupants, residents, or invitees of the subdivision or development, and  
47 these funds may be used for roads which serve more than one subdivision or  
48 development within the area. All funds received by the city pursuant to this  
49 subsection shall be used only for development of roads, including design,  
50 land acquisition, and construction. However, a city may undertake these  
51 activities in conjunction with the Department of Transportation under an

1 agreement between the city and the Department of Transportation. Any  
2 formula adopted to determine the amount of funds required to be paid in lieu  
3 of street construction shall be based on the trips generated from the  
4 subdivision or development. The regulation may require a combination of  
5 partial payment of funds and partial dedication of constructed streets when  
6 the governing board of the city determines that a combination is in the best  
7 interests of the citizens of the area to be served.

- 8 (3) Recreation areas and open space. The regulation may provide for the  
9 dedication or reservation of recreation areas serving residents of the  
10 immediate neighborhood within the subdivision or, alternatively, for  
11 payment of funds to be used to acquire recreation areas serving residents of  
12 the development or subdivision or more than one subdivision or  
13 development within the immediate area.

14 The regulation may require that a developer provide funds to the local  
15 government so that the local government may acquire or develop  
16 recreational land or areas to serve the development or subdivision, including  
17 the purchase of land that may be used to serve more than one subdivision or  
18 development within the immediate area. All funds received by the local  
19 government pursuant to this paragraph shall be used only for the acquisition  
20 or development of recreation, park, or open space sites. Any formula enacted  
21 to determine the amount of funds that are to be provided under this  
22 paragraph shall be based on the value of the development or subdivision for  
23 property tax purposes. The regulation may allow a combination or partial  
24 payment of funds and partial dedication of land when the governing board  
25 determines that this combination is in the best interests of the citizens of the  
26 area to be served.

- 27 (4) Community service facilities. The regulation may provide for the more  
28 orderly development of subdivisions by requiring the construction of  
29 community service facilities in accordance with local government plans,  
30 policies, and standards.

- 31 (5) Fees in lieu. When a dedication of land or construction of facilities is  
32 expressly authorized by this section, a regulation may allow for substitution  
33 of a payment in lieu of the dedication or construction. If a method of  
34 calculating the fee is not provided by this section, the fee required shall be  
35 no more than an amount generally equivalent to the cost of the dedication or  
36 construction that would otherwise be required.

- 37 (6) School sites. Unless expressly authorized by law, a local government may  
38 not impose a school impact fee as an impact mitigation measure. The  
39 regulation may provide for the reservation of school sites in accordance with  
40 plans approved by the governing board. In order for this authorization to  
41 become effective, before approving such plans the governing board and the  
42 board of education with jurisdiction over the area shall jointly determine the  
43 location and size of any school sites to be reserved. Whenever a subdivision  
44 is submitted for approval which includes part or all of a school site to be  
45 reserved under the plan, the governing board shall immediately notify the  
46 board of education, and the board of education shall promptly decide  
47 whether it still wishes the site to be reserved. If the board of education does  
48 not wish to reserve the site, it shall so notify the governing board, and no site  
49 shall be reserved. If the board of education does wish to reserve the site, the  
50 subdivision or site plan shall not be approved without such reservation. The  
51 board of education shall then have 18 months beginning on the date of final

1 approval of the subdivision or site plan within which to acquire the site by  
2 purchase or by initiating condemnation proceedings. If the board of  
3 education has not purchased or begun proceedings to condemn the site  
4 within 18 months, the landowner may treat the land as freed of the  
5 reservation.

6 (d) Performance Guarantees. To assure compliance with these and other development  
7 regulation requirements, the regulation may provide for performance guarantees to assure  
8 successful completion of required improvements. If a performance guarantee is required, the  
9 local government shall provide a range of options of types of performance guarantees,  
10 including, but not limited to, surety bonds or letters of credit, from which the person required to  
11 give the performance guarantee may choose. For any specific development, the type of  
12 performance guarantee from the range specified by the local government shall be at the election  
13 of the person required to give the performance guarantee.

14 **"§ 160D-8-5. Notice of new subdivision fees and fee increases; public comment period.**

15 (a) A local government shall provide notice to interested parties of the imposition of or  
16 increase in fees or charges applicable solely to the construction of development subject to this  
17 Article at least seven days prior to the first meeting where the imposition of or increase in the  
18 fees or charges is on the agenda for consideration. The local government shall employ at least  
19 two of the following means of communication in order to provide the notice required by this  
20 section:

- 21 (1) Notice of the meeting in a prominent location on a Web site managed or  
22 maintained by the local government.
- 23 (2) Notice of the meeting in a prominent physical location, including, but not  
24 limited to, any government building, library, or courthouse within the  
25 planning and development regulation jurisdiction of the local government.
- 26 (3) Notice of the meeting by electronic mail or other reasonable means to a list  
27 of interested parties that is created by the local government for the purpose  
28 of notification as required by this section.

29 If a city does not maintain its own Web site, it may employ the notice option provided by  
30 subdivision (1) of subsection (a) of this section by submitting a request to a county or counties  
31 in which the city is located to post such notice in a prominent location on a Web site that is  
32 maintained by the county or counties. Any city that elects to provide such notice shall make its  
33 request to the county or counties at least 15 days prior to the date of the first meeting where the  
34 imposition of or increase in the fees or charges is on the agenda for consideration.

35 (b) During the consideration of the imposition of or increase in fees or charges as  
36 provided in subsection (a) of this section, the governing board of the local government shall  
37 permit a period of public comment.

38 (c) This section shall not apply if the imposition of or increase in fees or charges is  
39 contained in a budget filed in accordance with the requirements of G.S. 159-12.

40 **"§ 160D-8-6. Effect of plat approval on dedications.**

41 The approval of a plat shall not be deemed to constitute or affect the acceptance by the local  
42 government or public of the dedication of any street or other ground, public utility line, or other  
43 public facility shown on the plat. However, any governing board may by resolution accept any  
44 dedication made to the public of lands or facilities for streets, parks, public utility lines, or other  
45 public purposes, when the lands or facilities are located within its planning and development  
46 regulation jurisdiction. Acceptance of dedication of lands or facilities located within the  
47 planning and development regulation jurisdiction but outside the corporate limits of a city shall  
48 not place on the city any duty to open, operate, repair, or maintain any street, utility line, or  
49 other land or facility, and a city shall in no event be held to answer in any civil action or  
50 proceeding for failure to open, repair, or maintain any street located outside its corporate limits.  
51 Unless a city, county, or other public entity operating a water system shall have agreed to begin

1 operation and maintenance of the water system or water system facilities within one year of the  
2 time of issuance of a certificate of occupancy for the first unit of housing in the subdivision, a  
3 city or county shall not, as part of its subdivision regulation applied to facilities or land outside  
4 the corporate limits of a city, require dedication of water systems or facilities as a condition for  
5 subdivision approval.

6 **"§ 160D-8-7. Penalties for transferring lots in unapproved subdivisions.**

7 (a) If a local government adopts a subdivision regulation, any person who, being the  
8 owner or agent of the owner of any land located within the planning and development  
9 regulation jurisdiction of that local government, thereafter subdivides his land in violation of  
10 the ordinance or transfers or sells land by reference to, exhibition of, or any other use of a plat  
11 showing a subdivision of the land before the plat has been properly approved under such  
12 ordinance and recorded in the office of the appropriate Register of Deeds, shall be guilty of a  
13 Class 1 misdemeanor. The description by metes and bounds in the instrument of transfer or  
14 other document used in the process of selling or transferring land shall not exempt the  
15 transaction from this penalty. The local government may bring an action for injunction of any  
16 illegal subdivision, transfer, conveyance, or sale of land, and the court shall, upon appropriate  
17 findings, issue an injunction and order requiring the offending party to comply with the  
18 subdivision ordinance. Building permits required pursuant to G.S. 160D-11-8 may be denied  
19 for lots that have been illegally subdivided. In addition to other remedies, a local government  
20 may institute any appropriate action or proceedings to prevent the unlawful subdivision of land,  
21 to restrain, correct, or abate the violation, or to prevent any illegal act or conduct.

22 (b) The provisions of this section shall not prohibit any owner or its agent from entering  
23 into contracts to sell or lease by reference to an approved preliminary plat for which a final plat  
24 has not yet been properly approved under the subdivision ordinance or recorded with the  
25 Register of Deeds, provided the contract does all of the following:

- 26 (1) Incorporates as an attachment a copy of the preliminary plat referenced in  
27 the contract and obligates the owner to deliver to the buyer a copy of the  
28 recorded plat prior to closing and conveyance.
- 29 (2) Plainly and conspicuously notifies the prospective buyer or lessee that a final  
30 subdivision plat has not been approved or recorded at the time of the  
31 contract, that no governmental body will incur any obligation to the  
32 prospective buyer or lessee with respect to the approval of the final  
33 subdivision plat, that changes between the preliminary and final plats are  
34 possible, and that the contract or lease may be terminated without breach by  
35 the buyer or lessee if the final recorded plat differs in any material respect  
36 from the preliminary plat.
- 37 (3) Provides that if the approved and recorded final plat does not differ in any  
38 material respect from the plat referred to in the contract, the buyer or lessee  
39 may not be required by the seller or lessor to close any earlier than five days  
40 after the delivery of a copy of the final recorded plat.
- 41 (4) Provides that if the approved and recorded final plat differs in any material  
42 respect from the preliminary plat referred to in the contract, the buyer or  
43 lessee may not be required by the seller or lessor to close any earlier than 15  
44 days after the delivery of the final recorded plat, during which 15-day period  
45 the buyer or lessee may terminate the contract without breach or any further  
46 obligation and may receive a refund of all earnest money or prepaid  
47 purchase price.

48 (c) The provisions of this section shall not prohibit any owner or its agent from entering  
49 into contracts to sell or lease land by reference to an approved preliminary plat for which a final  
50 plat has not been properly approved under the subdivision ordinance or recorded with the  
51 Register of Deeds where the buyer or lessee is any person who has contracted to acquire or

1 lease the land for the purpose of engaging in the business of construction of residential,  
2 commercial, or industrial buildings on the land, or for the purpose of resale or lease of the land  
3 to persons engaged in that kind of business, provided that no conveyance of that land may  
4 occur and no contract to lease it may become effective until after the final plat has been  
5 properly approved under the subdivision ordinance and recorded with the Register of Deeds.

6 **"§ 160D-8-8. Appeals of decisions on subdivision plats.**

7 Appeals of subdivision decisions may be made pursuant to G.S. 160D-14-3.

8 "Article 9.

9 "Regulation of Particular Uses and Areas.

10 "Part 1. Particular Land Uses and Areas.

11 **"§ 160D-9-1. Regulation of particular uses and areas.**

12 A local government may regulate the uses and areas set forth in this Article in regulations  
13 adopted under this Chapter or in regulations adopted under Article 8 of Chapter 160A of the  
14 General Statutes or Article 6 of Chapter 153A of the General Statutes. This shall not be deemed  
15 to expand, diminish, or alter the scope of authority granted pursuant to those Articles. In all  
16 instances, the substance of the local government regulation shall be consistent with the  
17 provisions in this Article.

18 **"§ 160D-9-2. Adult businesses.**

19 (a) The General Assembly finds and determines that sexually oriented businesses can  
20 and do cause adverse secondary impacts on neighboring properties. Numerous studies relevant  
21 to North Carolina have found increases in crime rates and decreases in neighboring property  
22 values as a result of the location of sexually oriented businesses in inappropriate locations or  
23 from the operation of such businesses in an inappropriate manner. Reasonable local  
24 government regulation of sexually oriented businesses in order to prevent or ameliorate adverse  
25 secondary impacts is consistent with the federal constitutional protection afforded to  
26 nonobscene but sexually explicit speech.

27 (b) In addition to State laws on obscenity, indecent exposure, and adult establishments,  
28 local government regulation of the location and operation of sexually oriented businesses is  
29 necessary to prevent undue adverse secondary impacts that would otherwise result from these  
30 businesses.

31 (c) A local government may regulate sexually oriented businesses through zoning  
32 regulations, licensing requirements, or other appropriate local ordinances. The local  
33 government may require a fee for the initial license and any annual renewal. Such local  
34 regulations may include, but are not limited to:

35 (1) Restrictions on location of sexually oriented businesses, such as limitation to  
36 specified zoning districts and minimum separation from sensitive land uses  
37 and other sexually oriented businesses;

38 (2) Regulations on operation of sexually oriented businesses, such as limits on  
39 hours of operation, open booth requirements, limitations on exterior  
40 advertising and noise, age of patrons and employees, required separation of  
41 patrons and performers, clothing restrictions for masseuses, and clothing  
42 restrictions for servers of alcoholic beverages;

43 (3) Clothing restrictions for entertainers; and

44 (4) Registration and disclosure requirements for owners and employees with a  
45 criminal record other than minor traffic offenses, and restrictions on  
46 ownership by or employment of a person with a criminal record that includes  
47 offenses reasonably related to the legal operation of sexually oriented  
48 businesses.

49 (d) In order to preserve the status quo while appropriate studies are conducted and the  
50 scope of potential regulations is deliberated, local government may enact moratoria of  
51 reasonable duration on either the opening of any new businesses authorized to be regulated

1 under this section or the expansion of any such existing business. Businesses existing at the  
2 time of the effective date of regulations adopted under this section may be required to come  
3 into compliance with newly adopted regulations within an appropriate and reasonable period of  
4 time.

5 (e) Local governments may enter into cooperative agreements regarding coordinated  
6 regulation of sexually oriented businesses, including provision of adequate alternative sites for  
7 the location of constitutionally protected speech within an interrelated geographic area.

8 (f) For the purpose of this section, "sexually oriented business" means any business or  
9 enterprise that has as one of its principal business purposes or as a significant portion of its  
10 business an emphasis on matter and conduct depicting, describing, or related to anatomical  
11 areas and sexual activities specified in G.S. 14-202.10. Local governments may adopt detailed  
12 definitions of these and similar businesses in order to precisely define the scope of any local  
13 regulations.

14 **"§ 160D-9-3. Agricultural uses.**

15 (a) Bona Fide Farming Exempt from County Zoning. County zoning regulations may  
16 affect property used for bona fide farm purposes only as provided in this section. This section  
17 does not limit zoning regulation with respect to the use of farm property for nonfarm purposes.

18 Except as provided in G.S. 106-743.4 for farms that are subject to a conservation agreement  
19 under G.S. 106-743.2, bona fide farm purposes include the production and activities relating or  
20 incidental to the production of crops, grains, fruits, vegetables, ornamental and flowering  
21 plants, dairy, livestock, poultry, and all other forms of agriculture, as defined in  
22 G.S. 106-581.1. For purposes of this section, "when performed on the farm" in  
23 G.S. 106-581.1(6) shall include the farm within the jurisdiction of the county and any other  
24 farm owned or leased to or from others by the bona fide farm operator, no matter where  
25 located. For purposes of this section, the production of a nonfarm product that the Department  
26 of Agriculture and Consumer Services recognizes as a "Goodness Grows in North Carolina"  
27 product that is produced on a farm subject to a conservation agreement under G.S. 106-743.2 is  
28 a bona fide farm purpose. For purposes of determining whether a property is being used for  
29 bona fide farm purposes, any of the following shall constitute sufficient evidence that the  
30 property is being used for bona fide farm purposes:

- 31 (1) A farm sales tax exemption certificate issued by the Department of Revenue.
- 32 (2) A copy of the property tax listing showing that the property is eligible for  
33 participation in the present use value program pursuant to G.S. 105-277.3.
- 34 (3) A copy of the farm owner's or operator's Schedule F from the owner's or  
35 operator's most recent federal income tax return.
- 36 (4) A forest management plan.
- 37 (5) A Farm Identification Number issued by the United States Department of  
38 Agriculture Farm Service Agency.

39 The definitions set out in G.S. 106-802 apply to this section. A county may adopt zoning  
40 regulations governing swine farms served by animal waste management systems having a  
41 design capacity of 600,000 pounds steady state live weight (SSLW) or greater provided that the  
42 zoning regulations may not have the effect of excluding swine farms served by an animal waste  
43 management system having a design capacity of 600,000 pounds SSLW or greater from the  
44 entire zoning jurisdiction.

45 (b) County Zoning of Residential Uses on Large Lots in Agricultural Districts. A  
46 county zoning regulation shall not prohibit single-family detached residential uses constructed  
47 in accordance with the North Carolina State Building Code on lots greater than 10 acres in size  
48 in zoning districts where more than fifty percent (50%) of the land is in use for agricultural or  
49 silvicultural purposes, except that this restriction shall not apply to commercial or industrial  
50 districts where a broad variety of commercial or industrial uses are permissible. An ordinance  
51 adopted pursuant to this section shall not require that a lot greater than 10 acres in size have

1 frontage on a public road or county-approved private road, or be served by public water or  
2 sewer lines, in order to be developed for single-family residential purposes.

3 (c) Agricultural Areas in Municipal Extraterritorial Jurisdiction. Property that is located  
4 in the geographic area of a municipality's extraterritorial planning and development regulation  
5 jurisdiction and that is used for bona fide farm purposes is exempt from the municipality's  
6 zoning regulation to the same extent bona fide farming activities are exempt from county  
7 zoning pursuant to this section. As used in this subsection, "property" means a single tract of  
8 property or an identifiable portion of a single tract. Property that ceases to be used for bona fide  
9 farm purposes shall become subject to exercise of the municipality's planning and development  
10 regulation jurisdiction under this Chapter. For purposes of complying with 44 C.F.R. Part 60,  
11 Subpart A, property that is exempt from the exercise of municipal extraterritorial planning and  
12 development regulation jurisdiction pursuant to this subsection shall be subject to the county's  
13 floodplain ordinance or all floodplain regulation provisions of the county's unified development  
14 ordinance.

15 (d) Accessory Farm Buildings. A municipality may provide in its zoning regulation that  
16 an accessory building of a "bona fide farm" has the same exemption from the building code as  
17 it would have under county zoning.

18 (e) City Regulations in Voluntary Agricultural Districts. A city may amend the  
19 ordinances applicable within its planning and development regulation jurisdiction to provide  
20 flexibility to farming operations that are located within a city or county voluntary agricultural  
21 district or enhanced voluntary agricultural district adopted under Article 61 of Chapter 106 of  
22 the General Statutes. Amendments to applicable ordinances may include provisions regarding  
23 on-farm sales, pick-your-own operations, road signs, agritourism, and other activities incident  
24 to farming.

25 **"§ 160D-9-4. Airport zoning.**

26 Any local government may enact and enforce airport zoning regulations pursuant to this  
27 Chapter or as authorized by Article 4 of Chapter 63 of the General Statutes. Airport zoning  
28 regulations for real property within six miles of any cargo airport complex site subject to  
29 regulation by the North Carolina Global TransPark Authority are governed by G.S. 63A-18.

30 **"§ 160D-9-5. Amateur radio antennas.**

31 A local government ordinance based on health, safety, or aesthetic considerations that  
32 regulates the placement, screening, or height of the antennas or support structures of amateur  
33 radio operators must reasonably accommodate amateur radio communications and must  
34 represent the minimum practicable regulation necessary to accomplish the purpose of the local  
35 government. A local government may not restrict antennas or antenna support structures of  
36 amateur radio operators to heights of 90 feet or lower unless the restriction is necessary to  
37 achieve a clearly defined health, safety, or aesthetic objective of the local government.

38 **"§ 160D-9-6. Family care homes.**

39 (a) The General Assembly finds it is the public policy of this State to provide persons  
40 with disabilities with the opportunity to live in a normal residential environment.

41 (b) As used in this section:

42 (1) "Family care home" means a home with support and supervisory personnel  
43 that provides room and board, personal care, and habilitation services in a  
44 family environment for not more than six resident persons with disabilities.

45 (2) "Person with disabilities" means a person with a temporary or permanent  
46 physical, emotional, or mental disability, including, but not limited to,  
47 mental retardation, cerebral palsy, epilepsy, autism, hearing and sight  
48 impairments, emotional disturbances, and orthopedic impairments, but not  
49 including mentally ill persons who are dangerous to others as defined in  
50 G.S. 122C-3(11)b.

1       (c) A family care home shall be deemed a residential use of property for zoning  
2 purposes and shall be a permissible use in all residential districts. No local government may  
3 require that a family care home, its owner, or operator obtain, because of the use, a special use  
4 permit or variance from any such zoning regulation; provided, however, that a local  
5 government may prohibit a family care home from being located within a one-half mile radius  
6 of an existing family care home.

7       (d) A family care home shall be deemed a residential use of property for the purposes of  
8 determining charges or assessments imposed by local governments or businesses for water,  
9 sewer, power, telephone service, cable television, garbage and trash collection, repairs or  
10 improvements to roads, streets, and sidewalks, and other services, utilities, and improvements.

11 **"§ 160D-9-7. Fraternities and sororities.**

12 A zoning or unified development ordinance may not differentiate in terms of the regulations  
13 applicable to fraternities or sororities between those fraternities or sororities that are approved  
14 or recognized by a college or university and those that are not.

15 **"§ 160D-9-8. Manufactured homes.**

16       (a) The General Assembly finds that manufactured housing offers affordable housing  
17 opportunities for low and moderate income residents of this State who could not otherwise  
18 afford to own their own home. The General Assembly further finds that some local  
19 governments have adopted zoning regulations which severely restrict the placement of  
20 manufactured homes. It is the intent of the General Assembly in enacting this section that local  
21 governments reexamine their land use practices to assure compliance with applicable statutes  
22 and case law, and consider allocating more residential land area for manufactured homes based  
23 upon local housing needs.

24       (b) For purposes of this section, the term "manufactured home" is defined as provided  
25 in G.S. 143-145(7).

26       (c) A local government may not adopt or enforce zoning regulations or other provisions  
27 which have the effect of excluding manufactured homes from the entire zoning jurisdiction.

28       (d) A local government may adopt and enforce appearance and dimensional criteria for  
29 manufactured homes. Such criteria shall be designed to protect property values, to preserve the  
30 character and integrity of the community or individual neighborhoods within the community,  
31 and to promote the health, safety, and welfare of area residents. The criteria shall be adopted by  
32 ordinance.

33       (e) In accordance with the local government's comprehensive plan and based on local  
34 housing needs, a local government may designate a manufactured home overlay district within  
35 a residential district. Such overlay district may not consist of an individual lot or scattered lots  
36 but shall consist of a defined area within which additional requirements or standards are placed  
37 upon manufactured homes.

38       (f) Nothing in this section shall be construed to preempt or supersede valid restrictive  
39 covenants running with the land. The terms "mobile home" and "trailer" in any valid restrictive  
40 covenants running with the land shall include the term "manufactured home" as defined in this  
41 section.

42 **"§ 160D-9-9. Modular homes.**

43 Development regulations adopted pursuant to this Chapter may impose construction and  
44 design standards for modular homes that are consistent with G.S. 143-139.1. A label or seal  
45 secured under G.S. 143-139.1 shall conclusively establish compliance with such design  
46 standards.

47 **"§ 160D-9-10. Outdoor advertising.**

48       (a) As used in this section, the term "off-premises outdoor advertising" includes  
49 off-premises outdoor advertising visible from the main-traveled way of any road.

50       (b) A local government may require the removal of an off-premises outdoor advertising  
51 sign that is nonconforming under a local ordinance and may regulate the use of off-premises



1 outdoor advertising within its planning and development regulation jurisdiction in accordance  
2 with the applicable provisions of this Chapter.

3 (c) A local government shall give written notice of its intent to require removal of  
4 off-premises outdoor advertising by sending a letter by certified mail to the last known address  
5 of the owner of the outdoor advertising and the owner of the property on which the outdoor  
6 advertising is located.

7 (d) No local government may enact or amend an ordinance of general applicability to  
8 require the removal of any nonconforming, lawfully erected off-premises outdoor advertising  
9 sign without the payment of monetary compensation to the owners of the off-premises outdoor  
10 advertising, except as provided below. The payment of monetary compensation is not required  
11 if:

12 (1) The local government and the owner of the nonconforming off-premises  
13 outdoor advertising enter into a relocation agreement pursuant to subsection  
14 (g) of this section.

15 (2) The local government and the owner of the nonconforming off-premises  
16 outdoor advertising enter into an agreement pursuant to subsection (k) of this  
17 section.

18 (3) The off-premises outdoor advertising is determined to be a public nuisance  
19 or detrimental to the health or safety of the populace.

20 (4) The removal is required for opening, widening, extending, or improving  
21 streets or sidewalks, or for establishing, extending, enlarging, or improving  
22 any of the public enterprises listed in G.S. 160A-311, and the local  
23 government allows the off-premises outdoor advertising to be relocated to a  
24 comparable location.

25 (5) The off-premises outdoor advertising is subject to removal pursuant to  
26 statutes, ordinances, or regulations generally applicable to the demolition or  
27 removal of damaged structures.

28 (e) Monetary compensation is the fair market value of the off-premises outdoor  
29 advertising in place immediately prior to its removal and without consideration of the effect of  
30 the ordinance or any diminution in value caused by the ordinance requiring its removal.  
31 Monetary compensation shall be determined based on:

32 (1) The factors listed in G.S. 105-317.1(a); and

33 (2) The listed property tax value of the property and any documents regarding  
34 value submitted to the taxing authority.

35 (f) If the parties are unable to reach an agreement under subsection (e) of this section  
36 on monetary compensation to be paid by the local government to the owner of the  
37 nonconforming off-premises outdoor advertising sign for its removal, and the local government  
38 elects to proceed with the removal of the sign, the local government may bring an action in  
39 superior court for a determination of the monetary compensation to be paid. In determining  
40 monetary compensation, the court shall consider the factors set forth in subsection (e) of this  
41 section. Upon payment of monetary compensation for the sign, the local government shall own  
42 the sign.

43 (g) In lieu of paying monetary compensation, a local government may enter into an  
44 agreement with the owner of a nonconforming off-premises outdoor advertising sign to relocate  
45 and reconstruct the sign. The agreement shall include the following:

46 (1) Provision for relocation of the sign to a site reasonably comparable to or  
47 better than the existing location. In determining whether a location is  
48 comparable or better, the following factors shall be taken into consideration:

49 a. The size and format of the sign.

50 b. The characteristics of the proposed relocation site, including  
51 visibility, traffic count, area demographics, zoning, and any

- 1                    uncompensated differential in the sign owner's cost to lease the  
2                    replacement site.
- 3                    c.     The timing of the relocation.
- 4                    (2)   Provision for payment by the local government of the reasonable costs of  
5                    relocating and reconstructing the sign, including:
- 6                    a.     The actual cost of removing the sign.
- 7                    b.     The actual cost of any necessary repairs to the real property for  
8                    damages caused in the removal of the sign.
- 9                    c.     The actual cost of installing the sign at the new location.
- 10                   d.     An amount of money equivalent to the income received from the  
11                   lease of the sign for a period of up to 30 days if income is lost during  
12                   the relocation of the sign.
- 13                   (h)   For the purposes of relocating and reconstructing a nonconforming off-premises  
14                   outdoor advertising sign pursuant to subsection (g) of this section, a local government,  
15                   consistent with the welfare and safety of the community as a whole, may adopt a resolution or  
16                   adopt or modify its ordinances to provide for the issuance of a permit or other approval,  
17                   including conditions as appropriate, or to provide for dimensional, spacing, setback, or use  
18                   variances as it deems appropriate.
- 19                   (i)   If a local government has offered to enter into an agreement to relocate a  
20                   nonconforming off-premises outdoor advertising sign pursuant to subsection (g) of this section,  
21                   and within 120 days after the initial notice by the local government the parties have not been  
22                   able to agree that the site or sites offered by the local government for relocation of the sign are  
23                   reasonably comparable to or better than the existing site, the parties shall enter into binding  
24                   arbitration to resolve their disagreements. Unless a different method of arbitration is agreed  
25                   upon by the parties, the arbitration shall be conducted by a panel of three arbitrators. Each party  
26                   shall select one arbitrator, and the two arbitrators chosen by the parties shall select the third  
27                   member of the panel. The American Arbitration Association rules shall apply to the arbitration  
28                   unless the parties agree otherwise.
- 29                   (j)   If the arbitration results in a determination that the site or sites offered by the local  
30                   government for relocation of the nonconforming sign are not comparable to or better than the  
31                   existing site, and the local government elects to proceed with the removal of the sign, the  
32                   parties shall determine the monetary compensation under subsection (e) of this section to be  
33                   paid to the owner of the sign. If the parties are unable to reach an agreement regarding  
34                   monetary compensation within 30 days of the receipt of the arbitrators' determination, and the  
35                   local government elects to proceed with the removal of the sign, then the local government may  
36                   bring an action in superior court for a determination of the monetary compensation to be paid  
37                   by the local government to the owner for the removal of the sign. In determining monetary  
38                   compensation, the court shall consider the factors set forth in subsection (e) of this section.  
39                   Upon payment of monetary compensation for the sign, the local government shall own the sign.
- 40                   (k)   Notwithstanding the provisions of this section, a local government and an  
41                   off-premises outdoor advertising sign owner may enter into a voluntary agreement allowing for  
42                   the removal of the sign after a set period of time in lieu of monetary compensation. A local  
43                   government may adopt an ordinance or resolution providing for a relocation, reconstruction, or  
44                   removal agreement.
- 45                   (l)   A local government has up to three years from the effective date of an ordinance  
46                   enacted under this section to pay monetary compensation to the owner of the off-premises  
47                   outdoor advertising provided the affected property remains in place until the compensation is  
48                   paid.
- 49                   (m)   This section does not apply to any ordinance in effect on the effective date of this  
50                   section. A local government may amend an ordinance in effect on the effective date of this  
51                   section to extend application of the ordinance to off-premises outdoor advertising located in

1 territory acquired by annexation or located in the extraterritorial jurisdiction of the city. A local  
2 government may repeal or amend an ordinance in effect on the effective date of this section so  
3 long as the amendment to the existing ordinance does not reduce the period of amortization in  
4 effect on the effective date of this section.

5 (n) The provisions of this section shall not be used to interpret, construe, alter, or  
6 otherwise modify the exercise of the power of eminent domain by an entity pursuant to Chapter  
7 40A of the General Statutes or Chapter 136 of the General Statutes.

8 (o) Nothing in this section shall limit a local government's authority to use amortization  
9 as a means of phasing out nonconforming uses other than off-premises outdoor advertising.

10 **"§ 160D-9-11. Public buildings.**

11 All of the provisions of local government zoning regulations are applicable to the erection,  
12 construction, and use of buildings or structures by the State of North Carolina and its political  
13 subdivisions.

14 Notwithstanding the provisions of any general or local law or ordinance, except as provided  
15 in Part 4 of Article 9 of this Chapter, no land owned by the State of North Carolina may be  
16 included within an overlay district or a conditional zoning district without approval of the  
17 Council of State or its delegee.

18 **"§ 160D-9-12. Solar collectors.**

19 (a) Except as provided in subsection (c) of this section, no local government ordinance  
20 shall prohibit, or have the effect of prohibiting, the installation of a solar collector that gathers  
21 solar radiation as a substitute for traditional energy for water heating, active space heating and  
22 cooling, passive heating, or generating electricity for a residential property, and no person shall  
23 be denied permission by a local government to install a solar collector that gathers solar  
24 radiation as a substitute for traditional energy for water heating, active space heating and  
25 cooling, passive heating, or generating electricity for a residential property. As used in this  
26 section, the term "residential property" means property where the predominant use is for  
27 residential purposes.

28 (b) This section does not prohibit an ordinance regulating the location or screening of  
29 solar collectors as described in subsection (a) of this section, provided the ordinance does not  
30 have the effect of preventing the reasonable use of a solar collector for a residential property.

31 (c) This section does not prohibit an ordinance that would prohibit the location of solar  
32 collectors as described in subsection (a) of this section that are visible by a person on the  
33 ground:

- 34 (1) On the facade of a structure that faces areas open to common or public  
35 access;
- 36 (2) On a roof surface that slopes downward toward the same areas open to  
37 common or public access that the facade of the structure faces; or
- 38 (3) Within the area set off by a line running across the facade of the structure  
39 extending to the property boundaries on either side of the facade, and those  
40 areas of common or public access faced by the structure.

41 (d) In any civil action arising under this section, the court may award costs and  
42 reasonable attorneys' fees to the prevailing party.

43 **"§ 160D-9-13. Temporary health care structures.**

44 (a) The following definitions apply in this section:

- 45 (1) Activities of daily living. – Bathing, dressing, personal hygiene, ambulation  
46 or locomotion, transferring, toileting, and eating.
- 47 (2) Caregiver. – An individual 18 years of age or older who (i) provides care for  
48 a mentally or physically impaired person and (ii) is a first or second degree  
49 relative of the mentally or physically impaired person for whom the  
50 individual is caring.

1           (3) First or second degree relative. – A spouse, lineal ascendant, lineal  
2 descendant, sibling, uncle, aunt, nephew, or niece and includes half, step,  
3 and in-law relationships.

4           (4) Mentally or physically impaired person. – A person who is a resident of this  
5 State and who requires assistance with two or more activities of daily living  
6 as certified in writing by a physician licensed to practice in this State.

7           (5) Temporary family health care structure. – A transportable residential  
8 structure, providing an environment facilitating a caregiver's provision of  
9 care for a mentally or physically impaired person, that (i) is primarily  
10 assembled at a location other than its site of installation, (ii) is limited to one  
11 occupant who shall be the mentally or physically impaired person, (iii) has  
12 no more than 300 gross square feet, and (iv) complies with applicable  
13 provisions of the State Building Code and G.S. 143-139.1(b). Placing the  
14 temporary family health care structure on a permanent foundation shall not  
15 be required or permitted.

16           (b) A local government shall consider a temporary family health care structure used by  
17 a caregiver in providing care for a mentally or physically impaired person on property owned  
18 or occupied by the caregiver as the caregiver's residence as a permitted accessory use in any  
19 single-family residential zoning district on lots zoned for single-family detached dwellings.

20           (c) A local government shall consider a temporary family health care structure used by  
21 an individual who is the named legal guardian of the mentally or physically impaired person a  
22 permitted accessory use in any single-family residential zoning district on lots zoned for  
23 single-family detached dwellings in accordance with this section if the temporary family health  
24 care structure is placed on the property of the residence of the individual and is used to provide  
25 care for the mentally or physically impaired person.

26           (d) Only one temporary family health care structure shall be allowed on a lot or parcel  
27 of land. The temporary family health care structures under subsections (b) and (c) of this  
28 section shall not require a special use permit or be subjected to any other local zoning  
29 requirements beyond those imposed upon other authorized accessory use structures, except  
30 otherwise provided in this section. Such temporary family health care structures shall comply  
31 with all setback requirements that apply to the primary structure and with any maximum floor  
32 area ratio limitations that may apply to the primary structure.

33           (e) Any person proposing to install a temporary family health care structure shall first  
34 obtain a permit from the local government. The local government may charge a fee of up to one  
35 hundred dollars (\$100.00) for the initial permit and an annual renewal fee of up to fifty dollars  
36 (\$50.00). The local government may not withhold a permit if the applicant provides sufficient  
37 proof of compliance with this section. The local government may require that the applicant  
38 provide evidence of compliance with this section on an annual basis as long as the temporary  
39 family health care structure remains on the property. The evidence may involve the inspection  
40 by the local government of the temporary family health care structure at reasonable times  
41 convenient to the caregiver, not limited to any annual compliance confirmation, and annual  
42 renewal of the doctor's certification.

43           (f) Notwithstanding subsection (i) of this section, any temporary family health care  
44 structure installed under this section may be required to connect to any water, sewer, and  
45 electric utilities serving the property and shall comply with all applicable State law, local  
46 ordinances, and other requirements, including Article 11 of this Chapter, as if the temporary  
47 family health care structure were permanent real property.

48           (g) No signage advertising or otherwise promoting the existence of the temporary  
49 health care structure shall be permitted either on the exterior of the temporary family health  
50 care structure or elsewhere on the property.

1       (h) Any temporary family health care structure installed pursuant to this section shall be  
2 removed within 60 days in which the mentally or physically impaired person is no longer  
3 receiving or is no longer in need of the assistance provided for in this section. If the temporary  
4 family health care structure is needed for another mentally or physically impaired person, the  
5 temporary family health care structure may continue to be used, or may be reinstated on the  
6 property within 60 days of its removal, as applicable.

7       (i) The local government may revoke the permit granted pursuant to subsection (e) of  
8 this section if the permit holder violates any provision of this section or G.S. 160A-202. The  
9 local government may seek injunctive relief or other appropriate actions or proceedings to  
10 ensure compliance with this section or G.S. 160A-202.

11       (j) Temporary family health care structures shall be treated as tangible personal  
12 property for purposes of taxation.

13 **"§ 160D-9-14. Streets and transportation.**

14       (a) Street Setbacks and Driveway Connection Regulations. Local governments may  
15 establish street setback and driveway connection regulations as a part of ordinances adopted  
16 pursuant to this Chapter or may do so pursuant to G.S. 160A-306 and G.S. 160A-307.

17       (b) Transportation Corridor Official Maps. Any local government may establish official  
18 transportation corridor maps and may enact and enforce ordinances pursuant to Article 2E of  
19 Chapter 136 of the General Statutes.

20                               "Part 2. Environmental Regulations.

21 **"§ 160D-9-20. Local environmental regulations.**

22       (a) Local governments are authorized to exercise the powers conferred by Article 8 of  
23 Chapter 160A of the General Statutes and Article 6 of Chapter 153A of the General Statutes to  
24 adopt and enforce local ordinances pursuant to this Part to the extent necessary to comply with  
25 State and federal law, rules and regulations, or permits consistent with the interpretations and  
26 directions of the State or federal agency issuing the permit.

27       (b) Local environmental regulations adopted pursuant to this Part are not subject to the  
28 variance provisions of G.S. 160D-7-5 unless that is specifically authorized by the local  
29 ordinance.

30 **"§ 160D-9-21. Forestry activities.**

31       (a) The following definitions apply to this section:

32       (1) Development. – Any activity, including timber harvesting, that is associated  
33 with the conversion of forestland to nonforest use.

34       (2) Forest management plan. – A document that defines a landowner's forest  
35 management objectives and describes specific measures to be taken to  
36 achieve those objectives. A forest management plan shall include  
37 silvicultural practices that both ensure optimal forest productivity and  
38 environmental protection of land by either commercially growing timber  
39 through the establishment of forest stands or by ensuring the proper  
40 regeneration of forest stands to commercial levels of production after the  
41 harvest of timber.

42       (3) Forestland. – Land that is devoted to growing trees for the production of  
43 timber, wood, and other forest products.

44       (4) Forestry. – The professional practice embracing the science, business, and  
45 art of creating, conserving, and managing forests and forestland for the  
46 sustained use and enjoyment of their resources, materials, or other forest  
47 products.

48       (5) Forestry activity. – Any activity associated with the growing, managing,  
49 harvesting, and related transportation, reforestation, or protection of trees  
50 and timber, provided that such activities comply with existing State rules and  
51 regulations pertaining to forestry.

1       **(b)** A local government shall not adopt or enforce any ordinance, rule, regulation, or  
2 resolution that regulates either:

3           **(1)** Forestry activity on forestland that is taxed on the basis of its present-use  
4 value as forestland under Article 12 of Chapter 105 of the General Statutes.

5           **(2)** Forestry activity that is conducted in accordance with a forest management  
6 plan that is prepared or approved by a forester registered in accordance with  
7 Chapter 89B of the General Statutes.

8       **(c)** This section shall not be construed to limit, expand, or otherwise alter the authority  
9 of a local government to:

10           **(1)** Regulate activity associated with development. A local government may  
11 deny a building permit or refuse to approve a site or subdivision plan for  
12 either a period of up to:

13           **a.** Three years after the completion of a timber harvest if the harvest  
14 results in the removal of all or substantially all of the trees that were  
15 protected under local government regulations governing development  
16 from the tract of land for which the permit or approval is sought.

17           **b.** Five years after the completion of a timber harvest if the harvest  
18 results in the removal of all or substantially all of the trees that were  
19 protected under local government regulations governing development  
20 from the tract of land for which the permit or approval is sought and  
21 the harvest was a willful violation of the local government  
22 regulations.

23           **(2)** Regulate trees pursuant to any local act of the General Assembly.

24           **(3)** Adopt ordinances that are necessary to comply with any federal or State law,  
25 regulation, or rule.

26           **(4)** Exercise its planning or zoning authority under this Chapter.

27           **(5)** Regulate and protect streets.

28 **"§ 160D-9-21. Erosion and sedimentation control.**

29 Any local government may enact and enforce erosion and sedimentation control ordinances  
30 as authorized by Article 4 of Chapter 113A of the General Statutes and shall comply with all  
31 applicable provisions of that Article and, to the extent not inconsistent with that Article, with  
32 this Chapter.

33 **"§ 160D-9-22. Floodplain regulations.**

34 Any local government may enact and enforce floodplain regulation or flood damage  
35 prevention regulation ordinances as authorized by Part 6 of Article 21 of Chapter 143 of the  
36 General Statutes and shall comply with all applicable provisions of that Part and, to the extent  
37 not inconsistent with that Article, with this Chapter.

38 **"§ 160D-9-23. Mountain ridge protection.**

39 Any local government may enact and enforce mountain ridge protection ordinances  
40 pursuant to Article 14 of Chapter 113A of the General Statutes and shall comply with all  
41 applicable provisions of that Article and, to the extent not inconsistent with that Article, with  
42 this Chapter unless the local government has removed itself from the coverage of Article 14 of  
43 Chapter 113A of the General Statutes through the procedure provided by law.

44 **"§ 160D-9-24. Stormwater control.**

45       **(a)** A local government may adopt and enforce a stormwater control ordinance to  
46 protect water quality and control water quantity. A local government may adopt a stormwater  
47 management ordinance pursuant to this Chapter, its charter, other applicable laws, or any  
48 combination of these powers.

49       **(b)** A federal, State, or local government project shall comply with the requirements of  
50 a local government stormwater control ordinance unless the federal, State, or local government  
51 agency has a National Pollutant Discharge Elimination System (NPDES) stormwater permit

1 that applies to the project. A local government may take enforcement action to compel a State  
2 or local government agency to comply with a stormwater control ordinance that implements the  
3 National Pollutant Discharge Elimination System (NPDES) stormwater permit issued to the  
4 local government. To the extent permitted by federal law, including Chapter 26 of Title 33 of  
5 the United States Code, a local government may take enforcement action to compel a federal  
6 government agency to comply with a stormwater control ordinance.

7 (c) A local government may implement illicit discharge detection and elimination  
8 controls, construction site stormwater runoff controls, and post-construction runoff controls  
9 through an ordinance or other regulatory mechanism to the extent allowable under State law.

10 (d) A local government that holds a National Pollutant Discharge Elimination System  
11 (NPDES) permit issued pursuant to G.S. 143-214.7 may adopt an ordinance, applicable within  
12 its planning and development regulation jurisdiction, to establish the stormwater control  
13 program necessary for the local government to comply with the permit. A local government  
14 may adopt an ordinance that bans illicit discharges within its planning and development  
15 regulation jurisdiction. A local government may adopt an ordinance, applicable within its  
16 planning and development regulation jurisdiction, that requires (i) deed restrictions and  
17 protective covenants to ensure that each project, including the stormwater management system,  
18 will be maintained so as to protect water quality and control water quantity and (ii) financial  
19 arrangements to ensure that adequate funds are available for the maintenance and replacement  
20 costs of the project.

21 (e) Unless the local government requests the permit condition in its permit application,  
22 the Environmental Management Commission may not require as a condition of a National  
23 Pollutant Discharge Elimination System (NPDES) stormwater permit issued pursuant to  
24 G.S. 143-214.7 that a city implement the measure required by 40 Code of Federal Regulations  
25 § 122.34(b)(3)(1 July 2003 Edition) in its extraterritorial jurisdiction.

26 "Part 3. Wireless Telecommunication Facilities.

27 **"§ 160D-9-30. Purpose and compliance with federal law.**

28 (a) The purpose of this section is to ensure the safe and efficient integration of facilities  
29 necessary for the provision of advanced mobile broadband and wireless telecommunications  
30 services throughout the community and to ensure the ready availability of reliable wireless  
31 service to the public, government agencies, and first responders, with the intention of furthering  
32 the public safety and general welfare.

33 (b) The deployment of wireless infrastructure is critical to ensuring first responders can  
34 provide for the health and safety of all residents of North Carolina and that, consistent with  
35 section 6409 of the federal Middle Class Tax Relief and Job Creation Act of 2012, 47 U.S.C. §  
36 1455(a), which creates a national wireless emergency communications network for use by first  
37 responders that in large measure will be dependent on facilities placed on existing wireless  
38 communications support structures, it is the policy of this State to facilitate the placement of  
39 wireless communications support structures in all areas of North Carolina. The following  
40 standards shall apply to a local government's actions, as a regulatory body, in the regulation of  
41 the placement, construction, or modification of a wireless communications facility.

42 (c) The placement, construction, or modification of wireless communications facilities  
43 shall be in conformity with the Federal Communications Act, 47 U.S.C. § 332 as amended,  
44 section 6409 of the federal Middle Class Tax Relief and Job Creation Act of 2012, 47 U.S.C. §  
45 1455(a), and in accordance with the rules promulgated by the Federal Communications  
46 Commission.

47 **"§ 160D-9-31. Definitions.**

48 The following definitions apply in this Part.

- 49 (1) **Antenna.** – Communications equipment that transmits, receives, or transmits  
50 and receives electromagnetic radio signals used in the provision of all types  
51 of wireless communications services.

- 1           (2)   Application. – A formal request submitted to the local government to  
2           construct or modify a wireless support structure or a wireless facility.
- 3           (3)   Base station. – A station at a specific site authorized to communicate with  
4           mobile stations, generally consisting of radio receivers, antennas, coaxial  
5           cables, power supplies, and other associated electronics.
- 6           (4)   Building permit. – An official administrative authorization issued by the  
7           local government prior to beginning construction consistent with the  
8           provisions of G.S. 160D-11-8.
- 9           (5)   Collocation. – The placement or installation of wireless facilities on existing  
10           structures, including electrical transmission towers, water towers, buildings,  
11           and other structures capable of structurally supporting the attachment of  
12           wireless facilities in compliance with applicable codes.
- 13           (6)   Eligible facilities request. – A request for modification of an existing  
14           wireless tower or base station that involves collocation of new transmission  
15           equipment or replacement of transmission equipment but does not include a  
16           substantial modification.
- 17           (7)   Equipment compound. – An area surrounding or near the base of a wireless  
18           support structure within which a wireless facility is located.
- 19           (8)   Fall zone. – The area in which a wireless support structure may be expected  
20           to fall in the event of a structural failure, as measured by engineering  
21           standards.
- 22           (9)   Land development regulation. – Any ordinance enacted pursuant to this  
23           Chapter.
- 24           (10)   Search ring. – The area within which a wireless support facility or wireless  
25           facility must be located in order to meet service objectives of the wireless  
26           service provider using the wireless facility or wireless support structure.
- 27           (11)   Substantial modification. – The mounting of a proposed wireless facility on  
28           a wireless support structure that substantially changes the physical  
29           dimensions of the support structure. A mounting is presumed to be a  
30           substantial modification if it meets any one or more of the criteria listed  
31           below. The burden is on the local government to demonstrate that a  
32           mounting that does not meet the listed criteria constitutes a substantial  
33           change to the physical dimensions of the wireless support structure.
- 34           a.    Increasing the existing vertical height of the structure by the greater  
35           of (i) more than ten percent (10%) or (ii) the height of one additional  
36           antenna array with separation from the nearest existing antenna not to  
37           exceed 20 feet.
- 38           b.    Except where necessary to shelter the antenna from inclement  
39           weather or to connect the antenna to the tower via cable, adding an  
40           appurtenance to the body of a wireless support structure that  
41           protrudes horizontally from the edge of the wireless support structure  
42           the greater of (i) more than 20 feet or (ii) more than the width of the  
43           wireless support structure at the level of the appurtenance.
- 44           c.    Increasing the square footage of the existing equipment compound  
45           by more than 2,500 square feet.
- 46           (12)   Utility pole. – A structure that is designed for and used to carry lines, cables,  
47           or wires for telephone, cable television, or electricity, or to provide lighting.
- 48           (13)   Water tower. – A water storage tank, a standpipe, or an elevated tank  
49           situated on a support structure originally constructed for use as a reservoir or  
50           facility to store or deliver water.



1           (14) Wireless facility. – The set of equipment and network components, exclusive  
2 of the underlying wireless support structure or tower, including antennas,  
3 transmitters, receivers, base stations, power supplies, cabling, and associated  
4 equipment necessary to provide wireless data and wireless  
5 telecommunications services to a discrete geographic area.

6           (15) Wireless support structure. – A new or existing structure, such as a  
7 monopole, lattice tower, or guyed tower that is designed to support or  
8 capable of supporting wireless facilities. A utility pole is not a wireless  
9 support structure.

10 **"§ 160D-9-32. Local authority.**

11           A local government may plan for and regulate the siting or modification of wireless support  
12 structures and wireless facilities in accordance with land development regulations and in  
13 conformity with this Part. Except as expressly stated, nothing in this Part shall limit a local  
14 government from regulating applications to construct, modify, or maintain wireless support  
15 structures, or construct, modify, maintain, or collocate wireless facilities on a wireless support  
16 structure based on consideration of land use, public safety, and zoning considerations,  
17 including aesthetics, landscaping, structural design, setbacks, and fall zones, or State and local  
18 building code requirements, consistent with the provisions of federal law provided in  
19 G.S. 160D-9-30. For purposes of this Part, public safety includes, without limitation, federal,  
20 State, and local safety regulations but does not include requirements relating to radio frequency  
21 emissions of wireless facilities.

22 **"§ 160D-9-33. Construction of new wireless support structures or substantial**  
23 **modifications of wireless support structures.**

24           (a) Any person that proposes to construct a new wireless support structure or  
25 substantially modify a wireless support structure within the planning and development  
26 regulation jurisdiction of a local government must do both of the following:

27           (1) Submit a completed application with the necessary copies and attachments to  
28 the appropriate planning authority.

29           (2) Comply with any local ordinances concerning land use and any applicable  
30 permitting processes.

31           (b) A local government's review of an application for the placement or construction of a  
32 new wireless support structure or substantial modification of a wireless support structure shall  
33 only address public safety, land development, or zoning issues. In reviewing an application, the  
34 local government may not require information on or evaluate an applicant's business decisions  
35 about its designed service, customer demand for its service, or quality of its service to or from a  
36 particular area or site. A local government may not require information that concerns the  
37 specific need for the wireless support structure, including if the service to be provided from the  
38 wireless support structure is to add additional wireless coverage or additional wireless capacity.  
39 A local government may not require proprietary, confidential, or other business information to  
40 justify the need for the new wireless support structure, including propagation maps and  
41 telecommunication traffic studies. In reviewing an application, the local government may  
42 review the following:

43           (1) Applicable public safety, land use, or zoning issues addressed in its adopted  
44 regulations, including aesthetics, landscaping, land use based location  
45 priorities, structural design, setbacks, and fall zones.

46           (2) Information or materials directly related to an identified public safety, land  
47 development, or zoning issue, including evidence that no existing or  
48 previously approved wireless support structure can reasonably be used for  
49 the wireless facility placement instead of the construction of a new wireless  
50 support structure; that residential, historic, and designated scenic areas  
51 cannot be served from outside the area; or that the proposed height of a new

1 wireless support structure or initial wireless facility placement or a proposed  
2 height increase of a substantially modified wireless support structure, or  
3 replacement wireless support structure is necessary to provide the applicant's  
4 designed service.

5 (3) A local government may require applicants for new wireless facilities to  
6 evaluate the reasonable feasibility of collocating new antennas and  
7 equipment on an existing wireless support structure or structures within the  
8 applicant's search ring. Collocation on an existing wireless support structure  
9 is not reasonably feasible if collocation is technically or commercially  
10 impractical or the owner of the existing wireless support structure is  
11 unwilling to enter into a contract for such use at fair market value. Local  
12 governments may require information necessary to determine whether  
13 collocation on existing wireless support structures is reasonably feasible.

14 (c) The local government shall issue a written decision approving or denying an  
15 application under this section within a reasonable period of time consistent with the issuance of  
16 other development approvals in the case of other applications, each as measured from the time  
17 the application is deemed complete.

18 (d) A local government may fix and charge an application fee, consulting fee, or other  
19 fee associated with the submission, review, processing, and approval of an application to site  
20 new wireless support structures or to substantially modify wireless support structures or  
21 wireless facilities that is based on the costs of the services provided and does not exceed what  
22 is usual and customary for such services. Any charges or fees assessed by a local government  
23 on account of an outside consultant shall be fixed in advance and incorporated into a permit or  
24 application fee and shall be based on the reasonable costs to be incurred by the local  
25 government in connection with the regulatory review authorized under this section. The  
26 foregoing does not prohibit a local government from imposing additional reasonable and  
27 cost-based fees for costs incurred should an applicant amend its application. On request, the  
28 amount of the consultant charges incorporated into the permit or application fee shall be  
29 separately identified and disclosed to the applicant. The fee imposed by a local government for  
30 review of the application may not be used for either of the following:

- 31 (1) Travel time or expenses, meals, or overnight accommodations incurred in  
32 the review of an application by a consultant or other third party.  
33 (2) Reimbursements for a consultant or other third party based on a contingent  
34 fee basis or a results-based arrangement.

35 (e) The local government may condition approval of an application for a new wireless  
36 support structure on the provision of documentation prior to the issuance of a building permit  
37 establishing the existence of one or more parties, including the owner of the wireless support  
38 structure, who intend to locate wireless facilities on the wireless support structure. A local  
39 government shall not deny an initial development approval based on such documentation. A  
40 local government may condition a development approval on a requirement to construct  
41 facilities within a reasonable period of time, which shall be no less than 24 months.

42 (f) The local government may not require the placement of wireless support structures  
43 or wireless facilities on local government owned or leased property but may develop a process  
44 to encourage the placement of wireless support structures or facilities on local government  
45 owned or leased property, including an expedited approval process.

46 (g) This section shall not be construed to limit the provisions or requirements of any  
47 historic district or landmark regulation adopted pursuant to this Article.

48 **"§ 160D-9-34. Collocation and eligible facilities requests of wireless support structures.**

49 (a) Pursuant to section 6409 of the federal Middle Class Tax Relief and Job Creation  
50 Act of 2012, 47 U.S.C. § 1455(a), a local government may not deny and shall approve any  
51 eligible facilities request as provided in this section. Nothing in this Part requires an application

1 and approval for routine maintenance or limits the performance of routine maintenance on  
2 wireless support structures and facilities, including in-kind replacement of wireless facilities.  
3 Routine maintenance includes activities associated with regular and general upkeep of  
4 transmission equipment, including the replacement of existing wireless facilities with facilities  
5 of the same size. A local government may require an application for collocation or an eligible  
6 facilities request.

7 (b) A collocation or eligible facilities request application is deemed complete unless the  
8 local government provides notice that the application is incomplete in writing to the applicant  
9 within 45 days of submission or within some other mutually agreed upon time frame. The  
10 notice shall identify the deficiencies in the application which, if cured, would make the  
11 application complete. A local government may deem an application incomplete if there is  
12 insufficient evidence provided to show that the proposed collocation or eligible facilities  
13 request will comply with federal, State, and local safety requirements. A local government may  
14 not deem an application incomplete for any issue not directly related to the actual content of the  
15 application and subject matter of the collocation or eligible facilities request. An application is  
16 deemed complete on resubmission if the additional materials cure the deficiencies indicated.

17 (c) The local government shall issue a written decision approving an eligible facilities  
18 request application within 45 days of such application being deemed complete. For a  
19 collocation application that is not an eligible facilities request, the local government shall issue  
20 its written decision to approve or deny the application within 45 days of the application being  
21 deemed complete.

22 (d) A local government may impose a fee not to exceed one thousand dollars (\$1,000)  
23 for technical consultation and the review of a collocation or eligible facilities request  
24 application. The fee must be based on the actual, direct, and reasonable administrative costs  
25 incurred for the review, processing, and approval of a collocation application. A local  
26 government may engage a third-party consultant for technical consultation and the review of a  
27 collocation application. The fee imposed by a local government for the review of the  
28 application may not be used for either of the following:

- 29 (1) Travel expenses incurred in a third-party's review of a collocation  
30 application.  
31 (2) Reimbursement for a consultant or other third party based on a contingent  
32 fee basis or results-based arrangement.

33 "Part 4. Historic Preservation.

34 **"§ 160D-9-40. Legislative findings.**

35 The historical heritage of our State is one of our most valued and important assets. The  
36 conservation and preservation of historic districts and landmarks stabilize and increase property  
37 values in their areas and strengthen the overall economy of the State. This Part authorizes local  
38 governments within their respective planning and development regulation jurisdictions and by  
39 means of listing, regulation, and acquisition:

- 40 (1) To safeguard the heritage of the city or county by preserving any district or  
41 landmark therein that embodies important elements of its culture, history,  
42 architectural history, or prehistory; and  
43 (2) To promote the use and conservation of such district or landmark for the  
44 education, pleasure, and enrichment of the residents of the city or county and  
45 the State as a whole.

46 **"§ 160D-9-41. Historic Preservation Commission.**

47 Before it may designate one or more landmarks or historic districts, a local government  
48 shall establish or designate a historic preservation commission in accordance with  
49 G.S. 160D-3-4.

50 **"§ 160D-9-42. Powers of the Historic Preservation Commission.**

1 A preservation commission established pursuant to this Chapter may, within the planning  
2 and development regulation jurisdiction of the local government:

- 3 (1) Undertake an inventory of properties of historical, prehistorical,  
4 architectural, and/or cultural significance;
- 5 (2) Recommend to the governing board areas to be designated by ordinance as  
6 "Historic Districts"; and individual structures, buildings, sites, areas, or  
7 objects to be designated by ordinance as "Landmarks";
- 8 (3) Acquire by any lawful means the fee or any lesser included interest,  
9 including options to purchase, to properties within established districts or to  
10 any such properties designated as landmarks; to hold, manage, preserve,  
11 restore, and improve such properties, and to exchange or dispose of the  
12 property by public or private sale, lease, or otherwise, subject to covenants  
13 or other legally binding restrictions which will secure appropriate rights of  
14 public access and promote the preservation of the property;
- 15 (4) Restore, preserve, and operate historic properties;
- 16 (5) Recommend to the governing board that designation of any area as a historic  
17 district or part thereof, or designation of any building, structure, site, area, or  
18 object as a landmark, be revoked or removed for cause;
- 19 (6) Conduct an educational program regarding historic properties and districts  
20 within its jurisdiction;
- 21 (7) Cooperate with the State, federal, and local governments in pursuance of the  
22 purposes of this Part. The governing board or the commission when  
23 authorized by the governing board may contract with the State, or the United  
24 States of America, or any agency of either, or with any other organization,  
25 provided the terms are not inconsistent with State or federal law;
- 26 (8) Enter, solely in performance of its official duties and only at reasonable  
27 times, upon private lands for examination or survey thereof. However, no  
28 member, employee, or agent of the commission may enter any private  
29 building or structure without the express consent of the owner or occupant  
30 thereof;
- 31 (9) Prepare and recommend the official adoption of a preservation element as  
32 part of the local government's comprehensive plan;
- 33 (10) Review and act upon proposals for alterations, demolitions, or new  
34 construction within historic districts, or for the alteration or demolition of  
35 designated landmarks, pursuant to this Part; and
- 36 (11) Negotiate at any time with the owner of a building, structure, site, area, or  
37 object for its acquisition or its preservation, when such action is reasonably  
38 necessary or appropriate.

39 **"§ 160D-9-43. Appropriations.**

40 A governing board is authorized to make appropriations to a historic preservation  
41 commission established pursuant to this Chapter in any amount determined necessary for the  
42 expenses of the operation of the commission and may make available any additional amounts  
43 necessary for the acquisition, restoration, preservation, operation, and management of historic  
44 buildings, structures, sites, areas, or objects designated as historic landmarks or within  
45 designated historic districts, or of land on which such buildings or structures are located, or to  
46 which they may be removed.

47 **"§ 160D-9-44. Designation of historic districts.**

48 (a) Any local government may, as part of a zoning or other development regulation  
49 enacted or amended pursuant to this Chapter, designate and from time to time amend one or  
50 more historic districts within the area subject to the ordinance. Historic districts established  
51 pursuant to this Part shall consist of areas which are deemed to be of special significance in

1 terms of their history, prehistory, architecture, and/or culture, and to possess integrity of design,  
2 setting, materials, feeling, and association.

3 Such ordinance may treat historic districts either as a separate use district classification or  
4 as districts which overlay other zoning districts. Where historic districts are designated as  
5 separate use districts, the zoning regulation may include as uses by right or as special uses  
6 those uses found by the Preservation Commission to have existed during the period sought to  
7 be restored or preserved, or to be compatible with the restoration or preservation of the district.

8 (b) No historic district or districts shall be designated under subsection (a) of this  
9 section until:

10 (1) An investigation and report describing the significance of the buildings,  
11 structures, features, sites, or surroundings included in any such proposed  
12 district, and a description of the boundaries of such district has been  
13 prepared; and

14 (2) The Department of Cultural Resources, acting through the State Historic  
15 Preservation Officer or his or her designee, shall have made an analysis of  
16 and recommendations concerning such report and description of proposed  
17 boundaries. Failure of the department to submit its written analysis and  
18 recommendations to the governing board within 30 calendar days after a  
19 written request for such analysis has been received by the Department of  
20 Cultural Resources shall relieve the governing board of any responsibility  
21 for awaiting such analysis, and the governing board may at any time  
22 thereafter take any necessary action to adopt or amend its zoning regulation.

23 (c) The governing board may also, in its discretion, refer the report and proposed  
24 boundaries under subsection (b) of this section to any local preservation commission or other  
25 interested body for its recommendations prior to taking action to amend the zoning regulation.  
26 With respect to any changes in the boundaries of such district subsequent to its initial  
27 establishment, or the creation of additional districts within the jurisdiction, the investigative  
28 studies and reports required by subdivision (1) of subsection (b) of this section shall be  
29 prepared by the preservation commission and shall be referred to the local planning board for  
30 its review and comment according to procedures set forth in the zoning regulation. Changes in  
31 the boundaries of an initial district or proposal for additional districts shall also be submitted to  
32 the Department of Cultural Resources in accordance with the provisions of subdivision (2) of  
33 subsection (b) of this section.

34 On receipt of these reports and recommendations, the local government may proceed in the  
35 same manner as would otherwise be required for the adoption or amendment of any appropriate  
36 zoning regulation.

37 (d) The provisions of G.S. 160D-9-10 apply to zoning or other development regulations  
38 pertaining to historic districts, and the authority under G.S. 160D-9-10(b) for the ordinance to  
39 regulate the location or screening of solar collectors may encompass requiring the use of  
40 plantings or other measures to ensure that the use of solar collectors is not incongruous with the  
41 special character of the district.

42 **"§ 160D-9-45. Designation of landmarks.**

43 Upon complying with G.S. 160D-9-46, the governing board may adopt and amend or repeal  
44 an ordinance designating one or more historic landmarks. No property shall be recommended  
45 for designation as a historic landmark unless it is deemed and found by the preservation  
46 commission to be of special significance in terms of its historical, prehistorical, architectural, or  
47 cultural importance, and to possess integrity of design, setting, workmanship, materials,  
48 feeling, and/or association.

49 The ordinance shall describe each property designated in the ordinance, the name or names  
50 of the owner or owners of the property, those elements of the property that are integral to its  
51 historical, architectural, or prehistorical value, including the land area of the property so

1 designated, and any other information the governing board deems necessary. For each building,  
2 structure, site, area, or object so designated as a historic landmark, the ordinance shall require  
3 that the waiting period set forth in this Part be observed prior to its demolition. For each  
4 designated landmark, the ordinance may also provide for a suitable sign on the property  
5 indicating that the property has been so designated. If the owner consents, the sign shall be  
6 placed upon the property. If the owner objects, the sign shall be placed on a nearby public  
7 right-of-way.

8 **"§ 160D-9-46. Required landmark designation procedures.**

9 As a guide for the identification and evaluation of landmarks, the commission shall  
10 undertake, at the earliest possible time and consistent with the resources available to it, an  
11 inventory of properties of historical, architectural, prehistorical, and cultural significance within  
12 its jurisdiction. Such inventories and any additions or revisions thereof shall be submitted as  
13 expeditiously as possible to the Office of Archives and History. No ordinance designating a  
14 historic building, structure, site, area, or object as a landmark nor any amendment thereto may  
15 be adopted, nor may any property be accepted or acquired by a preservation commission or the  
16 governing board, until all of the following procedural steps have been taken:

- 17 (1) The preservation commission shall (i) prepare and adopt rules of procedure  
18 and (ii) prepare and adopt principles and guidelines, not inconsistent with  
19 this Part, for altering, restoring, moving, or demolishing properties  
20 designated as landmarks.
- 21 (2) The preservation commission shall make or cause to be made an  
22 investigation and report on the historic, architectural, prehistorical,  
23 educational, or cultural significance of each building, structure, site, area, or  
24 object proposed for designation or acquisition. Such investigation or report  
25 shall be forwarded to the Office of Archives and History, North Carolina  
26 Department of Cultural Resources.
- 27 (3) The Department of Cultural Resources, acting through the State Historic  
28 Preservation Officer shall, upon request of the department or at the initiative  
29 of the preservation commission, be given an opportunity to review and  
30 comment upon the substance and effect of the designation of any landmark  
31 pursuant to this Part. Any comments shall be provided in writing. If the  
32 Department does not submit its comments or recommendation in connection  
33 with any designation within 30 days following receipt by the Department of  
34 the investigation and report of the commission, the preservation commission  
35 and any governing board shall be relieved of any responsibility to consider  
36 such comments.
- 37 (4) The preservation commission and the governing board shall hold a joint  
38 legislative hearing or separate legislative hearings on the proposed  
39 ordinance. Notice of the hearing shall be made as provided by  
40 G.S. 160D-6-1.
- 41 (5) Following the hearings, the governing board may adopt the ordinance as  
42 proposed, adopt the ordinance with any amendments it deems necessary, or  
43 reject the proposed ordinance.
- 44 (6) Upon adoption of the ordinance, the owners and occupants of each  
45 designated landmark shall be given written notice of such designation within  
46 a reasonable time. One copy of the ordinance and all amendments thereto  
47 shall be filed by the preservation commission in the office of the Register of  
48 Deeds of the county in which the landmark or landmarks are located. In the  
49 case of any landmark property lying within the planning and development  
50 jurisdiction of a city, a second copy of the ordinance and all amendments  
51 thereto shall be kept on file in the office of the city or town clerk and be

1 made available for public inspection at any reasonable time. A third copy of  
2 the ordinance and any amendments shall be given to the local government  
3 building inspector. The fact that a building, structure, site, area, or object has  
4 been designated a landmark shall be clearly indicated on all tax maps  
5 maintained by the local government for such period as the designation  
6 remains in effect.

7 (7) Upon the adoption of the landmarks ordinance or any amendment thereto, it  
8 shall be the duty of the preservation commission to give notice thereof to the  
9 tax supervisor of the county in which the property is located. The  
10 designation and any recorded restrictions upon the property limiting its use  
11 for preservation purposes shall be considered by the tax supervisor in  
12 appraising it for tax purposes.

13 **"§ 160D-9-47. Certificate of appropriateness required.**

14 (a) Certificate Required. From and after the designation of a landmark or a historic  
15 district, no exterior portion of any building or other structure, including masonry walls, fences,  
16 light fixtures, steps, and pavement, or other appurtenant features, nor above-ground utility  
17 structure nor any type of outdoor advertising sign shall be erected, altered, restored, moved, or  
18 demolished on such landmark or within such district until after an application for a certificate  
19 of appropriateness as to exterior features has been submitted to and approved by the  
20 preservation commission. The local government shall require such a certificate to be issued by  
21 the commission prior to the issuance of a building permit granted for the purposes of  
22 constructing, altering, moving, or demolishing structures, which certificate may be issued  
23 subject to reasonable conditions necessary to carry out the purposes of this Part. A certificate of  
24 appropriateness shall be required whether or not a building or other permit is required.

25 For purposes of this Part, "exterior features" shall include the architectural style, general  
26 design, and general arrangement of the exterior of a building or other structure, including the  
27 kind and texture of the building material, the size and scale of the building, and the type and  
28 style of all windows, doors, light fixtures, signs, and other appurtenant fixtures. In the case of  
29 outdoor advertising signs, "exterior features" shall be construed to mean the style, material,  
30 size, and location of all such signs. Such "exterior features" may, in the discretion of the local  
31 governing board, include historic signs, color, and significant landscape, archaeological, and  
32 natural features of the area.

33 Except as provided in subsection (b) of this section, the commission shall have no  
34 jurisdiction over interior arrangement. The commission shall take no action under this section  
35 except to prevent the construction, reconstruction, alteration, restoration, moving, or demolition  
36 of buildings, structures, appurtenant fixtures, outdoor advertising signs, or other significant  
37 features in the district which would be incongruous with the special character of the landmark  
38 or district.

39 (b) Interior Spaces. Notwithstanding subsection (a) of this section, jurisdiction of the  
40 commission over interior spaces shall be limited to specific interior features of architectural,  
41 artistic, or historical significance in publicly owned landmarks, and of privately owned historic  
42 landmarks for which consent for interior review has been given by the owner. Said consent of  
43 an owner for interior review shall bind future owners and/or successors in title, provided such  
44 consent has been filed in the office of the Register of Deeds of the county in which the property  
45 is located and indexed according to the name of the owner of the property in the grantee and  
46 grantor indexes. The landmark designation shall specify the interior features to be reviewed and  
47 the specific nature of the commission's jurisdiction over the interior.

48 (c) Rules And Standards. Prior to any action to enforce a landmark or historic district  
49 ordinance, the commission shall (i) prepare and adopt rules of procedure and (ii) prepare and  
50 adopt principles and standards not inconsistent with this Part for new construction, alterations,  
51 additions, moving, and demolition. The landmark or historic district ordinance may provide,

1 subject to prior adoption by the preservation commission of detailed standards, for staff review  
2 and approval as an administrative decision of applications for a certificate of appropriateness  
3 for minor work or activity as defined by ordinance; provided, however, that no application for a  
4 certificate of appropriateness may be denied without formal action by the preservation  
5 commission. Other than these administrative decisions on minor works, decisions on  
6 certificates of appropriateness are quasi-judicial and shall follow the procedures of  
7 G.S. 160D-4-6.

8 (d) Time for Review. All applications for certificates of appropriateness shall be  
9 reviewed and acted upon within a reasonable time, not to exceed 180 days from the date the  
10 application for a certificate of appropriateness is filed, as defined by the ordinance or the  
11 commission's rules of procedure. As part of its review procedure, the commission may view the  
12 premises and seek the advice of the Division of Archives and History or such other expert  
13 advice as it may deem necessary under the circumstances.

14 (e) Appeals. Appeals of administrative decisions allowed by ordinance may be made to  
15 the commission. All decisions of the commission in granting or denying a certificate of  
16 appropriateness may be appealed to the board of adjustment in the nature of certiorari within  
17 times prescribed for appeals of administrative decisions in G.S. 160D-4-5(c). Appeals from the  
18 board of adjustment may be made pursuant to G.S. 160D-14-1. Petitions for judicial review  
19 shall be taken within times prescribed for appeal of quasi-judicial decisions in G.S. 160D-14-4.  
20 Appeals in any such case shall be heard by the superior court of the county in which the local  
21 government is located.

22 (f) Public Buildings. All of the provisions of this Part are hereby made applicable to  
23 construction, alteration, moving, and demolition by the State of North Carolina, its political  
24 subdivisions, agencies, and instrumentalities, provided, however, they shall not apply to  
25 interiors of buildings or structures owned by the State of North Carolina. The State and its  
26 agencies shall have a right of appeal to the North Carolina Historical Commission or any  
27 successor agency assuming its responsibilities under G.S. 121-12(a) from any decision of a  
28 local preservation commission. The North Carolina Historical Commission shall render its  
29 decision within 30 days from the date that the notice of appeal by the State is received by it.  
30 The current edition of the Secretary of the Interior's Standards for Rehabilitation and  
31 Guidelines for Rehabilitating Historic Buildings shall be the sole principles and guidelines used  
32 in reviewing applications of the State for certificates of appropriateness. The decision of the  
33 North Carolina Historical Commission shall be final and binding upon both the State and the  
34 preservation commission.

35 **"§ 160D-9-48. Certain changes not prohibited.**

36 Nothing in this Part shall be construed to prevent the ordinary maintenance or repair of any  
37 exterior architectural feature in a historic district or of a landmark which does not involve a  
38 change in design, material, or appearance thereof, nor to prevent the construction,  
39 reconstruction, alteration, restoration, moving, or demolition of any such feature which the  
40 building inspector or similar official shall certify is required by the public safety because of an  
41 unsafe or dangerous condition. Nothing in this Part shall be construed to prevent a property  
42 owner from making any use of his property that is not prohibited by other law. Nothing in this  
43 Part shall be construed to prevent (i) the maintenance or, (ii) in the event of an emergency, the  
44 immediate restoration of any existing above-ground utility structure without approval by the  
45 preservation commission.

46 **"§ 160D-9-49. Delay in demolition of landmarks and buildings within historic district.**

47 (a) An application for a certificate of appropriateness authorizing the relocation,  
48 demolition, or destruction of a designated landmark or a building, structure, or site within the  
49 district may not be denied except as provided in subsection (c) of this section. However, the  
50 effective date of such a certificate may be delayed for a period of up to 365 days from the date  
51 of approval. The maximum period of delay authorized by this section shall be reduced by the



1 preservation commission where it finds that the owner would suffer extreme hardship or be  
2 permanently deprived of all beneficial use of or return from such property by virtue of the  
3 delay. During such period the preservation commission shall negotiate with the owner and with  
4 any other parties in an effort to find a means of preserving the building or site. If the  
5 preservation commission finds that a building or site within a district has no special  
6 significance or value toward maintaining the character of the district, it shall waive all or part  
7 of such period and authorize earlier demolition or removal.

8 If the preservation commission or planning board has voted to recommend designation of a  
9 property as a landmark or designation of an area as a district, and final designation has not been  
10 made by the governing board, the demolition or destruction of any building, site, or structure  
11 located on the property of the proposed landmark or in the proposed district may be delayed by  
12 the preservation commission or planning board for a period of up to 180 days or until the local  
13 governing board takes final action on the designation, whichever occurs first.

14 (b) The governing board may enact an ordinance to prevent the demolition by neglect  
15 of any designated landmark or any building or structure within an established historic district.  
16 Such ordinance shall provide appropriate safeguards to protect property owners from undue  
17 economic hardship.

18 (c) An application for a certificate of appropriateness authorizing the demolition or  
19 destruction of a building, site, or structure determined by the State Historic Preservation Officer  
20 as having statewide significance as defined in the criteria of the National Register of Historic  
21 Places may be denied except where the preservation commission finds that the owner would  
22 suffer extreme hardship or be permanently deprived of all beneficial use or return by virtue of  
23 the denial.

24 **"§ 160D-9-50. Demolition by neglect to contributing structures outside local historic**  
25 **districts.**

26 Notwithstanding G.S. 160D-9-49 or any other provision of law, the governing board may  
27 apply its demolition-by-neglect ordinances to contributing structures located outside the local  
28 historic district within an adjacent central business district. The governing board may modify  
29 and revise its demolition by neglect ordinances as necessary to implement this section and to  
30 further its intent. This section is applicable to any local government, provided such local  
31 government (i) has designated portions of the central business district and its adjacent historic  
32 district as an Urban Progress Zone as defined in G.S. 143B-437.09 and (ii) is recognized by the  
33 State Historic Preservation Office and the U.S. Department of the Interior as a Certified Local  
34 Government in accordance with the National Historic Preservation Act of 1966, as amended  
35 (16 U.S.C. § 470, et seq.), and the applicable federal regulations (36 C.F.R. Part 61) but is  
36 located in a county that has not received the same certification.

37 **"§ 160D-9-51. Conflict with other laws.**

38 Whenever any ordinance adopted pursuant to this Part requires a longer waiting period or  
39 imposes other higher standards with respect to a designated historic landmark or district than  
40 are established under any other statute, charter provision, or regulation, this Part shall govern.  
41 Whenever the provisions of any other statute, charter provision, ordinance, or regulation  
42 require a longer waiting period or impose other higher standards than are established under this  
43 Part, such other statute, charter provision, ordinance, or regulation shall govern.

44 "Part 5. Community Appearance.

45 **"§ 160D-9-60. Powers and duties of commission.**

46 A community appearance commission shall make careful study of the visual problems and  
47 needs of the local government within its planning and development regulation jurisdiction and  
48 shall make any plans and carry out any programs that will, in accordance with the provisions of  
49 this Part, enhance and improve the visual quality and aesthetic characteristics of the local  
50 government. To this end, the governing board may confer upon the appearance commission the  
51 following powers and duties:

- 1           (1)    To initiate, promote, and assist in the implementation of programs of general  
2           community beautification in the local government;
- 3           (2)    To coordinate the activities of individuals, agencies, and organizations,  
4           public and private, whose plans, activities, and programs bear upon the  
5           appearance of the local government;
- 6           (3)    To provide leadership and guidance in matters of area or community design  
7           and appearance to individuals, and to public and private organizations, and  
8           agencies;
- 9           (4)    To make studies of the visual characteristics and problems of the local  
10          government, including surveys and inventories of an appropriate nature, and  
11          to recommend standards and policies of design for the entire area, any  
12          portion or neighborhood thereof, or any project to be undertaken;
- 13          (5)    To prepare both general and specific plans for the improved appearance of  
14          the local government. These plans may include the entire area or any part  
15          thereof, and may include private as well as public property. The plans shall  
16          set forth desirable standards and goals for the aesthetic enhancement of the  
17          local government or any part thereof within its area of planning and  
18          development regulation jurisdiction, including public ways and areas, open  
19          spaces, and public and private buildings and projects;
- 20          (6)    To participate, in any way deemed appropriate by the governing board of the  
21          local government and specified in the ordinance establishing the  
22          commission, in the implementation of its plans. To this end, the governing  
23          board may include in the ordinance the following powers:
- 24            a.    To request from the proper officials of any public agency or body,  
25            including agencies of the State and its political subdivisions, its plans  
26            for public buildings, facilities, or projects to be located within the  
27            local government's area of planning and development regulation.
- 28            b.    To review these plans and to make recommendations regarding their  
29            aesthetic suitability to the appropriate agency or to the planning or  
30            governing board. All plans shall be reviewed by the commission in a  
31            prompt and expeditious manner, and all recommendations of the  
32            commission with regard to any public project shall be made in  
33            writing. Copies of the recommendations shall be transmitted  
34            promptly to the planning or governing board and to the appropriate  
35            agency.
- 36            c.    To formulate and recommend to the appropriate planning or  
37            governing board the adoption or amendment of ordinances, including  
38            zoning regulations, subdivision regulations, and other local  
39            development regulations, that will, in the opinion of the commission,  
40            serve to enhance the appearance of the city or county and  
41            surrounding areas.
- 42            d.    To direct the attention of local government officials to needed  
43            enforcement of any ordinance that may in any way affect the  
44            appearance of the city or county.
- 45            e.    To seek voluntary adherence to the standards and policies of its  
46            plans.
- 47            f.    To enter, in the performance of its official duties and at reasonable  
48            times, upon private lands and make examinations or surveys.
- 49            g.    To promote public interest in and an understanding of its  
50            recommendations, studies, and plans, and to that end to prepare,  
51            publish, and distribute to the public such studies and reports as will,

1 in the opinion of the commission, advance the cause of improved  
2 appearance.

3 h. To conduct public meetings and hearings, giving reasonable notice to  
4 the public thereof.

5 **"§ 160D-9-61. Staff services; advisory council.**

6 The commission may recommend to the governing board suitable arrangements for the  
7 procurement or provision of staff or technical services for the commission, and the governing  
8 board may appropriate such amount as it deems necessary to carry out the purposes for which it  
9 was created. The commission may establish an advisory council or other committees.

10 **"§ 160D-9-62. Annual report.**

11 The commission shall, no later than April 15 of each year, submit to the governing board a  
12 written report of its activities, a statement of its expenditures to date for the current fiscal year,  
13 and its requested budget for the next fiscal year. All accounts and funds of the commission  
14 shall be administered substantially in accordance with the requirements of the Municipal Fiscal  
15 Control Act or the County Fiscal Control Act.

16 **"§ 160D-9-63. Receipt and expenditure of funds.**

17 The commission may receive contributions from private agencies, foundations,  
18 organizations, individuals, the State or federal government, or any other source, in addition to  
19 any sums appropriated for its use by the governing board. It may accept and disburse these  
20 funds for any purpose within the scope of its authority as herein specified. All sums  
21 appropriated by the local government to further the work and purposes of the commission are  
22 deemed to be for a public purpose.

23 "Article 10.

24 "Development Agreements.

25 **"§ 160D-10-1. Authorization for development agreements.**

26 (a) The General Assembly finds:

- 27 (1) Large-scale development projects often occur in multiple phases over  
28 several years, requiring a long-term commitment of both public and private  
29 resources.  
30 (2) Such large-scale developments often create community impacts and  
31 opportunities that are difficult to accommodate within traditional zoning  
32 processes.  
33 (3) Because of their scale and duration, such large-scale projects often require  
34 careful coordination of public capital facilities planning, financing, and  
35 construction schedules and phasing of the private development.  
36 (4) Because of their scale and duration, such large-scale projects involve  
37 substantial commitments of private capital, which developers are usually  
38 unwilling to risk without sufficient assurances that development standards  
39 will remain stable through the extended period of the development.  
40 (5) Because of their size and duration, such developments often permit  
41 communities and developers to experiment with different or nontraditional  
42 types of development concepts and standards, while still managing impacts  
43 on the surrounding areas.  
44 (6) To better structure and manage development approvals for such large-scale  
45 developments and ensure their proper integration into local capital facilities  
46 programs, local governments need flexibility to negotiate such  
47 developments.

48 (b) Local governments may enter into development agreements with developers, subject  
49 to the procedures of this Article. In entering into such agreements, a local government may not  
50 exercise any authority or make any commitment not authorized by general or local act and may  
51 not impose any tax or fee not authorized by otherwise applicable law.

1       (c) This Article is supplemental to the powers conferred upon local governments and  
2 does not preclude or supersede rights and obligations established pursuant to other law  
3 regarding development approvals, site-specific vesting plans, phased vesting plans, or other  
4 provisions of law. A development agreement shall not exempt the property owner or developer  
5 from compliance with the State Building Code or State or local housing codes that are not part  
6 of the local government's development regulations.

7       (d) Development authorized by a development agreement shall comply with all  
8 applicable laws, including all ordinances, resolutions, regulations, permits, policies, and laws  
9 affecting the development of property, including laws governing permitted uses of the property,  
10 density, intensity, design, and improvements.

11 **"§ 160D-10-2. Definitions.**

12       The following definitions apply in this Article:

13           (1) Development. – The planning for or carrying out of a building activity, the  
14 making of a material change in the use or appearance of any structure or  
15 property, or the dividing of land into two or more parcels. When appropriate  
16 to the context, "development" refers to the planning for or the act of  
17 developing or to the result of development. Reference to a specific operation  
18 is not intended to mean that the operation or activity, when part of other  
19 operations or activities, is not development. Reference to particular  
20 operations is not intended to limit the generality of this item.

21           (2) Public facilities. – Major capital improvements, including, but not limited to,  
22 transportation, sanitary sewer, solid waste, drainage, potable water,  
23 educational, parks and recreational, and health systems and facilities.

24 **"§ 160D-10-3. Approval of governing board required.**

25       A local government may establish procedures and requirements, as provided in this Article,  
26 to consider and enter into development agreements with developers. A development agreement  
27 must be approved by the governing board of a local government following the procedures  
28 specified in G.S. 160D-10-5. No protest petition under G.S. 160D-6-3 is applicable to a  
29 development agreement. A development agreement may be considered concurrently with a  
30 zoning map or text amendment affecting the property and development subject to the  
31 development agreement.

32 **"§ 160D-10-4. Size and duration.**

33       (a) A local government may enter into a development agreement with a developer for  
34 the development of property as provided in this Article, provided the property contains 25 acres  
35 or more of developable property (exclusive of wetlands, mandatory buffers, unbuildable slopes,  
36 and other portions of the property which may be precluded from development at the time of  
37 application).

38       (b) Notwithstanding the acreage requirements of subsection (a) of this section, a local  
39 government may enter into a development agreement with a developer for developable property  
40 of any size if the property that would be subject to the development agreement is (i) subject to  
41 an executed brownfields agreement pursuant to Part 5 of Article 9 of Chapter 130A of the  
42 General Statutes; or (ii) within or adjacent to a central business district and the governing board  
43 determines the development would have a substantial effect on the character or function of the  
44 central business district.

45       (c) Development agreements may be of any reasonable term specified in the agreement.

46       (d) The entire development agreement, or any terms or conditions within the  
47 development agreement, may be incorporated directly or by reference into the conditions of a  
48 conditional zoning district. If incorporated into a conditional district, the provisions shall be  
49 treated as any other zoning conditions in the event of the developer's bankruptcy.

50 **"§ 160D-10-5. Public hearing.**

1 Before entering into a development agreement, a local government shall conduct a  
2 legislative hearing on the proposed agreement. The notice provisions of G.S. 160D-6-2  
3 applicable to zoning map amendments shall be followed for this hearing. The notice for the  
4 public hearing must specify the location of the property subject to the development agreement,  
5 the development uses proposed on the property, and must specify a place where a copy of the  
6 proposed development agreement can be obtained.

7 **"§ 160D-10-6 Content and modification.**

8 (a) A development agreement shall, at a minimum, include all of the following:

- 9 (1) A description of the property subject to the agreement and the names of its  
10 legal and equitable property owners.
- 11 (2) The duration of the agreement. However, the parties are not precluded from  
12 entering into subsequent development agreements that may extend the  
13 original duration period.
- 14 (3) The development uses permitted on the property, including population  
15 densities and building types, intensities, placement on the site, and design.
- 16 (4) A description of public facilities that will serve the development, including  
17 who provides the facilities, the date any new public facilities, if needed, will  
18 be constructed, and a schedule to assure public facilities are available  
19 concurrent with the impacts of the development. In the event that the  
20 development agreement provides that the local government shall provide  
21 certain public facilities, the development agreement shall provide that the  
22 delivery date of such public facilities will be tied to successful performance  
23 by the developer in implementing the proposed development.
- 24 (5) A description, where appropriate, of any reservation or dedication of land for  
25 public purposes and any provisions agreed to by the developer that exceed  
26 existing laws related to protection of environmentally sensitive property.
- 27 (6) A description of any conditions, terms, restrictions, or other requirements for  
28 the protection of public health, safety, or welfare.
- 29 (7) A description, where appropriate, of any provision for the preservation and  
30 restoration of historic structures.

31 (b) A development agreement may also provide that the entire development or any  
32 phase of it be commenced or completed within a specified period of time. If required by  
33 ordinance or in the agreement, the development agreement shall provide a development  
34 schedule, including commencement dates and interim completion dates at no greater than  
35 five-year intervals; provided, however, the failure to meet a commencement or completion date  
36 shall not constitute a material breach of the development agreement pursuant to  
37 G.S. 160D-10-8 but must be judged based upon the totality of the circumstances. The developer  
38 may request a modification in the dates as set forth in the agreement.

39 (c) If more than one local government is made party to an agreement, the agreement  
40 must specify which local government is responsible for the overall administration of the  
41 development agreement. A local or regional utility authority may also be made a party to the  
42 development agreement.

43 (d) The development agreement also may cover any other matter, including defined  
44 performance standards, not inconsistent with this Chapter. The development agreement may  
45 include mutually acceptable terms regarding provision of public facilities and other amenities  
46 and the allocation of financial responsibility for their provision, provided any impact mitigation  
47 measures offered by the developer beyond those that could be required by the local government  
48 pursuant to G.S. 160D-8-4 shall be expressly enumerated within the agreement, and provided  
49 the agreement may not include a tax or fee not otherwise authorized by law.

50 (e) Consideration of a proposed major modification of the agreement shall follow the  
51 same procedures as required for initial approval of a development agreement. What changes

1 constitute a major modification may be determined by ordinance adopted pursuant to  
2 G.S. 160D-10-3 or as provided for in the development agreement.

3 **"§ 160D-10-7. Vesting.**

4 (a) Unless the development agreement specifically provides for the application of  
5 subsequently enacted laws, the laws applicable to development of the property subject to a  
6 development agreement are those in force at the time of execution of the agreement.

7 (b) Except for grounds specified in G.S. 160D-1-8, a local government may not apply  
8 subsequently adopted ordinances or development policies to a development that is subject to a  
9 development agreement.

10 (c) In the event State or federal law is changed after a development agreement has been  
11 entered into and the change prevents or precludes compliance with one or more provisions of  
12 the development agreement, the local government may modify the affected provisions, upon a  
13 finding that the change in State or federal law has a fundamental effect on the development  
14 agreement.

15 (d) This section does not abrogate vested rights otherwise preserved by law.

16 **"§ 160D-10-8. Breach and cure.**

17 (a) Procedures established pursuant to G.S. 160D-10-3 may include a provision  
18 requiring periodic review by the zoning administrator or other appropriate officer of the local  
19 government at which time the developer shall demonstrate good faith compliance with the  
20 terms of the development agreement.

21 (b) If the local government finds and determines that the developer has committed a  
22 material breach of the agreement, the local government shall notify the developer in writing  
23 setting forth with reasonable particularity the nature of the breach and the evidence supporting  
24 the finding and determination, and providing the developer a reasonable time in which to cure  
25 the material breach.

26 (c) If the developer fails to cure the material breach within the time given, then the local  
27 government unilaterally may terminate or modify the development agreement; provided the  
28 notice of termination or modification may be appealed to the board of adjustment in the manner  
29 provided by G.S. 160D-4-5.

30 (d) An ordinance adopted pursuant to G.S. 160D-10-3 or the development agreement  
31 may specify other penalties for breach in lieu of termination, including, but not limited to,  
32 penalties allowed for violation of a development regulation. Nothing in this Article shall be  
33 construed to abrogate or impair the power of local government to enforce applicable law.

34 (e) A development agreement shall be enforceable by any party to the agreement  
35 notwithstanding any changes in the development regulations made subsequent to the effective  
36 date of the development agreement. Any party to the agreement may file an action for  
37 injunctive relief to enforce the terms of a development agreement.

38 **"§ 160D-10-9. Amendment or termination.**

39 Subject to the provisions of G.S. 160D-10-6(e), a development agreement may be amended  
40 or terminated by mutual consent of the parties.

41 **"§ 160-10-10. Change of jurisdiction.**

42 (a) Except as otherwise provided by this Article, any development agreement entered  
43 into by a local government before the effective date of a change of jurisdiction shall be valid  
44 for the duration of the agreement or eight years from the effective date of the change in  
45 jurisdiction, whichever is earlier. The parties to the development agreement and the local  
46 government assuming jurisdiction have the same rights and obligations with respect to each  
47 other regarding matters addressed in the development agreement as if the property had  
48 remained in the previous jurisdiction.

49 (b) A local government assuming jurisdiction may modify or suspend the provisions of  
50 the development agreement if the local government determines that the failure of the local  
51 government to do so would place the residents of the territory subject to the development

1 agreement or the residents of the local government, or both, in a condition dangerous to their  
2 health or safety, or both.

3 **"§ 160D-10-11. Recordation.**

4 The developer shall record the agreement with the register of deeds in the county where the  
5 property is located within 14 days after the local government and developer execute an  
6 approved development agreement. No development approvals may be issued until the  
7 development agreement has been recorded. The burdens of the development agreement are  
8 binding upon, and the benefits of the agreement shall inure to, all successors in interest to the  
9 parties to the agreement.

10 **"§ 160D-10-12. Applicability of procedures to approve debt.**

11 In the event that any of the obligations of the local government in the development  
12 agreement constitute debt, the local government shall comply, at the time of the obligation to  
13 incur the debt and before the debt becomes enforceable against the local government, with any  
14 applicable constitutional and statutory procedures for the approval of this debt.

15 "Article 11.

16 "Building Code Enforcement.

17 **"§ 160D-11-1. Building defined.**

18 As used in this Article, the words

19 (a) "Building" or "buildings" include other structures.

20 (b) "Governing board" or "board of commissioners" includes the Tribal Council of a  
21 federally recognized Indian Tribe.

22 (c) "Local government" also means a federally recognized Indian Tribe, and as to such  
23 tribe includes lands held in trust for the tribe.

24 (d) "Public officer" means the officer or officers who are authorized by ordinances  
25 adopted hereunder to exercise the powers prescribed by the ordinances and by this Article.

26 **"§ 160D-11-2. Building code administration.**

27 A local government may create an inspection department and may appoint inspectors who  
28 may be given appropriate titles, such as building inspector, electrical inspector, plumbing  
29 inspector, housing inspector, zoning inspector, heating and air-conditioning inspector, fire  
30 prevention inspector, or deputy or assistant inspector, or such other titles as may be generally  
31 descriptive of the duties assigned. A local government may elect to combine inspections under  
32 any ordinance authorized by this Article. Every local government shall perform the duties and  
33 responsibilities set forth in G.S. 160D-11-5 either by: (i) creating its own inspection  
34 department; (ii) creating a joint inspection department in cooperation with one or more other  
35 units of local government, pursuant to G.S. 160D-11-5 or Part 1 of Article 20 of Chapter 160A  
36 of the General Statutes; (iii) contracting with another unit of local government for the provision  
37 of inspection services pursuant to Part 1 of Article 20 of Chapter 160A of the General Statutes;  
38 or (iv) arranging for the county in which a city is located to perform inspection services within  
39 the city's jurisdiction as authorized by G.S. 160D-11-5 and G.S. 160D-2-2.

40 In the event that any local government fails to provide inspection services or ceases to  
41 provide such services, the Commissioner of Insurance shall arrange for the provision of such  
42 services, either through personnel employed by the department or through an arrangement with  
43 other units of government. In either event, the Commissioner shall have and may exercise  
44 within the local government's jurisdiction all powers made available to the governing board  
45 with respect to building inspection under this Article and Part 1 of Article 20 of Chapter 160A  
46 of the General Statutes. Whenever the Commissioner has intervened in this manner, the local  
47 government may assume provision of inspection services only after giving the Commissioner  
48 two years' written notice of its intention to do so; provided, however, that the Commissioner  
49 may waive this requirement or permit assumption at an earlier date upon finding that such  
50 earlier assumption will not unduly interfere with arrangements made for the provision of those  
51 services.

**"§ 160D-11-3. Qualifications of inspectors.**

No local government shall employ an inspector to enforce the State Building Code who does not have one of the following types of certificates issued by the North Carolina Code Officials Qualification Board attesting to the inspector's qualifications to hold such position: (i) a probationary certificate; (ii) a standard certificate; or (iii) a limited certificate which shall be valid only as an authorization to continue in the position held on the date specified in G.S. 143-151.13(c) and which shall become invalid if the inspector does not successfully complete in-service training specified by the Qualification Board within the period specified in G.S. 143-151.13(c). An inspector holding one of the above certificates can be promoted to a position requiring a higher level certificate only upon issuance by the Board of a standard certificate or probationary certificate appropriate for such new position.

**"§ 160D-11-4. Duties and responsibilities.**

(a) The duties and responsibilities of an inspection department and of the inspectors in it shall be to enforce within their planning and development regulation jurisdiction State and local laws relating to:

(1) The construction of buildings and other structures.

(2) The installation of such facilities as plumbing systems, electrical systems, heating systems, refrigeration systems, and air-conditioning systems.

(3) The maintenance of buildings and other structures in a safe, sanitary, and healthful condition.

(4) Other matters that may be specified by the governing board.

These duties shall include the receipt of applications for permits and the issuance or denial of permits, the making of any necessary inspections, the issuance or denial of certificates of compliance, the issuance of orders to correct violations, the bringing of judicial actions against actual or threatened violations, the keeping of adequate records, and any other actions that may be required in order adequately to enforce those laws. The city council shall have the authority to enact reasonable and appropriate provisions governing the enforcement of those laws.

(b) Except as provided in G.S. 160D-11-15 and G.S. 160D-12-7, a local government may not adopt a local ordinance or resolution or any other policy that requires regular, routine inspections of buildings or structures constructed in compliance with the North Carolina Residential Code for One- and Two-Family Dwellings in addition to the specific inspections required by the North Carolina Building Code without first obtaining approval from the North Carolina Building Code Council. The North Carolina Building Code Council shall review all applications for additional inspections requested by a local government and shall, in a reasonable manner, approve or disapprove the additional inspections. This subsection does not limit the authority of the local government to require inspections upon unforeseen or unique circumstances that require immediate action.

**"§ 160D-11-5. Other arrangements for inspections.**

A local government may contract with an individual who is not a local government employee but who holds one of the applicable certificates as provided in G.S. 160D-11-3 or with the employer of an individual who holds one of the applicable certificates as provided in G.S. 160D-11-3.

**"§ 160D-11-6. Conflicts of interest.**

Staff members, agents, or contractors responsible for inspections shall comply with G.S. 160D-1-9(c). No member of an inspection department shall be financially interested or employed by a business that is financially interested in the furnishing of labor, material, or appliances for the construction, alteration, or maintenance of any building within the local government's planning and development regulation jurisdiction or any part or system thereof, or in the making of plans or specifications therefor, unless he or she is the owner of the building. No member of an inspection department or other individual or an employee of a company contracting with a local government to conduct building inspections shall engage in



1 any work that is inconsistent with his or her duties or with the interest of the local government,  
2 as determined by the local government. The local government must find a conflict of interest if  
3 any of the following is the case:

- 4 (1) If the individual, company, or employee of a company contracting to  
5 perform building inspections for the local government has worked for the  
6 owner, developer, contractor, or project manager of the project to be  
7 inspected within the last two years.
- 8 (2) If the individual, company, or employee of a company contracting to  
9 perform building inspections for the local government is closely related to  
10 the owner, developer, contractor, or project manager of the project to be  
11 inspected.
- 12 (3) If the individual, company, or employee of a company contracting to  
13 perform building inspections for the local government has a financial or  
14 business interest in the project to be inspected.

15 The provisions of this section do not apply to a firefighter whose primary duties are fire  
16 suppression and rescue, but who engages in some fire inspection activities as a secondary  
17 responsibility of the firefighter's employment as a firefighter, except no firefighter may inspect  
18 any work actually done, or materials or appliances supplied, by the firefighter or the  
19 firefighter's business within the preceding six years.

20 **"§ 160D-11-7. Failure to perform duties.**

21 If any member of an inspection department shall willfully fail to perform the duties required  
22 of him by law, or willfully shall improperly issue a permit, or shall give a certificate of  
23 compliance without first making the inspections required by law, or willfully shall improperly  
24 give a certificate of compliance, the member shall be guilty of a Class 1 misdemeanor.

25 **"§ 160D-11-8. Building permits.**

26 (a) Except as provided in subsection (c) of this section, no person shall commence or  
27 proceed with any of the following without first securing all permits required by the State  
28 Building Code and any other State or local laws applicable to the work:

- 29 (1) The construction, reconstruction, alteration, repair, movement to another  
30 site, removal, or demolition of any building or structure.
- 31 (2) The installation, extension, or general repair of any plumbing system except  
32 that in any one- or two-family dwelling unit a permit shall not be required  
33 for the connection of a water heater that is being replaced, provided that the  
34 work is performed by a person licensed under G.S. 87-21, who personally  
35 examines the work at completion and ensures that a leak test has been  
36 performed on the gas piping, and provided the energy use rate or thermal  
37 input is not greater than that of the water heater which is being replaced,  
38 there is no change in fuel, energy source, location, capacity, or routing or  
39 sizing of venting and piping, and the replacement is installed in accordance  
40 with the current edition of the State Building Code.
- 41 (3) The installation, extension, alteration, or general repair of any heating or  
42 cooling equipment system.
- 43 (4) The installation, extension, alteration, or general repair of any electrical  
44 wiring, devices, appliances, or equipment except that in any one- or  
45 two-family dwelling unit a permit shall not be required for repair or  
46 replacement of electrical lighting fixtures or devices, such as receptacles and  
47 lighting switches, or for the connection of an existing branch circuit to an  
48 electric water heater that is being replaced, provided that all of the following  
49 requirements are met:

- a. With respect to electric water heaters, the replacement water heater is placed in the same location and is of the same or less capacity and electrical rating as the original.
- b. With respect to electrical lighting fixtures and devices, the replacement is with a fixture or device having the same voltage and the same or less amperage.
- c. The work is performed by a person licensed under G.S. 87-43.
- d. The repair or replacement installation meets the current edition of the State Building Code, including the State Electrical Code.

10 However, a building permit is not required for the installation, maintenance, or replacement  
11 of any load control device or equipment by an electric power supplier, as defined in  
12 G.S. 62-133.8, or an electrical contractor contracted by the electric power supplier, so long as  
13 the work is subject to supervision by an electrical contractor licensed under Article 4 of  
14 Chapter 87 of the General Statutes. The electric power supplier shall provide such installation,  
15 maintenance, or replacement in accordance with (i) an activity or program ordered, authorized,  
16 or approved by the North Carolina Utilities Commission pursuant to G.S. 62-133.8 or  
17 G.S. 62-133.9 or (ii) a similar program undertaken by a municipal electric service provider,  
18 whether the installation, modification, or replacement is made before or after the point of  
19 delivery of electric service to the customer. The exemption under this subdivision applies to all  
20 existing installations.

21 (b) A building permit shall be in writing and shall contain a provision that the work  
22 done shall comply with the State Building Code and all other applicable State and local laws.  
23 Nothing in this section shall require a local government to review and approve residential  
24 building plans submitted to the local government pursuant to the North Carolina Residential  
25 Code, provided that the local government may review and approve such residential building  
26 plans as it deems necessary. No building permits shall be issued unless the plans and  
27 specifications are identified by the name and address of the author thereof, and if the General  
28 Statutes of North Carolina require that plans for certain types of work be prepared only by a  
29 registered architect or registered engineer, no building permit shall be issued unless the plans  
30 and specifications bear the North Carolina seal of a registered architect or of a registered  
31 engineer. When any provision of the General Statutes of North Carolina or of any ordinance  
32 requires that work be done by a licensed specialty contractor of any kind, no permit for the  
33 work shall be issued unless the work is to be performed by such a duly licensed contractor. No  
34 permit issued under Articles 9 or 9C of Chapter 143 of the General Statutes shall be required  
35 for any construction, installation, repair, replacement, or alteration costing five thousand dollars  
36 (\$5,000) or less in any single-family residence or farm building unless the work involves the  
37 addition, repair, or replacement of load-bearing structures; the addition (excluding replacement  
38 of same size and capacity) or change in the design of plumbing; the addition, replacement, or  
39 change in the design of heating, air-conditioning, or electrical wiring, devices, appliances, or  
40 equipment; the use of materials not permitted by the North Carolina Uniform Residential  
41 Building Code; or the addition (excluding replacement of like grade of fire resistance) of  
42 roofing. Violation of this section shall constitute a Class 1 misdemeanor.

43 (c) A local government shall not require more than one building permit for the  
44 complete installation or replacement of any natural gas, propane gas, or electrical appliance on  
45 an existing structure when the installation or replacement is performed by a person licensed  
46 under G.S. 87-21 or G.S. 87-43. The cost of the building permit for such work shall not exceed  
47 the cost of any one individual trade permit issued by that local government, nor shall the local  
48 government increase the costs of any fees to offset the loss of revenue caused by this provision.

49 (d) No building permit shall be issued pursuant to subsection (a) of this section for any  
50 land-disturbing activity, as defined in G.S. 113A-52(6), or for any activity covered by  
51 G.S. 113A-57, unless an erosion and sedimentation control plan for the site of the activity or a

1 tract of land, including the site of the activity has been approved under the Sedimentation  
2 Pollution Control Act.

3 (e) No building permit shall be issued pursuant to subsection (a) of this section for any  
4 land-disturbing activity that is subject to, but does not comply with, the requirements of  
5 G.S. 113A-71.

6 (f) No building permit shall be issued pursuant to subdivision (1) of subsection (a) of  
7 this section where the cost of the work is thirty thousand dollars (\$30,000) or more, other than  
8 for improvements to an existing single-family residential dwelling unit as defined in  
9 G.S. 87-15.5(7) that the owner occupies as a residence, or for the addition of an accessory  
10 building or accessory structure as defined in the North Carolina Uniform Residential Building  
11 Code, the use of which is incidental to that residential dwelling unit, unless the name, physical  
12 and mailing address, telephone number, facsimile number, and electronic mail address of the  
13 lien agent designated by the owner pursuant to G.S. 44A-11.1(a) is conspicuously set forth in  
14 the permit or in an attachment thereto. The building permit may contain the lien agent's  
15 electronic mail address. The lien agent information for each permit issued pursuant to this  
16 subsection shall be maintained by the inspection department in the same manner and in the  
17 same location in which it maintains its record of building permits issued.

18 **"§ 160D-11-9. Expiration of building permits.**

19 A building permit issued pursuant to this Article shall expire by limitation six months, or  
20 any lesser time fixed by ordinance of the city council, after the date of issuance if the work  
21 authorized by the permit has not been commenced. If after commencement the work is  
22 discontinued for a period of 12 months, the permit therefor shall immediately expire. No work  
23 authorized by any building permit that has expired shall thereafter be performed until a new  
24 permit has been secured.

25 **"§ 160D-11-10. Changes in work.**

26 After a building permit has been issued, no changes or deviations from the terms of the  
27 application, plans, and specifications, or the permit, except where changes or deviations are  
28 clearly permissible under the State Building Code, shall be made until specific written approval  
29 of proposed changes or deviations has been obtained from the inspection department.

30 **"§ 160D-11-10. Inspections of work in progress.**

31 As the work pursuant to a building permit progresses, local inspectors shall make as many  
32 inspections thereof as may be necessary to satisfy them that the work is being done according  
33 to the provisions of any applicable State and local laws and of the terms of the permit. In  
34 exercising this power, members of the inspection department shall have a right to enter on any  
35 premises within the jurisdiction of the department at all reasonable hours for the purposes of  
36 inspection or other enforcement action, upon presentation of proper credentials. If a building  
37 permit has been obtained by an owner exempt from licensure under G.S. 87-1(b)(2), no  
38 inspection shall be conducted without the owner being present, unless the plans for the building  
39 were drawn and sealed by an architect licensed pursuant to Chapter 83A of the General  
40 Statutes.

41 **"§ 160D-11-11. Appeals of stop orders.**

42 (a) The owner or builder may appeal from a stop order involving alleged violation of  
43 the State Building Code or any approved local modification thereof to the North Carolina  
44 Commissioner of Insurance or his designee within a period of five days after the order is  
45 issued. Notice of appeal shall be given in writing to the Commissioner of Insurance or his  
46 designee, with a copy to the local inspector. The Commissioner of Insurance or his designee  
47 shall promptly conduct an investigation and the appellant and the inspector shall be permitted  
48 to submit relevant evidence. The Commissioner of Insurance or his designee shall as  
49 expeditiously as possible provide a written statement of the decision setting forth the facts  
50 found, the decision reached, and the reasons for the decision. Pending the ruling by the  
51 Commissioner of Insurance or his designee on an appeal, no further work shall take place in

1 violation of a stop order. In the event of dissatisfaction with the decision, the person affected  
2 shall have the options of:

- 3 (1) Appealing to the Building Code Council, or
- 4 (2) Appealing to the Superior Court as provided in G.S. 143-141.

5 (b) The owner or builder may appeal from a stop order involving alleged violation of a  
6 local development regulation as provided in G.S. 160D-4-5.

7 **"§ 160D-11-13. Revocation of building permits.**

8 The appropriate inspector may revoke and require the return of any building permit by  
9 notifying the permit holder in writing stating the reason for the revocation. Building permits  
10 shall be revoked for any substantial departure from the approved application, plans, or  
11 specifications; for refusal or failure to comply with the requirements of any applicable State or  
12 local laws; or for false statements or misrepresentations made in securing the permit. Any  
13 building permit mistakenly issued in violation of an applicable State or local law may also be  
14 revoked.

15 **"§ 160D-11-14. Certificates of compliance.**

16 At the conclusion of all work done under a building permit, the appropriate inspector shall  
17 make a final inspection, and if the inspector finds that the completed work complies with all  
18 applicable State and local laws and with the terms of the permit, the inspector shall issue a  
19 certificate of compliance. No new building or part thereof may be occupied, no addition or  
20 enlargement of an existing building may be occupied, and no existing building that has been  
21 altered or moved may be occupied, until the inspection department has issued a certificate of  
22 compliance. A temporary certificate of occupancy or compliance may be issued permitting  
23 occupancy for a stated period of time of either the entire building or property or of specified  
24 portions of the building if the inspector finds that such building or property may safely be  
25 occupied prior to its final completion. Violation of this section shall constitute a Class 1  
26 misdemeanor. A local government may require the applicant for a temporary certificate of  
27 occupancy to post suitable security to ensure code compliance.

28 **"§ 160D-11-15. Periodic inspections.**

29 (a) The inspection department may make periodic inspections, subject to the governing  
30 board's directions, for unsafe, unsanitary, or otherwise hazardous and unlawful conditions in  
31 buildings or structures within its planning and development regulation jurisdiction. In  
32 exercising this power, members of the department shall have a right to enter on any premises  
33 within the jurisdiction of the department at all reasonable hours for the purposes of inspection  
34 or other enforcement action, upon presentation of proper credentials.

35 **"§ 160D-11-16. Defects in buildings to be corrected.**

36 When a local inspector finds any defects in a building, or finds that the building has not  
37 been constructed in accordance with the applicable State and local laws, or that a building  
38 because of its condition is dangerous or contains fire hazardous conditions, it shall be the  
39 inspector's duty to notify the owner or occupant of the building of its defects, hazardous  
40 conditions, or failure to comply with law. The owner or occupant shall immediately remedy the  
41 defects, hazardous conditions, or violations of law in the property.

42 **"§ 160D-11-17. Unsafe buildings condemned.**

43 (a) Designation of Unsafe Buildings. Every building that shall appear to the inspector to  
44 be especially dangerous to life because of its liability to fire or because of bad condition of  
45 walls, overloaded floors, defective construction, decay, unsafe wiring or heating system,  
46 inadequate means of egress, or other causes shall be held to be unsafe, and the inspector shall  
47 affix a notice of the dangerous character of the structure to a conspicuous place on the exterior  
48 wall of the building.

49 (b) Nonresidential Building or Structure. In addition to the authority granted in  
50 subsection (a) of this section, an inspector may declare a nonresidential building or structure

1 within a community development target area to be unsafe if it meets both of the following  
2 conditions:

3 (1) It appears to the inspector to be vacant or abandoned.

4 (2) It appears to the inspector to be in such dilapidated condition as to cause or  
5 contribute to blight, disease, vagrancy, fire or safety hazard, to be a danger  
6 to children, or to tend to attract persons intent on criminal activities or other  
7 activities that would constitute a public nuisance.

8 (c) Notice Posted on Structure. If an inspector declares a nonresidential building or  
9 structure to be unsafe under subsection (b) of this section, the inspector must affix a notice of  
10 the unsafe character of the structure to a conspicuous place on the exterior wall of the building.  
11 For the purposes of this section, the term "community development target area" means an area  
12 that has characteristics of an urban progress zone under G.S. 143B-437.09, a "nonresidential  
13 redevelopment area" under G.S. 160A-503(10), or an area with similar characteristics  
14 designated by the governing board as being in special need of revitalization for the benefit and  
15 welfare of its citizens.

16 (d) Applicability to Residential Structures. A local government may expand subsections  
17 (b) and (c) of this section to apply to residential buildings by adopting an ordinance. Before  
18 adopting such an ordinance, a local government shall hold a legislative hearing with published  
19 notice as provided by G.S. 160D-6-1.

20 **"§ 160D-11-18. Removing notice from condemned building.**

21 If any person shall remove any notice that has been affixed to any building or structure by a  
22 local inspector of any municipality and that states the dangerous character of the building or  
23 structure, that person shall be guilty of a Class 1 misdemeanor.

24 **"§ 160D-11-19. Action in event of failure to take corrective action.**

25 If the owner of a building or structure that has been condemned as unsafe pursuant to  
26 G.S. 160A-426 shall fail to take prompt corrective action, the local inspector shall give written  
27 notice, by certified mail to the owner's last known address or by personal service:

28 (1) That the building or structure is in a condition that appears to meet one or  
29 more of the following conditions:

30 a. Constitutes a fire or safety hazard.

31 b. Is dangerous to life, health, or other property.

32 c. Is likely to cause or contribute to blight, disease, vagrancy, or danger  
33 to children.

34 d. Has a tendency to attract persons intent on criminal activities or other  
35 activities which would constitute a public nuisance.

36 (2) That an administrative hearing will be held before the inspector at a  
37 designated place and time, not later than 10 days after the date of the notice,  
38 at which time the owner shall be entitled to be heard in person or by counsel  
39 and to present arguments and evidence pertaining to the matter; and

40 (3) That following the hearing, the inspector may issue such order to repair,  
41 close, vacate, or demolish the building or structure as appears appropriate.

42 If the name or whereabouts of the owner cannot after due diligence be discovered, the  
43 notice shall be considered properly and adequately served if a copy is posted on the outside of  
44 the building or structure in question at least 10 days prior to the hearing and a notice of the  
45 hearing is published in a newspaper having general circulation in the local government's area of  
46 jurisdiction at least once not later than one week prior to the hearing.

47 **"§ 160D-11-20. Order to take corrective action.**

48 If, upon a hearing held pursuant to the notice prescribed in G.S. 160D-11-19, the inspector  
49 shall find that the building or structure is in a condition that constitutes a fire or safety hazard or  
50 renders it dangerous to life, health, or other property, the inspector shall make an order in  
51 writing, directed to the owner of such building or structure, requiring the owner to remedy the

1 defective conditions by repairing, closing, vacating, or demolishing the building or structure or  
2 taking other necessary steps, within such period, not less than 60 days, as the inspector may  
3 prescribe; provided that where the inspector finds that there is imminent danger to life or other  
4 property, the inspector may order that corrective action be taken in such lesser period as may be  
5 feasible.

6 **"§ 160D-11-21. Appeal; finality of order if not appealed.**

7 Any owner who has received an order under G.S. 160D-11-20 may appeal from the order to  
8 the governing board by giving notice of appeal in writing to the inspector and to the local  
9 government clerk within 10 days following issuance of the order. In the absence of an appeal,  
10 the order of the inspector shall be final. The governing board shall hear and render a decision in  
11 an appeal within a reasonable time. The governing board may affirm, modify and affirm, or  
12 revoke the order.

13 **"§ 160D-11-22. Failure to comply with order.**

14 If the owner of a building or structure fails to comply with an order issued pursuant to  
15 G.S. 160D-11-20 from which no appeal has been taken, or fails to comply with an order of the  
16 governing board following an appeal, the owner shall be guilty of a Class 1 misdemeanor.

17 **"§ 160D-11-23. Enforcement.**

18 (a) Action Authorized. Whenever any violation is denominated a misdemeanor under  
19 the provisions of this Part, the local government, either in addition to or in lieu of other  
20 remedies, may initiate any appropriate action or proceedings to prevent, restrain, correct, or  
21 abate the violation or to prevent the occupancy of the building or structure involved.

22 (b) Removal of Building. In the case of a building or structure declared unsafe under  
23 G.S. 160D-11-17 or an ordinance adopted pursuant to G.S. 160D-11-17, a local government  
24 may, in lieu of taking action under subsection (a) of this section, cause the building or structure  
25 to be removed or demolished. The amounts incurred by the local government in connection  
26 with the removal or demolition shall be a lien against the real property upon which the cost was  
27 incurred. The lien shall be filed, have the same priority, and be collected in the same manner as  
28 liens for special assessments provided in Article 10 of Chapter 160A of the General Statutes. If  
29 the building or structure is removed or demolished by the local government, the local  
30 government shall sell the usable materials of the building and any personal property, fixtures,  
31 or appurtenances found in or attached to the building. The local government shall credit the  
32 proceeds of the sale against the cost of the removal or demolition. Any balance remaining from  
33 the sale shall be deposited with the clerk of superior court of the county where the property is  
34 located and shall be disbursed by the court to the person found to be entitled thereto by final  
35 order or decree of the court.

36 (c) Additional Lien. The amounts incurred by a local government in connection with  
37 the removal or demolition shall also be a lien against any other real property owned by the  
38 owner of the building or structure and located within the local government's planning and  
39 development regulation jurisdiction or, for municipalities, within one mile of the city limits,  
40 except for the owner's primary residence. The provisions of subsection (b) of this section apply  
41 to this additional lien, except that this additional lien is inferior to all prior liens and shall be  
42 collected as a money judgment.

43 (d) Nonexclusive Remedy. Nothing in this section shall be construed to impair or limit  
44 the power of the local government to define and declare nuisances and to cause their removal or  
45 abatement by summary proceedings, or otherwise.

46 **"§ 160D-11-24. Records and reports.**

47 The inspection department shall keep complete and accurate records in convenient form of  
48 all applications received, permits issued, inspections and reinspections made, defects found,  
49 certificates of compliance or occupancy granted, and all other work and activities of the  
50 department. These records shall be kept in the manner and for the periods prescribed by the  
51 North Carolina Department of Cultural Resources. Periodic reports shall be submitted to the

1 governing board and to the Commissioner of Insurance as they shall by ordinance, rule, or  
2 regulation require.

3 **"§ 160D-11-25. Appeals.**

4 Unless otherwise provided by law, appeals from any order, decision, or determination by a  
5 member of a local inspection department pertaining to the State Building Code or other State  
6 building laws shall be taken to the Commissioner of Insurance or the Commissioner's designee  
7 or other official specified in G.S. 143-139, by filing a written notice with the Commissioner  
8 and with the inspection department within a period of 10 days after the order, decision, or  
9 determination. Further appeals may be taken to the State Building Code Council or to the courts  
10 as provided by law.

11 **"§ 160D-11-26. Fire limits.**

12 (a) County Fire Limits. A county may by ordinance establish and define fire limits in  
13 any area within the county and not within a city. The limits may include only business and  
14 industrial areas. Within any fire limits, no frame or wooden building or addition thereto may be  
15 erected, altered, repaired, or moved (either into the fire limits or from one place to another  
16 within the limits) except upon the permit of the inspection department and approval of the  
17 Commissioner of Insurance. The governing board may make additional regulations necessary  
18 for the prevention, extinguishment, or mitigation of fires within the fire limits.

19 (b) Municipal Fire Limits. The governing board of every incorporated city shall pass  
20 one or more ordinances establishing and defining fire limits, which shall include the principal  
21 business portions of the city and which shall be known as primary fire limits. In addition, the  
22 governing board may, in its discretion, establish and define one or more separate areas within  
23 the city as secondary fire limits.

24 (c) Restrictions Within Municipal Primary Fire Limits. Within the primary fire limits of  
25 any city, as established and defined by ordinance, no frame or wooden building or structure or  
26 addition thereto shall hereafter be erected, altered, repaired, or moved (either into the limits or  
27 from one place to another within the limits), except upon the permit of the local inspection  
28 department approved by the governing board and by the Commissioner of Insurance or his  
29 designee. The governing board may make additional regulations for the prevention,  
30 extinguishment, or mitigation of fires within the primary fire limits.

31 (d) Restriction Within Municipal Secondary Fire Limits. Within any secondary fire  
32 limits of any city or town, as established and defined by ordinance, no frame or wooden  
33 building or structure or addition thereto shall be erected, altered, repaired, or moved except in  
34 accordance with any rules and regulations established by ordinance of the areas.

35 (e) Failure to Establish Municipal Primary Fire Limits. If the governing board of any  
36 city shall fail or refuse to establish and define the primary fire limits of the city as required by  
37 law, after having such failure or refusal called to their attention in writing by the State  
38 Commissioner of Insurance, the Commissioner shall have the power to establish the limits upon  
39 making a determination that they are necessary and in the public interest.

40 **"§ 160D-11-27. Ordinance authorized as to repair, closing, and demolition of  
41 nonresidential buildings or structures; order of public officer.**

42 (a) Authority. The governing board of the local government may adopt and enforce  
43 ordinances relating to nonresidential buildings or structures that fail to meet minimum  
44 standards of maintenance, sanitation, and safety established by the governing board. The  
45 minimum standards shall address only conditions that are dangerous and injurious to public  
46 health, safety, and welfare and identify circumstances under which a public necessity exists for  
47 the repair, closing, or demolition of such buildings or structures. The ordinance shall provide  
48 for designation or appointment of a public officer to exercise the powers prescribed by the  
49 ordinance, in accordance with the procedures specified in this section. Such ordinance shall be  
50 applicable within the local government's planning and development regulation jurisdiction.

1       **(b) Investigation.** Whenever it appears to the public officer that any nonresidential  
2 building or structure has not been properly maintained so that the safety or health of its  
3 occupants or members of the general public are jeopardized for failure of the property to meet  
4 the minimum standards established by the governing board, the public officer shall undertake a  
5 preliminary investigation. If entry upon the premises for purposes of investigation is necessary,  
6 such entry shall be made pursuant to a duly issued administrative search warrant in accordance  
7 with G.S. 15-27.2 or with permission of the owner, the owner's agent, a tenant, or other person  
8 legally in possession of the premises.

9       **(c) Complaint and Hearing.** If the preliminary investigation discloses evidence of a  
10 violation of the minimum standards, the public officer shall issue and cause to be served upon  
11 the owner of and parties in interest in the nonresidential building or structure a complaint. The  
12 complaint shall state the charges and contain a notice that an administrative hearing will be  
13 held before the public officer (or his or her designated agent) at a place within the county  
14 scheduled not less than 10 days nor more than 30 days after the serving of the complaint; that  
15 the owner and parties in interest shall be given the right to answer the complaint and to appear  
16 in person, or otherwise, and give testimony at the place and time fixed in the complaint; and  
17 that the rules of evidence prevailing in courts of law or equity shall not be controlling in  
18 hearings before the public officer.

19       **(d) Order.** If, after notice and hearing, the public officer determines that the  
20 nonresidential building or structure has not been properly maintained so that the safety or  
21 health of its occupants or members of the general public is jeopardized for failure of the  
22 property to meet the minimum standards established by the governing board, the public officer  
23 shall state in writing findings of fact in support of that determination and shall issue and cause  
24 to be served upon the owner thereof an order. The order may require the owner to take remedial  
25 action, within a reasonable time specified, subject to the procedures and limitations herein.

26       **(e) Limitations on Orders.**

27       **(1)** An order may require the owner to repair, alter, or improve the  
28 nonresidential building or structure in order to bring it into compliance with  
29 the minimum standards established by the governing board or to vacate and  
30 close the nonresidential building or structure for any use.

31       **(2)** An order may require the owner to remove or demolish the nonresidential  
32 building or structure if the cost of repair, alteration, or improvement of the  
33 building or structure would exceed fifty percent (50%) of its then current  
34 value. Notwithstanding any other provision of law, if the nonresidential  
35 building or structure is designated as a local historic landmark, listed in the  
36 National Register of Historic Places, or located in a locally designated  
37 historic district or in a historic district listed in the National Register of  
38 Historic Places and the governing board determines, after a public hearing as  
39 provided by ordinance, that the nonresidential building or structure is of  
40 individual significance or contributes to maintaining the character of the  
41 district, and the nonresidential building or structure has not been condemned  
42 as unsafe, the order may require that the nonresidential building or structure  
43 be vacated and closed until it is brought into compliance with the minimum  
44 standards established by the governing board.

45       **(3)** An order may not require repairs, alterations, or improvements to be made to  
46 vacant manufacturing facilities or vacant industrial warehouse facilities to  
47 preserve the original use. The order may require such building or structure to  
48 be vacated and closed, but repairs may be required only when necessary to  
49 maintain structural integrity or to abate a health or safety hazard that cannot  
50 be remedied by ordering the building or structure closed for any use.

51       **(f) Action by Governing Board Upon Failure to Comply With Order.**



1           (1) If the owner fails to comply with an order to repair, alter, or improve or to  
2 vacate and close the nonresidential building or structure, the governing  
3 board may adopt an ordinance ordering the public officer to proceed to  
4 effectuate the purpose of this section with respect to the particular property  
5 or properties that the public officer found to be jeopardizing the health or  
6 safety of its occupants or members of the general public. The property or  
7 properties shall be described in the ordinance. The ordinance shall be  
8 recorded in the office of the register of deeds and shall be indexed in the  
9 name of the property owner or owners in the grantor index. Following  
10 adoption of an ordinance, the public officer may cause the building or  
11 structure to be repaired, altered, or improved or to be vacated and closed.  
12 The public officer may cause to be posted on the main entrance of any  
13 nonresidential building or structure so closed a placard with the following  
14 words: "This building is unfit for any use; the use or occupation of this  
15 building for any purpose is prohibited and unlawful." Any person who  
16 occupies or knowingly allows the occupancy of a building or structure so  
17 posted shall be guilty of a Class 3 misdemeanor.

18           (2) If the owner fails to comply with an order to remove or demolish the  
19 nonresidential building or structure, the governing board may adopt an  
20 ordinance ordering the public officer to proceed to effectuate the purpose of  
21 this section with respect to the particular property or properties that the  
22 public officer found to be jeopardizing the health or safety of its occupants  
23 or members of the general public. No ordinance shall be adopted to require  
24 demolition of a nonresidential building or structure until the owner has first  
25 been given a reasonable opportunity to bring it into conformity with the  
26 minimum standards established by the governing board. The property or  
27 properties shall be described in the ordinance. The ordinance shall be  
28 recorded in the office of the register of deeds and shall be indexed in the  
29 name of the property owner or owners in the grantor index. Following  
30 adoption of an ordinance, the public officer may cause the building or  
31 structure to be removed or demolished.

32           (g) Action by Governing Board Upon Abandonment of Intent to Repair. If the  
33 governing board has adopted an ordinance or the public officer has issued an order requiring  
34 the building or structure to be repaired or vacated and closed and the building or structure has  
35 been vacated and closed for a period of two years pursuant to the ordinance or order, the  
36 governing board may make findings that the owner has abandoned the intent and purpose to  
37 repair, alter, or improve the building or structure and that the continuation of the building or  
38 structure in its vacated and closed status would be inimical to the health, safety, and welfare of  
39 the local government in that it would continue to deteriorate, would create a fire or safety  
40 hazard, would be a threat to children and vagrants, would attract persons intent on criminal  
41 activities, or would cause or contribute to blight and the deterioration of property values in the  
42 area. Upon such findings, the governing board may, after the expiration of the two-year period,  
43 enact an ordinance and serve such ordinance on the owner, setting forth the following:

44           (1) If the cost to repair the nonresidential building or structure to bring it into  
45 compliance with the minimum standards is less than or equal to fifty percent  
46 (50%) of its then current value, the ordinance shall require that the owner  
47 either repair or demolish and remove the building or structure within 90  
48 days; or

49           (2) If the cost to repair the nonresidential building or structure to bring it into  
50 compliance with the minimum standards exceeds fifty percent (50%) of its

1                   then current value, the ordinance shall require the owner to demolish and  
2                   remove the building or structure within 90 days.

3           In the case of vacant manufacturing facilities or vacant industrial warehouse facilities, the  
4 building or structure must have been vacated and closed pursuant to an order or ordinance for a  
5 period of five years before the governing board may take action under this subsection. The  
6 ordinance shall be recorded in the office of the register of deeds in the county wherein the  
7 property or properties are located and shall be indexed in the name of the property owner in the  
8 grantor index. If the owner fails to comply with the ordinance, the public officer shall  
9 effectuate the purpose of the ordinance.

10        (h) Service of Complaints and Orders. Complaints or orders issued by a public officer  
11 pursuant to an ordinance adopted under this section shall be served upon persons either  
12 personally or by certified mail so long as the means used are reasonably designed to achieve  
13 actual notice. When service is made by certified mail, a copy of the complaint or order may  
14 also be sent by regular mail. Service shall be deemed sufficient if the certified mail is refused,  
15 but the regular mail is not returned by the post office within 10 days after the mailing. If regular  
16 mail is used, a notice of the pending proceedings shall be posted in a conspicuous place on the  
17 premises affected. If the identities of any owners or the whereabouts of persons are unknown  
18 and cannot be ascertained by the public officer in the exercise of reasonable diligence, and the  
19 public officer makes an affidavit to that effect, the serving of the complaint or order upon the  
20 owners or other persons may be made by publication in a newspaper having general circulation  
21 in the local government planning and development regulation jurisdiction area at least once no  
22 later than the time that personal service would be required under this section. When service is  
23 made by publication, a notice of the pending proceedings shall be posted in a conspicuous place  
24 on the premises affected.

25        (i) Liens.

26           (1) The amount of the cost of repairs, alterations, or improvements, or vacating  
27 and closing, or removal or demolition by the public officer shall be a lien  
28 against the real property upon which the cost was incurred, which lien shall  
29 be filed, have the same priority, and be collected as the lien for special  
30 assessment provided in Article 10 of Chapter 160A of the General Statutes.

31           (2) If the real property upon which the cost was incurred is located in an  
32 incorporated city, the amount of the costs is also a lien on any other real  
33 property of the owner located within the city limits except for the owner's  
34 primary residence. The additional lien provided in this subdivision is inferior  
35 to all prior liens and shall be collected as a money judgment.

36           (3) If the nonresidential building or structure is removed or demolished by the  
37 public officer, he or she shall offer for sale the recoverable materials of the  
38 building or structure and any personal property, fixtures, or appurtenances  
39 found in or attached to the building or structure and shall credit the proceeds  
40 of the sale, if any, against the cost of the removal or demolition, and any  
41 balance remaining shall be deposited in the superior court by the public  
42 officer, shall be secured in a manner directed by the court, and shall be  
43 disbursed by the court to the persons found to be entitled thereto by final  
44 order or decree of the court. Nothing in this section shall be construed to  
45 impair or limit in any way the power of the governing board to define and  
46 declare nuisances and to cause their removal or abatement by summary  
47 proceedings or otherwise.

48        (j) Ejectment. If any occupant fails to comply with an order to vacate a nonresidential  
49 building or structure, the public officer may file a civil action in the name of the local  
50 government to remove the occupant. The action to vacate shall be in the nature of summary  
51 ejectment and shall be commenced by filing a complaint naming as parties-defendant any

1 person occupying the nonresidential building or structure. The clerk of superior court shall  
2 issue a summons requiring the defendant to appear before a magistrate at a certain time, date,  
3 and place not to exceed 10 days from the issuance of the summons to answer the complaint.  
4 The summons and complaint shall be served as provided in G.S. 42-29. The summons shall be  
5 returned according to its tenor, and if on its return it appears to have been duly served and if at  
6 the hearing the public officer produces a certified copy of an ordinance adopted by the  
7 governing board pursuant to subsection (f) of this section to vacate the occupied nonresidential  
8 building or structure, the magistrate shall enter judgment ordering that the premises be vacated  
9 and all persons be removed. The judgment ordering that the nonresidential building or structure  
10 be vacated shall be enforced in the same manner as the judgment for summary ejectment  
11 entered under G.S. 42-30. An appeal from any judgment entered under this subsection by the  
12 magistrate may be taken as provided in G.S. 7A-228, and the execution of the judgment may be  
13 stayed as provided in G.S. 7A-227. An action to remove an occupant of a nonresidential  
14 building or structure who is a tenant of the owner may not be in the nature of a summary  
15 ejectment proceeding pursuant to this subsection unless the occupant was served with notice, at  
16 least 30 days before the filing of the summary ejectment proceeding, that the governing board  
17 has ordered the public officer to proceed to exercise his duties under subsection (f) of this  
18 section to vacate and close or remove and demolish the nonresidential building or structure.

19 (k) Civil Penalty. The governing board may impose civil penalties against any person or  
20 entity that fails to comply with an order entered pursuant to this section. However, the  
21 imposition of civil penalties shall not limit the use of any other lawful remedies available to the  
22 governing board for the enforcement of any ordinances adopted pursuant to this section.

23 (l) Supplemental Powers. The powers conferred by this section are supplemental to the  
24 powers conferred by any other law. An ordinance adopted by the governing board may  
25 authorize the public officer to exercise any powers necessary or convenient to carry out and  
26 effectuate the purpose and provisions of this section, including the following powers in addition  
27 to others herein granted:

28 (1) To investigate nonresidential buildings and structures in the local  
29 government's planning and development regulation jurisdiction to determine  
30 whether they have been properly maintained in compliance with the  
31 minimum standards so that the safety or health of the occupants or members  
32 of the general public are not jeopardized.

33 (2) To administer oaths, affirmations, examine witnesses, and receive evidence.

34 (3) To enter upon premises pursuant to subsection (b) of this section for the  
35 purpose of making examinations in a manner that will do the least possible  
36 inconvenience to the persons in possession.

37 (4) To appoint and fix the duties of officers, agents, and employees necessary to  
38 carry out the purposes of the ordinances adopted by the governing board.

39 (5) To delegate any of his or her functions and powers under the ordinance to  
40 other officers and agents.

41 (m) Appeals. The governing board may provide that appeals may be taken from any  
42 decision or order of the public officer to the local government's housing appeals board or board  
43 of adjustment. Any person aggrieved by a decision or order of the public officer shall have the  
44 remedies provided in G.S. 160D-12-8.

45 (n) Funding. The governing board is authorized to make appropriations from its  
46 revenues necessary to carry out the purposes of this section and may accept and apply grants or  
47 donations to assist in carrying out the provisions of the ordinances adopted by the governing  
48 board.

49 (o) No Effect on Just Compensation for Taking by Eminent Domain. Nothing in this  
50 section shall be construed as preventing the owner or owners of any property from receiving  
51 just compensation for the taking of property by the power of eminent domain under the laws of

1 this State, nor as permitting any property to be condemned or destroyed except in accordance  
2 with the police power of the State.

3 (p) Definitions. As used in this section:

4 (1) "Parties in interest" means all individuals, associations, and corporations  
5 who have interests of record in a nonresidential building or structure and any  
6 who are in possession thereof.

7 (2) "Vacant industrial warehouse" means any building or structure designed for  
8 the storage of goods or equipment in connection with manufacturing  
9 processes, which has not been used for that purpose for at least one year and  
10 has not been converted to another use.

11 (3) "Vacant manufacturing facility" means any building or structure previously  
12 used for the lawful production or manufacturing of goods, which has not  
13 been used for that purpose for at least one year and has not been converted to  
14 another use.

15 "Article 12.

16 "Minimum Housing Codes.

17 **"§ 160D-12-1. Authorization.**

18 (a) Occupied Dwellings. The existence and occupation of dwellings that are unfit for  
19 human habitation are inimical to the welfare and dangerous and injurious to the health and  
20 safety of the people of this State. A public necessity exists for the repair, closing, or demolition  
21 of such dwellings. Whenever any local government finds that there exists in the planning and  
22 development regulation jurisdiction dwellings that are unfit for human habitation due to  
23 dilapidation, defects increasing the hazards of fire, accidents or other calamities, lack of  
24 ventilation, light, or sanitary facilities, or due to other conditions rendering the dwellings unsafe  
25 or unsanitary, or dangerous or detrimental to the health, safety, morals, or otherwise inimical to  
26 the welfare of the residents of the local government, power is conferred upon the local  
27 government to exercise its police powers to repair, close, or demolish the dwellings consistent  
28 with the provisions of this Article.

29 (b) Abandoned Structures. Any local government may by ordinance provide for the  
30 repair, closing, or demolition of any abandoned structure which the governing board finds to be  
31 a health or safety hazard as a result of the attraction of insects or rodents, conditions creating a  
32 fire hazard, dangerous conditions constituting a threat to children, or frequent use by vagrants  
33 as living quarters in the absence of sanitary facilities. The ordinance may provide for the repair,  
34 closing, or demolition of such structure pursuant to the same provisions and procedures as are  
35 prescribed herein for the repair, closing, or demolition of dwellings found to be unfit for human  
36 habitation.

37 **"§ 160A-12-2. Definitions.**

38 The following terms shall have the meanings whenever used or referred to as indicated  
39 when used in this Part unless a different meaning clearly appears from the context:

40 (1) "Owner" means the holder of the title in fee simple interest and every  
41 mortgagee of record.

42 (2) "Parties in interest" means all individuals, associations, and corporations  
43 who have interests of record in a dwelling and any who are in possession  
44 thereof.

45 (3) "Public authority" means any housing authority or any officer who is in  
46 charge of any department or branch of the government of the city, county, or  
47 State relating to health, fire, building regulations, or other activities  
48 concerning dwellings in the city.

49 (4) "Public officer" means the officer or officers who are authorized by  
50 ordinances adopted hereunder to exercise the powers prescribed by the  
51 ordinances and by this Article.

1 "§ 160D-12-3. Ordinance authorized as to repair, closing, and demolition; order of public  
2 officer.

3 Upon the adoption of an ordinance finding that dwelling conditions of the character  
4 described in G.S. 160D-12-1 exist, the governing board is authorized to adopt and enforce  
5 ordinances relating to dwellings within the planning and development regulation jurisdiction  
6 that are unfit for human habitation. These ordinances shall include the following provisions:

7 (1) Designation of enforcement officer. One or more public officers shall be  
8 designated to exercise the powers prescribed by the ordinance.

9 (2) Investigation, complaint, hearing. When it appears to the public officer that  
10 any dwelling is unfit for human habitation, the public officer shall, if a  
11 preliminary investigation discloses a basis for such charges, issue and cause  
12 to be served upon the owner of and parties in interest in such dwellings a  
13 complaint stating the charges in that respect and containing a notice that an  
14 administrative hearing will be held before the public officer (or the officer's  
15 designated agent) at a place within the county in which the property is  
16 located. The hearing shall be not less than 10 days nor more than 30 days  
17 after the serving of the complaint. The owner and parties in interest shall be  
18 given the right to file an answer to the complaint and to appear in person, or  
19 otherwise, and give testimony at the place and time fixed in the complaint.  
20 The rules of evidence prevailing in courts of law shall not be controlling in  
21 administrative hearings before the public officer.

22 (3) Orders. If, after notice and hearing, the public officer determines that the  
23 dwelling under consideration is unfit for human habitation, the officer shall  
24 state in writing findings of fact in support of that determination and shall  
25 issue and cause to be served upon the owner one of the two following orders,  
26 whichever is appropriate:

27 a. If the repair, alteration, or improvement of the dwelling can be made  
28 at a reasonable cost in relation to the value of the dwelling, requiring  
29 the owner, within the time specified, to repair, alter, or improve the  
30 dwelling in order to render it fit for human habitation. The ordinance  
31 may fix a certain percentage of this value as being reasonable. The  
32 order may require that the property be vacated and closed only if  
33 continued occupancy during the time allowed for repair will present a  
34 significant threat of bodily harm, taking into account the nature of the  
35 necessary repairs, alterations, or improvements; the current state of  
36 the property; and any additional risks due to the presence and  
37 capacity of minors under the age of 18 or occupants with physical or  
38 mental disabilities. The order shall state that the failure to make  
39 timely repairs as directed in the order shall make the dwelling subject  
40 to the issuance of an unfit order under subdivision (4) of this section;  
41 or

42 b. If the repair, alteration, or improvement of the dwelling cannot be  
43 made at a reasonable cost in relation to the value of the dwelling,  
44 requiring the owner, within the time specified in the order, to remove  
45 or demolish such dwelling. The ordinance may fix a certain  
46 percentage of this value as being reasonable. However,  
47 notwithstanding any other provision of law, if the dwelling is located  
48 in a historic district and the Historic District Commission determines,  
49 after a public hearing as provided by ordinance, that the dwelling is  
50 of particular significance or value toward maintaining the character  
51 of the district, and the dwelling has not been condemned as unsafe,

1                   the order may require that the dwelling be vacated and closed  
2                   consistent with G.S. 160D-9-49.

3           (4)   Repair, closing, and posting. If the owner fails to comply with an order to  
4                   repair, alter, or improve or to vacate and close the dwelling, the public  
5                   officer may cause the dwelling to be repaired, altered, or improved or to be  
6                   vacated and closed; the public officer may cause to be posted on the main  
7                   entrance of any dwelling so closed, a placard with the following words:  
8                   "This building is unfit for human habitation; the use or occupation of this  
9                   building for human habitation is prohibited and unlawful." Occupation of a  
10                   building so posted shall constitute a Class 1 misdemeanor. The duties of the  
11                   public officer set forth in this subdivision shall not be exercised until the  
12                   governing board shall have by ordinance ordered the public officer to  
13                   proceed to effectuate the purpose of this Article with respect to the particular  
14                   property or properties which the public officer shall have found to be unfit  
15                   for human habitation and which property or properties shall be described in  
16                   the ordinance. This ordinance shall be recorded in the office of the Register  
17                   of Deeds in the county wherein the property or properties are located and  
18                   shall be indexed in the name of the property owner in the grantor index.

19           (5)   Demolition. If the owner fails to comply with an order to remove or  
20                   demolish the dwelling, the public officer may cause such dwelling to be  
21                   removed or demolished. The duties of the public officer set forth in this  
22                   subdivision shall not be exercised until the governing board shall have by  
23                   ordinance ordered the public officer to proceed to effectuate the purpose of  
24                   this Article with respect to the particular property or properties which the  
25                   public officer shall have found to be unfit for human habitation and which  
26                   property or properties shall be described in the ordinance. No such ordinance  
27                   shall be adopted to require demolition of a dwelling until the owner has first  
28                   been given a reasonable opportunity to bring it into conformity with the  
29                   housing code. This ordinance shall be recorded in the office of the Register  
30                   of Deeds in the county wherein the property or properties are located and  
31                   shall be indexed in the name of the property owner in the grantor index.

32           (5a)   Abandonment of intent to repair. If the governing board shall have adopted  
33                   an ordinance as provided in subdivision (4) of this section, or the public  
34                   officer shall have:

35                   (1)   Issued an order or commenced proceedings under the substandard  
36                   housing regulations regarding a dwelling to be repaired or vacated and  
37                   closed, as provided in sub-division a. of subdivision (3) of this section; and

38                   (2)   If the dwelling has been vacated and closed for a period of one  
39                   year pursuant to the ordinance or after such proceedings have commenced,  
40                   then if the governing board shall find that the owner has abandoned the  
41                   intent and purpose to repair, alter, or improve the dwelling in order to render  
42                   it fit for human habitation and that the continuation of the dwelling in its  
43                   vacated and closed status would be inimical to the health, safety, and welfare  
44                   of the local government in that the dwelling would continue to deteriorate,  
45                   would create a fire and safety hazard, would be a threat to children and  
46                   vagrants, would attract persons intent on criminal activities, would cause or  
47                   contribute to blight and the deterioration of property values in the area, and  
48                   would render unavailable property and a dwelling which might otherwise  
49                   have been made available to ease the persistent shortage of decent and  
50                   affordable housing in this State, then in such circumstances, the governing

board may, after the expiration of such one year period, enact an ordinance and serve such ordinance on the owner, setting forth the following:

- a. If it is determined that the repair of the dwelling to render it fit for human habitation can be made at a cost not exceeding fifty percent (50%) of the then current value of the dwelling, the ordinance shall require that the owner either repair or demolish and remove the dwelling within 90 days; or
- b. If it is determined that the repair of the dwelling to render it fit for human habitation cannot be made at a cost not exceeding fifty percent (50%) of the then current value of the dwelling, the ordinance shall require the owner to demolish and remove the dwelling within 90 days.

This ordinance shall be recorded in the Office of the Register of Deeds in the county wherein the property or properties are located and shall be indexed in the name of the property owner in the grantor index. If the owner fails to comply with this ordinance, the public officer shall effectuate the purpose of the ordinance.

(6) Liens.

- a. That the amount of the cost of repairs, alterations, or improvements, or vacating and closing, or removal or demolition by the public officer shall be a lien against the real property upon which the cost was incurred, which lien shall be filed, have the same priority, and be collected as the lien for special assessment provided in Article 10 of Chapter 160A of the General Statutes.
- b. If the real property upon which the cost was incurred is located in an incorporated city, then the amount of the cost is also a lien on any other real property of the owner located within the city limits or within one mile thereof except for the owner's primary residence. The additional lien provided in this sub-subdivision is inferior to all prior liens and shall be collected as a money judgment.
- c. If the dwelling is removed or demolished by the public officer, the local government shall sell the materials of the dwelling, and any personal property, fixtures, or appurtenances found in or attached to the dwelling, and shall credit the proceeds of the sale against the cost of the removal or demolition, and any balance remaining shall be deposited in the superior court by the public officer, shall be secured in a manner directed by the court, and shall be disbursed by the court to the persons found to be entitled thereto by final order or decree of the court. Nothing in this section shall be construed to impair or limit in any way the power of the local government to define and declare nuisances and to cause their removal or abatement by summary proceedings, or otherwise.

(7) Civil action. If any occupant fails to comply with an order to vacate a dwelling, the public officer may file a civil action in the name of the local government to remove such occupant. The action to vacate the dwelling shall be in the nature of summary ejection and shall be commenced by filing a complaint naming as defendant any person occupying such dwelling. The clerk of superior court shall issue a summons requiring the defendant to appear before a magistrate at a certain time, date, and place not to exceed 10 days from the issuance of the summons to answer the complaint. The summons and complaint shall be served as provided in G.S. 42-29. If the

1 summons appears to have been duly served, and if at the hearing the public  
2 officer produces a certified copy of an ordinance adopted by the governing  
3 board pursuant to subdivision (5) of this section authorizing the officer to  
4 proceed to vacate the occupied dwelling, the magistrate shall enter judgment  
5 ordering that the premises be vacated and that all persons be removed. The  
6 judgment ordering that the dwelling be vacated shall be enforced in the same  
7 manner as the judgment for summary ejection entered under G.S. 42-30.  
8 An appeal from any judgment entered hereunder by the magistrate may be  
9 taken as provided in G.S. 7A-228, and the execution of such judgment may  
10 be stayed as provided in G.S. 7A-227. An action to remove an occupant of a  
11 dwelling who is a tenant of the owner may not be in the nature of a summary  
12 ejection proceeding pursuant to this paragraph unless such occupant was  
13 served with notice at least 30 days before the filing of the summary  
14 ejection proceeding that the governing board has ordered the public officer  
15 to proceed to exercise his duties under subdivisions (4) and (5) of this  
16 section to vacate and close or remove and demolish the dwelling.

17 (8) Additional notices to affordable housing organizations. Whenever a  
18 determination is made pursuant to subdivision (3) of this section that a  
19 dwelling must be vacated and closed or removed or demolished, under the  
20 provisions of this section, notice of the order shall be given by first-class  
21 mail to any organization involved in providing or restoring dwellings for  
22 affordable housing that has filed a written request for such notices. A  
23 minimum period of 45 days from the mailing of such notice shall be given  
24 before removal or demolition by action of the public officer to allow the  
25 opportunity for any organization to negotiate with the owner to make repairs,  
26 lease, or purchase the property for the purpose of providing affordable  
27 housing. The public officer or clerk shall certify the mailing of the notices,  
28 and the certification shall be conclusive in the absence of fraud. Only an  
29 organization that has filed a written request for such notices may raise the  
30 issue of failure to mail such notices, and the sole remedy shall be an order  
31 requiring the public officer to wait 45 days before causing removal or  
32 demolition.

33 **§ 160D-12-4. Heat source required.**

34 (a) A local government shall, by ordinance, require that every dwelling unit leased as  
35 rental property within the city shall have, at a minimum, a central or electric heating system or  
36 sufficient chimneys, flues, or gas vents, with heating appliances connected, so as to heat at least  
37 one habitable room, excluding the kitchen, to a minimum temperature of 68 degrees Fahrenheit  
38 measured three feet above the floor with an outside temperature of 20 degrees Fahrenheit.

39 (b) If a dwelling unit contains a heating system or heating appliances that meet the  
40 requirements of subsection (a) of this section, the owner of the dwelling unit shall not be  
41 required to install a new heating system or heating appliances, but the owner shall be required  
42 to maintain the existing heating system or heating appliances in a good and safe working  
43 condition. Otherwise, the owner of the dwelling unit shall install a heating system or heating  
44 appliances that meet the requirements of subsection (a) of this section and shall maintain the  
45 heating system or heating appliances in a good and safe working condition.

46 (c) Portable kerosene heaters are not acceptable as a permanent source of heat as  
47 required by subsection (a) of this section but may be used as a supplementary source in  
48 single-family dwellings and duplex units. An owner who has complied with subsection (a) of  
49 this section shall not be held in violation of this section where an occupant of a dwelling unit  
50 uses a kerosene heater as a primary source of heat.



1       (d) This section applies only to local governments with a population of 200,000 or over  
2 within their planning and development regulation jurisdiction, according to the most recent  
3 decennial federal census.

4       (e) Nothing in this section shall be construed as:

5           (1) Diminishing the rights of or remedies available to any tenant under a lease  
6 agreement, statute, or at common law; or

7           (2) Prohibiting a city from adopting an ordinance with more stringent heating  
8 requirements than provided for by this section.

9 **"§ 160D-12-5. Standards.**

10 An ordinance adopted under this Article shall provide that the public officer may determine  
11 that a dwelling is unfit for human habitation if the officer finds that conditions exist in the  
12 dwelling that render it dangerous or injurious to the health or safety of the occupants of the  
13 dwelling, the occupants of neighboring dwellings, or other residents of the jurisdiction.  
14 Defective conditions may include the following (without limiting the generality of the  
15 foregoing): defects therein increasing the hazards of fire, accident, or other calamities; lack of  
16 adequate ventilation, light, or sanitary facilities; dilapidation; disrepair; structural defects;  
17 uncleanliness. The ordinances may provide additional standards to guide the public officers in  
18 determining the fitness of a dwelling for human habitation.

19 **"§ 160D-12-6. Service of complaints and orders.**

20       (a) Complaints or orders issued by a public officer pursuant to an ordinance adopted  
21 under this Article shall be served upon persons either personally or by certified mail. When  
22 service is made by certified mail, a copy of the complaint or order may also be sent by regular  
23 mail. Service shall be deemed sufficient if the certified mail is unclaimed or refused, but the  
24 regular mail is not returned by the post office within 10 days after the mailing. If regular mail is  
25 used, a notice of the pending proceedings shall be posted in a conspicuous place on the  
26 premises affected.

27       (a1) If the identities of any owners or the whereabouts of persons are unknown and  
28 cannot be ascertained by the public officer in the exercise of reasonable diligence, or, if the  
29 owners are known but have refused to accept service by certified mail, and the public officer  
30 makes an affidavit to that effect, then the serving of the complaint or order upon the owners or  
31 other persons may be made by publication in a newspaper having general circulation in the  
32 jurisdiction at least once no later than the time at which personal service would be required  
33 under the provisions of this Article. When service is made by publication, a notice of the  
34 pending proceedings shall be posted in a conspicuous place on the premises thereby affected.

35 **"§ 160D-12-7. Periodic inspections.**

36       (a) Except as provided in subsection (b) of this section, the inspection department may  
37 make periodic inspections only when there is reasonable cause to believe that unsafe,  
38 unsanitary, or otherwise hazardous or unlawful conditions may exist in a residential building or  
39 structure. For purposes of this section, the term "reasonable cause" means any of the following:  
40 (i) the landlord or owner has a history of more than two verified violations of the housing  
41 ordinances or codes within a 12-month period; (ii) there has been a complaint that substandard  
42 conditions exist within the building or there has been a request that the building be inspected;  
43 (iii) the inspection department has actual knowledge of an unsafe condition within the building;  
44 or (iv) violations of the local ordinances or codes are visible from the outside of the property. In  
45 conducting inspections authorized under this section, the inspection department shall not  
46 discriminate between single-family and multifamily buildings. In exercising this power,  
47 members of the department shall have a right to enter on any premises within the jurisdiction of  
48 the department at all reasonable hours for the purposes of inspection or other enforcement  
49 action, upon presentation of proper credentials. Nothing in this section shall be construed to  
50 prohibit periodic inspections in accordance with State fire prevention code or as otherwise  
51 required by State law.

1        (b) A local government may require periodic inspections as part of a targeted effort  
2 within a geographic area that has been designated by the governing board. The local  
3 government shall not discriminate in its selection of areas or housing types to be targeted and  
4 shall (i) provide notice to all owners and residents of properties in the affected area about the  
5 periodic inspections plan and information regarding a public hearing regarding the plan; (ii)  
6 hold a public hearing regarding the plan; and (iii) establish a plan to address the ability of  
7 low-income residential property owners to comply with minimum housing code standards.

8        (c) In no event may a local government do any of the following: (i) adopt or enforce  
9 any ordinance that would require any owner or manager of rental property to obtain any permit  
10 or permission under Article 11 or Article 12 of this Chapter from the local government to lease  
11 or rent residential real property, except for those properties that have more than three verified  
12 violations in a 12-month period or upon the property being identified within the top 10% of  
13 properties with crime or disorder problems as set forth in a local ordinance; (ii) require that an  
14 owner or manager of residential rental property enroll or participate in any governmental  
15 program as a condition of obtaining a certificate of occupancy; or (iii) except as provided in  
16 subsection (d) of this section, levy a special fee or tax on residential rental property that is not  
17 also levied against other commercial and residential properties.

18        (d) A local government may levy a fee for residential rental property registration under  
19 subsection (c) of this section for those rental units which have been found with more than two  
20 verified violations of local ordinances within the previous 12 months or upon the property  
21 being identified within the top ten percent (10%) of properties with crime or disorder problems  
22 as set forth in a local ordinance. The fee shall be an amount that covers the cost of operating a  
23 residential registration program and shall not be used to supplant revenue in other areas. Local  
24 governments using registration programs that charge registration fees for all residential rental  
25 properties as of June 1, 2011, may continue levying a fee on all residential rental properties as  
26 follows:

- 27            (1) For properties with 20 or more residential rental units, the fee shall be no  
28 more than fifty dollars (\$50.00) per year.  
29            (2) For properties with fewer than 20 but more than three residential rental units,  
30 the fee shall be no more than twenty-five dollars (\$25.00) per year.  
31            (3) For properties with three or fewer residential rental units, the fee shall be no  
32 more than fifteen dollars (\$15.00) per year.

33 **"§ 160D-12-8. Remedies.**

34        (a) An ordinance adopted pursuant to this Article may provide for a housing appeals  
35 board as provided by G.S. 160D-3-6. An appeal from any decision or order of the public officer  
36 may be taken by any person aggrieved thereby or by any officer, board, or commission of the  
37 local government. Any appeal from the public officer shall be taken within 10 days from the  
38 rendering of the decision or service of the order by filing with the public officer and with the  
39 housing appeals board a notice of appeal which shall specify the grounds upon which the  
40 appeal is based. Upon the filing of any notice of appeal, the public officer shall forthwith  
41 transmit to the board all the papers constituting the record upon which the decision appealed  
42 from was made. When an appeal is from a decision of the public officer refusing to allow the  
43 person aggrieved thereby to do any act, the decision shall remain in force until modified or  
44 reversed. When any appeal is from a decision of the public officer requiring the person  
45 aggrieved to do any act, the appeal shall have the effect of suspending the requirement until the  
46 hearing by the board, unless the public officer certifies to the board, after the notice of appeal is  
47 filed with the officer, that because of facts stated in the certificate (a copy of which shall be  
48 furnished the appellant), a suspension of the requirement would cause imminent peril to life or  
49 property. In that case the requirement shall not be suspended except by a restraining order,  
50 which may be granted for due cause shown upon not less than one day's written notice to the

1 public officer, by the board, or by a court of record upon petition made pursuant to subsection  
2 (f) of this section.

3 (b) The housing appeals board shall fix a reasonable time for hearing appeals, shall give  
4 due notice to the parties, and shall render its decision within a reasonable time. Any party may  
5 appear in person or by agent or attorney. The board may reverse or affirm, wholly or partly, or  
6 may modify the decision or order appealed from, and may make any decision and order that in  
7 its opinion ought to be made in the matter, and to that end it shall have all the powers of the  
8 public officer, but the concurring vote of four members of the board shall be necessary to  
9 reverse or modify any decision or order of the public officer. The board shall have power also  
10 in passing upon appeals, when unnecessary hardships would result from carrying out the strict  
11 letter of the ordinance, to adapt the application of the ordinance to the necessities of the case to  
12 the end that the spirit of the ordinance shall be observed, public safety and welfare secured, and  
13 substantial justice done.

14 (c) Every decision of the housing appeals board shall be subject to review by  
15 proceedings in the nature of certiorari instituted within 15 days of the decision of the board, but  
16 not otherwise.

17 (d) Any person aggrieved by an order issued by the public officer or a decision rendered  
18 by the housing appeals board may petition the superior court for an injunction restraining the  
19 public officer from carrying out the order or decision, and the court may, upon such petition,  
20 issue a temporary injunction restraining the public officer pending a final disposition of the  
21 cause. The petition shall be filed within 30 days after issuance of the order or rendering of the  
22 decision. Hearings shall be had by the court on a petition within 20 days and shall be given  
23 preference over other matters on the court's calendar. The court shall hear and determine the  
24 issues raised and shall enter such final order or decree as law and justice may require. It shall  
25 not be necessary to file bond in any amount before obtaining a temporary injunction under this  
26 subsection.

27 (e) If any dwelling is erected, constructed, altered, repaired, converted, maintained, or  
28 used in violation of this Article or of any ordinance or code adopted under authority of this  
29 Article or any valid order or decision of the public officer or board made pursuant to any  
30 ordinance or code adopted under authority of this Article, the public officer or board may  
31 institute any appropriate action or proceedings to prevent the unlawful erection, construction,  
32 reconstruction, alteration, or use, to restrain, correct, or abate the violation, to prevent the  
33 occupancy of the dwelling, or to prevent any illegal act, conduct, or use in or about the  
34 premises of the dwelling.

35 **"§ 160D-12-9. Compensation to owners of condemned property.**

36 Nothing in this Article shall be construed as preventing the owner or owners of any  
37 property from receiving just compensation for the taking of property by the power of eminent  
38 domain under the laws of this State, nor as permitting any property to be condemned or  
39 destroyed except in accordance with the police power of the State.

40 **"§ 160D-12-10. Additional powers of public officer.**

41 An ordinance adopted by the governing board may authorize the public officer to exercise  
42 any powers necessary or convenient to carry out and effectuate the purpose and provisions of  
43 this Article, including the following powers in addition to others herein granted:

- 44 (1) To investigate the dwelling conditions in the local government's planning  
45 and development regulation jurisdiction in order to determine which  
46 dwellings therein are unfit for human habitations;
- 47 (2) To administer oaths, affirmations, examine witnesses, and receive evidence;
- 48 (3) To enter upon premises for the purpose of making examinations in a manner  
49 that will do the least possible inconvenience to the persons in possession;
- 50 (4) To appoint and fix the duties of officers, agents, and employees necessary to  
51 carry out the purposes of the ordinances; and

1           (5) To delegate any of his functions and powers under the ordinance to other  
2           officers and other agents.

3 **"§ 160D-12-11. Administration of ordinance.**

4           A local government adopting an ordinance under this Article shall, as soon as possible  
5 thereafter, prepare an estimate of the annual expenses or costs to provide the equipment,  
6 personnel, and supplies necessary for periodic examinations and investigations of the dwellings  
7 for the purpose of determining the fitness of dwellings for human habitation, and for the  
8 enforcement and administration of its ordinances adopted under this Article. The local  
9 government is authorized to make appropriations from its revenues necessary for this purpose  
10 and may accept and apply grants or donations to assist it in carrying out the provisions of the  
11 ordinances.

12 **"§ 160D-12-12. Supplemental nature of Article.**

13           Nothing in this Article shall be construed to abrogate or impair the powers of the courts or  
14 of any department of any local government to enforce any provisions of its charter or its  
15 ordinances or regulations, nor to prevent or punish violations thereof. The powers conferred by  
16 this Article shall be supplemental to the powers conferred by any other law.

17                           "Article 13.

18                           "Additional Authority.

19                           "Part 1. Open Space Acquisition.

20 **"§ 160D-13-1. Legislative intent.**

21           It is the intent of the General Assembly to provide a means whereby any local government  
22 may acquire, by purchase, gift, grant, devise, lease, or otherwise, and through the expenditure  
23 of public funds, the fee or any lesser interest or right in real property in order to preserve,  
24 through limitation of their future use, open spaces and areas for public use and enjoyment.

25 **"§ 160D-13-2. Finding of necessity.**

26           The General Assembly finds that the rapid growth and spread of urban development in the  
27 State is encroaching upon, or eliminating, many open areas and spaces of varied size and  
28 character, including many having significant scenic or aesthetic values, which areas and spaces  
29 if preserved and maintained in their present open state would constitute important physical,  
30 social, esthetic, or economic assets to existing and impending urban development. The General  
31 Assembly declares that it is necessary for sound and proper urban development and in the  
32 public interest of the people of this State for any local government to expend or advance public  
33 funds for, or to accept by purchase, gift, grant, devise, lease, or otherwise, the fee or any lesser  
34 interest or right in real property so as to acquire, maintain, improve, protect, limit the future use  
35 of, or otherwise conserve open spaces and areas within their respective jurisdictions as defined  
36 by this Article.

37           The General Assembly declares that the acquisition of interests or rights in real property for  
38 the preservation of open spaces and areas constitutes a public purpose for which public funds  
39 may be expended or advanced.

40 **"§ 160D-13-3. Local governments authorized to acquire and reconvey real property.**

41           Any local government may acquire by purchase, gift, grant, devise, lease, or otherwise, the  
42 fee or any lesser interest, development right, easement, covenant, or other contractual right of  
43 or to real property within its respective jurisdiction, when it finds that the acquisition is  
44 necessary to achieve the purposes of this Part. Any local government may also acquire the fee  
45 to any property for the purpose of conveying or leasing the property back to its original owner  
46 or other person under covenants or other contractual arrangements that will limit the future use  
47 of the property in accordance with the purposes of this Part, but when this is done, the property  
48 may be conveyed back to its original owner but to no other person by private sale.

49 **"§ 160D-13-4. Joint action by governing bodies.**

50           A local government may enter into any agreement with any other local government for the  
51 purpose of jointly exercising the authority granted by this Part.

**"§ 160D-13-5. Power of governing bodies.**

A local government, in order to exercise the authority granted by this Part, may:

- (1) Enter into and carry out contracts with the State or federal government or any agencies thereof under which grants or other assistance are made to the local government;
- (2) Accept any assistance or funds that may be granted by the State or federal government with or without a contract;
- (3) Agree to and comply with any reasonable conditions imposed upon grants;
- (4) Make expenditures from any funds so granted.

**"§ 160D-13-6. Appropriations authorized.**

For the purposes set forth in this Part, a local government may appropriate funds not otherwise limited as to use by law.

**"§ 160D-13-7. Definitions.**

(a) For the purpose of this Part an "open space" or "open area" is any space or area (i) characterized by great natural scenic beauty or (ii) whose existing openness, natural condition, or present state of use, if retained, would enhance the present or potential value of abutting or surrounding urban development, or would maintain or enhance the conservation of natural or scenic resources.

(b) For the purposes of this Part "open space" or "open area" and the "public use and enjoyment" of interests or rights in real property shall also include open space land and open space uses. The term "open space land" means any undeveloped or predominantly undeveloped land in an urban area that has value for one or more of the following purposes: (i) park and recreational purposes, (ii) conservation of land and other natural resources, or (iii) historic or scenic purposes. The term "open space uses" means any use of open space land for (i) park and recreational purposes, (ii) conservation of land and other natural resources, or (iii) historic or scenic purposes.

"Part 2. Community Development and Redevelopment.

**"§ 160D-13-11. Community development programs and activities.**

(a) A local government is authorized to engage in, to accept federal and State grants and loans for, and to appropriate and expend funds for community development programs and activities. In undertaking community development programs and activities, in addition to other authority granted by law, a city may engage in the following activities:

- (1) Programs of assistance and financing of rehabilitation of private buildings principally for the benefit of low and moderate income persons, or for the restoration or preservation of older neighborhoods or properties, including direct repair, the making of grants or loans, the subsidization of interest payments on loans, and the guaranty of loans;
- (2) Programs concerned with employment, economic development, crime prevention, child care, health, drug abuse, education, and welfare needs of persons of low and moderate income.

(b) A governing board may exercise directly those powers granted by law to municipal redevelopment commissions and those powers granted by law to municipal housing authorities, and may do so whether or not a redevelopment commission or housing authority is in existence in such city. Any governing board desiring to do so may delegate to any redevelopment commission or to any housing authority the responsibility of undertaking or carrying out any specified community development activities. Any governing board may by agreement undertake or carry out for each other any specified community development activities. A governing board may contract with any person, association, or corporation in undertaking any specified community development activities. Any county or city board of health, county board of social services, or county or city board of education may by agreement undertake or carry out for any governing board any specified community development activities.

1       (c) A local government undertaking community development programs or activities  
2 may create one or more advisory committees to advise it and to make recommendations  
3 concerning such programs or activities.

4       (d) A governing board proposing to undertake any loan guaranty or similar program for  
5 rehabilitation of private buildings is authorized to submit to its voters the question whether such  
6 program shall be undertaken, such referendum to be conducted pursuant to the general and  
7 local laws applicable to special elections in such local government. No State or local taxes shall  
8 be appropriated or expended by a county pursuant to this section for any purpose not expressly  
9 authorized by G.S. 153A-149, unless the same is first submitted to a vote of the people as  
10 therein provided.

11       (e) A local government may receive and dispense funds from the Community  
12 Development Block Grant Section 108 Loan Guarantee program, Subpart M, 24  
13 C.F.R. § 570.700 et seq., either through application to the North Carolina Department of  
14 Commerce or directly from the federal government, in accordance with State and federal laws  
15 governing these funds. Any local government that receives these funds directly from the federal  
16 government may pledge current and future CDBG funds for use as loan guarantees in  
17 accordance with State and federal laws governing these funds. A local government may  
18 implement the receipt, dispensing, and pledging of CDBG funds under this subsection by  
19 borrowing CDBG funds and lending all or a portion of those funds to a third party in  
20 accordance with applicable laws governing the CDBG program.

21       A local government that has pledged current or future CDBG funds for use as loan  
22 guarantees prior to the enactment of this subsection is authorized to have taken such action. A  
23 pledge of future CDBG funds under this subsection is not a debt or liability of the State or any  
24 political subdivision of the State or a pledge of the faith and credit of the State or any political  
25 subdivision of the State. The pledging of future CDBG funds under this subsection does not  
26 directly, indirectly, or contingently obligate the State or any political subdivision of the State to  
27 levy or to pledge any taxes.

28       (f) All program income from Economic Development Grants from the Small Cities  
29 Community Development Block Grant Program may be retained by recipient cities and  
30 counties in "economically distressed counties", as defined in G.S. 143B-437.01, for the  
31 purposes of creating local economic development revolving loan funds. Such program income  
32 derived through the use by cities of Small Cities Community Development Block Grant money  
33 includes, but is not limited to: (i) payment of principal and interest on loans made by the county  
34 using Community Development Block Grant Funds; (ii) proceeds from the lease or disposition  
35 of real property acquired with Community Development Block Grant Funds; and (iii) any late  
36 fees associated with loan or lease payments in (i) and (ii) of this subsection. The local  
37 economic development revolving loan fund set up by the city shall fund only those activities  
38 eligible under Title I of the federal Housing and Community Development Act of 1974, as  
39 amended (P.L. 93-383), and shall meet at least one of the three national objectives of the  
40 Housing and Community Development Act. Any expiration of G.S. 143B-437.01 or  
41 G.S. 105-129.3 shall not affect this subsection as to designations of economically distressed  
42 counties made prior to its expiration.

43 **"§ 160D-13-12. Acquisition and disposition of property for redevelopment.**

44       Any local government is authorized, either as a part of a community development program  
45 or independently thereof, and without the necessity of compliance with the Urban  
46 Redevelopment Law, to exercise the following powers:

- 47           (1) To acquire, by voluntary purchase from the owner or owners, real property  
48               which is either:  
49               a. Blighted, deteriorated, deteriorating, undeveloped, or inappropriately  
50                 developed from the standpoint of sound community development and  
51                 growth;

- 1            b.     Appropriate for rehabilitation or conservation activities;  
2            c.     Appropriate for housing construction or the economic development  
3            of the community; or  
4            d.     Appropriate for the preservation or restoration of historic sites, the  
5            beautification of urban land, the conservation of open space, natural  
6            resources, and scenic areas, the provision of recreational  
7            opportunities, or the guidance of urban development;

8            (2)    To clear, demolish, remove, or rehabilitate buildings and improvements on  
9            land so acquired;

10          (3)    To retain property so acquired for public purposes, or to dispose, through  
11          sale, lease, or otherwise, of any property so acquired to any person, firm,  
12          corporation, or governmental unit; provided, the disposition of such property  
13          shall be undertaken in accordance with the procedures of Article 12 of  
14          Chapter 160A of the General Statutes, or the procedures of G.S. 160A-514,  
15          or any applicable local act or charter provision modifying such procedures;  
16          or subsection (4) of this section;

17          (4)    To sell, exchange, or otherwise transfer real property or any interest therein  
18          in a community development project area to any redeveloper at private sale  
19          for residential, recreational, commercial, industrial, or other uses or for  
20          public use in accordance with the community development plan, subject to  
21          such covenants, conditions, and restrictions as may be deemed to be in the  
22          public interest or to carry out the purposes of this Article; provided, that such  
23          sale, exchange, or other transfer, and any agreement relating thereto, may be  
24          made only after approval of the governing board and after a public hearing; a  
25          notice of the public hearing shall be given once a week for two successive  
26          weeks in a newspaper having general circulation in the local government  
27          planning and development regulation jurisdiction area, and the notice shall  
28          be published the first time not less than 10 days nor more than 25 days  
29          preceding the public hearing; and the notice shall disclose the terms of the  
30          sale, exchange, or transfer. At the public hearing the appraised value of the  
31          property to be sold, exchanged, or transferred shall be disclosed; and the  
32          consideration for the conveyance shall not be less than the appraised value.

33    **"§ 160D-13-13. Urban Development Action Grants.**

34          Any local government is authorized, either as a part of a community development program  
35          or independently thereof, to enter into contracts or agreements with any person, association, or  
36          corporation to undertake and carry out specified activities in furtherance of the purposes of  
37          Urban Development Action Grants authorized by the Housing and Community Development  
38          Act of 1977 (P.L. 95-128) or any amendment thereto which is a continuation of such grant  
39          programs by whatever designation, including the authority to enter into and carry out contracts  
40          or agreements to extend loans, loan subsidies, or grants to persons, associations, or corporations  
41          and to dispose of real or personal property by private sale in furtherance of such contracts or  
42          agreements.

43          Any enabling legislation contained in local acts which refers to "Urban Development  
44          Action Grants" or the Housing and Community Development Act of 1977 (P.L. 95-128) shall  
45          be construed also to refer to any continuation of such grant programs by whatever designation.

46    **"§ 160D-13-14. Urban homesteading programs.**

47          A local government may establish a program of urban homesteading, in which residential  
48          property of little or no value is conveyed to persons who agree to rehabilitate the property and  
49          use it, for a minimum number of years, as their principal place of residence. Residential  
50          property is considered of little or no value if the cost of bringing the property into compliance  
51          with the local government's housing code exceeds sixty percent (60%) of the property's

1 appraised value on the county tax records. In undertaking such a program a local government  
2 may:

- 3 (1) Acquire by purchase, gift, or otherwise, but not eminent domain, residential  
4 property specifically for the purpose of reconveyance in the urban  
5 homesteading program or may transfer to the program residential property  
6 acquired for other purposes, including property purchased at a tax  
7 foreclosure sale.
- 8 (2) Under procedures and standards established by the local government, convey  
9 residential property by private sale under G.S. 160A-267 and for nominal  
10 monetary consideration to persons who qualify as grantees.
- 11 (3) Convey property subject to conditions that:
- 12 a. Require the grantee to use the property as his or her principal place  
13 of residence for a minimum number of years;
- 14 b. Require the grantee to rehabilitate the property so that it meets or  
15 exceeds minimum housing code standards;
- 16 c. Require the grantee to maintain insurance on the property;
- 17 d. Set out any other specific conditions (including, but not limited to,  
18 design standards) or actions that the local government may require;  
19 and
- 20 e. Provide for the termination of the grantee's interest in the property  
21 and its reversion to the local government upon the grantee's failure to  
22 meet any condition so established.
- 23 (4) Subordinate the local government's interest in the property to any security  
24 interest granted by the grantee to a lender of funds to purchase or rehabilitate  
25 the property.

26 **§ 160D-13-15. Joint development projects.**

27 (a) Definition. In this section, "joint development project" means a capital project, as  
28 that district is defined by the governing board, comprising one or more buildings and including  
29 both public and private facilities. By way of illustration but not limitation, such a project might  
30 include a single building comprising a publicly owned parking structure and publicly owned  
31 convention center and a privately owned hotel or office building.

32 (b) Authorization. If the governing board finds that it is likely to have a significant  
33 effect on the revitalization of the jurisdiction, the local government may acquire, construct,  
34 own, and operate or participate in the acquisition, construction, ownership, and operation of a  
35 joint development project or of specific facilities within such a project. The local government  
36 may enter into binding contracts with one or more private developers with respect to acquiring,  
37 constructing, owning, or operating such a project. Such a contract may, among other  
38 provisions, specify the following:

- 39 (1) The property interests of both the local government and the developer or  
40 developers in the project, provided that the property interests of the local  
41 government shall be limited to facilities for a public purpose;
- 42 (2) The responsibilities of the local government and the developer or developers  
43 for construction of the project; and
- 44 (3) The responsibilities of the local government and the developer or developers  
45 with respect to financing the project.

46 Such a contract may be entered into before the acquisition of any real property necessary to  
47 the project.

48 (c) Eligible Property. A joint development project may be constructed on property  
49 acquired by the developer or developers, on property directly acquired by the local government,  
50 or on property acquired by the local government while exercising the powers, duties, and



1 responsibilities of a redevelopment commission pursuant to G.S. 160A-505 or  
2 G.S. 160D-13-11.

3 (d) Conveyance of Property Rights. In connection with a joint development project, the  
4 local government may convey interests in property owned by it, including air rights over public  
5 facilities, as follows:

6 (1) If the property was acquired while the local government was exercising the  
7 powers, duties, and responsibilities of a redevelopment commission, the  
8 local government may convey property interests pursuant to the "Urban  
9 Redevelopment Law" or any local modification thereof.

10 (2) If the property was acquired by the local government directly, the local  
11 government may convey property interests pursuant to G.S. 160D-13-12,  
12 and Article 12 of Chapter 160A of the General Statutes does not apply to  
13 such dispositions.

14 (3) In lieu of conveying the fee interest in air rights, the local government may  
15 convey a leasehold interest for a period not to exceed 99 years, using the  
16 procedures of subdivisions (1) or (2) of this subsection, as applicable.

17 (e) Construction. The contract between the local government and the developer or  
18 developers may provide that the developer or developers shall be responsible for construction  
19 of the entire joint development project. If so, the contract shall include such provisions as the  
20 governing board deems sufficient to assure that the public facility or facilities included in the  
21 project meet the needs of the local government and are constructed at a reasonable price. A  
22 project constructed pursuant to this paragraph is not subject to Article 8 of Chapter 143 of the  
23 General Statutes, provided that local government funds constitute no more than fifty percent  
24 (50%) of the total costs of the joint development project. Federal funds available for loan to  
25 private developers in connection with a joint development project shall not be considered local  
26 government funds for purposes of this subsection.

27 (f) Operation. The local government may contract for the operation of any public  
28 facility or facilities included in a joint redevelopment project by a person, partnership, firm, or  
29 corporation, public or private. Such a contract shall include provisions sufficient to assure that  
30 any such facility or facilities are operated for the benefit of the citizens of the local government.

31 (g) Grant Funds. To assist in the financing of its share of a joint development project,  
32 the local government may apply for, accept, and expend grant funds from the federal or State  
33 governments.

34 **"§ 160D-13-16. Low- and moderate-income housing programs.**

35 Any local government is authorized to exercise the following powers:

36 (1) To engage in and to appropriate and expend funds for residential housing  
37 construction, new or rehabilitated, for sale or rental to persons and families  
38 of low and moderate income. Any governing board may contract with any  
39 person, association, or corporation to implement the provisions of this  
40 subdivision.

41 (2) To acquire real property by voluntary purchase from the owners to be  
42 developed by the local government or to be used by the local government to  
43 provide affordable housing to persons of low and moderate income.

44 (3) To convey property by private sale to any public or private entity that  
45 provides affordable housing to persons of low or moderate income under  
46 procedures and standards established by the local government. The local  
47 government shall include as part of any such conveyance covenants or  
48 conditions that assure the property will be developed by the entity for sale or  
49 lease to persons of low or moderate income.

50 (4) To convey residential property by private sale to persons of low or moderate  
51 income, in accordance with procedures and standards established by the

1 local government, with G.S. 160A-267, and with any terms and conditions  
2 that the governing board may determine.

3 "Part 3. Miscellaneous.

4 **"§ 160D-13-20. Program to finance energy improvements.**

5 (a) Purpose. The General Assembly finds it is in the best interest of the citizens of  
6 North Carolina to promote and encourage renewable energy and energy efficiency within the  
7 State in order to conserve energy, promote economic competitiveness, and expand employment  
8 in the State. The General Assembly also finds that a local government has an integral role in  
9 furthering this purpose by promoting and encouraging renewable energy and energy efficiency  
10 within the local government's territorial jurisdiction. In furtherance of this purpose, a local  
11 government may establish a program to finance the purchase and installation of distributed  
12 generation renewable energy sources or energy efficiency improvements that are permanently  
13 affixed to residential, commercial, or other real property.

14 (b) Financing Assistance. A local government may establish a revolving loan fund and  
15 a loan loss reserve fund for the purpose of financing or assisting in the financing of the  
16 purchase and installation of distributed generation renewable energy sources or energy  
17 efficiency improvements that are permanently fixed to residential, commercial, or other real  
18 property. A local government may establish other local government energy efficiency and  
19 distributed generation renewable energy source finance programs funded through federal  
20 grants. A local government may use State and federal grants and loans and its general revenue  
21 for this financing. The annual interest rate charged for the use of funds from the revolving fund  
22 may not exceed eight percent (8%) per annum, excluding other fees for loan application review  
23 and origination. The term of any loan originated under this section may not be greater than 20  
24 years.

25 (c) Definition. As used in this Article, "renewable energy source" has the same meaning  
26 as "renewable energy resource" in G.S. 62-133.8.

27 "Article 14.

28 "Judicial Review.

29 **"§ 160D-14-1. Declaratory judgments.**

30 Challenges of legislative decisions of governing boards, including the construction or  
31 validity of ordinances adopted pursuant to this Chapter, and actions authorized by  
32 G.S. 160D-4-5(b) may be brought pursuant to Article 26 of Chapter 1 of the General Statutes.  
33 The governmental unit making the challenged legislative decision shall be named a party to the  
34 action.

35 **"§ 160D-14-2. Appeals in the nature of certiorari.**

36 (a) Applicability. This section applies to appeals of quasi-judicial decisions of  
37 decision-making boards when that appeal is in the nature of certiorari as required by this  
38 Chapter.

39 (b) Filing the Petition. An appeal in the nature of certiorari shall be initiated by filing  
40 petition for writ of certiorari with the superior court. The petition shall:

- 41 (1) State the facts that demonstrate that the petitioner has standing to seek  
42 review.
- 43 (2) Set forth allegations to sufficiently give the court and parties notice of the  
44 grounds upon which the petitioner contends that an error was made.
- 45 (3) Set forth with particularity the allegations and facts, if any, in support of  
46 allegations that, as the result of an impermissible conflict as described in  
47 G.S. 160D-1-9, or locally adopted conflict rules, the decision-making body  
48 was not sufficiently impartial to comply with due process principles.
- 49 (4) Set forth the relief the petitioner seeks.

1        (d) Standing. A petition may be filed under this section only by a petitioner who has  
2 standing to challenge the decision being appealed. The following persons shall have standing to  
3 file a petition under this section:

4            (1) Any person possessing any of the following criteria:

5            a. An ownership interest in the property that is the subject of the  
6 decision being appealed, a leasehold interest in the property that is  
7 the subject of the decision being appealed, or an interest created by  
8 easement, restriction, or covenant in the property that is the subject  
9 of the decision being appealed.

10           b. An option or contract to purchase the property that is the subject of  
11 the decision being appealed.

12           c. An applicant before the decision-making board whose decision is  
13 being appealed.

14           (2) Any other person who will suffer special damages as the result of the  
15 decision being appealed.

16           (3) An incorporated or unincorporated association to which owners or lessees of  
17 property in a designated area belong by virtue of their owning or leasing  
18 property in that area, or an association otherwise organized to protect and  
19 foster the interest of the particular neighborhood or local area, so long as at  
20 least one of the members of the association would have standing as an  
21 individual to challenge the decision being appealed, and the association was  
22 not created in response to the particular development or issue that is the  
23 subject of the appeal.

24           (4) A local government whose decision-making board has made a decision that  
25 the governing board believes improperly grants a variance from or is  
26 otherwise inconsistent with the proper interpretation of an ordinance adopted  
27 by that governing board.

28        (e) Respondent. The respondent named in the petition shall be the local government  
29 whose decision-making board made the decision that is being appealed, except that if the  
30 petitioner is a local government that has filed a petition pursuant to subdivision (4) of  
31 subsection (d) of this section, then the respondent shall be the decision-making board. If the  
32 petitioner is not the applicant before the decision-making board whose decision is being  
33 appealed, the petitioner shall also name that applicant as a respondent. Any petitioner may  
34 name as a respondent any person with an ownership or leasehold interest in the property that is  
35 the subject of the decision being appealed who participated in the hearing, or was an applicant,  
36 before the decision-making board.

37        (f) Writ of Certiorari. Upon filing the petition, the petitioner shall present the petition  
38 and a proposed writ of certiorari to the clerk of superior court of the county in which the matter  
39 arose. The writ shall direct the respondent local government, or the respondent decision-making  
40 board if the petitioner is a local government that has filed a petition pursuant to subdivision (4)  
41 of subsection (d) of this section, to prepare and certify to the court the record of proceedings  
42 below within a specified date. The writ shall also direct that the petitioner shall serve the  
43 petition and the writ upon each respondent named therein in the manner provided for service of  
44 a complaint under Rule 4(j) of the Rules of Civil Procedure, except that, if the respondent is a  
45 decision-making board, the petition and the writ shall be served upon the chair of that  
46 decision-making board. Rule 4(j)(5)d. of the Rules of Civil Procedure shall apply in the event  
47 the chair of a decision-making board cannot be found. No summons shall be issued. The clerk  
48 shall issue the writ without notice to the respondent or respondents if the petition has been  
49 properly filed and the writ is in proper form. A copy of the executed writ shall be filed with the  
50 court.

1       (g) Answer to the Petition. The respondent may, but need not, file an answer to the  
2 petition, except that, if the respondent contends that any petitioner lacks standing to bring the  
3 appeal, that contention must be set forth in an answer served on all petitioners at least 30 days  
4 prior to the hearing on the petition.

5       (h) Intervention. Rule 24 of the Rules of Civil Procedure shall govern motions to  
6 intervene as a petitioner or respondent in an action initiated under this section with the  
7 following exceptions:

8           (1) Any person described in subdivision (1) of subsection (d) of this section  
9           shall have standing to intervene and shall be allowed to intervene as a matter  
10          of right.

11          (2) Any person, other than one described in subdivision (1) of subsection (d) of  
12          this section, who seeks to intervene as a petitioner must demonstrate that the  
13          person would have had standing to challenge the decision being appealed in  
14          accordance with subdivisions (2) through (4) of subsection (d) of this  
15          section.

16          (3) Any person, other than one described in subdivision (d)(1) of this section,  
17          who seeks to intervene as a respondent must demonstrate that the person  
18          would have had standing to file a petition in accordance with subdivisions  
19          (2) through (4) of subsection (d) of this section if the decision-making board  
20          had made a decision that is consistent with the relief sought by the petitioner.

21       (i) The Record. The record shall consist of the decision and all documents and exhibits  
22 submitted to the decision-making board whose decision is being appealed, together with the  
23 minutes of the meeting or meetings at which the decision being appealed was considered. Upon  
24 request of any party, the record shall also contain an audio or videotape of the meeting or  
25 meetings at which the decision being appealed was considered if such a recording was made.  
26 Any party may also include in the record a transcript of the proceedings, which shall be  
27 prepared at the cost of the party choosing to include it. The parties may agree that matters  
28 unnecessary to the court's decision be deleted from the record. The record shall be bound and  
29 paginated or otherwise organized for the convenience of the parties and the court. A copy of the  
30 record shall be served by the local government respondent, or the respondent decision-making  
31 board, upon all petitioners within three days after it is filed with the court.

32       (j) Hearing on the Record. The court shall hear and decide all issues raised by the  
33 petition by reviewing the record submitted in accordance with subsection (i) of this section.  
34 The court may, in its discretion, allow the record to be supplemented with affidavits, testimony  
35 of witnesses, or documentary or other evidence if, and to the extent that, the record is not  
36 adequate to allow an appropriate determination of the following issues:

37           (1) Whether a petitioner or intervenor has standing.

38           (2) Whether, as a result of impermissible conflict as described in G.S. 160D-1-9  
39           or locally adopted conflict rules, the decision-making body was not  
40           sufficiently impartial to comply with due process principles.

41           (3) Whether the decision-making body erred for the reasons set forth in  
42           sub-subdivisions a. and b. of subdivision (1) of subsection (k) of this section.

43       (k) Scope of Review.

44           (1) When reviewing a decision of a decision-making board under the provisions  
45           of this section, the court shall review the decision and ensure that the rights  
46           of petitioners have not been prejudiced because the decision-making body's  
47           findings, inferences, conclusions, or decisions were:

48           a. In violation of constitutional provisions, including those protecting  
49           procedural due process rights.

- 1            b. In excess of the statutory authority conferred upon the local  
2            government or the authority conferred upon the decision-making  
3            board by ordinance.
- 4            c. Inconsistent with applicable procedures specified by statute or  
5            ordinance.
- 6            d. Affected by other error of law.
- 7            e. Unsupported by competent, material, and substantial evidence in  
8            view of the entire record.
- 9            f. Arbitrary or capricious.
- 10          (2) When the issue before the court is whether the decision-making board erred  
11          in interpreting an ordinance, the court shall review that issue de novo. The  
12          court shall consider the interpretation of the decision-making board, but is  
13          not bound by that interpretation, and may freely substitute its judgment as  
14          appropriate.
- 15          (3) The term "competent evidence," as used in this subsection, shall not preclude  
16          reliance by the decision-making board on evidence that would not be  
17          admissible under the rules of evidence as applied in the trial division of the  
18          General Court of Justice if the evidence appears to be sufficiently  
19          trustworthy and was admitted under such circumstances that it was  
20          reasonable for the decision-making board to rely upon it. The term  
21          "competent evidence," as used in this subsection, shall not be deemed to  
22          include the opinion testimony of lay witnesses as to any of the following:
- 23            a. The use of property in a particular way affects the value of other  
24            property.
- 25            b. The increase in vehicular traffic resulting from a proposed  
26            development poses a danger to the public safety.
- 27            c. Matters about which only expert testimony would generally be  
28            admissible under the rules of evidence.
- 29          (l) Decision of the Court. Following its review of the decision-making board in  
30          accordance with subsection (k) of this section, the court may affirm the decision, reverse the  
31          decision and remand the case with appropriate instructions, or remand the case for further  
32          proceedings. If the court does not affirm the decision below in its entirety, then the court shall  
33          determine what relief should be granted to the petitioners:
- 34            (1) If the court concludes that the error committed by the decision-making board  
35            is procedural only, the court may remand the case for further proceedings to  
36            correct the procedural error.
- 37            (2) If the court concludes that the decision-making board has erred by failing to  
38            make findings of fact such that the court cannot properly perform its  
39            function, then the court may remand the case with appropriate instructions so  
40            long as the record contains competent, material, and substantial evidence  
41            that could support the decision below with appropriate findings of fact.  
42            However, findings of fact are not necessary when the record sufficiently  
43            reveals the basis for the decision below or when the material facts are  
44            undisputed and the case presents only an issue of law.
- 45            (3) If the court concludes that the decision by the decision-making board is not  
46            supported by competent, material, and substantial evidence in the record or  
47            is based upon an error of law, then the court may remand the case with an  
48            order that directs the decision-making board to take whatever action should  
49            have been taken had the error not been committed or to take such other  
50            action as is necessary to correct the error. Specifically:

1           a.     If the court concludes that a permit was wrongfully denied because  
2           the denial was not based on competent, material, and substantial  
3           evidence or was otherwise based on an error of law, the court may  
4           remand with instructions that the permit be issued, subject to  
5           reasonable and appropriate conditions.

6           b.     If the court concludes that a permit was wrongfully issued because  
7           the issuance was not based on competent, material, and substantial  
8           evidence or was otherwise based on an error of law, the court may  
9           remand with instructions that the permit be revoked.

10       (m)   Ancillary Injunctive Relief. Upon motion of a party to a proceeding under this  
11       section, and under appropriate circumstances, the court may issue an injunctive order requiring  
12       any other party to that proceeding to take certain action or refrain from taking action that is  
13       consistent with the court's decision on the merits of the appeal.

14       **"§ 160D-14-3. Appeals of decisions on subdivision plats.**

15       (a)   When a subdivision ordinance adopted under this Chapter provides that the decision  
16       whether to approve or deny a preliminary or final subdivision plat is quasi-judicial, then that  
17       decision of the board shall be subject to review by the superior court by proceedings in the  
18       nature of certiorari. The provisions of G.S. 160D-4-6 and this section shall apply to those  
19       appeals.

20       (b)   When a subdivision ordinance adopted under this Chapter provides that the decision  
21       whether to approve or deny a preliminary or final subdivision plat is administrative and for all  
22       decisions made by the governing board, then any party aggrieved by that decision may seek to  
23       have the decision reviewed by filing an action in superior court seeking appropriate declaratory  
24       or equitable relief. Such an action must be filed within the time frame specified in  
25       G.S. 160D-14-5 for petitions in the nature of certiorari.

26       (c)   For purposes of this section, an ordinance shall be deemed to authorize a  
27       quasi-judicial decision if the governing board or planning board is authorized to decide whether  
28       to approve or deny the plat based not only upon whether the application complies with the  
29       specific requirements set forth in the ordinance, but also on whether the application complies  
30       with one or more generally stated standards requiring a discretionary decision to be made by  
31       the governing board or planning board.

32       **"§ 160D-14-4. Other civil actions**

33       Except as expressly stated, this Article does not limit the availability to any party of civil  
34       actions otherwise authorized by law or alter the times in which they may be brought.

35       **"§ 160D-14-5. Statutes of limitations.**

36       (a)   Zoning Map Adoption Or Amendments. A cause of action as to the validity of any  
37       ordinance adopting or amending a zoning map adopted under this Chapter or other applicable  
38       law or a development agreement adopted under Article 10 of this Chapter shall accrue upon  
39       adoption of such ordinance and shall be brought within sixty days as provided in G.S. 1-54.1.

40       (b)   Text Adoption or Amendment. Except as otherwise provided in subsection (a) of  
41       this section, an action challenging the validity of any development regulation adopted under  
42       this Chapter or other applicable law shall be brought within one year of the accrual of such  
43       action. Such an action accrues when the party bringing such action first has standing to  
44       challenge the ordinance. A challenge to an ordinance on the basis of an alleged defect in the  
45       adoption process shall be brought within three years after the adoption of the ordinance.

46       (c)   Enforcement Defense. Nothing in this section or in G.S. 1-54(10) or G.S. 1-54.1  
47       shall bar a party in an action involving the enforcement of a development regulation from  
48       raising as a defense to such enforcement action the invalidity of the ordinance. Nothing in this  
49       section or in G.S. 1-54(10) or G.S. 1-54.1 shall bar a party who files a timely appeal from an  
50       order, requirement, decision, or determination made by an administrative official contending  
51       that such party is in violation of a zoning or unified development ordinance from raising in the

1 judicial appeal the invalidity of such ordinance as a defense to such order, requirement,  
2 decision, or determination. A party in an enforcement action or appeal may not assert the  
3 invalidity of the ordinance on the basis of an alleged defect in the adoption process unless the  
4 defense is formally raised within three years of the adoption of the challenged ordinance.

5 (d) Quasi-Judicial Decisions. Unless specifically provided otherwise, a petition for  
6 review of a quasi-judicial decision shall be filed with the clerk of superior court by the later of  
7 30 days after the decision is effective or after a written copy thereof is given in accordance with  
8 G.S. 160D-4-6(j). When first-class mail is used to deliver notice, three days shall be added to  
9 the time to file the petition."

10 **SECTION 4.1.** G.S. 1-54(10) is amended to read as follows:

11 "(10) Actions contesting the validity of any zoning or unified development  
12 ordinance or any provision thereof adopted under ~~Part 3 of Article 18 of~~  
13 ~~Chapter 153A or Part 3 of Article 19 of Chapter 160A~~Chapter 160D of the  
14 General Statutes or other applicable law, other than an ordinance adopting or

44 any structure, or permit the growth of any tree, or otherwise use his property, in violation of

46 provided in G.S. 63-33, subsection (c), for a variance from the zoning regulations in question.

33 variance petitions made pursuant to this section. ~~Where a zoning board of appeals or adjustment~~  
34 ~~already exists, it may be appointed as the board of appeals. Otherwise, the board of appeals~~  
35 ~~shall consist of five members, each to be appointed for a term of three years and to be~~  
36 ~~removable for cause by the appointing authority upon written charges and after public hearing.~~

37 ~~The board shall adopt rules in accordance with the provisions of any ordinance adopted~~  
38 ~~under this Article. Meetings of the board shall be held at the call of the chairman and at such~~  
39 ~~other times as the board may determine. The chairman, or in his absence the acting chairman,~~  
40 ~~may administer oaths and compel the attendance of witnesses. All meetings of the board shall~~  
41 ~~be public. The board shall keep minutes of its proceedings, showing the vote of each member~~  
42 ~~upon each question, or, if absent or failing to vote, indicating such fact, and shall keep records~~  
43 ~~of its examinations and other official actions, all of which shall immediately be filed in the~~  
44 ~~office of the board and shall be a public record.~~

45 Appeals to the board may be taken by any person aggrieved, or by any officer, department,  
46 board, or bureau of the political subdivision affected, by any decision of the administrative  
47 agency. An appeal must be taken within a reasonable time, as provided by the rules of the  
48 board, by filing with the agency from which the appeal is taken and with the board, a notice of  
49 appeal specifying the grounds thereof. The agency from which the appeal is taken shall  
50 forthwith transmit to the board all the papers constituting the record upon which the action  
51 appealed from was taken.



1 An appeal shall stay all proceedings in furtherance of the action appealed from, unless the  
2 agency from which the appeal is taken certifies to the board, after the notice of appeal has been  
3 filed with it, that by reason of the facts stated in the certificate a stay would, in its opinion,  
4 cause imminent peril to life or property. In such case proceedings shall not be stayed otherwise  
5 than by a restraining order which may be granted by the board or by a court of record on  
6 application on notice to the agency from which the appeal is taken and on due cause shown.

7 The board shall fix a reasonable time for the hearing of the appeal, give public notice and  
8 due notice to the parties in interest, and decide the same within a reasonable time. Upon the  
9 hearing any party may appear in person or by agent or by attorney.

10 The board may, in conformity with the provisions of this Article, reverse or affirm, wholly  
11 or partly, or modify, the order, requirement, decision or determination appealed from and may  
12 make such order, requirement, decision or determination as ought to be made, and to that end  
13 shall have all the powers of the administrative agency from which the appeal is taken.

14 The concurring vote of a majority of the members of the board shall be sufficient to reverse  
15 any order, requirement, decision, or determination of the administrative agency, or to decide in  
16 favor of the applicant on any matter upon which it is required to pass under any such ordinance,  
17 or to effect any variation in such ordinance."

18 **SECTION 4.6.** G.S. 63-34 reads as rewritten:

19 "**§ 63-34. Judicial review.**

20 Administrative and quasi-judicial decisions made pursuant to this Article are subject to  
21 judicial review as provided by G.S. 160D-14-1.

22 (a) Any person aggrieved by any decision of the board of appeals, or any taxpayer, or  
23 any officer, department, board, or bureau of the political subdivision, may present to the  
24 superior court a verified petition setting forth that the decision is illegal, in whole or in part, and  
25 specifying the grounds of the illegality. Such petition shall be presented to the court within 30  
26 days after the decision is filed in the office of the board. Such petition shall comply with the  
27 provisions of G.S. 160A-393.

28 (b) The allowance of the writ shall not stay proceedings upon the decision appealed  
29 from, but the court may, on application, on notice to the board and on due cause shown, grant a  
30 restraining order.

31 (c) The board of appeals shall not be required to return the original papers acted upon  
32 by it, but it shall be sufficient to return certified or sworn copies thereof or of such portions  
33 thereof as may be called for by the writ. The return shall concisely set forth such other facts as  
34 may be pertinent and material to show the grounds of the decision appealed from and shall be  
35 verified.

36 (d) Repealed by Session Laws 2009-421, s. 3, effective January 1, 2010.

37 (e) Costs shall not be allowed against the board of appeals unless it appears to the court  
38 that it acted with gross negligence, in bad faith, or with malice, in making the decision appealed  
39 from."

40 **SECTION 4.7.** G.S. 63-35 reads as rewritten:

41 "**§ 63-35. Enforcement and remedies.**

42 G.S. 160D-4-4 applies to ordinances adopted pursuant to this Article for the purposes of  
43 enforcement and remedies pertaining to violations of those ordinances. Each violation of this  
44 Article or of any regulations, order, or ruling promulgated or made pursuant to this Article,  
45 shall constitute a Class 3 misdemeanor, and each day a violation continues to exist shall

47 located may institute in any court of competent jurisdiction, an action to prevent, restrain,  
48 correct or abate any violation of this Article, or of airport zoning regulations adopted under this

17 G.S. 113A-206(6).

19 (f) Any county or city that adopts an ordinance pursuant to this section ~~must hold a~~  
20 ~~public hearing before adopting the ordinance upon the question of adopting the ordinance or of~~  
21 ~~allowing the construction of tall buildings on protected mountain ridges to be governed by~~  
22 ~~G.S. 113A-209. The public hearing required by this section shall be held upon at least 10 days'~~  
23 ~~notice in a newspaper of general circulation in the unit adopting the ordinance. Testimony at~~  
24 ~~the hearing shall be recorded and any and all exhibits shall be preserved within the custody of~~  
25 ~~the governing body. The testimony and evidence shall be made available for inspection and~~  
26 ~~scrutiny by any person.~~ shall follow the procedures in Article 6 of Chapter 160D of the General  
27 Statutes."

28 **SECTION 4.9.** G.S. 113A-211(a) reads as rewritten:

51 must be accompanied by a map of the proposed zoning area. The

8 privileges, powers and duties granted to ~~municipal corporations~~

10 Article 7 of Chapter 160D of the General Statutes. However, the  
11 sanitary district board shall not be required to appoint any zoning  
12 commission or board of adjustment. If neither a zoning commission  
13 nor board of adjustment is appointed, the sanitary district board shall

15 c. A sanitary district board may enter into an agreement with any city,  
16 town or sanitary district for the establishment of a joint zoning  
17 commission.

18 d. A sanitary district board is authorized to use the income of the  
19 district and levy and collect taxes upon the taxable property within  
20 the district necessary to carry out and enforce the rules and  
21 provisions of this subsection.

22 e. This subsection shall apply only to sanitary districts which adjoin and  
23 are contiguous to an incorporated city or town and are located within  
24 three miles or less of the boundaries of two other cities or towns."

25 **SECTION 4.11.** G.S. 143-214.5(d) reads as rewritten:

26 "(d) Mandatory Local Programs. – The Department shall assist local governments to  
27 develop water supply watershed protection programs that comply with this section. Local  
28 government compliance programs shall include an implementing local ordinance and shall  
29 provide for maintenance, inspection, and enforcement procedures. As part of its assistance to  
30 local governments, the Commission shall approve and make available a model local water  
31 supply watershed management and protection ordinance. The model management and

44 must comply with the provisions of Article 6 of Chapter 160D of the General Statutes. This  
45 section shall not be construed to affect the validity of any local ordinance adopted for the  
46 protection of water supply watersheds prior to completion of the review of the ordinance by the  
47 Commission or prior to the assumption by the Commission of responsibility for a local water  
48 supply watershed protection program. Local governments may create or designate agencies to  
49 administer and enforce such programs. The Commission shall approve a local program only if  
50 it determines that the requirements of the program equal or exceed the minimum statewide  
51 water supply watershed management requirements adopted pursuant to this section."

17 Article 4 of Chapter 160D of the General Statutes applies to the administration, enforcement,  
18 and appeals regarding these ordinances.~~A city may exercise the powers granted in this Part not~~  
19 ~~only within its corporate boundaries but also within the area of its extraterritorial zoning~~  
20 ~~jurisdiction. A county may exercise the powers granted in this Part at any place within the~~  
21 ~~county that is outside the zoning jurisdiction of a city in the county. If a city does not exercise~~  
22 ~~the powers granted in this Part in the city's extraterritorial zoning jurisdiction, the county may~~

27 ~~no further effect within the city's jurisdiction.~~

28       (c) ~~The local governing body is hereby empowered to adopt regulations it may deem~~  
29 ~~necessary concerning the form, time, and manner of submission of applications for permits~~  
30 ~~under this Part. These regulations may provide for the issuance of permits under this Part by the~~  
31 ~~local governing body or by an agency designated by the local governing body, as prescribed by~~  
32 ~~the governing body. Every final decision granting or denying a permit under this Part shall be~~  
33 ~~subject to review by the superior court of the county, with the right of jury trial at the election~~  
34 ~~of the party seeking review. The time and manner of election of a jury trial shall be governed~~  
35 ~~by G.S. 1A-1, Rule 38(b) of the Rules of Civil Procedure. Pending the final disposition of an~~

3 **"§ 153A-457. Submission of statement concerning improvements.**

4           A county may by ordinance require that when a property owner improves property at a cost  
5 of more than two thousand five hundred dollars (\$2,500) but less than five thousand dollars  
6 (\$5,000), the property owner must, within 14 days after the completion of the work, submit to  
7 the county assessor a statement setting forth the nature of the improvement and the total cost  
8 thereof.

9 **"§ 153A-458. Authorization to provide grants.**

10           A county may provide grants to unaffiliated, qualified private providers of high-speed  
11 Internet access service, as that term is defined in G.S. 160A-340(4), for the purpose of  
12 expanding service in unserved areas for economic development in the county. The grants shall  
13 be awarded on a technology neutral basis, shall be open to qualified applicants, and may  
14 require matching funds by the private provider. A county shall seek and consider request for  
15 proposals from qualified private providers within the county prior to awarding a broadband  
16 grant and shall use reasonable means to ensure that potential applicants are made aware of the  
17 grant, including, at a minimum, compliance with the notice procedures set forth in  
18 G.S. 160A-340.6(c). The county shall use only unrestricted general fund revenue for the grants.  
19 For the purposes of this section, a qualified private provider is a private provider of high-speed  
20 Internet access service in the State prior to the issuance of the grant proposal. Nothing in this  
21 section authorizes a county to provide high-speed Internet broadband service."

22           **SECTION 7.** If any provision of this act or its application is held invalid, the  
23 invalidity does not affect other provisions or applications of this act that can be given effect  
24 without the invalid provisions or application, and to this end the provisions of this act are  
25 severable.

26           **SECTION 8.1.** Any otherwise valid permit or development approval made prior to  
27 July 1, 2016, shall not be invalid based on inconsistency with the provisions of this Act. The  
28 validity of any plan adopted prior to July 1, 2016, is not affected by a failure to comply with the  
29 procedural requirements of G.S. 160D-5-1(b).

30           **SECTION 8.2.** Any special use district or conditional use district zoning district  
31 that is valid and in effect as of July 1, 2016, shall be deemed a conditional zoning district  
32 consistent with the terms of this act and the special or conditional use permits issued  
33 concurrently with establishment of those districts shall be valid as specified in Section 8.1 of  
34 this act. Any valid "conditional use permit" issued prior to July 1, 2016, shall be deemed a  
35 "special use permit" consistent with the provisions of this act.

36           **SECTION 8.3.** Any local government that has adopted zoning regulations but that  
37 has not adopted a comprehensive plan shall adopt such a plan no later than December 31, 2017,  
38 in order to retain the authority to adopt and apply zoning regulations.

39           **SECTION 9.** This act becomes effective July 1, 2016, and applies to local  
40 government development regulation decisions made on or after that date.
