Short Title: Facilitate Successful Reentry. (Public)

1 A BILL TO BE ENTITLED  
2 AN ACT TO DIRECT THE DIVISION OF ADULT CORRECTION TO TAKE ACTION TO  
3 FACILITATE SUCCESSFUL REENTRY AND IMPROVE JUDICIAL EFFICIENCY  
4 THROUGH THE USE OF THE ELECTRONIC REPOSITORY COMMONLY KNOWN  
5 AS NCAWARE TO RESOLVE OUTSTANDING WARRANTS ON INMATES WHILE  
6 THEY ARE STILL IN CUSTODY.

7 The General Assembly of North Carolina enacts:

8 SECTION 1. Article 1 of Chapter 148 of the General Statutes is amended by  
9 adding a new section to read:

10 "**§ 148-10.5. Facilitation of reentry.**

11 In order to facilitate successful reentry and improve judicial efficiency, the Division of  
12 Adult Correction of the Department of Public Safety shall do the following:

- 13 (1) Establish a policy requiring that, both at intake and before release, the  
14 Electronic Repository established under G.S. 15A-301.1 shall be checked for  
15 each inmate to identify all outstanding warrants on the inmate.  
16 (2) Develop and implement a plan, in consultation with district attorneys'  
17 offices, for resolving inmates' outstanding warrants while in custody,  
18 whenever feasible. In the course of resolving an outstanding warrant while in  
19 custody, an inmate shall be notified of his or her right to counsel if such a  
20 right exists."

21 SECTION 2. G.S. 15A-301.1(a) reads as rewritten:

22 "(a) The Administrative Office of the Courts shall create and maintain, in cooperation  
23 with State and local law enforcement agencies, an automated electronic repository for criminal  
24 process (hereinafter referred to as the Electronic Repository), which shall comprise a secure  
25 system of electronic data entry, storage, and retrieval that provides for creating, signing,  
26 issuing, entering, filing, and retaining criminal process in electronic form, and that provides for  
27 the following with regard to criminal process in electronic form:

- 28 (1) Tracking criminal process.  
29 (2) Accessing criminal process through remote electronic means by all  
30 authorized judicial officials and employees and all authorized law  
31 enforcement officers and agencies that have compatible electronic access  
32 capacity, capacity, including officials of the Division of Adult Correction of  
33 the Department of Public Safety to the extent necessary for the Division to  
34 comply with the requirements of G.S. 148-10.5.  
35 (3) Printing any criminal process in paper form by any authorized judicial  
36 official or employee or any authorized law enforcement officer or agency.

2 through use of the system meet the requirements of G.S. 15A-101.1(5)."  
3       **SECTION 3.** This act becomes effective October 1, 2015.
