4 POLITICAL ACTION COMMITTEE (PAC).

5 The General Assembly of North Carolina enacts:

6 SECTION 1. G.S. 163-278.6 reads as rewritten:

7 "§ 163-278.6. Definitions.

8 When used in this Article:

9 ...

10 (12a) The term "local membership organization" means any entity that has all of  
11 the following characteristics:

12 a. Is organized under the laws of Article 1 of Chapter 55A of the  
13 General Statutes.

14 b. Does not have the purpose of generating business income.

15 c. Does not have shareholders or other persons who have an economic  
16 interest in its assets and earnings.

17 d. Is a trade association.

18 e. In exchange for dues payments, offers memberships to persons who  
19 are both:

20 1. Affiliated with a particular industry.

21 2. Located in a particular geographic subset of this State.

22 f. Whose members are all members of a state membership organization,  
23 as that term is defined in this section.

24 g. Shares the same purposes of a State membership organization, as that  
25 term is defined in this section.

26 ...

27 (17) The term "professional association" means any trade association, group,  
28 organization, association, State membership organization, local membership  
29 organization, or collection of persons or individuals formed for the purposes  
30 of advancing, representing, improving, furthering or preserving the interests  
31 of persons or individuals having a common vocation, profession, calling,  
32 occupation, employment, or training.

34 (18c) The term "state membership organization" means any entity that has all of  
35 the following characteristics:

12                   **SECTION 2.** G.S. 163-278.19(b) reads as rewritten:

13                   "(b) It shall, however, be lawful for any corporation, business entity, labor union,  
14 professional association or insurance company to communicate with its employees,  
15 stockholders or members and their families on any subject; to conduct nonpartisan registration  
16 and get-out-the-vote campaigns aimed at their employees, stockholders, or members and their  
17 families; or for officials and employees of any corporation, insurance company or business  
18 entity or the officials and members of any labor union or professional association to establish,  
19 administer, contribute to, and to receive and solicit contributions to a separate segregated fund  
20 to be utilized for political purposes, and those individuals shall be deemed to become and be a  
21 political committee as that term is defined in G.S. 163-278.6(14) or a referendum committee as  
22 defined in G.S. 163-278.6(18b); ~~provided, however, that~~ or for a local membership  
23 organization and its members to administer, contribute to, and to receive and solicit  
24 contributions to a separate segregated fund established by a State membership organization  
25 with which the local membership organization is affiliated. However, it shall be unlawful for  
26 any such fund to make a contribution or expenditure by utilizing contributions secured by  
27 physical force, job discrimination, financial reprisals or the threat of force, job discrimination  
28 or financial reprisals, or by dues, fees, or other moneys required as a condition of membership  
29 or employment or as a requirement with respect to any terms or conditions of employment,  
30 including, without limitation, hiring, firing, transferring, promoting, demoting, or granting  
31 seniority or employment-related benefits of any kind, or by moneys obtained in any  
32 commercial transaction whatsoever."

33                   **SECTION 3.** This act is effective when it becomes law.
