moves to amend the bill on page 499, lines 10-20, by rewriting the lines to read:

- "(e) Triangle Regional Public Transportation Authority. Notwithstanding subsection (a) of this section, the local sales and use tax rate of a county may exceed two and one-half percent (2 1/2%) if the county meets either of the conditions listed in this subsection. In no event may a county's local sales and use tax rate exceed two and three-quarters percent (2 3/4%). The conditions are:
  - (1) The county lies within the territorial jurisdiction of a special district that is subject to a tax levied by a transportation authority under Part 4 of Article 43 of this Chapter.
  - The county conducted one or more advisory referendums on or before December 31, 2016, in which a majority of the voters approved the levy of a local sales and use tax at the rate of one-half percent (1/2%) under Part 4 of Article 43 of this Chapter, and the county is subsequently included in a special district subject to a tax levied by a transportation authority under Part 4 of Article 43 of this Chapter.";

And on page 501, lines 23-33, by rewriting the lines to read:

- "(b) Triangle Regional Public Transportation Authority. Notwithstanding subsection (a) of this section, the local sales and use tax rate of a county may exceed two and one-half percent (2 1/2%) if the county meets either of the conditions listed in this subsection. In no event may a county's local sales and use tax rate exceed two and three-quarters percent (2 3/4%). The conditions are:
  - (1) The county lies within the territorial jurisdiction of a special district that is subject to a tax levied by a transportation authority under Part 4 of Article 43 of this Chapter.
  - The county conducted one or more advisory referendums on or before December 31, 2016, in which a majority of the voters approved the levy of a local sales and use tax at the rate of one-half percent (1/2%) under Part 4 of Article 43 of this Chapter, and the county is subsequently included in a special district subject to a tax levied by a transportation authority under Part 4 of Article 43 of this Chapter.";
