- 22 (1) Passes a course of driver education prescribed in ~~G.S. 115C-215~~G.S.
- 23 115D-76.5 or a course of driver instruction at a nonpublic secondary school
- 24 or licensed commercial driver training school.
- 25 (2) Passes a written test administered by the Division.
- 26 (3) Has a driving eligibility certificate or a high school diploma or its
- 27 equivalent.""; and

- 29 on page 76, lines 16-17, by inserting between the lines the following:
- 30 "**SECTION 8.39.(a1)** From funds appropriated in this act to the Department of
- 31 Public Instruction, the sum of twenty-seven million three hundred ninety-three seven hundred
- 32 sixty-eight dollars (\$27,393,768) in nonrecurring funds for the 2015-2016 fiscal year shall be
