1 moves to amend the bill on page on page 2, line 4, by increasing the amount for the 2015-2016  
2 fiscal year by \$109,100,000 and by increasing the amount for 2016-2017 fiscal year by  
3 349,100,000; and

5 on page 5, line 35, by adding after that line the following:  
6 "Repeal Corporate Income Tax Trigger 109,100,000 349,100,000"; and

8 on page 6, line 6, by increasing the reduction for the 2015-2016 fiscal year by \$109,100,000  
9 and by increasing the reduction for 2016-2017 fiscal year by \$349,100,000; and

11 by changing the totals in section 2.1 and section 2.2 of the bill accordingly; and

13 on page 466, lines 31-43, by deleting the lines and substituting the following language to read:

15 **"CORPORATE INCOME TAX CHANGES";**

17 and on page 470, lines 25-26, by deleting "Except as otherwise provided, subsections (a)  
18 through (c) of this section are effective when this act becomes law."; and  
19

20 on page 86, lines 4-5, by inserting between those lines a new section to read:

22 **"FUNDS FOR TEACHER ASSISTANTS**

23 **SECTION 8.44.** Notwithstanding any other provision of law, the total amount of  
24 expansion funds available to the Department of Public Instruction in Section 2.1 of this act for  
25 teacher assistants shall be fifty-one million five hundred eighty-three thousand three hundred  
26 fifty dollars (\$51,583,350) for the 2015-2016 fiscal year and one hundred eighty-two million  
27 nine hundred fifty-three thousand one hundred ninety-five dollars (\$182,953,195) for the 2016-  
28 2017 fiscal year."
