1 moves to amend the bill on page 136, by inserting between lines 15 and 16, the following new
2 section to read:

3 **"ADDITIONAL FUNDS FOR NC PRE-K**

4 **SECTION 12B.1A.** Notwithstanding any other provision in this act, additional
5 funds are appropriated in this act from the General Fund to the Department of Health and
6 Human Services, Division of Child Development and Early Education, for the prekindergarten
7 program (NC Pre-K) in the amount of seven million five hundred thousand dollars
8 (\$7,500,000) for the 2015-2016 fiscal year and fifteen million dollars (\$15,000,000) for the
9 2016-2017 fiscal year to further expand the NC Pre-K program by 1,500 additional slots in the
10 2015-2016 fiscal year and 3,000 additional slots in the 2016-2017 fiscal year."; and

12 on page 136, line 22, by deleting "5" and substituting "8"; and

14 on page 136, line 23, by deleting "6" and substituting "9"; and

15
16 on page 136, lines 32-33, by deleting the sentence "Co-payments shall not be prorated for
17 part-time care." and substituting the sentence "Co-payments shall be prorated for part-time care
18 based on policies that were in place prior to October 1, 2014."; and

19
20 on page 138, by inserting between lines 18 and 19, the following new section to read:

21 **"ADDITIONAL FUNDS FOR CHILD CARE SUBSIDY**

22 **SECTION 12B.2B.** Notwithstanding any other provision of this act, additional
23 funds are appropriated in this act from the General Fund to the Department of Health and
24 Human Services, Division of Child Development and Early Education, in the amount of
25 twenty-five million dollars (\$25,000,000) for each year of the 2015-2017 fiscal biennium to
26 increase child care subsidy funding by providing for an additional 5,000 slots in each year of
27 the 2015-2017 fiscal biennium."; and

29 on page 466, line 36, by deleting "four percent (4%)." and substituting "four and three tenths
30 percent (4.3%)."; and
