A BILL TO BE ENTITLED
AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE SPECIAL
REGISTRATION PLATES THAT HAVE MET STATUTORY REQUIREMENTS AND
TO MAKE CHANGES TO VARIOUS SPECIAL REGISTRATION PLATES.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-63(b1) reads as rewritten:

"(b1) The following special registration plates do not have to be a "First in Flight" plate or "First in Freedom" plate as provided in subsection (b) of this section. The design of the plates that are not "First in Flight" plates or "First in Freedom" plates must be developed in accordance with G.S. 20-79.4(a3). For special plates authorized in G.S. 20-79.7 on or after July 1, 2013, the Division may not issue the plate on a background under this subsection unless it receives at least 200 applications for the plate in addition to the applications required under G.S. 20-79.4 or G.S. 20-81.12.

(49) Carolina Panthers.

(50) NC Surveyors.

(51) North Carolina Sheriffs' Association.

(52) Save the Honey Bee (SB)."

SECTION 2. G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

...

() Carolina Panthers. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase "Keep Pounding", the logo of the Carolina Panthers, and the letters "CP". The Division shall not develop a plate under this subdivision without a license to use copyrighted or registered words, symbols, trademarks, or designs associated with the plate. The Division shall not pay a royalty for the license to use the copyrighted or registered words, symbols, trademarks, or designs associated with the plate. The plate authorized by this subdivision is not subject to the provisions of G.S. 20-79.3A or G.S. 20-79.8.

() NC Surveyors. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase "Following In Their Footsteps", a picture representing a surveyor, and the letters "PS" on the right side of the plate.

 2 () North Carolina Sheriffs' Association. – Issuable to the registered owner of a
 3 motor vehicle in accordance with G.S. 20-81.12. The plate may bear a
 4 phrase and logo selected by the North Carolina Sheriffs' Association, Inc.

 6 (190) Register of Deeds. – Issuable to a register of ~~deeds~~ deeds of a county of this
 7 State. The plate shall bear the words "Register of Deeds" and the letter "R"
 8 followed by a number representing the county of the register of deeds. The
 9 number of a county shall be the order of the county in an alphabetical list of
 10 counties that assigns number one to the first county in the list. A plate issued
 11 to a retired register of deeds shall bear the phrase "Register of Deeds,
 12 Retired," followed by a number that indicates the county where the register
 13 of deeds served and a designation indicating the retired status of the register
 14 of deeds. For purposes of this subdivision, a "retired register of deeds" is a
 15 person (i) with at least 10 years of service as a register of deeds of a county
 16 of this State and (ii) who no longer holds that office for any reason other
 17 than removal under G.S. 161-27.

 19 () Save the Honey Bee (HB). – Issuable to the registered owner of a motor
 20 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase
 21 "Save the Honey Bee", a picture representing a honey bee, and the letters
 22 "HB" on the right side of the plate.

 24 () Save the Honey Bee (SB). – Issuable to the registered owner of a motor
 25 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase
 26 "Save the Honey Bee", a picture representing a honey bee on a blue flower
 27 inside of a hexagon, a honeycomb background, and the letters "SB" on the
 28 right side of the plate.

 30 **SECTION 3.** G.S. 20-79.7 reads as rewritten:

31 **"§ 20-79.7. Fees for special registration plates and distribution of the fees.**

 33 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle
 34 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

3 (b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate
 4 and Cultural Attraction Plate Account are established within the Highway Fund. The Division
 5 must credit the additional fee imposed for the special registration plates listed in subsection (a)
 6 of this section among the Special Registration Plate Account (SRPA), the Collegiate and
 7 Cultural Attraction Plate Account (CCAPA), the Clean Water Management Trust Fund
 8 (CWMTF), which is established under G.S. 113A-253, and the Parks and Recreation Trust
 9 Fund, which is established under G.S. 113-44.15, as follows:

29 **SECTION 4.** G.S. 20-81.12 reads as rewritten:
 30 **"§ 20-81.12. Collegiate insignia plates and certain other special plates.**

31 ...

32 (b148) North Carolina Paddle Festival. – The Division must receive 300 or more
 33 applications for a North Carolina Paddle Festival plate before the plate may be developed. The
 34 Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate
 35 Account derived from the sale of North Carolina Paddle Festival plates to the Friends of the
 36 Hammocks and Bear Island, Inc.

37 (b149) Carolina Panthers. – The Division shall transfer quarterly one-half of the money in
 38 the Collegiate and Cultural Attraction Plate Account derived from the sale of Carolina Panthers
 39 plates to the Keep Pounding Fund of the Carolinas Healthcare Foundation, Inc., to be used to
 40 support cancer research at the Carolinas Medical Center, and shall transfer quarterly one-half of
 41 the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of the
 42 Carolina Panthers plates to the Carolina Panthers Charities Fund of the Foundation for the
 43 Carolinas to be used to create new athletic opportunities for children, support their educational
 44 needs, and promote healthy lifestyles for families.

45 (b150) NC Surveyors. – The applicable requirements of G.S. 20-79.3A shall be met before
 46 the NC Surveyors plate may be developed. The Division shall transfer quarterly the money in
 47 the Collegiate and Cultural Attraction Plate Account derived from the sale of NC Surveyors
 48 plates to the North Carolina Society of Surveyors Education Foundation, Inc., to be used to
 49 grant financial assistance to those persons genuinely interested in pursuing or continuing to
 50 pursue a formal education in the field of surveying.

1 (b151) North Carolina Sheriffs' Association. – The applicable requirements of
2 G.S. 20-79.3A shall be met before the North Carolina Sheriffs' Association plate may be
3 developed. The Division shall transfer quarterly the money in the Collegiate and Cultural
4 Attraction Plate Account derived from the sale of North Carolina Sheriffs' Association plates to
5 the North Carolina Sheriffs' Association, Inc., to support the operating expenses of the North
6 Carolina Sheriffs' Association.

7 (b152) Save the Honey Bee (HB). – The applicable requirements of G.S. 20-79.3A shall be
8 met before the Save the Honey Bee plate may be developed. The Division shall transfer
9 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the
10 sale of Save the Honey Bee plates to the North Carolina State University Apiculture Program.

11 (b153) Save the Honey Bee (SB). – The applicable requirements of G.S. 20-79.3A shall be
12 met before the Save the Honey Bee plate may be developed. The Division shall transfer
13 quarterly one-half of the money in the Collegiate and Cultural Attraction Plate Account derived
14 from the sale of Save the Honey Bee plates to the Grandfather Mountain Stewardship
15 Foundation to be used to support the Honey Bee Haven and honey bee educational programs
16 and shall transfer one-half of the money in the Collegiate and Cultural Attraction Plate Account
17 derived from the sale of Save the Honey Bee plates to the North Carolina State University
18 Apiculture Program to be used to support work on honey bee biology and apicultural science.

20 **SECTION 5.** The Division of Motor Vehicles shall not issue, and shall not
21 produce, any more special registration plates developed for the Carolina Panthers under the
22 authority in G.S. 20-79.4(b)(185).

23 **SECTION 6.(a)** G.S. 20-79.4(b)(122), as it existed on September 30, 2014, is
24 reenacted.

25 **SECTION 6.(b)** G.S. 20-79.4(b)(122), as reenacted by subsection (a) of this
26 section, reads as rewritten:

27 "(b) Types. – The Division shall issue the following types of special registration plates:

28 ...

29 (122) Military Veteran. – Issuable to an individual who served honorably in the
30 Armed Forces of the United States. The plate shall bear the words "U.S.
31 Military Veteran" and the name and insignia of the branch of service in
32 which the individual served. ~~The Division may not issue the plate authorized~~
33 ~~by this subdivision unless it receives at least 300 applications for the~~
34 ~~plate. The plate authorized by this subdivision is not subject to the provisions~~
35 ~~of G.S. 20-79.3A or G.S. 20-79.8."~~

36 **SECTION 6.(c)** The fee amount set for "Military Veteran" special registration
37 plates in G.S. 20-79.7(a1) is reenacted.

38 **SECTION 6.(d)** This section becomes effective 90 days after it becomes law.

39 **SECTION 7.(a)** G.S. 20-79.4(b)(171), as it existed on June 30, 2015, is reenacted.
40 The corresponding provisions for fees under G.S. 20-79.7(a1) and (b) and any other
41 corresponding requirements for the plates under G.S. 20-81.12 are also reenacted.

42 **SECTION 7.(b)** G.S. 20-81.12(b140), as reenacted by subsection (a) of this section
43 reads as rewritten:

44 "(b140) Order of the Long Leaf Pine. – ~~The Division must receive 300 or more~~
45 ~~applications for the Order of the Long Leaf Pine plate before the plate may be developed. The~~
46 Order of the Long Leaf Pine plate is not subject to the provisions of G.S. 20-79.3A or
47 G.S. 20-79.8. The Division shall transfer quarterly the money in the Collegiate and Cultural
48 Attraction Plate Account derived from the sale of Order of the Long Leaf Pine plates to the
49 General Fund."

1 **SECTION 8.** The Revisor of Statutes is authorized to alphabetize, number, and
2 renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
3 registration plates are listed in alphabetical order and numbered accordingly.

4 **SECTION 9.** Except as otherwise provided, this act is effective when it becomes
5 law.
