A BILL TO BE ENTITLED

AN ACT TO PROVIDE REGULATORY RELIEF TO THE AGRICULTURAL  
COMMUNITY OF NORTH CAROLINA BY PROVIDING FOR VARIOUS  
TRANSPORTATION AND ENVIRONMENTAL REFORMS AND BY MAKING  
VARIOUS OTHER STATUTORY CHANGES.

The General Assembly of North Carolina enacts:

**REVISE HORSE INDUSTRY PROMOTION ACT TO INCREASE CAPS ON  
DURATION AND AMOUNT OF AN ASSESSMENT**

**SECTION 1.** G.S. 106-823 reads as rewritten:

**"§ 106-823. Referendum.**

(a) The Council may conduct a referendum among horse owners upon the question of whether an assessment shall be levied consistent with this Article.

(b) The Council shall determine all of the following:

(1) The amount of the proposed assessment, not to exceed ~~two dollars~~  
~~(\$2.00)~~four dollars (\$4.00) per ton of commercial horse feed.

(2) The period for which the assessment shall be levied, not to exceed ~~three~~10  
years.

(3) The time and place of the referendum.

(4) Procedures for conducting the referendum and counting votes.


(5) Any other matters pertaining to the referendum.

...."

**CONFORM COMPENSATION PAID TO AN H-2A AGRICULTURAL WORKER TO  
FEDERAL WAGE WITHHOLDING STANDARDS**

**SECTION 2.(a)** G.S. 105-163.3(b) reads as rewritten:

"(b) Exemptions. – The withholding requirement does not apply to the following:

- 1 (1) Compensation that is subject to the withholding requirement of  
2 G.S. 105-163.2.  
3 (2) Compensation paid to an ordained or licensed member of the clergy.  
4 (3) Compensation paid to an entity exempt from tax under G.S. 105-130.11.  
5 (4) Compensation paid to an alien, as described by 8 U.S.C. §  
6 1101(a)(15)(H)(ii)(a), that is not subject to federal income tax withholding  
7 under section 1441 of the Code."

8 **SECTION 2.(b)** This section is effective for taxable years beginning on or after  
9 January 1, 2015.

## 10 ESTABLISH POLICY SUPPORTING SOUND SCIENCE IN AGRICULTURE

11 **SECTION 3.** Article 1 of Chapter 106 of the General Statutes is amended by  
12 adding a new section to read:

### 13 **"§ 106-26.3. Declaration of policy supporting sound science in agriculture.**

14 The General Assembly hereby finds and declares that it shall be the policy of this State to  
15 support and promote sound science in agriculture. For purposes of this section, "sound science  
16 in agriculture" means the use of science-based agricultural practices, technologies, or biological  
17 systems supported by research or otherwise demonstrated to lead to broad outcomes-based  
18 improvements, including such critical outcomes as increasing agricultural productivity and  
19 improving human health through access to safe, nutritious, affordable food and other  
20 agricultural products, including organically produced foods and products, while enhancing  
21 agricultural and surrounding environmental conditions through the stewardship of water, soil,  
22 air quality, biodiversity, and wildlife habitat. Further, the General Assembly finds and declares  
23 that it is in the interest of the people of this State to use sound science in agriculture to meet the  
24 needs of the present and to improve the ability of future generations to meet their own needs,  
25 while advancing progress toward environmental and economic goals and the well-being of  
26 agricultural producers and rural communities."  
27

## 28 MODIFY OVERSIZE VEHICLE PERMIT TIME RESTRICTIONS

29 **SECTION 4.(a)** 19A NCAC 02D .0607 (Permits-Weight, Dimensions and  
30 Limitations). – Until the effective date of the revised permanent rule that the Department of  
31 Transportation is required to adopt pursuant to Section 4(d) of this act, the Department shall  
32 implement 19A NCAC 02D .0607 (Permits-Weight, Dimensions and Limitations) as provided  
33 in subsections (b) and (c) of this section.

34 **SECTION 4.(b)** Implementation. – Notwithstanding subdivision (h)(1) of 19A  
35 NCAC 02D .0607 (Permits-Weight, Dimensions and Limitations), the Secretary of  
36 Transportation shall allow movement of a permitted oversize vehicle between sunrise and  
37 sunset Monday through Sunday. However, a 16-foot-wide mobile or modular home unit with a  
38 maximum three-inch gutter edge is restricted to travel from 9:00 A.M. to 2:30 P.M. Monday  
39 through Sunday. A 16-foot-wide unit is authorized to continue operation after 2:30 P.M., but  
40 not beyond sunset, when traveling on an approved route as determined by an engineering study  
41 and the unit is being exported out-of-state.

42 **SECTION 4.(c)** Implementation. – Notwithstanding subdivision (h)(2) of 19A  
43 NCAC 02D .0607 (Permits-Weight, Dimensions and Limitations), the Secretary of  
44 Transportation shall only prohibit movement of a permitted oversize vehicle and vehicle  
45 combination after noon on the weekday preceding the three holidays of Independence Day,  
46 Thanksgiving Day, and Christmas Day until noon on the weekday following a holiday. If the  
47 observed holiday falls on the weekend, travel is restricted from noon on the preceding Friday  
48 until noon on the following Monday.

49 **SECTION 4.(d)** Additional Rule-Making Authority. – The Department of  
50 Transportation shall adopt rules to amend 19A NCAC 02D .0607 (Permits-Weight, Dimensions  
51

1 and Limitations) consistent with subsections (b) and (c) of this section. Notwithstanding  
2 G.S. 150B-19(4), the rule adopted by the Department pursuant to this section shall be  
3 substantively identical to the provisions of subsections (b) and (c) of this section. Rules adopted  
4 pursuant to this section are not subject to Part 3 of Article 2A of Chapter 150B of the General  
5 Statutes. Rules adopted pursuant to this section shall become effective as provided in  
6 G.S. 150B-21.3(b1) as though 10 or more written objections had been received as provided by  
7 G.S. 150B-21.3(b2).

8 **SECTION 4.(e)** Effective Date. – Subsections (b) and (c) of this section expire on  
9 the date that rules adopted pursuant to subsection (d) of this act become effective.

## 10 11 **ALLOW OVERSIZE TRANSPORTATION OF HAY BALES**

12 **SECTION 5.** G.S. 20-116 is amended by adding a new subsection to read:

### 13 **"§ 20-116. Size of vehicles and loads.**

14 ...

15 (o) Any vehicle carrying baled hay from place to place on the same farm, from one  
16 farm to another, from farm to market, or from market to farm that does not exceed 12 feet in  
17 width may be operated on the highways of this State. Vehicles carrying baled hay that exceed  
18 10 feet in width may only be operated under the following conditions:

19 (1) The vehicle may only be operated during daylight hours.

20 (2) The vehicle shall display a red flag or a flashing warning light on both the  
21 rear and front ends. The flags or lights shall be attached to the equipment as  
22 to be visible from both directions at all times while being operated on the  
23 public highway for not less than 300 feet."

## 24 25 **AMEND RIGHT-OF-CENTER REQUIREMENTS FOR CERTAIN AGRICULTURAL** 26 **VEHICLES**

27 **SECTION 6.(a)** G.S. 20-116(j) reads as rewritten:

28 "(j) Nothing in this section shall be construed to prevent the operation of self-propelled  
29 grain combines or other self-propelled farm equipment with or without implements, not  
30 exceeding 25 feet in width on any highway, unless the operation violates a provision of this  
31 subsection. Farm equipment includes a vehicle that is designed exclusively to transport  
32 compressed seed cotton from a farm to a gin and has a self-loading bed. Combines or  
33 equipment which exceed 10 feet in width may be operated only if they meet all of the  
34 conditions listed in this subsection. A violation of one or more of these conditions does not  
35 constitute negligence per se.

36 (1) The equipment may only be operated during daylight hours.

37 (2) The equipment must display a red flag on front and rear ends or a flashing  
38 warning light. The flags or lights shall be attached to the equipment as to be  
39 visible from both directions at all times while being operated on the public  
40 highway for not less than 300 feet.

41 (3) Equipment covered by this section, which by necessity must travel more  
42 than 10 miles or where by nature of the terrain or obstacles the flags or lights  
43 referred to in subdivision (2) of this subsection are not visible from both  
44 directions for 300 feet at any point along the proposed route, must be  
45 preceded at a distance of 300 feet and followed at a distance of 300 feet by a  
46 flagman in a vehicle having mounted thereon an appropriate warning light or  
47 flag. No flagman in a vehicle shall be required pursuant to this subdivision if  
48 the equipment is being moved under its own power or on a trailer from any  
49 field to another field, or from the normal place of storage of the vehicle to  
50 any field, for no more than ten miles and if visible from both directions for  
51 300 feet at any point along the proposed route.

(4) Every piece of equipment so operated shall operate to the right of the center line ~~when meeting traffic coming from the opposite direction and at all other times when possible and practical~~ unless the combined width of the traveling lane and the accessible shoulder is less than the width of the equipment.

...."

**SECTION 6.(b)** G.S. 20-146 is amended by adding a new subsection to read:

**"§ 20-146. Drive on right side of highway; exceptions.**

(a) Upon all highways of sufficient width a vehicle shall be driven upon the right half of the highway except as follows:

- (1) When overtaking and passing another vehicle proceeding in the same direction under the rules governing such movement;
- (2) When an obstruction exists making it necessary to drive to the left of the center of the highway; provided, any person so doing shall yield the right-of-way to all vehicles traveling in the proper direction upon the unobstructed portion of the highway within such distance as to constitute an immediate hazard;
- (3) Upon a highway divided into three marked lanes for traffic under the rules applicable thereon; or
- (4) Upon a highway designated and signposted for one-way traffic.

(a1) Self-propelled grain combines or other self-propelled farm equipment shall be operated to the right of the centerline except as provided in G.S. 20-116(j)(4).

(b) Upon all highways any vehicle proceeding at less than the legal maximum speed limit shall be driven in the right-hand lane then available for thru traffic, or as close as practicable to the right-hand curb or edge of the highway, except when overtaking and passing another vehicle proceeding in the same direction or when preparing for a left turn.

...."

**AMEND DEFINITION OF "AGRICULTURAL SPREADER VEHICLE," INCREASE SPEED LIMIT FOR AGRICULTURAL SPREADER VEHICLES**

**SECTION 7.** G.S. 20-51 reads as rewritten:

**"§ 20-51. Exempt from registration.**

The following shall be exempt from the requirement of registration and certificate of title:

...

- (16) A vehicle that meets all of the following conditions is exempt from the requirement of registration and certificate of title. The provisions of G.S. 105-449.117 continue to apply to the vehicle and to the person in whose name the vehicle would be registered.
  - a. Is an agricultural spreader vehicle. An "agricultural spreader vehicle" is a vehicle that is designed for off-highway use on a farm to spread feed, fertilizer, seed, lime, or other agricultural products ~~on a field, products.~~
  - b. Is driven on the highway only for the purpose of going from the location of its supply source for fertilizer or other products to and from a farm.
  - c. Does not exceed a speed of ~~35~~45 miles per hour.
  - d. Does not drive outside a radius of 50 miles from the location of its supply source for fertilizer and other products.
  - e. Is driven by a person who has a license appropriate for the class of the vehicle.
  - f. Is insured under a motor vehicle liability policy in the amount required under G.S. 20-309.

g. Displays a valid federal safety inspection decal if the vehicle has a gross vehicle weight rating of at least 10,001 pounds.

...."

**ALLOW ALL-TERRAIN VEHICLES AND UTILITY VEHICLES USED FOR AGRICULTURAL PURPOSES TO OPERATE ON PUBLIC ROADS**

**SECTION 8.** G.S. 20-171.22 reads as rewritten:

**"§ 20-171.22. Exceptions.**

(a) The provisions of this Part do not apply to any owner, operator, lessor, or renter of a farm or ranch, or that person's employees or immediate family or household members, when operating an all-terrain vehicle while engaged in farming operations.

(a1) Any person may operate an all-terrain vehicle or utility vehicle on a public street or highway while engaged in farming operations.

(b) The provisions of this Part do not apply to any person using an all-terrain vehicle for hunting or trapping purposes if the person is otherwise lawfully engaged in those activities.

(c) The provisions of G.S. 20-171.19(a1) do not apply to any person 16 years of age or older if the person is otherwise lawfully using the all-terrain vehicle on any ocean beach area where such vehicles are allowed by law. As used in this subsection, "ocean beach area" means the area adjacent to the ocean and ocean inlets that is subject to public trust rights. Natural indicators of the landward extent of the ocean beaches include, but are not limited to, the first line of stable, natural vegetation; the toe of the frontal dune; and the storm trash line."

**CLARIFY THE ROAD WEIGHT LIMITATION EXCEPTIONS FOR TRANSPORTATION OF AGRICULTURAL PRODUCTS AND SUPPLIES**

**SECTION 9.(a)** G.S. 20-118(c)(12) reads as rewritten:

"(12) Subsections (b) and (e) of this section do not apply to a vehicle or vehicle combination that meets all of the conditions set out below:

a. Is transporting any of the following items within 150 miles of the point of origination:

1. ~~Agriculture~~ Agriculture, dairy, and crop products transported from a farm or holding facility to a processing plant-plant, feed mill, or market.
2. Water, fertilizer, pesticides, seeds, fuel, or animal waste transported to or from a ~~farm by a farm vehicle as defined in G.S. 20-37.16(e)(3).~~ farm.
3. Meats, livestock, or live poultry transported from the farm where they were raised to a processing plant or market.
- 3a. Feed or feed ingredients that is-are used in the feeding of poultry or livestock and transported from a storage facility, holding facility, or mill to a farm.
4. Forest products originating and transported from a farm or woodlands to market with delay interruption or delay for further packaging or processing after initiating transport.
5. Wood residuals, including wood chips, sawdust, mulch, or tree bark from any site.
6. Raw logs to market.
7. Trees grown as Christmas trees from field, farm, stand, or grove to a processing point.

...."

**SECTION 9.(b)** This section becomes effective October 1, 2015.

1 **ESTABLISH MARKING AND NOTICE REQUIREMENTS FOR**  
2 **METEOROLOGICAL TOWERS**

3 **SECTION 10.(a)** Chapter 63 of the General Statutes is amended by adding a new  
4 Article to read:

5 "Article 11.

6 "Marking and Notice of Meteorological Towers.

7 **"§ 63-110. Marking of meteorological towers.**

8 (a) As used in this Article, the term:

9 (1) "Height" means the distance from the base of a tower to the highest point of  
10 the tower.

11 (2) "Meteorological tower" means a structure that is either self-standing or  
12 supported by guy wires and ground anchors and has guy wires and accessory  
13 facilities on which equipment used to measure wind speed and direction is  
14 mounted. "Meteorological tower" does not include a structure that is affixed  
15 or located adjacent to a building, house, or barn.

16 (b) Except as required by federal law, rule, or regulation, any meteorological tower over  
17 50 feet in height shall be marked and painted or otherwise constructed to be visible in clear air  
18 during daylight hours from a distance of not less than 2,000 feet. Meteorological towers shall  
19 also comply with the following additional requirements:

20 (1) A meteorological tower shall be painted in equal alternating bands of  
21 aviation orange and white, beginning with orange at the top of the tower.

22 (2) One marker ball shall be attached to the top third of each outside guy wire.

23 (3) Guy wires shall have a seven-foot-long safety sleeve at each anchor point  
24 that extends from the anchor point along each guy wire attached to the  
25 anchor point.

26 **"§ 63-111. Registration; notification; tower database; penalty.**

27 (a) The Department of Transportation shall adopt rules requiring any person proposing  
28 to construct a meteorological tower to register with the Department. The person proposing to  
29 construct the tower shall notify the Department of the proposal, the location and height of the  
30 proposed tower, and any other information the Department may require to ensure aviation  
31 safety and shall pay a registration fee of three hundred fifty dollars (\$350.00). The rules shall  
32 require the owner of a meteorological tower to notify the Department upon removal or  
33 destruction of a tower.

34 (b) The Department of Transportation shall establish and maintain an electronic  
35 database that contains the location of all meteorological towers in the State by January 1, 2017.  
36 The Department may contract with a governmental entity or private entity to create and  
37 maintain the database. The Department shall make the contents of the database available on its  
38 Web site.

39 **"§ 63-112. Penalties.**

40 The Secretary of Transportation may assess a civil penalty of not more than ten thousand  
41 dollars (\$10,000) per violation against any person who violates any provision of this Article."

42 **SECTION 10.(b)** This section becomes effective January 1, 2017, and applies to  
43 meteorological towers erected on or after that date.

44  
45 **ALLOW SHELLFISH CULTIVATION LEASES IN AREAS CONTAINING**  
46 **SUBMERGED AQUATIC VEGETATION**

47 **SECTION 11.(a)** G.S. 113-202(b) reads as rewritten:

48 "(b) The Secretary may delete any part of an area proposed for lease or may condition a  
49 lease to protect the public interest with respect to the factors enumerated in subsection (a) of  
50 this section. The Secretary may not grant a new lease in an area heavily used for recreational  
51 purposes. Except as prohibited by federal law, the Secretary shall not exclude any area from

1 leasing solely on the basis that the area contains submerged aquatic vegetation and shall make  
2 specific findings based on the standards set forth in subsection (a) of this section prior to  
3 reaching a decision not to grant or renew a lease for shellfish cultivation for any area containing  
4 submerged aquatic vegetation."

5 **SECTION 11.(b)** This section becomes effective October 1, 2015, and applies to  
6 any new shellfish cultivation leases or renewals of existing shellfish cultivation leases issued on  
7 or after that date.

## 9 PRESENT-USE VALUE MODIFICATIONS

10 **SECTION 12.(a)** G.S. 105-277.2 reads as rewritten:

11 "**§ 105-277.2. Agricultural, horticultural, and forestland – Definitions.**

12 The following definitions apply in G.S. 105-277.3 through G.S. 105-277.7:

13 (1) Agricultural land. – Land that is a part of a farm unit that is actively engaged  
14 in the commercial production or growing of crops, plants, or animals under a  
15 sound management program. For purposes of this definition, the commercial  
16 production or growing of animals includes the rearing, feeding, training,  
17 caring, and managing of horses. Agricultural land includes woodland and  
18 wasteland that is a part of the farm unit, but the woodland and wasteland  
19 included in the unit must be appraised under the use-value schedules as  
20 woodland or wasteland. A farm unit may consist of more than one tract of  
21 agricultural land, but at least one of the tracts must meet the requirements in  
22 G.S. 105-277.3(a)(1), and each tract must be under a sound management  
23 program. If the agricultural land includes less than 20 acres of woodland,  
24 then the woodland portion is not required to be under a sound management  
25 program. Also, woodland is not required to be under a sound management  
26 program if it is determined that the highest and best use of the woodland is  
27 to diminish wind erosion of adjacent agricultural land, protect water quality  
28 of adjacent agricultural land, or serve as buffers for adjacent livestock or  
29 poultry operations.

30 ...

31 (4) Individually owned. – Owned by one of the following:

32 a. An individual.

33 b. A business entity that meets all of the following conditions:

34 1. Its principal business is farming agricultural land,  
35 horticultural land, or forestland. When determining whether  
36 an applicant under G.S. 105-277.4 has as its principal  
37 business farming agricultural land, horticultural land, or  
38 forestland, the assessor shall presume the applicant's principal  
39 business to be farming agricultural land, horticultural land, or  
40 forestland if the applicant has been approved by another  
41 county for present-use value taxation for a qualifying  
42 property located within the other county; provided, however,  
43 the presumption afforded the applicant may be rebutted by  
44 the assessor and shall have no bearing on the determination of  
45 whether the individual parcel of land meets one or more of  
46 the classes defined in G.S. 105-277.3(a). If the assessor is  
47 able to rebut the presumption, this shall not invalidate the  
48 determination that the applicant's principal business is  
49 farming agricultural land, horticultural land, or forestland in  
50 the other county.

2 **PROCEDURE FOR TERMINATION OR MODIFICATION OF CONSERVATION**  
3 **AGREEMENTS**

4 **SECTION 13.(a)** Article 4 of Chapter 121 of the General Statutes is amended by  
5 adding a new section to read:

6 **"§ 121-39A. Termination or modification of agreements.**

7 (a) Easements secured by the Agricultural Development and Farmland Preservation  
8 Trust Fund, including perpetual agricultural conservation easements and forest land easements,  
9 military base protection and flyway easements regardless of funding source, or any other  
10 agricultural conservation easement that has been secured, in whole or in part, with federal funds  
11 and where at least one party to the agreement is a public body of this State, shall not be  
12 terminated or modified for the purpose of economic development.

13 (b) Prior to any modification or termination of a conservation agreement where at least  
14 one party to the agreement is a public body of this State, the agency requesting the conservation  
15 agreement modification or termination shall conduct a conservation benefit analysis. The  
16 criteria for the conservation benefit analysis shall be established by the agency requesting the  
17 conservation agreement modification or termination. Conservation agreements may only be  
18 modified or terminated if the conservation benefit analysis concludes that the modification or  
19 termination results in a greater benefit to conservation purposes consistent with this Article.

20 (c) The conservation benefit analysis conducted by the requesting agency shall be  
21 reported to the Council of State prior to the vote of the Council of State on the final decision to  
22 modify the agreement.

23 (d) Notwithstanding any authority given to a public body of this State, including the  
24 State, any of its agencies, any city, county, district or other political subdivision, municipal or  
25 public corporation, or any instrumentality of any of the foregoing, to release or terminate  
26 conservation easements under other law, this section shall apply to conservation agreements  
27 that are intended to be effective perpetually or that are terminated or modified prior to the  
28 period of time stipulated in the agreement, and where at least one party to the agreement is a  
29 public body of this State, including the State, any of its agencies, any city, county, district or  
30 other political subdivision, municipal or public corporation, or any instrumentality of any of the  
31 foregoing.

32 (e) Parties to a conservation agreement may include a provision at the time an  
33 agreement is executed requiring the consent of the grantor or the grantor's successors in interest  
34 to terminate or modify the agreement for any purpose.

35 (f) Any agency managing a conservation agreement program may adopt rules  
36 governing its procedure for termination or modification of a conservation agreement, provided  
37 that any such rules may be no less stringent than the requirements of this section.

38 (g) This section shall not apply to a condemnation action initiated by a condemnor  
39 governed by Article 6 of Chapter 40A of the General Statutes."

40 **SECTION 13.(b)** G.S. 106-744(c1) reads as rewritten:

41 "(c1) The Commissioner shall distribute Trust Fund monies for only the purposes under  
42 subsection (c) of this section, including transaction costs, as follows:

- 43 (1) To a private nonprofit conservation organization that matches thirty percent  
44 (30%) of the Trust Fund monies it receives with funds from sources other  
45 than the Trust Fund.
- 46 (2) To counties according to the match requirements under subsection (c2) of  
47 this section.
- 48 (3) To the Department of Agriculture and Consumer Services for the purchase  
49 of agricultural conservation easements or agreements to be held by the  
50 Department."

1 SECTION 13.(c) Subsection (a) of this section is effective when it becomes law  
2 and applies to conservation agreements executed on or after that date. The remainder of this  
3 section is effective when it becomes law and applies to easements or agreements in effect on  
4 that date and executed on or after that date.

5  
6 **TRANSFER CAPTIVE CERVID PROGRAM TO THE DEPARTMENT OF**  
7 **AGRICULTURE AND CONSUMER SERVICES**

8 SECTION 14.(a) Article 49H of Chapter 106 of the General Statutes reads as  
9 rewritten:

10 "Article 49H.

11 ~~"Production and Sale~~Production, Sale, and Transportation of Fallow Deer and Red  
12 ~~Deer.~~Farmed Cervids.

13 **"§ 106-549.97. Regulation by Department of Agriculture and Consumer Services of**  
14 **certain~~farmed~~ cervids produced and sold for commercial purposes; certain**  
15 **~~authority of North Carolina Wildlife Resources Commission not affected;~~**  
16 **~~definitions.~~**

17 (a) ~~The Department of Agriculture and Consumer Services shall regulate the production~~  
18 ~~and sale of farmed cervids. The Board of Agriculture shall adopt rules for the production and~~

43 (a2) The Department of Agriculture and Consumer Services shall regulate the  
44 production, sale, possession, and transportation, including importation and exportation, of  
45 farmed cervids. The Department shall have sole authority with regard to farmed cervids,  
46 including administration of the North Carolina Captive Cervid Herd Certification Program. The  
47 Department shall allow the sale of farmed cervids, whether alive or dead, whole or in part,

(b) The Commercial Fund shall be used for the payment of the following costs up to an aggregate maximum of one million dollars (\$1,000,000) per occurrence resulting from a discharge or release of a petroleum product from a commercial underground storage tank:

(5) Compensation to third parties for bodily injury and property damage in excess of one hundred thousand dollars (\$100,000) per occurrence. Claims for third-party property damage shall be based on the rental costs of comparable property during the period of loss of use up to a maximum amount equal to the fair market value. In the case of property that is actually destroyed as a result of a petroleum release, reimbursement shall be at an amount necessary to replace or repair the destroyed property.

(12) Compensation to third parties for bodily injury and property damage in excess of one hundred thousand dollars (\$100,000) per occurrence caused by releases from noncommercial underground storage tanks reported to the Department prior to October 1, 2015, if the claim for compensation is made prior to July 1, 2016. Claims for third-party property damage shall be based on the rental costs of comparable property during the period of loss of use up to a maximum amount equal to the fair market value. In the case of property that is actually destroyed as a result of a petroleum release, reimbursement shall be at an amount necessary to replace or repair the destroyed property.

SECTION 20.(d) This section is effective when it becomes law and applies to claims for reimbursement pending or submitted on or after that date.

**AMEND DEFINITION OF MINING RELATIVE TO AGRICULTURAL ACTIVITIES**

SECTION 23. G.S. 74-49(7) reads as rewritten:

**"§ 74-49. Definitions.**

Wherever used or referred to in this Article, unless a different meaning clearly appears from the context:

- (7) "Mining" ~~means:~~means any of the following:
- a. ~~The (i) the~~ breaking of the surface soil in order to facilitate or accomplish the extraction or removal of minerals, ores, or other solid ~~matter.~~
  - b. ~~Any matter;~~ (ii) any activity or process constituting all or part of a process for the extraction or removal of minerals, ores, soils, and other solid matter from their original ~~location.~~
  - e. ~~The location;~~ or (iii) the preparation, washing, cleaning, or other treatment of minerals, ores, or other solid matter so as to make them suitable for commercial, industrial, or construction use.

"Mining" does not include:

- a. Those aspects of deep mining not having significant effect on the surface, where the affected land does not exceed one acre in area.
- b. Mining operations where the affected land does not exceed one acre in area.
- c. Plants engaged in processing minerals produced elsewhere and whose refuse does not affect more than one acre of land.
- d. Excavation or grading when conducted solely ~~in aid of on-site farming or offor~~ on-site construction for purposes other than mining.

- 1 e. Removal of overburden and mining of limited amounts of any ores or  
2 mineral solids when done only for the purpose and to the extent  
3 necessary to determine the location, quantity, or quality of any  
4 natural deposit, provided that no ores or mineral solids removed  
5 during exploratory excavation or mining are sold, processed for sale,  
6 or consumed in the regular operation of a business, and provided  
7 further that the affected land resulting from any exploratory  
8 excavation does not exceed one acre in area.
- 9 f. Excavation or grading where all of the following apply:
- 10 1. The excavation or grading is conducted to provide soil or  
11 other unconsolidated material to be used without further  
12 processing for a single off-site construction project for which  
13 an erosion and sedimentation control plan has been approved  
14 in accordance with Article 4 of Chapter 113A of the General  
15 Statutes.
  - 16 2. The affected land, including nonpublic access roads, does not  
17 exceed five acres.
  - 18 3. The excavation or grading is completed within one year.
  - 19 4. The excavation or grading does not involve blasting, the  
20 removal of material from rivers or streams, the disposal of  
21 off-site waste on the affected land, or the surface disposal of  
22 groundwater beyond the affected land.
  - 23 5. The excavation or grading is not in violation of any local  
24 ordinance.
  - 25 6. An erosion and sedimentation control plan for the excavation  
26 or grading has been approved in accordance with Article 4 of  
27 Chapter 113A of the General Statutes.
- 28 g. Excavation or grading when conducted solely for activities  
29 undertaken on agricultural land that are exempt, pursuant to  
30 G.S. 113A-52.01(1), from the requirements of Article 4 of Chapter  
31 113A of the General Statutes."

### 33 AMEND THE HOLDING AND ADVERTISING PERIOD FOR UNCLAIMED 34 LIVESTOCK

35 SECTION 24.(a) G.S. 68-20 reads as rewritten:

#### 36 "§ 68-20. Notice of sale and sale where owner fails to redeem or is unknown; application 37 of proceeds.

38 If the owner fails to redeem his livestock within three days after the notice and demand as  
39 provided in G.S. 68-18 is received or within three days after the determination of the costs and  
40 damages as provided in G.S. 68-19, ~~then, upon written notice fully describing the livestock,~~  
41 ~~stating the place, date, and hour of sale posted at the courthouse door and three or more public~~  
42 ~~places in the township where the owner resides, and after the impounder shall notify the local~~  
43 ~~Sheriff's office and the Sheriff shall post a notice fully describing the livestock and stating the~~  
44 ~~place, date, and hour of sale on the Web site of the Sheriff's department. After 10 days from~~  
45 ~~such posting, the impounder shall sell the livestock at public auction. If the owner of the~~  
46 ~~livestock remains unknown to the impounder, then, 30-three days after publication of the notice~~  
47 ~~required by G.S. 68-18.1, the impounder shall post at the courthouse door and three public~~  
48 ~~places in the township where the livestock is impounded a written notice fully describing the~~  
49 ~~livestock, and stating the place, date, and hour of sale. notify the local Sheriff's office and the~~  
50 ~~Sheriff shall post a notice fully describing the livestock and stating the place, date, and hour of~~  
51 ~~sale on the Web site of the Sheriff's department. After 20-10 days from such posting, the~~

1 impounder shall sell the livestock at public auction. The proceeds of any such public sale shall  
2 be applied to pay the reasonable costs of impounding and maintaining the livestock and the  
3 damages to the impounder caused by the livestock. Reasonable costs of impounding shall  
4 include any fees paid pursuant to G.S. 68-18.1 in an attempt to locate the owner of the  
5 livestock. The balance, if any, shall be paid to the owner of the livestock, if known, or, if the  
6 owner is not known, then to the school fund of the county where the livestock was impounded."

7 **SECTION 24.(b)** This section is effective when this act becomes law and applies  
8 to livestock impounded on or after that date.

## 10 **MODIFY DEPARTMENT OF AGRICULTURE REPORTING REQUIREMENTS**

11 **SECTION 25.(a)** G.S. 106-815 is repealed.

12 **SECTION 25.(b)** G.S. 19A-62(c) reads as rewritten:

13 "(c) Report. – In ~~February~~ March of each year, the Department must report to the Joint  
14 Legislative Commission on Governmental Operations and the Fiscal Research Division. The  
15 report must contain information regarding all revenues and expenditures of the Spay/Neuter  
16 Account."

## 18 **PRESCRIBED BURNING ACT MODIFICATIONS**

19 **SECTION 26.** G.S. 106-968 reads as rewritten:

20 "**§ 106-968. Prescribed burning.**

21 (a) Prior to conducting a prescribed burning, the landowner shall obtain a prescription  
22 for the prescribed burning prepared by a certified prescribed burner and filed with the North  
23 Carolina Forest Service of the Department of Agriculture and Consumer Services. A copy of  
24 the prescription shall be provided to the landowner. A copy of this prescription shall be in the  
25 possession of the responsible burner on site throughout the duration of the prescribed burning.  
26 The prescription shall include:

- 27 (1) The landowner's name and address.
- 28 (2) A description of the area to be burned.
- 29 (3) A map of the area to be burned.
- 30 (4) An estimate ~~in~~ of tons of the fuel located on the area.
- 31 (5) The objectives of the prescribed burning.
- 32 (6) A list of the acceptable weather conditions and parameters for the prescribed  
33 burning sufficient to minimize the likelihood of smoke damage and fire  
34 escaping onto adjacent areas.
- 35 (7) The name of the certified prescribed burner responsible for conducting the  
36 prescribed burning.
- 37 (8) A summary of the methods that are adequate for the particular circumstances  
38 involved to be used to start, control, and extinguish the prescribed burning.
- 39 (9) Provision for reasonable notice of the prescribed burning to be provided to  
40 nearby homes and businesses to avoid effects on health and property.

41 (b) The prescribed burning shall be conducted by a certified prescribed burner in  
42 accordance with a prescription that satisfies subsection (a) of this section. The certified  
43 prescribed burner shall be present on the site and shall be in charge of the burning throughout  
44 the period of the burning. A landowner may conduct a prescribed burning and be in compliance  
45 with this Article without being a certified prescribed burner if the landowner is burning a tract  
46 of forestland of 50 acres or less owned by that landowner and is following all conditions  
47 established in a prescription prepared by a certified prescribed burner.

48 (c) Prior to conducting a prescribed burning, the landowner or the landowner's agent  
49 shall obtain an open-burning permit under Article 78 of this Chapter from the North Carolina  
50 Forest Service of the Department of Agriculture and Consumer Services. This open-burning

1 permit must remain in effect throughout the period of the prescribed burning. The prescribed  
2 burning shall be conducted in compliance with all the following:

- 3 (1) The terms and conditions of the open-burning permit under Article 78 of this  
4 Chapter.
- 5 (2) The State's air pollution control statutes under Article 21 and Article 21B of  
6 Chapter 143 of the General Statutes and any rules adopted pursuant to these  
7 statutes.
- 8 (3) Any applicable local ordinances relating to open burning.
- 9 (4) The ~~voluntary~~-smoke management guidelines adopted by the North Carolina  
10 Forest Service of the Department of Agriculture and Consumer Services.
- 11 (5) Any rules adopted by the North Carolina Forest Service of the Department  
12 of Agriculture and Consumer Services, to implement this Article.

13 (d) The North Carolina Forest Service may accept prescribed burner certification from  
14 another State or other entity for the purpose of prescribed burning under this Article."

## 15 16 **MODIFY PENALTY FOR FAILURE TO GUARD A FIRE BY WATCHMAN**

17 **SECTION 27.** G.S. 14-140.1 reads as rewritten:

### 18 **"§ 14-140.1. Certain fire to be guarded by watchman.**

19 Any person, firm, corporation, or other legal entity who shall burn any brush, grass, or other  
20 material whereby any property may be endangered or destroyed, without keeping and  
21 maintaining a careful watchman in charge of the burning, shall be guilty of a ~~Class 3~~  
22 ~~misdemeanor~~ an infraction which may include a fine of not less than ten dollars (\$10.00) or  
23 more than fifty dollars (\$50.00). Fire escaping from the brush, grass, or other material while  
24 burning shall be prima facie evidence of violation of this provision."  
25

## 26 **CLARIFY THE PESTICIDE BOARD'S AUTHORITY TO RELICENSE AND** 27 **RECERTIFY LICENSEES FOR PESTICIDE DEALERS, APPLICATORS, AND PEST** 28 **CONTROL CONSULTANTS**

29 **SECTION 29.(a)** G.S. 143-449 reads as rewritten:

### 30 **"§ 143-449. Qualifications for pesticide dealer license; examinations.**

31 (a) An applicant for a license must present evidence satisfactory to the Board  
32 concerning his qualifications for such license.

33 (b) Each applicant shall satisfy the Board as to his responsibility in carrying on the  
34 business of a pesticide dealer. Each applicant for an original license must demonstrate upon  
35 written, or written and oral, examination to be prescribed by the Board his knowledge of  
36 pesticides, their usefulness and their hazards; his competence as a pesticide dealer; and his  
37 knowledge of the laws and regulations governing the use and sale of pesticides. A  
38 nonrefundable fee of fifty dollars (\$50.00) shall be charged for each examination required by  
39 this section. This examination fee is in addition to any fee authorized pursuant to any other  
40 provision of Article 4C of Chapter 106 of the General Statutes.

41 (c) The Board shall by regulation:

- 42 (1) Designate what persons or class of persons shall be required to pass the  
43 examination in the case of a pesticide dealer operating more than one  
44 location, and in the case of an applicant that is a corporation, governmental  
45 unit or agency, or other organized group;
- 46 (2) Provide for license renewal license examinations by completion of  
47 continuing certification credit requirements as prescribed by the Board or  
48 reexaminations at intervals not more frequent than four years."

49 **SECTION 29.(b)** G.S. 143-453 reads as rewritten:

### 50 **"§ 143-453. Qualifications for pesticide applicator's license; examinations.**

51 ...

1 (c) The Board shall by regulation:

2 (1) Designate what persons or class of persons shall be required to pass the  
3 examination in the case of an applicant that is a corporation or governmental  
4 unit or agency;

5 (2) Provide for license renewal ~~examinations~~ by completion of continuing  
6 certification credit requirements as prescribed by the Board or  
7 reexaminations at intervals not more frequent than four years, or more  
8 frequently if found by the Board to be required to be necessary in order to  
9 qualify North Carolina's State pesticide control plan for federal approval."

10 **SECTION 29.(c)** G.S. 143-455 reads as rewritten:

11 **"§ 143-455. Pest control consultant license.**

12 ...

13 (d) Pest control consultants shall be subject to the same provisions as pesticide  
14 applicators concerning penalties for late applications for license, changes of address,  
15 transferability of licenses, continuing certification credit requirements, periodic reexamination,  
16 and examinations for corporate applicants."

17  
18 **CLARIFY THAT PROJECTS FOR THE PURPOSE OF COMMERCIAL RESALE OF**  
19 **NATURAL GAS OR PROPANE GAS ARE NOT ELIGIBLE FOR THE EXPANDED**  
20 **GAS PRODUCTS SERVICE TO AGRICULTURE FUND**

21 **SECTION 30.** G.S. 143B-437.020(a)(3) reads as rewritten:

22 **"§ 143B-437.020. Natural gas and propane gas for agricultural projects.**

23 (a) Definitions. –

24 ...

25 (3) Eligible project. – A discrete and specific economic development project  
26 that would expand agricultural production or processing capabilities that  
27 requires new or expanded natural gas or propane gas service. A project  
28 intended for the purpose of commercial resale of natural gas or propane gas  
29 shall not be an eligible project."

30  
31 **LIMIT THE PERSONALLY IDENTIFYING INFORMATION THAT THE**  
32 **DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES MAY DISCLOSE**  
33 **ABOUT ITS ANIMAL HEALTH PROGRAMS**

34 **SECTION 31.** G.S. 106-24.1 reads as rewritten:

35 **"§ 106-24.1. Confidentiality of information collected and published.**

36 All information published by the Department of Agriculture and Consumer Services  
37 pursuant to this Part shall be classified so as to prevent the identification of information  
38 received from individual farm operators. All information generated by any federal agency  
39 received pursuant to this Part from individual farm operators that is confidential under federal  
40 law shall be held confidential by the Department and its employees. All information collected  
41 by the Department from individual farm operators for the purposes of its animal health  
42 programs, farm owners or animal owners, including, but not limited to, certificates of  
43 veterinary inspection, animal medical records, laboratory reports, reports received or generated  
44 from samples submitted for analysis, or other records that may be used to identify a person or  
45 private business entity subject to regulation by the Department shall not be disclosed without  
46 the permission of the owner unless the State Veterinarian determines that disclosure is  
47 necessary to prevent the spread of an animal disease or to protect the public health, or the  
48 disclosure is necessary in the implementation of these animal health programs."

1 **ALLOW DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES TO**  
2 **REGISTER OUTSOURCING FACILITIES ENGAGED IN THE COMPOUNDING OF**  
3 **STERILE DRUGS**

4 **SECTION 32.** G.S. 106-140.1, as amended by S.L. 2015-241, reads as rewritten:

5 **"§ 106-140.1. Registration of producers of prescription drugs and devices.**

6 (a) On or before December 31 of each year, every person doing business in North  
7 Carolina and operating as a wholesaler, manufacturer, outsourcing facility, or repackager, as  
8 those terms are defined in subsection (j) of this section, shall register with the Commissioner  
9 his name and business location(s) in North Carolina. If said person has no business locations in  
10 North Carolina, he shall register his name and location of his corporate offices.

11 (b) Every person, upon first operating as a wholesaler, ~~manufacturer~~ manufacturer,  
12 outsourcing facility, or repackager in North Carolina shall immediately register with the  
13 Commissioner his name, place of business, and such establishment. If said person has no  
14 business locations in North Carolina, he shall register his name and location of his corporate  
15 offices.

16 (c) Every person duly registered in accordance with subsections (a) and (b) of this  
17 section shall register with the Commissioner any additional establishment that he owns or  
18 operates in the State of North Carolina prior to doing business as a manufacturer,  
19 ~~wholesaler~~ wholesaler, outsourcing facility, or repackager.

20 (d) The Commissioner may assign a registration number to any person or any  
21 establishment registered in accordance with this section.

22 (e) The Commissioner shall make available for inspection to any person so requesting  
23 any registration filed pursuant to this section.

24 (f) The following classes of people are exempt from the registration requirements of  
25 this section:

- 26 (1) Pharmacists as defined in G.S. 90-85.3(q) holding a valid permit as defined  
27 in G.S. 90-85.3(m);
- 28 (2) Practitioners licensed or registered by law to prescribe or administer drugs  
29 and who manufacture, prepare, compound, or process drugs or devices  
30 solely for use in the course of their professional practice.
- 31 (3) Persons who manufacture, prepare, compound, or process drugs solely for  
32 use in research, teaching, or chemical analysis and not for sale.
- 33 (4) Other classes of persons the Commissioner may by rule exempt from the  
34 application of this section upon a finding that registration by these classes of  
35 persons in accordance with this section is not necessary for the protection of  
36 the public health.
- 37 (5) Wholesale distributors of prescription drugs licensed under G.S. 106-145.3.

38 (g) Every establishment in the State of North Carolina registered with the  
39 Commissioner pursuant to this section shall be subject to inspection pursuant to G.S. 106-140.

40 (h) The Commissioner shall adopt rules to implement the registration requirements of  
41 this section. These rules shall provide for an annual registration fee of one thousand dollars  
42 (\$1,000) for companies operating as ~~manufacturers~~ manufacturers, outsourcing facilities, or  
43 repackagers and seven hundred dollars (\$700.00) for companies operating as wholesalers. The  
44 Department of Agriculture and Consumer Services shall use these funds for the implementation  
45 of the North Carolina Food, Drug and Cosmetic Act.

46 (i) For the purposes of this act, name means the name of the partnership if a partnership  
47 and the name of the corporation if a corporation.

48 (j) As used in this section:

- 49 (1) The term "manufacturer" means a person who prepares, derives, or produces  
50 a prescription drug. Pharmacists are specifically excluded from this

- 1 definition if they are acting in the course of their professional practice as  
2 defined in Chapter 90 and rules adopted pursuant to it.
- 3 (2) The term "prescription drug" means a drug that under federal law is required,  
4 prior to being dispensed or delivered, to be labeled with the following  
5 statement: "Caution: Federal law prohibits dispensing without a  
6 prescription."
- 7 (3) The term "repackager" means a person who repacks, relabels, or manipulates  
8 a prescription drug which was in a unit packaged and sealed by a  
9 manufacturer. Pharmacists are specifically exempted from this definition if  
10 they are acting in the course of their professional practice as defined in  
11 Chapter 90 and rules adopted pursuant to it.
- 12 (4) The term "wholesaler" means a person acting as a jobber, wholesale  
13 merchant, salvager, or broker, or agent thereof, who sells or distributes for  
14 resale a prescription drug. Pharmacists are specifically exempted from this  
15 definition if they are acting in the course of their professional practice as  
16 defined in Chapter 90 and rules adopted pursuant to it.
- 17 (5) The term "outsourcing facility" means a manufacturer at a single geographic  
18 location or address that is engaged in the compounding of sterile drugs, has  
19 elected to register as an outsourcing facility with the Food and Drug  
20 Administration, and complies with the requirements as provided in 21  
21 U.S.C. § 353b. Exemptions provided by 21 U.S.C. § 353b(a) with respect to  
22 labeling, new drug registration, and distribution supply chain requirements  
23 shall also apply to compounded drugs distributed in North Carolina by an  
24 outsourcing facility."

25  
26 **EXEMPTIONS FROM CERTAIN DEPARTMENT OF ENVIRONMENTAL AND**  
27 **NATURAL RESOURCES PERMITS AND WASTE ANALYSIS DURING IMMINENT**  
28 **THREAT OF CONTAGIOUS ANIMAL DISEASE**

29 **SECTION 33.(a)** G.S. 106-399.4(a) reads as rewritten:

30 "(a) When determined by the State Veterinarian, in consultation with the Commissioner  
31 of Agriculture and with the approval of the Governor, that there is an imminent threat within  
32 the State of a contagious animal disease that has the potential for very serious and rapid spread,  
33 is of serious socioeconomic and public health consequence, or is of major importance in the  
34 international trade of animals and animal products, the State Veterinarian or an authorized  
35 representative may develop and implement any emergency measures and procedures that the  
36 State Veterinarian determines necessary to prevent and control the animal disease. Any  
37 emergency measure or procedure relating to composting of dead domesticated animals pursuant  
38 to this Part shall be deemed to be permitted pursuant to G.S. 143-215.1(b) and it shall not be  
39 necessary for the Department of Environment and Natural Resources to issue individual  
40 permits."

41 **SECTION 33.(b)** G.S. 143-215.10C is amended by adding a new subsection to  
42 read:

43 "(f2) Periodic testing of waste products as required in subdivision (6) of subsection (e) of  
44 this section, subsection (f) of this section and subsection (f1) of this section may be temporarily  
45 suspended in compliance with G.S. 106-399.4 when the State Veterinarian, in consultation with  
46 the Commissioner of Agriculture and with the approval of the Governor, determines that there  
47 is an imminent threat within the State of a contagious animal disease. The suspension of testing  
48 only applies to the animal operation types designated by the State Veterinarian, and shall be in  
49 effect for a period of time that the State Veterinarian deems necessary to prevent and control  
50 the animal disease. During the suspension of waste analysis, waste product nutrient content to

1 be used for application of waste at no greater than agronomic rates shall be established by the  
2 1217 Interagency Committee as created by Session Law 1995-626."  
3

#### 4 **CLARIFY CONSTRUCTION OF FARM BUILDINGS ON STATE PROPERTY**

5 **SECTION 34.** G.S. 143-138(b4) reads as rewritten:

6 "(b4) Exclusion for Certain Farm Buildings. – Building rules do not apply to (i) farm  
7 buildings that are located outside the building-rules jurisdiction of any municipality, (ii) farm  
8 buildings that are located inside the building-rules jurisdiction of any municipality if the farm  
9 buildings are greenhouses, (iii) a primitive camp, or (iv) a primitive farm building. For the  
10 purposes of this subsection:

11 (1) A "farm building" shall ~~include any~~ include:

12 a. Any structure used or associated with equine activities, including, but  
13 not limited to, the care, management, boarding, or training of horses  
14 and the instruction and training of riders. Structures that are  
15 associated with equine activities include, but are not limited to, free  
16 standing or attached sheds, barns, or other structures that are utilized  
17 to store any equipment, tools, commodities, or other items that are  
18 maintained or used in conjunction with equine activities. The specific  
19 types of equine activities, structures, and uses set forth in this  
20 subdivision are for illustrative purposes, and should not be construed  
21 to limit, in any manner, the types of activities, structures, or uses that  
22 may be considered under this subsection as exempted from building  
23 rules. A farm building that might otherwise qualify for exemption  
24 from building rules shall remain subject only to an annual safety  
25 inspection by the applicable city or county building inspection  
26 department of any grandstand, bleachers, or other spectator-seating  
27 structures in the farm building. An annual safety inspection shall  
28 include an evaluation of the overall safety of spectator-seating  
29 structures as well as ensuring the spectator-seating structure's  
30 compliance with any building codes related to the construction of  
31 spectator-seating structures in effect at the time of the construction of  
32 the spectator-seating.

33 b. Any structure used for the display and sale of produce, no more than  
34 1,000 square feet in size, open to the public for no more than 180  
35 days per year, and certified by the Department of Agriculture and  
36 Consumer Services as a Certified Roadside Farm Market.

37 c. Any unoccupied structure built upon land owned by the State of  
38 North Carolina and administratively allocated to the North Carolina  
39 Department of Agriculture and Consumer Services or North Carolina  
40 State University which is used primarily for forestry production and  
41 research or agriculture production and research. The term  
42 "agriculture" has the same meaning as in G.S. 106-581.1. The term  
43 "unoccupied" does not exclude the keeping of livestock.

44 (1a) A "farm building" shall not lose its status as a farm building because it is  
45 used for public or private events, including, but not limited to, weddings,  
46 receptions, meetings, demonstrations of farm activities, meals, and other  
47 events that are taking place on the farm because of its farm or rural setting.

48 (2) A "greenhouse" is a structure that has a glass or plastic roof, has one or more  
49 glass or plastic walls, has an area over ninety-five percent (95%) of which is  
50 used to grow or cultivate plants, is built in accordance with the National  
51 Greenhouse Manufacturers Association Structural Design manual, and is not

- 1 used for retail sales. Additional provisions addressing distinct life safety  
2 hazards shall be approved by the local building-rules jurisdiction.
- 3 (3) ~~A "farm building" shall include any structure used for the display and sale of  
4 produce, no more than 1,000 square feet in size, open to the public for no  
5 more than 180 days per year, and certified by the Department of Agriculture  
6 and Consumer Services as a Certified Roadside Farm Market.~~
- 7 (4) A "primitive camp" shall include any structure primarily used or associated  
8 with outdoor camping activities, including structures used for educational,  
9 instructional, or recreational purposes for campers and for management  
10 training, that are (i) not greater than 4,000 square feet in size and (ii) are not  
11 intended to be occupied for more than 24 hours consecutively. "Structures  
12 primarily used or associated with outdoor camping activities" include, but  
13 are not limited to, shelters, tree stands, outhouses, sheds, rustic cabins,  
14 campfire shelters, picnic shelters, tents, tepees or other indigenous huts,  
15 support buildings used only for administrative functions and not for

39 SECTION 35.(a) G.S. 113-136(k) reads as rewritten:

40 "(k) It is unlawful to refuse to exhibit upon request by any inspector, protector, or other  
41 law enforcement officer any item required to be carried by any law or rule as to which  
42 inspectors or protectors have enforcement jurisdiction. The items that must be exhibited include  
43 boating safety or other equipment or any license, permit, tax receipt, certificate, or  
44 identification. It is unlawful to refuse to allow inspectors, protectors, or other law enforcement  
45 officers to inspect ~~weapons, equipment, fish, or wildlife that~~ weapons or equipment if the officer  
46 reasonably believes them to be possessed incident to an activity regulated by any law or rule as  
47 to which inspectors and protectors have enforcement jurisdiction. ~~jurisdiction and the officer has~~  
48 a reasonable suspicion that a violation has been committed, except that an officer may inspect a  
49 shotgun to confirm whether it is plugged or unplugged without a reasonable suspicion that a  
50 violation has been committed. It is unlawful to refuse to allow inspectors, protectors, or other  
51 law enforcement officers to inspect fish or wildlife for the purpose of ensuring compliance with

1 bag limits and size limits. Except as authorized by G.S. 113-137, nothing in this section gives  
2 an inspector, protector, or other law enforcement officer the authority to inspect, in the absence  
3 of a person in apparent control of the item to be inspected, any of the following:

4 (1) Weapons.

5 (2) Equipment, except for equipment left unattended in the normal operation of  
6 the equipment, including, but not limited to, traps, trot lines, crab pots, and  
7 fox pens.

8 (3) Fish.

9 (4) Wildlife."

10 **SECTION 35.(b)** The Wildlife Resources Commission shall report to the Joint  
11 Legislative Oversight Committee on Justice and Public Safety no later than March 1, 2016, and  
12 annually thereafter, on the number of complaints received against Commission law  
13 enforcement officers, the subject matter of the complaints, and the geographic areas in which  
14 the complaints were filed.

15 **SECTION 35.(c)** Subsection (a) of this section becomes effective December 1,  
16 2015, and applies to offenses committed on or after that date. The remainder of this section is  
17 effective when it becomes law.
