7 WAIVER PARTICIPANTS

8 SECTION 12F.18.(a) In order to promote self-determination, increase
9 independence and enhance the ability of individuals with intellectual and other related
10 developmental disabilities to interact with and contribute to the local community, the
11 Department of Health and Human Services shall develop a plan for extending Community
12 Guide services to all individuals on the Innovations Waiver waiting list. The Department shall
13 engage local management entities/managed care organizations (LME/MCOs) and other
14 relevant stakeholders in the process of developing the plan. The plan shall include at least all
15 of the following:

- 16 (1) Any necessary revisions to current service definitions, any proposed new
17 service definitions, or both.
- 18 (2) The potential cost of extending Community Guide services to all individuals
19 on the Innovations Waiver waiting list.
- 20 (3) The delineation of any changes that would require approval of the federal
21 Centers for Medicare and Medicaid Services.
- 22 (4) Detailed information on comprehensive strategies to ensure that providers of
23 Community Guide services transmit to LME/MCOs information regarding
24 the critical needs of the individuals being served.

25 SECTION 12F.18.(b) By March 15, 2016, the Department shall report to the Joint
26 Legislative Oversight Committee on Health and Human Services and the Fiscal Research
27 Division on the plan developed pursuant to subsection (a) of this section.""
