1 Moves to amend the bill on page 23, lines 34-35, by inserting between the lines a section to
2 read:

3 "SECTION 40.6.(a) G.S. 20-63(b1), as amended by subsection (a) of Section
4 29.40 of S.L. 2015-241, reads as rewritten:

5 "(b1) The following special registration plates do not have to be a "First in Flight" plate or
6 "First in Freedom" plate as provided in subsection (b) of this section. The design of the plates
7 that are not "First in Flight" plates or "First in Freedom" plates must be developed in
8 accordance with G.S. 20-79.4(a3). For special plates authorized in G.S. 20-79.7 on or after July
9 1, 2013, the Division may not issue the plate on a background under this subsection unless it
10 receives at least 200 applications for the plate in addition to the applications required under
11 G.S. 20-79.4 or G.S. 20-81.12.

12 ...

13 (53) Kappa Alpha Psi Fraternity."

14 SECTION 40.6.(b) G.S. 20-79.4(b)(105) reads as rewritten:

15 "(105) Kappa Alpha Psi Fraternity. – Issuable to the registered owner of a motor
16 ~~vehicle~~ vehicle who is a member of the Kappa Alpha Psi Fraternity. The
17 plate shall bear the fraternity's symbol and name. The Division may not issue
18 the plate authorized by this subdivision unless it receives at least 300
19 applications for the plate."

20 SECTION 40.6.(c) Nothing in G.S. 20-63(b1) or G.S. 20-79.3A(a) shall be
21 construed as requiring an additional 200 applications for the Division of Motor Vehicles to
22 issue a full-color background "Kappa Alpha Psi Fraternity" special registration plate in
23 accordance with G.S. 20-63(b1), as amended by subsection (a) of this section.

24 SECTION 40.6.(d) This section becomes effective 90 days after S.L. 2015-241
25 became law."
