9	(a)	The fit	nance officer shall have the following powers and duties:
10		(1)	He shall keepKeep the accounts of the local government or public authority in
11			accordance with generally accepted principles of governmental accounting and
12			the rules and regulations of the Commission.
13		(2)	He shall disburse Disburse all funds of the local government or public authority
14			in strict compliance with this Chapter, the budget ordinance, and each project
15			ordinance and shall preaudit obligations and disbursements as required by this
16			Chapter.
17		(3)	As often as may be requested by the governing board or the manager, he shall
18			prepare Prepare and file with the board a statement of the financial condition of
19			the local government or public authority.authority, as often as may be requested
20			by the governing board or the manager.
21		(4)	He shall receive Receive and deposit all moneys accruing to the local
22			government or public authority, or supervise the receipt and deposit of money
23			by other duly authorized officers or employees.
24		(5)	He shall maintain Maintain all records concerning the bonded debt and other
25			obligations of the local government or public authority, determine the amount
26			of money that will be required for debt service or the payment of other
27			obligations during each fiscal year, and maintain all sinking funds.
28		(6)	He shall supervise Supervise the investment of idle funds of the local
29			government or public authority.
30		(7)	He shall perform Perform such other duties as may be assigned to him by law,

1 duties conferred by this section on the finance officer shall be deemed to refer to the finance 2 officer. 3 Except as otherwise provided by law, all checks or drafts on an official depository shall (b) 4 be signed by the finance officer or a properly designated deputy finance officer and countersigned 5 by another official of the local government or public authority designated for this purpose by the 6 governing board. If the board makes no other designation, the chairman of the board or chief 7 executive officer of the local government or public authority shall countersign these checks and 8 drafts. The governing board of a unit or authority may waive the requirements of this subsection if 9 the board determines that the internal control procedures of the unit or authority will be 10 satisfactory in the absence of dual signatures. 11 The Local Government Commission has authority to issue rules and regulations having (c) 12 the force of law governing procedures for the receipt, deposit, investment, transfer, and 13 disbursement of money and other assets by units of local government and public authorities, may 14 inquire into and investigate the internal control procedures of a local government or public 15 authority, and may require any modifications in internal control procedures which, in the opinion 16 of the Commission, are necessary or desirable to prevent embezzlements or mishandling of public 17 moneys. 18 (d) The Local Government Commission has the authority to require any finance officer or 19 any other employee who performs the duties of a finance officer to participate in training related to the powers, duties, and responsibilities of the finance officer, if the Commission is exercising its 20 21 authority under Article 10 of this Chapter with respect to the employing local government or 22 public authority or the employing local government or public authority has received a unit letter 23 from the Commission due to a deficiency in complying with this Chapter. The Commission may 24 collaborate with the School of Government at the University of North Carolina, the North Carolina 25 Community College System, and other educational institutions in the State to develop and deliver 26 the training required by this subsection." **SECTION 2.** G.S. 159-6 is amended by adding a new subsection to read: 27 28 "(f) The Commission may charge and collect fees for expenses incurred in developing and 29 delivering the training for finance officers and other employees who perform the duties of a 30 finance officer under G.S. 159-25." 31 **SECTION 3.** This act is effective when it becomes law.
