Short Title: Modify Various Appointments. (Public)

Sponsors: Committee on Rules, Calendar, and Operations of the House.

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO MODIFY TERMS OF APPOINTMENT FOR VARIOUS BOARDS.  
3 The General Assembly of North Carolina enacts:

4 SECTION 1. G.S. 143-548 reads as rewritten:  
5 "§ 143-548. Vocational Rehabilitation Council.

- 6 ...  
7 (d1) Terms of Appointment. –  
8 (1) Length of Term. – Each member of the Council shall serve for a term of not  
9 more than three years, except that:  
10 a. A member appointed to fill a vacancy occurring prior to the expiration  
11 of the term for which a predecessor was appointed shall be appointed  
12 for the remainder of that term;  
13 b. The terms of service of the members initially appointed are as specified  
14 by the appointing authority for a fewer number of years as will provide  
15 for the expiration of terms on a staggered basis and shall include the  
16 members of the existing Council to the extent possible with appropriate  
17 adjustments to their terms;  
18 c. The appointing authority shall have the power to remove any member of  
19 the Council from office in accordance with the provisions of  
20 G.S. 143B-16; and  
21 d. A member may continue to serve until a successor for the position is  
22 appointed;  
23 (2) Number of Terms. – No member of the Council other than the representative of  
24 the Client Assistance ~~Program-Program~~, the representative of a parent training  
25 and information center, and the representative of the directors of projects  
26 carried out under section 121 of the Rehabilitation Act of 1973, 29 U.S.C. §  
27 741, as amended, may serve more than two consecutive full terms.

29 SECTION 2. G.S. 140-5.13 reads as rewritten:  
30 "§ 140-5.13. Board of Trustees. – establishment; members; selection; quorum;  
31 compensation; officers; meetings.

33 (b) The Board of Trustees of the North Carolina Museum of Art shall consist of 25  
34 members, chosen as follows:

1 All regular appointments or elections except those by the General Assembly shall be for terms of  
2 six years, except that each member shall serve until the member's successor is chosen and  
3 qualifies. No person may be appointed or elected to more than two consecutive terms of six years.  
4 All ~~regular~~ appointments by the General Assembly shall be for ~~the then current legislative term,~~  
5 ~~and no appointee of the General Assembly may be appointed to more than two consecutive terms~~  
6 ~~of two years-four years with no person being appointed to more than three consecutive terms.~~  
7 ...."

8 **SECTION 3.** This act is effective when it becomes law.
