 2 by rewriting that line to read:
 3 "SECTION 12. G.S. 143B-68 reads as rewritten:
 4 "**§ 143B-68. Public Librarian Certification Commission – members; selection; quorum;**
 5 **compensation.**
 6 The Public Librarian Certification Commission of the Department of Natural and Cultural
 7 Resources shall consist of five members as follows: (i) ~~the chairman of the North Carolina~~
 8 ~~Association of Library Trustees, (ii) the chairman of the public libraries section of the North~~
 9 ~~Carolina Library Association, (iii) an individual (ii) two individuals~~ named by the Governor upon
 10 the nomination of the North Carolina Library Association, ~~(iv) (iii) the dean of a State or regionally~~
 11 ~~accredited graduate school of librarianship in North Carolina appointed by the Governor~~
 12 ~~Governor, and (v) (iv) one member at large appointed by the Governor.~~
 13 The members shall serve four-year terms or while holding the appropriate chairmanships. Any
 14 appointment to fill a vacancy created by the resignation, dismissal, death or disability of a member
 15 shall be for the balance of the unexpired term.
 16 The Governor shall have the power to remove any member of the Commission from office for
 17 misfeasance, malfeasance, and nonfeasance according to the provisions of G.S. 143B-13 of the
 18 Executive Organization Act of 1973.
 19 The members of the Commission shall receive per diem, and necessary travel expenses in
 20 accordance with the provisions of G.S. 138-5.
 21 A majority of the Commission shall constitute a quorum for the transaction of business.
 22 All clerical and other services required by the Commission shall be supplied by the Secretary
 23 of the Department through the regular staff of the Department."
 24 **SECTION 13.** This act is effective when it becomes law."
