Short Title: Morrow Mountain State Park License Plate. (Public)

1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A  
3 MORROW MOUNTAIN STATE PARK SPECIAL REGISTRATION PLATE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.4(b) reads as rewritten:

6 "(b) Types. – The Division shall issue the following types of special registration plates:

7 ...

8 (i) Morrow Mountain State Park. – Issuable to the registered owner of a motor  
9 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase  
10 "Morrow Mountain State Park" and a logo designed by the Friends of Morrow  
11 Mountain State Park. The plate authorized by this subdivision is not subject to  
12 the provisions of G.S. 20-79.3A.

13 ...."

14 **SECTION 2.** G.S. 20-79.7 reads as rewritten:

15 "**§ 20-79.7. Fees for special registration plates and distribution of the fees.**

16 ...

17 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle  
18 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

25 (b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and  
26 Cultural Attraction Plate Account are established within the Highway Fund. The Division must  
27 credit the additional fee imposed for the special registration plates listed in subsection (a) of this  
28 section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural  
29 Attraction Plate Account (CCAPA), the Clean Water Management Trust Fund (CWMTF), which  
30 is established under G.S. 113A-253, and the Parks and Recreation Trust Fund, which is  
31 established under G.S. 113-44.15, as follows:

3 **SECTION 3.** G.S. 20-81.12 reads as rewritten:

4 "**§ 20-81.12. Collegiate insignia plates and certain other special plates.**

5 ...

6 (b155) Morrow Mountain State Park. – The Division must receive 300 or more applications  
7 for the Morrow Mountain State Park plate before the plate may be developed. The Division shall  
8 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from  
9 the sale of Morrow Mountain State Park plates to the Friends of Morrow Mountain State Park to  
10 be used to provide support for the organization.

11 ...."

12 **SECTION 4.** The Revisor of Statutes is authorized to alphabetize, number, and  
13 renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special  
14 registration plates are listed in alphabetical order and numbered accordingly.

15 **SECTION 5.** This act becomes effective July 1, 2018.
