Short Title: Mayberry Special Registration Plate. (Public)

Sponsors: Senator Randleman (Primary Sponsor).

Referred to:

1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A
3 MAYBERRY SPECIAL REGISTRATION PLATE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.4(b) reads as rewritten:

6 "(b) Types. – The Division shall issue the following types of special registration plates:

7 ...

8 () Mayberry. – Issuable to the registered owner of a motor vehicle in accordance
9 with G.S. 20-81.12. The plate shall bear a representation of an adult and a child
10 going fishing that is similar to the imagery in the opening credits of "The Andy
11 Griffith Show" and the word "Mayberry" below the representation.

13 **SECTION 2.** G.S. 20-79.7 reads as rewritten:

14 **"§ 20-79.7. Fees for special registration plates and distribution of the fees.**

15 ...

16 (a1) Fees. – All other special registration plates are subject to the regular motor vehicle
17 registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

23 (b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and
24 Cultural Attraction Plate Account are established within the Highway Fund. The Division must
25 credit the additional fee imposed for the special registration plates listed in subsection (a) of this
26 section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural
27 Attraction Plate Account (CCAPA), the Clean Water Management Trust Fund (CWMTF), which
28 is established under G.S. 113A-253, and the Parks and Recreation Trust Fund, which is
29 established under G.S. 113-44.15, as follows:

3 **SECTION 3.** G.S. 20-81.12 reads as rewritten:

4 "**§ 20-81.12. Collegiate insignia plates and certain other special plates.**

5 ...

6 (b155) Mayberry. – The applicable requirements of G.S. 20-79.3A shall be met before the
7 Mayberry plate may be developed. The Division shall transfer quarterly the money in the
8 Collegiate and Cultural Attraction Plate Account derived from the sale of Mayberry plates to the
9 Surry Arts Council to be used to provide support for the Council.

11 **SECTION 4.** The Revisor of Statutes is authorized to alphabetize, number, and
12 renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
13 registration plates are listed in alphabetical order and numbered accordingly.

14 **SECTION 5.** This act becomes effective July 1, 2018.
