1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE COASTAL PREPARATORY ACADEMY, GIRLS
3 LEADERSHIP ACADEMY OF WILMINGTON, PINE SPRINGS PREPARATORY
4 ACADEMY, AND UNITY CLASSICAL CHARTER SCHOOL TO ELECT TO
5 PARTICIPATE IN THE STATE HEALTH PLAN FOR TEACHERS AND STATE
6 EMPLOYEES.

7 The General Assembly of North Carolina enacts:

8 **SECTION 1.** Notwithstanding the time limitation contained in G.S. 135-48.54, the
9 Board of Directors of Coastal Preparatory Academy, a charter school located in Wilmington,
10 may elect to become a participating employing unit in the State Health Plan for Teachers and
11 State Employees in accordance with Article 3B of Chapter 135 of the General Statutes. The
12 election authorized by this act shall be made no later than 30 days after the effective date of this
13 act and shall be made in accordance with all other requirements of G.S. 135-48.54.

14 **SECTION 2.** Notwithstanding the time limitation contained in G.S. 135-48.54, the
15 Board of Directors of Girls Leadership Academy of Wilmington, a charter school located in
16 Wilmington, may elect to become a participating employing unit in the State Health Plan for
17 Teachers and State Employees in accordance with Article 3B of Chapter 135 of the General
18 Statutes. The election authorized by this act shall be made no later than 30 days after the
19 effective date of this act and shall be made in accordance with all other requirements of
20 G.S. 135-48.54.

21 **SECTION 3.** Notwithstanding the time limitation contained in G.S. 135-48.54, the
22 Board of Directors of Pine Springs Preparatory Academy, a charter school located in Holly
23 Springs, may elect to become a participating employing unit in the State Health Plan for
24 Teachers and State Employees in accordance with Article 3B of Chapter 135 of the General
25 Statutes. The election authorized by this act shall be made no later than 30 days after the
26 effective date of this act and shall be made in accordance with all other requirements of
27 G.S. 135-48.54.

28 **SECTION 4.** Notwithstanding the time limitation contained in G.S. 135-48.54, the
29 Board of Directors of Unity Classical Charter School, a charter school located in Charlotte,
30 may elect to become a participating employing unit in the State Health Plan for Teachers and
31 State Employees in accordance with Article 3B of Chapter 135 of the General Statutes. The
32 election authorized by this act shall be made no later than 30 days after the effective date of this
33 act and shall be made in accordance with all other requirements of G.S. 135-48.54.

34 **SECTION 5.** This act is effective when it becomes law.
