HOUSE BILL DRH10175-MT-103A (03/09)

Short Title: School Calendar Flex./Union County. (Local)

Sponsors: Representatives Arp, Brody, and Horn (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED
2 AN ACT TO PROVIDE ADDITIONAL FLEXIBILITY TO UNION COUNTY PUBLIC
3 SCHOOLS IN ADOPTING THE SCHOOL CALENDAR.

4 Whereas, the State-mandated, late-August start date combined with the instructional
5 time requirement means that high schools cannot complete the first semester until mid-January,
6 which can negatively impact their preparation and performance; and

7 Whereas, the State-mandated, late-August start date puts high school calendars out
8 of alignment with community colleges and four-year universities, which typically begin the
9 first semester earlier in August and begin the second semester two or three weeks before high
10 school students complete the fall semester, which creates barriers to enrollment; and

11 Whereas, the late-August start date and other requirements of the calendar law make
12 it more difficult for school districts to schedule professional development days during the
13 school year; and

14 Whereas, the Union County Board of Education has recognized the need to provide
15 additional days of instruction to students in school where there is a higher percentage of
16 children in poverty; and

17 Whereas, local boards of education have powers of supervision and control over
18 local school systems; and

19 Whereas, allowing the Union County Board of Education to have additional
20 flexibility with setting start and end dates for its school calendar will help alleviate the issues
21 delineated above while giving more authority to that locally elected body, which is statutorily
22 empowered to govern the school system; Now, therefore,
23 The General Assembly of North Carolina enacts:

24 **SECTION 1.** G.S. 115C-84.2(d) reads as rewritten:

25 "(d) Opening and Closing Dates. – Local boards of education shall determine the dates
26 of opening and closing the public schools under subdivision (a)(1) of this section. Except for
27 year-round schools, the opening date for students shall be no earlier than the ~~Monday closest to~~
28 ~~August 26, second Tuesday in August,~~ and the closing date for students shall be no later than
29 the ~~Friday closest to June 11. On a showing of good cause, the State Board of Education may~~
30 ~~waive the requirement that the opening date for students be no earlier than the Monday closest~~
31 ~~to August 26 and may allow the local board of education to set an opening date no earlier than~~
32 ~~the Monday closest to August 19, to the extent that school calendars are able to provide~~
33 ~~sufficient days to accommodate anticipated makeup days due to school closings.~~
34 second Tuesday in June. A local board may revise the scheduled closing date if necessary in order to
35 comply with the minimum requirements for instructional days or instructional time. ~~For~~
36 ~~purposes of this subsection, the term "good cause" means that schools in any local school~~

1 ~~administrative unit in a county have been closed eight days per year during any four of the last~~
2 ~~10 years because of severe weather conditions, energy shortages, power failures, or other~~
3 ~~emergency situations.~~

4 The required opening and closing dates under this subsection shall not apply to any school
5 that a local board designated as having a modified calendar for the 2003-2004 school year or to
6 any school that was part of a planned program in the 2003-2004 school year for a system of
7 modified calendar schools, so long as the school operates under a modified calendar."

8 **SECTION 2.** G.S. 115C-174.12(a)(4) reads as rewritten:

9 "(4) All annual assessments of student achievement adopted by the State Board
10 of Education pursuant to G.S. 115C-174.11(c)(1) and (3) and all final exams
11 for courses shall be administered within the final 10 instructional days of the
12 school year for year-long courses and within the final five instructional days
13 of the semester for semester courses. Exceptions shall be permitted to
14 accommodate a student's individualized education program and section 504
15 (29 U.S.C. § 794) plans and for the administration of final exams for courses
16 with national or international curricula required to be held at designated
17 times. A local board of education that has implemented a school calendar
18 that concludes the fall semester prior to December 31 shall be permitted to
19 administer assessments prior to the conclusion of that semester."

20 **SECTION 3.** This act applies only to Union County Public Schools.

21 **SECTION 4.** This act is effective when it becomes law and applies beginning with
22 the 2017-2018 academic year.
