3 **SECTION 4.** The Office of the Secretary of State and the Department of Revenue 4 may include in the instructions of the annual report forms an explanation that status as a 5 veteran-owned small business or service-disabled veteran-owned small business is being 6 requested to assist the State in documenting the importance and impact of the State's military 7 population in our communities and on our State and local economies. The Office of the Secretary of State shall submit the first annual report required by G.S. 55-16-22.2, 57D-2-25, 8 9 and 59-84.5 to the Department of Military and Veterans Affairs no later than March 1, 2019.

10 SECTION 5. This act becomes effective January 1, 2018, and applies to annual 11 reports filed by business entities on or after that date.
